## NEWSBRIEFS

### Tax notice time

*Courier* readers are advised that the next several issues will contain the effective tax rate notices of many taxing entities in both the Eastern portions and the Upper Valley areas of El Paso County, such as school districts, water districts and municipalities. These notices contain information about current and proposed tax rates and public meetings to be held by the various elected boards. Our readers who own property and pay taxes are encouraged to be aware of the notices that concern them. Most regular features of the *Courier* will be included in these issues, however, management apologizes that other news content may be lighter than normal.

### Fabens bridge debate

The El Paso County Commissioners Court as a whole is not as concerned about the speed with which the Fabens Bridge Project is progressing as one of its members, County Commissioner Miguel Teran, who wants the commission to send a sharp letter to the Texas Department of Transportation because, he said, they are not moving fast enough to assure the government of Mexico. Teran said that TxDOT isn't moving fast enough on environmental assessment of the project to keep up with "the political situation in Mexico." TxDOT advanced planning administrator Judy Ramsey said the state is moving as fast as it can. The court declined to send the letter and turned down a request by the County Planning Dept. and Teran to approve the project's design and construction plans before they are finished in order to assure Mexico that the project is moving ahead.

## Schulte's resignation as superintendent of SISD accepted

EAST EL PASO COUNTY — The Socorro School District school year is well underway since its 30,000 or students trooped back to class July 29. However, the top job in the district experienced a vacuum as of last Friday evening.

On a split vote, 4-3, the Socorro ISD trustees voted to accept the resignation of Dr. Don P. Schulte.

Those voting in favor of releasing Schulte were Craig Patton, Alex Vidales, Martha Contreras, and Guillermo Gandara.

Those voting against acceptance of the resignation were Barbara Perez-Peña, Isela Rosales and Brenda Castañeda.

Though the board met subsequently in closed session to consider alternative leadership for the district, no decision was announced other than to take the matter up again during future meetings.

Schulte was not at the meeting and a Socorro district spokesman said he will be on vacation until his resignation becomes effective, Aug. 31.

In a letter faxed to the *Courier* last Tuesday evening, Schulte thanked the Socorro district

and community for all the opportunities he has enjoyed over the past years.

"I am proud of my years at Socorro," Schulte wrote. "Together we have attained significant achievements. Our outstanding student performance led to three straight years as a Recognized District from 1998 to 2001. Our quality building program has provided beautiful new schools for our children and allowed us this year to offer full day kindergarten for the first time in our history.

"I have seen the district grow from about 3,000 students in the late 70s to a current enrollment of almost 30,000. During my years we were among those districts that fought for equity in public school funding. It was a courageous move for a small property-poor school district, but we succeeded.

"Socorro has been more than just a job to me...it's been my home. My coworkers are like my family."

Schulte has been a part of the Socorro school district for almost 25 years, first as a teacher, then administrator. He was assistant to two of his predecessors, former superintendents Bill Sybert and Jerry Barber, before being ap-

## Historic fiesta in Clint enters 88th year

CLINT — This year marks the 88th Annual Fiesta de San Lorenzo. Since the church was completed in 1914 the parishioners and the Lower Valley community have honored St. Lawrence on his feast day, Aug. 10.

St. Lawrence is a favorite of Catholic St. because he is said to answer more prayers. More than 30,000 pilgrims visit the small town of Clint each year from all over the world for the fiesta. Locals from Clint, San Elizario, Socorro and Fabens consider the Fiesta both family and class reunion time, as many of the family and friends who now live out of town come home for this annual event.

This year's fiesta begins on Aug. 9 at noon with 60 vendor booths. Saturday, Aug. 10, the festivities begin at 3 a.m. with a pilgrimage from San Elizario Mission to San Lorenzo. Buses will carry pilgrims beginning at 2 a.m. from San Lorenzo to San Elizario for the two mile procession led by matachines and pastoral members from the El Paso Catholic Diocese. Mass will follow the procession at daybreak. A second mass is at 11 a.m. followed by a shorter procession and the third mass is at 6

p.m. The matachines dance all day Saturday in honor of San Lorenzo until midnight. Sunday, mass is at 8 a.m. in Spanish, 9:30 a.m. and 11 a.m. in English.

The Fiesta organizers encourage everyone wishing to walk in pilgrimage to be a part of the organized procession on Saturday morning which will be escorted by local law enforcement and the volunteer fire department. Those walking on their own should use extreme caution and carry an umbrella, water, do not walk alone, and wear light colored clothing or reflective vest so that motorists can see you. Texas 20 (Alameda), North Loop and FM 1110 are rural roads and do not have street lighting and in some areas do not have asphalt or gravel shoulders.

To get to San Lorenzo Church take I-10 east to the Clint exit. Turn south at FM 1110 to North Loop. Turn right on North Loop heading west and a left turn at Fenter Rd. will lead you to the FM 1110 extension. Turn left onto the extension which will lead you to the front of the fiesta plaza. From the Lower Valley take Texas Highway 20 (Alameda) east to Clint. Turn left at Clint Rd. and over the railroad tracks.

## Canutillo High School gets new principal in personnel shift

CANUTILLO — Renee Rios-O'Donnell says her professional life no longer revolves around a class bell schedule.

School life for Rios-O'Donnell, former principal of Canutillo High, is no longer the educational microcosm, as she put it, reflecting the larger picture of the Canutillo Independent School District. As the new executive director of human resources for Canutillo ISD, that microcosm is now a wide-angle lens with which she sees new issues as well as many of the same ones she dealt with as principal.

An educator with 25 years experience, she replaces Gwen Keefer who retired in June. The reassignment of Rios-O'Donnell from high school campus to central administration building was one of seven recent personnel shifts in Canutillo ISD necessitated by retirements and reorganization.

Dr. John Kessinger, assistant superintendent, describes the changes as "fine-tuning" the school district's operations and making it more efficient with a "better match" of personnel with their job.

"I miss the high school very much; I miss being around the students," says Rios-O'Donnell who was its principal for four years. She says that stepping out into the hallways filled with students gave her a good feeling — a new feeling that was "rejuvenating, uplifting and motivational" in nature.

The programs and duties of one position have been restructured into two in the central office. The position of special programs director, previously held by Dr. Pam Padilla, has been separated into curriculum/evaluation director and student/community services director.

Padilla was named assistant superintendent for student performance in February,

## Socorro mayor appoints new interim chief of police

SOCORRO — The City of Socorro Police Dept. has been functioning with instability for the past year. It has been less than a year since their Chief of Police resigned in October of 2001. Following his resignation, City Council appointed Sgt. Manuel Ponce as the Interim Chief of Police.

Most recently, during a regular work day, Socorro Mayor Irma Sanchez released Interim Chief of Police Ponce of his duties as Chief of Police, subsequently appointing Officer Irma Molina as the new Interim Chief of Police.

Several community members came forward during open forum of the regularly scheduled City Council meeting on Aug. 1, 2002, to express their concern over the Mayor's recent appointment.

It is their opinion that other police officers are more experienced and are higher ranking than Molina should have been considered for the position. Mayor Sanchez did not respond to the community members' concerns and instead proceeded with the remainder of the meeting.

In another issue that has stirred controversy in the Socorro community, Council dealt with the appointment of a new City Judge. The issue has been placed on the agenda of the previous two Council meetings but was tabled to allow councilmen the opportunity to further research all applicants.

The City Charter calls for the position to be held by a qualified applicant and also a resident of the City of Socorro, Texas. These restrictions have caused some of the applicants to be disqualified as viable candidates.

During the Aug. 1 meeting Mayor Sanchez recommended that Eduardo Flores be the new City Judge and Council approved the Mayor's recommendation. Flores holds a Bachelor's degree in Criminal Justice and is also a resident of Socorro. Flores will work part-time as the City Judge and will also receive half the salary due to the position now being a part-time position.

In other business, a public hearing was held on an ordinance amending the budget for FY Oct. 1, 2001 to Sept. 30, 2002. There was very little input regarding the waiver of building permits for the Socorro Independent School District either for and against. Mayor Sanchez then closed the hearing and Council approved the ordinance.

Mayor Sanchez also told Council she would like to either amend the current travel policy for the City of Socorro employees and Council members or completely rewrite the policy. Some concerns regarding per diem reimbursements is what brought her to the decision to study the policy and possibly amend it or rewrite it. City Council tabled the agenda item in order to investigate the Mayor's concern.

# Schulte latest victim of insidious, pesky, incurable virus

Such style and grace. Reminds me of the proverb about using kindness to heap coals of fire on the heads of your enemies.

Don Schulte can afford to. After all, the Socorro school district needs him a lot more than he needs it. Too bad the new school board majority doesn't recognize that.

Dr. Schulte resigned one other time, in March of 1998, when a similar political situation fomented until he was not allowed to do his job. In a similarly gracious letter, he wished the board well, and quietly accepted a supervisory position with Region 19.

By June of that year, the people had spoken and the primary discordant force — Hector Enriquez — has been given his walking papers. A new board majority promptly tossed out a requirement that the superintendent must hold a doctorate and invited him back with open arms. Schulte, with equal promptness, completed his doctorate.

There are two common factors in Schulte's resignations. Trustees Craig Patton and Alex Vidales.

Patton was known to be allied with Enriquez at the time of Schulte's first resignation. Like any good politician, Patton could see that with Enriquez no longer leading the charge, the ship was sinking. He leapt with considerable deftness onto the life raft of offering the elusive superintendent his old job back. Vidales stuck to his guns, voting no.

When his term was up, Patton did not run again.

Fast-forward a few years.

Re-elected to the board in May of this year, Patton was handed the plum position of board president, a soap box from which he resumed his pattern of "questioning" and "investigating" — politically correct terms that are interchangeable with "interfer-

ing" and "meddling." These are terms often paraded by politicians to show how involved and incisive they will be when elected to positions of power.

The problem with this, however, is that these grandiose "questionings" are seldom followed up with positive alternatives or decisive action.

For example, Patton's dissatisfaction with the Montwood Wellness Clinic contract with Texas Tech has been well-publicized in the El Paso media since his new board presidency was in its infancy. Even so, as late as last week, Patton said he still did not have enough information to make a recommendation.

Excuse me?


As an attorney, you'd think he would be able to find out what he needs to know in a matter of weeks, not months, especially since he made it such a media issue. I keep waiting for that decisive action, that positive alternative — anything to back up the smoke and mirrors.

Heaven forbid that he should have taken the matter quietly to Schulte and Tech officials for resolution.

I have no personal idea why Schulte decided to resign. Based on his references to "home" and "family" when he mentions the Socorro district and staff in his resignation, I don't believe he really wanted to. It is being rumored in the media — which can't seem to let well enough alone, either — whether or not family issues are to blame.

Perhaps so. But it makes little difference. The insidious, pesky, incurable virus of political ambition has once again infected the Socorro school board and the fruits of that disease are well known throughout El Paso County.

I don't believe the recent push to have Socorro ISD board meetings



televised is based on a genuine concern for the public's right to know.

It is always amazing to me that the unpaid, supposedly altruistic

position of school board trustee can become such a springboard for political posturing.

Schulte has publicly mentioned he desires to eventually teach education at the college level — certainly a college professor isn't subject to the whims and political aspirations of small-time politics.

With all he has to offer, Schulte will be of extraordinary value to any academic unit he joins. I just hate to see the Socorro school board allow him to pull up a rocking chair beside all the other good guys on the porch.

that time, Schulte was my assistant. He was a hell of a lot more capable than I was."

Considering that Schulte had supervised every district function from finance, food service, transportation and construction, the 1997 board decided to waive the requirement that the superintendent must have completed a doctorate — Schulte was in a doctorate program at the time which he has since successfully completed.

The '97 board was also aware that Schulte had been the Socorro ISD representative on the Texas State Board of Education and before the Texas Legislature for four years, and played a key leadership role in bringing about historic changes to make state funding of schools more equitable for poor districts.

Known for giving credit where credit is due, Schulte's superintendency has emphasized the term "we" based on his stated philosophy that academic progress rests on the collective power of unified teachers, students and faculty.

In conclusion to his resignation, Schulte said he believed the commitment to excellence he sought to foster would continue.

"Change is never easy, but I feel good about what we've accomplished here and I know that commitment to excellence will continue. I truly appreciate all the school boards I have served with and I wish the current board the best of luck in the future."

## NOTICE OF EFFECTIVE TAX RATE

### 2002 Property Tax Rates in the City of Socorro

This notice concerns 2002 property tax rates for the **City of Socorro**. It presents information about three tax rates. Last year's tax rate is the actual rate the taxing unit used to determine property taxes last year. This year's *effective* tax rate would impose the same total taxes as last year if you compare properties taxed in both years. This year's *rollback* tax rate is the highest tax rate the taxing unit can set before taxpayers can start tax rollback procedures. In each case these rates are found by dividing the total amount of taxes by the tax base (the total value of taxable property) with adjustments as required by state law. The rates are given per \$100 of property value.



## Phamiliar phrases "climb on the bandwagon"

This phrase, meaning "to join in support of," comes from the once-common practice of sending a band around town on a wagon to rally voters to come to a meeting. Local leaders might hop on and ride along, calling out slogans in support of the candidate.







# San Elizario elementary schools get new look with uniforms

SAN ELIZARIO — Alarcón Elementary will start new look August 19; Middle School implements standard gym attire

Students attending Alarcón Elementary will begin the 2002-03 school year wearing uniforms thanks to overwhelming parental support while Borrego and Sambrano Elementary Schools won't be too far behind.

Alarcón parents voiced strong interest for the change during the 2001-02 school year and this prompted the campus to survey teachers and parents in the spring. The surveys showed that 87% of parents at the campus approved of their children wearing uniforms. Borrego and Sambrano Elementary Schools are also getting very favorable feedback from parents at their respective campuses. The Board of Trustees approved of the mandatory attire during the regular July meeting.

"Research has proven that uniforms provide a stabilizing affect on students," said Superintendent Mike Quatrini. "The affects range from disciplinary and behavioral issues, academic success and even cost-effectiveness for parents. Since the Middle School implemented standard uniform attire, much improvement has occurred with regard to these same issues."

Alarcón Principal Virginia Padilla agreed. She said that the uniforms worn at her campus will help students place a shift towards academics rather than how they look.

"It's going to enhance academics," Padilla said. "For parents, the change will help economically."

From now on, students at Alarcón will wear navy blue polo shirts with no logos on them and khaki pants and shorts for the boys, khaki pants, shorts, skirts/skorts and capris for girls. There has been no change in the dress code for footwear. Parents can purchase uniforms at Wal-Mart, Target, K-Mart, Mex-Tex, a specialty uniform store, sells navy blue polo shirts with the San Elizario district logo (the only acceptable logo for shirts), as well as khaki apparel.

Meanwhile, Borrego and Sambrano Elementary Schools will gradually start implementing the new uniform policy as parents continue to turn in their surveys during the 2002-03 school year. The policy would then become mandatory during the 2003-04 school year.

Uniforms are not new to the district. San Elizario Middle School became the first district campus to implement standard attire during the 1999-2000 year. In 2002-03, Middle School students will be required to suit out in standard gym attire for P.E. classes.


