## National recognition goes to Canutillo HS seniors

CANUTILLO — Tahlia Leyva and Erik Pavia, Canutillo High School seniors, were recognized recently by the College Board's National Hispanic Recognition Program (NHRP).

The NHRP is a college board program that provides national recognition of the exceptional academic achievements of Hispanic high school seniors. The Board identifies these students for post-secondary institutions that are particularly interested in communicating with

## Socorro council will start meeting earlier in the evening

SOCORRO — It is common practice for City Council meetings in Socorro to be very lengthy and Council members are committed to staying late in the evening to complete the agenda — one recent meeting went as late as 2 a.m.

Because of the consistent excessive length of City Council meetings, City Representative Mary Perez said she decided to put an item on the agenda to change the time for regularly scheduled City Council meetings.

Some council members suggested meeting early in the day as a council, to discuss the agenda items prior to the regularly scheduled meeting, which they felt would expedite the meeting. However, because some City Council members have other commitments during

the day, it would not be feasible to meet prior to each meeting.

After several minutes of discussion, Council voted to change the meeting time for regularly scheduled meetings to 5 p.m. It is the hope of City Council to also ease the burden of late night meetings on concerned citizens who wish to attend the meetings.

In other council business, an ordinance to ban cigarette smoking in all public buildings in Socorro will be brought up for a public hearing on Dec. 7, according to Socorro Mayor Trini Lopez, who said he has not been approached by anyone who is opposed to the ban.

The smoking ban ordinance was drafted after a presentation from the Texas Department of Health and Texas A&M University officials who recommended Socorro implement tighter restrictions on public smoking due to health hazards created by second-hand smoke.

## Horizon City Council rejects proposal to hire special counsel

HORIZON CITY — A recent agenda item proposing that the Horizon City council hire a "special counsel" law firm raised numerous questions among members of that council before it was unanimously rejected.

During the regular Nov. 14 council meeting, an agenda item to hire the Austin-based firm of Bovey, Akers and Bojorquez was strongly questioned by several council members.

Attorney Robert Duran has been the attorney of record for Horizon City during the tenure of the past four mayors, including former Mayors Tom Ruiz, Pat Randleel, Diane Whitty, and current Mayor Raymond Morales.

During Whitty's term, she attempted to hire this Austin-based group as special counsel, but did not have the needed support to be successful.

The agenda item in question on Nov. 14 was authored by Whitty's sister, Councilwoman Carol Zimmerman. It again called for discussion and action to hire Bovey, Akers and Bojorquez as special counsel for Horizon City.

City Councilman Keith McClellan said he was disturbed by the fact that information on this law firm was not provided to members of the council until the meeting at which it was to be voted on and that the need for special counsel had not been put forth to other members of City Council prior to it being put on the agenda.

City Councilwoman Jennifer Whiskeyman asked if the need for special counsel had been discussed with City Attorney Duran and whether he was ever asked his opinion on the need for special counsel.

Duran stated he was never approached by anyone on City Council regarding this issue.

Former Mayor Diane Whitty was in the audience and spoke on this agenda item. She stated that when she was the mayor, she tried to hire this law firm as special counsel because of their expertise in municipal law. She said there were times during her term as mayor that she would ask Duran a question or request some advice and she would have to wait for several days before receiving an answer.

She also added that there were times when she felt she was "submerged" by Duran.

Council asked Duran if he would like to address this issue and he vehemently denied the accusation that he had "submerged" Whitty. He went on to say he has always been prompt in answering any questions asked of him. He said there were times when he did not have an answer to a question, but said he researched it and promptly returned with an answer.

Duran said he had not been approached regarding a need to hire special counsel to assist him, and he reminded Council that Horizon City is a member of the Texas Municipal League (TML) which affords them the opportunity to contact TML on any legal issue if advice is not readily available from the City Attorney. He said he does not see a need for any special counsel.

Mayor Ray Morales was asked if he has

## One perspective

### Precedence and really bad ideas

Apologies to decent lawyers everywhere, if such exist, but members of the bar have been behind a lot of really bad ideas. As a result of some really bad ideas gaining approval just one time, something called a "precedent" occurs. Now, precedence is a mighty powerful concept to the folks who sit behind tall benches in black robes and rule on judicial matters. In fact, if a really bad idea has a legal precedent you can pretty much assume that any judge will agree with the lawyerly argument that if it was approved once, it should be again, no matter how bad it was. It's called passing the buck. It is the incredibly intelligent method we use to establish law in our system of justice. It is also how our kids get away with all kinds of misbehavior because, they will argue, "you let so-and-so sibling do it..." It starts early. But that's a whole other story. As for the power of precedence, take the classic cases of the Roe v. Wade and the less-famous Doe v. Bolton, which led our legal system to open the door so that nowadays you can snuff out the life of a totally defenseless person — not even strong enough to breathe on his or her own yet — for virtually any reason you want to and it's perfectly legal. Now, the woman who was "Roe," lesser known as Norma McCorvey, many years ago recanted her part in the issue and asked the court to reverse the ruling. Sandra Cano, who was "Doe," has also asked the courts to revisit, and reverse, their ruling, particularly in light of improved medical treatments. But, of course they can't. It has precedence — no matter how bad this idea is. There is a really, really bad idea circulating out there right now I want to tell you about — even the guy who proposed didn't think anyone would actually take it seriously — but this really bad idea is getting some really serious attention. This is also how, by the way, that Charles Darwin got saddled with being known as the father of the worst idea in history — evolution. The poor guy wasn't even the one who first thought it up, but because he wrote it down in a convincing sort of way, he got stuck with it. Anyway, back to this really bad idea I was telling you about. It is the most insane idea I have ever heard as a solution to the problem of global warming. There is a man named Paul J. Crutzen, a fellow of Germany's Max Planck Institute for Chemistry and a Nobel Prize-winning scientist, who has proposed creating a "shade" between the earth and the sun — a layer of pollution deliberately spewed into the atmosphere to help cool the planet. Now, Crutzen himself says he is "not enthusiastic" about his idea, and said he proposed it simply as a means to "startle the policy makers" into taking some kind of concrete steps to reduce our use of fossil fuels. However, because he has conceptualized it and had it published, if it becomes reality, he could join Darwin in having fathered something maybe he didn't really intend to father. Unfortunately, the scientific community missed Crutzen's point altogether. Tom Wigley, a senior U.S.




had any problems getting information from Duran. Morales replied that he has always been provided a prompt response and has experienced no problems with Duran's expertise.

City Councilman Walter Miller brought up the issue of who would be allowed to call or contact this law firm and for how many times. There was no answer for this question, therefore, he suggested this should be researched further before hiring this law firm.

City Councilwoman Whiskeyman asked Councilwoman Zimmerman if the references mentioned on the law firm have been contacted. Zimmerman replied that she had not contacted the references given.

City Councilman Luis Najera said since there would be no actual contract signed committing the city to any length of time or any terms, he didn't see the harm of hiring this law firm.

After considerable discussion, it was decided by the City Council to reject the agenda item and the vote was unanimous.



# Clint, three others try to advance in football playoffs

## Four area teams already out of picture

Sometimes you can feel when the momentum is shifting. Sometimes you can tell when what was considered "the norm" is now a thing of the past.

And then again, sometimes you can't. Over the last couple of years, El Paso high school football teams had begun to make a dent on that inferiority complex they had developed after years of getting pummeled by those big, bad, out-of-town playoff teams.

After years of losing against those superior programs, local schools like Riverside, Franklin, Montwood and Chapin were proving that El Paso football could compete and even advance past these annual roadblocks by winning some of those tough encounters in recent years.

But the local teams took a gigantic step backward last weekend by losing every game to the out-of-towners, including a couple in which they were favored to win.

Four local Class 1-5A squads, Coronado, Montwood, Hanks and Americas, challenged four Class 2-5A teams last week in the bi-district round of the state playoffs.

Coronado figured to get past a so-so Amarillo Tascosa team who had a 6-4 record and hadn't won a football playoff game since 1967.

Final score, Tascosa 33, Coronado 23.

government climatologist, picked right up on Crutzen's idea and followed up with an article in the leading U.S. journal, *Science*, describing

experiments he has done using supercomputer climate models. He also cited — what else? — the "precedent" set by the huge volcanic eruption of Mount Pinatubo in the Philippines in 1991.

All we need, he says, is between five and 10 million tons of sulfates injected into the atmosphere every

two or three years, since this incredible creation we call earth actually manages to clean the pollution out of the atmosphere through rain. Wigley makes this insane proposal in spite of the fact that earlier this year, the World Health Organization said air pollution is killing about two million people

worldwide yearly. Well, I've got a really bad idea myself, but I won't tell you unless you promise not to give me credit for it. How about if we drop a nuclear bomb and create a sort of "nuclear winter" ever so often just to cool things off. And if we study it care-

fully enough we can even make an estimate as to how many lives will have to be sacrificed in the name of global good. I'd say that makes about as much sense as intentionally creating massive air pollution. And besides, we have a precedent for it.



# Social Security Q&A By Ray Vigil

**Q:** I plan to start receiving my Social Security retirement benefits in about two years. I have a 13-year-old daughter from a previous marriage who lives with her mother, my ex-wife. Can my daughter get any kind of benefits based on my earnings record? And, if so, would the checks go to her directly, or would I get them on her behalf?

**A:** Once you start receiving Social Security retirement benefits, your daughter can get benefits as your de-

pendent until she's 18, or 19 if still in secondary school. A child's monthly benefit rate is generally one-half the parent's benefit amount. When you file for Social Security, you may file for benefits on your daughter's behalf and also file to be her representative payee. Generally, we appoint a representative payee for a beneficiary younger than age 18. The Social Security claims representative is required to attempt to contact the custodial parent, who has the option of filing to be payee. Whoever

is named representative payee will be required to do an annual accounting of how your daughter's benefits are spent.

**Q:** What is the average monthly Social Security survivors benefit payment for a widow and two children?

**A:** In 2006, the average monthly Social Security survivors insurance benefit payment for a widowed mother or father and two children is \$2,074. The amount of the survivors insurance benefit is depended on two factors, number of years the deceased worked under social security covered wages and/or self-employment and

the actual amount of his/her earnings. **Q:** I have had several unexpected and severe financial setbacks since I retired two years ago. Is it true that if my income has dropped dramatically I can get help paying for my Medicare premiums?

**A:** Yes. If your monthly income is limited, the state in which you live may help with your Medicare premiums and may also help pay Medicare deductibles and coinsurance amounts. Contact your state or local medical assistance, social services or welfare office, or call the Medicare hotline, 1-800-

MEDICARE (1-800-633-4227) and ask about the Medicare Savings Programs. Also, if your income and assets are low enough, you may want to explore the possibility of getting extra help with your Medicare Part D prescription drug premiums, deductibles and co-payments.


