Socorro Walgreens

The City of Socorro is set to discuss a tax abatement for a proposed Walgreens at Horizon Blvd. and North Loop. The item may come as early as the next regular council meeting scheduled for August 2. At least one member of Socorro's council believes that Walgreens does not need the abatement. Sergio Cox, the at-large representative, spells out his position in an editorial on page three of this paper. Cox says the Walgreens would be a good business asset for Socorro but that the citizens shouldn't need to pay for businesses to open shop in Socorro. Published reports say that Mayor Trini Lopez is undecided and studying the issue.

Crime Stoppers

At 3:30 a.m. a man forces his way into an apartment, armed with a handgun, and sends both occupants of the apartment to the hospital with serious injuries. He was last seen wearing a gray shirt with "Sponge Bob" characters, khaki pants and black shoes. Haugen picked to lead Anthony ISD

ANTHONY — It is official now: Ronald Haugen is the new superintendent of the Anthony Independent School District.

The only finalist for the position, Haugen was approved unanimously on July 17 by AISD's board of trustees at its regular monthly meeting.

However, Haugen, presently superintendent of the Gadsden Independent School District, doesn't officially begin his new duties until Aug. 1. He replaces Vern Butler who retired June 30.

"I look forward to a great experience here," Haugen said after assuming his seat at the board table. "I plan to

hit the ground running. We will do what we have to do to make our children successful."

One of the issues he faces was highlighted in two subsequent presentations by prospective vendors to the board.

In separate surveys, CFI Security and Sonitrol representatives found serious deficiencies in AISD's fire and security alarm systems, that couldn't provide adequate protection for students and property.

CFI described it as a "nightmare."

The board took no action.

Trustees approved the district's participation in TEEG (Texas Educational Excellence Grant) program. It provides \$40,000 in financial incentives for middle

school teachers to help "educationally disadvantaged" students.

Mosquitoes found in Fabens test positive for West Nile Virus

The El Paso City-County Health and Environmental District received confirmation from the Texas Department of State Health Services Laboratory in Austin yesterday that mosquitoes collected in a drainage ditch in Fabens tested positive for West Nile Virus (WNV). Mosquito specimens collected by light traps on July 17 were sent to the Texas Department of Health Laboratory for species and arbovirus identification. Results revealed that WNV was isolated from Culex Tarsalis mosquitoes. These are the first mosquitoes that test positive for WNV in El Paso this summer. Vector Control has increased fogging in the area and is treating ponding areas with minnows or bacteria. We are asking for the cooperation of area residents in getting rid of standing water on their property.

West Nile is transmitted through the bite of a mosquito that has picked up the virus by feeding on an infected bird. The illness is not spread person-to-person or from bird-to-person. Most people infected with WNV usually have mild symptoms. If symptoms do occur, they develop in 5 to 15 days after the bite of an infected mosquito. Mild cases may have flu-like symptoms, a slight fever, headache and lethargy. Severe

infections can cause sleepiness, headache, stiff neck, high fever, confusion, seizures, tremors, double vision and loss of consciousness, paralysis or death. Persons, especially infants and the elderly, who become sick quickly with any of the above symptoms, should see their doctor immediately. WNV can also infect horses, many types of birds and some other animals.

The Health District suggests following the 4 D's to reduce your risk of exposure:

- DAWN AND DUSK- Stay indoors at dusk and dawn when mosquitoes are most active.
- DRESS- If you are outside, cover up by wearing long-sleeved shirts, pants, shoes and socks.
- DEET- Use mosquito repellent with DEET (N, N-Diethyl-m-toluamide). Be sure to follow the manufacturer's directions for use. Spray clothing with repellent as well as exposed skin.
- DRAIN- Eliminate mosquito-breeding sites. Drain standing water in buckets, tires, empty cans, flower pot bases or any other type of container that can hold water. Drain standing water on the ground on your property.
- Mosquito-proof your home. Make sure door seals are secure and window screens are intact.

Foundation provides low-interest loans for water wells

Certain low- to moderate-income individuals or families may be eligible for money to construct, repair or improve household water well systems through one-percent interest loans from the Foundation for Affordable Drinking Water.

Qualified applicants can borrow up to \$8,000 at one-percent interest for a term not to exceed 20 years. To qualify, households must:

- Own the home and use it as the principal

residence;

- Have as the primary drinking water source an individual household well system located on the property of the home;
- Must meet income and other eligibility requirements; and
- Be located in a city, town, or unincorporated area with a population of less than 50,000.

The program is available in Alabama, Colorado, Idaho, Indiana, Iowa, Kansas, Maine, Massachusetts, Minnesota, Nebraska, New York, North Carolina, Ohio, Tennessee, Texas,

Food recall expanded

The Texas Department of State Health Services (DSHS) is urging Texas consumers to heed instructions issued in a nationwide recall of certain hot dog sauces and other products manufactured by Castleberry Food Products, Augusta, Ga. Consumers should not eat any of the recalled products and should discard any they have on hand.

The recall, announced earlier this week by the U.S. Food and Drug Administration and the company, was done because of possible contamination with the organism that causes botulism, a serious paralytic illness. Four people, including two from Texas, became ill after consuming Castleberry's or Castleberry's Austex hot dog chili sauce. The other recalled products were produced in the same plant. The initial recall list has been expanded to more than 25 brands, includes pet food and is over 90 items long.

Anyone with symptoms of botulism should seek immediate medical attention. Symptoms may include double vision, blurred vision, drooping eyelids, slurred speech, difficulty swallowing, and muscle weakness that moves progressively down the body. Botulism can cause paralysis of the breathing muscles, which can be deadly without prompt medical attention.

Take for instance, some morning when I head out to work with a nice, hot drink nestled in my cup holder. I ease out into traffic, hoist my cup to toast the day, and promptly burn my tongue. I jerk the cup away and spill dark, hot liquid down the front of my nice, clean white shirt.

Now this could be a real downer unless, of course, I start thinking about those boys in Louisiana who stole some gunpowder from Walmart and were standing around smoking when somebody flicked an ember off a cigarette and ignited their ill-gotten gains. Jail receives high marks

Hola, mi gente,

On July 23, I attended a ceremony at

the Rogelio Sanchez State Jail. Essentially, the ceremony was intended to disclose the recommendation by the American Correctional Association (ACA) as to the re-accreditation of the facility.

The Rogelio Sanchez State Jail is located on Montana just east of the Loop 375 intersection. Many of you probably have never heard of the unit and that is a good thing. My office has not received any complaints about the unit that I can recall. The warden and staff are running a very good operation. While that statement is only my opinion, it is strongly reinforced by the findings and recommendations of the ACA.

The ACA performs audits on a regular basis; once every three years I believe. The audit measures certain criteria along with measuring progress on past recommendations made on previous audits.

I am proud to say that the Rogelio

Sanchez State Jail attained a score of 100% on one part of the audit and a score in the high 90% range on a second part of the audit. I was very impressed to hear that the recommendations made on previous audits had been satisfied almost completely. The outcome of this years audit clearly indicate that the unit is run superbly by the warden and staff and that Sanchez should be re-accredited.

I would like at this moment to recognize Warden William E. Walker and his staff for the way they are managing the jail. The comments made at the ceremony by the ACA auditors were so complementary of the jail management team. There are not many, if any, jails in the country that have been given such high marks. Thank you, Warden Walker.

I would like to share one other bit of information about the jail, the inmates and the management team at the Rogelio Sanchez State Jail. The warden has made available for community service the labor of its inmate population. The inmates actually volunteer to participate in events such as post Fourth of July cleanups.

One major benefit that our community received from the jail occurred last summer. During the torrential and dangerous rains last year, the jail population produced 50,000 sandbags for emergency purposes. Throughout El Paso County, these bags provided some protection from the immense flood waters. I discussed with Warden Walker the possibility of producing sandbags in great numbers and stock piling them in the event of a similar disaster. He responded by saying it was considered but without a location to store the bags, the material would deteriorate in the open. But, it is an option in the event we can locate a warehouse to store tens of thousands of sandbags.

I have commented that the audit reflected a management team that was superlative. I should have also recognized the fact that the jail has a model inmate population seeking to reenter the civilian world. I encourage them to continue their service to El Paso County.

A fair day's pay

This Tuesday, July 24, millions of Americans and almost a million workers in Texas received a pay raise for the first time since 1997. It has been 10 years since Americans have seen an increase in the federal minimum wage. Over the past decade, the effect of the 1997 raise has been all but erased, leaving millions of families in poverty. When adjusted for inflation, the minimum wage today is at its lowest level in more than half a century. Texans have been disproportionately impacted because we have the lowest minimum wage allowed by federal law — \$5.15 per hour.

Nationwide, raising the federal minimum wage to \$7.25 an hour will benefit nearly 13 million hard-working Americans, including over 2.3 million Hispanics and over 2 million African-Americans. Here in Texas, 863,000 workers will see a direct increase in their hourly pay and 1,771,000 workers overall will benefit from the raise over the next two years. This pay raise will help families who live paycheck to paycheck at a time when they are experiencing record prices at the pump, skyrocketing health care costs, and the rising cost of college tuition.

The effects of the increased minimum wage are far greater for families than they are for individual workers.

A full-time minimum wage worker making \$5.15 an hour brings home \$10,712 a year, an annual income barely above the federal poverty level for an individual. These numbers mask even more bleak circumstance for the entire family. Nearly half of low-wage workers in families with children are the sole breadwinner for their household, leaving their family nearly \$6,000 below the federal poverty level for a family of three.

Raising the minimum wage is about more than just economics; it is about valuing our families. This raise will help 7.4 million women and 3.3 million parents. About 6 million children will see their parents' income rise. This pay raise is also critical to the families making the supreme sacrifice for our nation. Some 50,000 military families will benefit from an increase in the minimum wage to \$7.25 per hour. The overall increase of \$2.10 an hour will give families like these an additional \$4,400 a year to meet critical needs. That's 15 months of groceries, over two years of health care, 19 months of utilities, or 20 months of child care.

I believe an honest day's work deserves a fair day's pay. On July 24 we took the first step as a nation to ensure that millions of hardworking Americans and their families will earn what they deserve.

School board notes By Don Woodyard

Canutillo, July 17

Larry Baskind, legal counsel for the school district, informed the trustees of recent important changes in state election laws.

According to Board Notes, prepared by the district's public information office, "it appears that the November 2007 board election is not allowable, and that the school district may need to consider changing the

length of board members' terms.

"He advised board members to review the informational packets that he provided them. The packet contains four options that adhere to the changes of the law and the recent Texas Attorney General's opinion."

He added that a transition plan must be in compliance with state law and should be discussed at the August board meeting.

Dr. Pam Padilla, CISD superinten-

dent, outlined external funding efforts. She praised Jose Lopez, CISD grant writer, for his work in securing more than \$4 million in grants. More than \$12 million in grant proposals are pending.

The board approved an inter-local agreement with San Elizario ISD for health services.

The board authorized issuance of \$1.9 million in tax maintenance notes.

San Eli, July 18

District trustees sold an unused wastewater treatment facility to the Border Environmental Cooperation Commission (BECC) for \$10,000, reports Superintendent Dr. Mike Quatrini. The facility, which had served the old high school/middle school, has been out of service for 8-9 years, Quatrini says, but has been maintained.

The BECC will disassemble all pipeline components and transport them to the interior of Mexico where it will serve a rural community.

The BECC is a binational agency established by the U.S. and Mexican governments "to identify and evaluate and certify environmental infrastructure projects," according to an internet document.

Quatrini also said that the school board has established a committee to take proposed names for the new park behind Excel Academy. He said it was agreed that it was in the district's best interests to get input from the community before making a final decision on naming the new park.

Deadline for submitting names is Aug. 31.

The board also approved a 2 percent hike in the employee contribution to dependent health insurance coverage.

The free package's publications make it easier to ask your doctor or pharmacist informed questions about these medications.

From ACE inhibitors to niacin, there are lots of different types of medicine you could be taking. The booklets provide a convenient way to look up and compare brand name and generic medications, along with a place to record important facts your doctor shares with you about how to take the medicine. It's helpful to have all the instructions written down, especially if you need to remember possible drug interaction problems or situations when you shouldn't take certain drugs. With this package, you can also learn how to read over-the-counter drug labels and ask informed questions about how the drugs might interact with cholesterol and blood pressure medicines.

Use advice and examples in the booklets to make sure your medications are working as effectively as possible.

Walgreens welcome in Socorro, but abatements are the wrong way to go

With the City of Socorro growing in leaps and bounds, for instance, with the population, according to our last census, of 27,000 people and an anticipated number of 35,000 at a minimum for the census year 2010, I would agree that a drug store is essential to Socorro and a Walgreens pharmacy would be a good asset.

First and foremost, I welcome a business of this nature with open arms. The anticipated location for this Walgreens is at the corner of North Loop and Horizon Blvd. This is a prime location that is ideal for Walgreens. It is the type of corner location that historically Walgreens desires when purchasing to set up their businesses nationwide.

In researching their webpage, www.walgreens.com, one would get an idea of just how big Walgreens is. In their 2006 annual report they inform all concerned that they average \$8.5 million in annual sales per store. August 31, 1996, 100 shares of Walgreens stock sold for \$3,288. Ten years later as of August 31, 2006, those 100 shares split twice to 400 shares worth \$19,784, for a gain of 502 percent. They are the number one ranked food and drug store on the list of Most Admired Companies in Fortune Magazine and ranked 45th on the Fortune 500 list of largest U.S. based companies. They are due to open about 550 stores in Texas alone this year if they haven't already. They are and will continue to be one of the biggest conglomerates for years to come.

So what's the problem you might ask? They are asking the City of Socorro to give them a 10-year tax abatement at 70-percent or asking for a grant on the behalf of Socorro that would pay them for building and placing a drugstore in the City of Socorro. They wrote our city manager asking for just that. What's wrong with this picture? How does this grab you? I did my homework and I got on the phone and I started calling around. I called the City of El Paso and made contact with their city attorneys' office. I spoke with one of the attorneys who handle their business affairs and he e-mailed me back stating that with all of the Walgreens stores that are going up in their community they have never asked for a tax abatement or tax break from El Paso. In speaking to a alderman from the City of Horizon, he informed me that they were never asked for tax abatement. Yet Walgreens is scheduled to construct one in their community.

So, why the City of Socorro? I decided to contact the people that represented Walgreens in their letter and I spoke to two of their officers. I asked them that specific question.

"Why were they asking for a tax abatement specifically from us when they didn't bother with the other two entities?" I was told that they would have to get back to me and when one of them finally did, he did not have an answer for me. I informed him about Socorro and how having a drugstore located here would be a win/win situation for both them and the community. As it is, the City of Socorro has already helped them with getting the Texas Department of Transportation to make alterations to Horizon Blvd. and North Loop to accommodate that Walgreens location. They have also asked for easement accommodations which we have agreed to provide.

I informed Walgreens that Socorro is going through growing pains. Our city is currently looking at having to pass a Socorro Independent School District bond election in order to build additional schools in our area. The Central Appraisal District has raised the property value for homeowners, which subsequently raises our taxes. Socorro is also looking at a feasibility study to conduct our own bond election for the purpose of rebuilding our streets and sidewalks. How can we ask the citizens of Socorro for additional tax money and then turn around and give a ten year tax break to a multi-million dollar for-profit company? To me it just doesn't make practical sense.

In the past we have given fledgling companies tax breaks only to have them backfire on us with little or no gain in revenue for Socorro in the long run. There have been studies about tax abatements that show that they just don't work. I am asking that the voting citizens of Socorro contact their representatives and speak with them at length about this issue, whether or not you're in favor. You know my stand on this issue, but I would like to hear from you on this. This issue is due to be on the agenda for the next City Council Meeting on August 2. So please contact your representative this week.



iPhone almost too full of features

As one of the leading "techies" in my household — behind my son but well ahead of my wife and cat — I thought it was time to allow everyone the benefit of my expertise regarding the iPhone.

The iPhone is simply the greatest gadget ever invented since whatever that last greatest gadget was.

In fact, it has so many features some of the following have gotten lost in the hype:

iNaked — Contrary to a widespread but completely bizarre urban legend, the iPhone camera does not allow you to see through people's clothes. The legend presumably springs from Google's highly anticipated project to photograph all adults in the world naked.

Naturally, these pictures are available on the iPhone, but what's impressive is how they are cross-referenced for easy browsing.

You may, for example, type in a person's name, but the iPhone also allows users, simply by moving their finger across the screen, to look through streets, neighborhoods and whole towns of naked people. You may also search by college or business name. Likewise, the bookmarking feature, for photos you wish to view again, is simple and logical.

Verdict: It's a winner. Some have complained about their photos being posted, but most agree it's another must-have information marvel from Google and Apple. Warning: Some report mixed results when iNaked is paired with the iPhone's Matchmaking service.

iTranslations/Animal — Pre-market, this was thought likely to become the iPhone's most popular feature, but it's facing a surprising backlash as people discover

what their pets really think of them.

Cats, as might be expected, think their humans are idiots, but many people have been shocked to find out their dogs are two-faced phonies — acting all happy to see them when they come home but making sarcastic remarks behind their back and sometimes to their face.

Even animals considered dumb have proven surprisingly critical, with one heartbroken customer complaining that her goldfish made fun of the TV shows she watched. "We used to watch everything together, but she complained so much I had to get her her own hi-def TV."

Verdict: iTranslations/Animal can be fascinating and revealing, but many early users have discovered, to their regret, that the best thing about pets is they don't talk.

iCelebrity — Feature alerts users when a celebrity enters area. It works fairly well, but rural residents should expect noticeably lame results.

In small towns, for example, iCelebrity may alert you when the Homecoming Queen of 1964 walks by. If you ever received some local notoriety, such as being the first in your class to get a tattoo, you may be updated constantly about your own presence. (Some with low esteem, however, really enjoy this feature.)

Verdict: Great if you're in New York or L.A.; not so much in Hardscrabble, Del. In celebrity-rich areas, the iPhone also allows you to narrow your search to one of the many subcategories, such as "drunken D-list celebrities."

Overall verdict: A definite buy. It's what Alexander Graham Bell would have invented if he only had a little more gumption.
