School dedicated

More than 40 years after his death in Vietnam, Sgt. Roberto Ituarte's legacy lives on and his code of trust, integrity, and honesty will be instilled in future generations. On Nov. 8, Socorro Independent School District formally dedicated the first El Paso school named after a Vietnam War veteran. Sgt. Ituarte Elementary which opened in July 2006 held a ceremony to recognize the 24-year-old El Pasoan who was killed in action in Vietnam in 1965. Held to commemorate Veterans Day, the school located at 12860 Tierra Sonora, welcomed friends and family of Sgt. Ituarte to tour the school and witness the official dedication. Students sang, family members spoke with pride and former soldiers held back tears as the school was dedicated in honor of Sgt. Roberto Ituarte.

Pricey girdles

U.S. Customs and Border Protection (CBP) officers performing anti-terror inspections at the Paso Del Norte international crossing in El Paso seized 14.9 pounds of cocaine Saturday night. Two Mexican women were taken into custody following the drug bust. The seizure was made at approximately 6:15 p.m. when a 2005 Ford Focus with two female occupants arrived at the port from Mexico. A CBP officer at the primary inspection booth interviewed the driver and passenger of the car and noted they were nervous and evasive during routine questioning. The vehicle was sent to the secondary inspection area for a more thorough exam. During the secondary inspection, CBP officers determined that both women had bundles concealed under their clothing. CBP officers continued the inspection and found that each woman had cocaine-filled bundles held in place against their abdomen with elastic girdles. The women were taken into custody. U.S. Immigration and Customs Enforcement (ICE) special agents arrested both women in connection with the failed smuggling attempt. The driver of the car, 30-year-old Maria Mercedes Hidalgo Lopez of Camargo, Chihuahua, Mexico, carried three cocaine-filled bundles weighing 7.4 pounds. The passenger, 20-year-old Armida Prieto Vasquez of Camargo, Chihuahua, Mexico, also carried three cocaine-filled bundles weighing 7.5 pounds.

IRS has undelivered refund checks for Texans

An average refund of \$856 is waiting for 9,627 Texas taxpayers whose refund checks were returned to the Internal Revenue Service this year as undeliverable. The refunds can be claimed as soon as their owners update their addresses with the IRS. In some cases, a taxpayer has more than one check waiting.

The IRS wants Texas taxpayers to get this money as soon as possible. It's easy to update your information and claim your refund by using the "Where's My Refund?" tool on IRS.gov — it enables taxpayers to check the status of their refunds. A taxpayer must submit his or her social security number, filing status and amount of refund shown on their 2006 return. The tool will provide the status of their refund and in some cases provide instructions on how to resolve delivery problems.

Taxpayers can access a telephone version of "Where's My Refund?" by calling 1-800-829-1954.

The number of undeliverable refunds each year is a relatively small portion of all refunds returned to taxpayers. So far in 2007, the IRS has processed nearly 105 million refunds, totaling about \$240 billion, either by mail or direct deposit.

In fact, undeliverable refunds account for less than one-tenth of 1 percent of all refunds, or about one in a thousand.

A refund check is normally returned as undeliverable when a taxpayer moves without updating his or her address with either the U.S. Postal Service or the IRS.

The list of taxpayers due undeliverable refunds this year rose about 21 percent from 95,746 last year. The sharp increase is due in part to the Telephone Excise Tax Refund. The refund is a one-time payment available on 2006 federal income tax returns. It was designed to return to taxpayers previously collected long-distance telephone taxes. Individuals, businesses and tax-exempt organizations are eligible to request it.

Bad addresses also cause delays. Refund checks are mailed to a taxpayer's last known address. Checks are returned to the IRS if a taxpayer moves without notifying the IRS or the U.S. Postal Service.

Taxpayers can update their addresses with the IRS on the "Where's My Refund?" feature. Also, taxpayers checking on a refund will be prompted to provide an updated address if there is an undelivered check outstanding within the last 12 months. Taxpayers checking on a refund over the phone will be given instructions on how to update their address.

A taxpayer can also ensure the IRS has his or her correct address by filing Form 8822, Change of Address. Download the form from IRS.gov or request it by calling 1-800-TAX-FORM (1-800-829-3676).

One perspective

A view to die for

I'm scared of heights. Though I kept gasping a little, like you do when jumping off into a pool of cold water, my lack of courage didn't keep me away from the edge.

The Grand Canyon is one of the world's greatest marvels. It's one of those places where you can experience earth's majesty up close and personal, for a few breath-taking moments, for an entire day, or longer. I don't think you could ever see it all.

The wondrous colors intertwined with modulation of depth and shadow are mesmerizing. I could almost feel myself float out across the yawning abyss like the hawk that was surfing the afternoon breeze.

Because this landmark is so awesome, its fame is global. It attracts people by the thousands daily, of practically every age, circumstance and nationality. Unfortunately, because it is so up close and personal, people can become numb to the reality of the place, as if it were simply a part of an interactive video game, with no real consequence other than if you fall, maybe you lose one of your lives.

Equally unfortunate is that, in real life, you have only one.

The day I was marveling at the Canyon's edge was Oct. 6. I was accompanied by numerous members of my family, including two grandboys, ages six and three.

A scant three days later, at about 11:30 a.m. on a beautiful fall morning, a four-year-old girl fell nearly 450 feet from the Canyon's edge, from one of the places I had stood taking pictures. She didn't live long. She died at the scene from blunt force trauma, primarily to her head.

According to news reports, she was

there vacationing with her parents, two brothers and a family friend. They had only been there about 30 minutes. The tragedy occurred at one of the places where a paved trail runs parallel to the Canyon, several yards back from the edge. Her parents were walking along the path when the little girl began to wander toward the rim.

Witnesses told news reporters that her mother told the child, "in a stern manner," to stay on the path. As they turned and resumed their walk, the child reportedly ran back to the edge, lost her balance, and tumbled over.

Her father, a fighter pilot stationed at Luke Air Force Base near Phoenix, scrambled over the edge after her. When he reached her, he started CPR and was soon joined by a Park Service ranger who rappelled down. A second ranger, lowered by helicopter, determined the child was dead.

On average, one to three people die each year in falls from the rim of the Canyon. Don Singer, safety manager for the Grand Canyon National Park, told *The Arizona Republic* that research data dating back to 1925 shows that the highest risk group are young men in their 20s and 30s who fall because they put themselves in danger by doing daredevil stunts or climbing into unsafe places.

While taking photos, I personally watched several people climb down from the rim out onto a narrow point of the bluff that extended far over the Canyon's drop.

One slip, that would have been it. Along most of the Canyon's rim, there is no railing, and Singer said there is no plan to add fencing. "People can choose the level of risk they want when they come to the Canyon. It is a natural area and we do want them to experience as natural an area as possible."


Natalie Yeargan, the child who fell, is the third death this year. A 50-year-old man fell 300 feet on Aug. 2, and later that month, a body was found 150 feet below Walhalla Overlook. Officials don't know the circumstances surrounding the man's fall.

Previously, the youngest person to die of a fall was 13. There's even a book on the subject, *Over the Edge: Death in the Grand Canyon*, by Michael Ghiglieri and Thomas Myers, which says that 53 people have died from falling into the Canyon since they started keeping records back in 1925.

The news reports about the little girl brought back vivid memories of the worried mothers and diligent fathers who kept white-knuckled grips on the hands and collars of my two grandboys as we traversed this wonderful place. I know all too well how quick a little one can move, how precious and irretrievable are those seconds between almost and all-over.

I have deep sympathy for the parents of that tiny child who will visit no more landmarks in this life. Except by the grace of God many more parents would walk in their shoes.

Dr. Scott Goodman's comment pretty much said it all for me: "Nature is beautiful, alluring and spectacular, and on the other side of the coin, harsh and uncompromising.






Small business, veterans need access to contracts

The U.S. House of Representatives recently passed H.R. 3867, the Small Business Contracting Program Improvements Act, which includes the essential changes for 8(a) businesses that I proposed earlier this year in H.R. 1611, the 8(a) Modernization Act, and assists small business owners in contracting with the federal government.

In 1968, Congress established the 8(a) program to assist small businesses owned by those who are socially and economically disadvantaged. A large part of the program's success is a provision that makes companies with 8(a) certification eligible for smaller government contracts on a sole source basis and over the years, 8(a) has helped businesses in El Paso and across the country grow and prosper by allowing entrepreneurs valuable access to federal contracts. However, in the forty years since then, Congress has failed to update the program to empower the business owners of today. In 1968, those smaller contracts were defined as contracts not exceeding \$3 million in value for services, and a small businesses' net worth was set at \$250,000, which freezes thousands of relatively small businesses today out of 8(a) assistance.

My legislation, and the Small Business Contracting Program Improvements Act, though, making critical updates to the 8(a) program. H.R. 3867 would:

- Increase the limit for sole source contracts awarded under the 8(a) program from \$3 million to \$5.1 million; and
- Increase the net worth limit for 8(a) applicants from \$250,000 to \$550,000.

The bill also improves small business opportunities for service-disabled veterans. Service-disabled veteran-owned businesses currently receive less than one percent of federal contracts. This bill:

- Places veteran small business owners at the top of the list for receiving federal contracts;
- Requires the Small Business Administration (SBA) to fulfill its obligations under Executive Order 13360, which will give veterans access to procurement assistance; and
- Creates penalties for misrepresentation of

a service-disabled veteran-owned business classification.

Through events such as the annual Veterans Business Conference in El Paso, I have taken intentional steps to provide our veterans with support and information from federal agencies. These proved helpful for El Pasoans, and the provisions of this bill will help service-disabled veterans in El Paso and across the country succeed as they work to make their entrepreneurial ideas a reality.

The bill also expands opportunities for women entrepreneurs. H.R. 3867 sets out requirements for the SBA to implement the Women's Procurement Program to help level the playing field for women-owned businesses in federal contracting. Women have been waiting nearly seven years for the SBA to implement this program, while losing tens of billions of dollars in contracting opportunities.

The bill strengthens community development, through the Historically Underutilized Business Zone (HUBZone) Empowerment Contracting Program. This program promotes business in historically underutilized urban and rural areas with lower-than-average incomes by verifying that small businesses receiving contracts under its authority are qualified. It further specifies that only local companies can get HUBZone construction contracts.

Since arriving in Congress in 1997, one of my main goals as El Paso's representative has been to improve our economic prosperity and vitality. Upon learning that a large number of El Paso businesses had never worked with the federal government, the largest buyer in the world, I joined with the El Paso Hispanic Chamber to reach out to these businesses and together, we certified many businesses as HUBZone businesses.

All these different programs take important steps to help businesses that deserve assistance most, and the Small Business Contracting Program Improvements Act modernizes and requires them to serve the business owners of today, which are increasingly women, veterans and minorities. The engine of El Paso's economy is our small businesses. I am proud to help create opportunities that allow them to contract with the federal government.

internet and think they may be missing a refund should first check their records or contact their tax preparer, then call the IRS toll-free assistance line at 1-800-829-1040 to up-

date their address.

Signing up for Direct Deposit can put an end to undelivered refunds, as well lost or stolen refund checks. Taxpayers can receive refunds directly into personal checking or savings accounts. Direct Deposit is available for filers of both paper and electronic returns. Taxpayers can sign up for direct deposit on their tax form.


from all public and private schools in the El Paso area.

Q: Your recent performance at MTV's Video Music Awards was widely recognized as the most exciting and professional in world history. You also received rave reviews for your outfit.



Gather around the computer

Each year, people from across the nation spend Thanksgiving Day enjoying good food and quality time with their families. During this year's holiday we hope you will consider assisting a loved one by visiting www.socialsecurity.gov.

The Social Security Administration has a cornucopia of services, many of which are online. You can visit us at www.socialsecurity.gov/onlineservices from the privacy of your home or office. Using the agency's website is convenient, easy and secure.

Here are a few of the things you can help your loved ones do online:

• **Apply for benefits**

You can help them apply for Social Security retirement, spouse's or disability benefits. After you have applied, you can check back online for the status of the application as well.

• **See if they qualify for Social Security**

You can use our online Benefit Eligibility Screening Tool (BEST) to see which kind of benefits they might be eligible for. Just answer a series of questions and find out whether they're eligible for retirement, disability or Supplemental Security Income (SSI) benefits. You can even find out whether they might be eligible for Medicare. All of this can be done by completing one simple questionnaire, and it only takes five to ten minutes.

• **Change your address or phone number**

If you currently receive Social Security benefits, it's important that you keep us updated about changes to your mailing address and phone number in case we need to contact you—even if you have direct deposit. The most convenient way to update your information is by using our online services. You can change your address, phone number, even your direct deposit information.

• **Apply for help with your Medicare prescription drug costs**
