### Clint pets go online

Second Chance Rescue Farm, Clint, recently has joined other animal welfare organizations in the area who list their homeless pets on Petfinder.com, the oldest and largest database of adoptable animals on the Internet. The site currently has about 250,000 homeless pets listed, and it is updated continuously. More than 11,500 animal welfare organizations in the U.S., Canada, and beyond post their pets on Petfinder.com. The adoptable pets at Second Chance Rescue Farm can be viewed at <http://www.petfinder.com/shelters/TX1165>. Once visitors to the site find a pet they are interested in, they contact the organization where the pet is housed. Each animal placement group has its own policies and handles its own adoptions. Petfinder.com is an online database of pets that need homes in over 11,500 animal placement organizations in the U.S., Canada and Mexico. The site has facilitated over 11 million adoptions in the 11 years since it launched. Thanks to its sponsors, Petfinder.com is free to both visitors and to its animal placement organization members.

### Food bank grant

West Texas Food Bank received \$20,000 from the Charity Projects Entertainment Fund to combat child hunger in El Paso Colonias. The grant will be used for the "Para Los Niños De Las Colonias" initiative. The initiative will consist of providing over 600 (40 lbs) emergency boxes to children of El Paso Colonias on a monthly basis for 6 months. The first distribution will be held on Wednesday, April 9 at 9:00 a.m. and 11:00 a.m. at the El Paso County Self-Help Center and Alianza para el Desarrollo Comunitario. In El Paso, the West Texas Food Bank provides food to more than 40,000 people living at risk of hunger. "This grant will help WTFB and other food banks across the country continue to ensure that these children do not go to bed hungry or wonder where their

## Paso del Norte teaches students to be prepared

*Backpacks help keep students occupied during emergencies*

Among all the backpacks in Lynda Melendez' classroom there is one that will help her and her students through any emergency. Developed by the Paso Del Norte school safety committee, each of the school's 85 classrooms is equipped with a red backpack that will serve students and teachers during fire drills or any other evacuation situation. Filled with crayons, pencils and activity books to keep students occupied, the backpacks also hold first aid kits and a class roster.

"We used it during the last fire drill. In case of a real emergency, our students know its there and they are familiar with the items inside," said Melendez, a second grade teacher at Paso Del Norte.

"This project helps prepare our students and our teachers in case of any emergency. The students are being brought into the process and learning to be responsible for one another," said SISD Superintendent Dr. Sylvia P. Atkinson.

Paso Del Norte Assistant Principal Pat Bonilla has worked on this project for two years and was supported by teachers, administrators and the community.

"We had parents go out to businesses ask-

ing for the items we needed," said Bonilla. "We would like to thank Sports World for the donation of backpacks that will have first aid kits, flashlights, gloves, masks and more. Our teachers are happy to have these backpacks ready to go."

Bonilla explained all the teachers know to take the backpacks with them in case of bus evacuations, fire and Code Blue drills. The

school is still looking for items such as masks, flashlights, batteries, and 80 water bottles.

"The school has done a wonderful job of getting these backpacks and filling them with items teachers and students would need. Administrators have recognized the need to be ready to respond to future needs at any given time," said SISD Board President Charles E. Garcia.

## Clint ISD trumpet player one of Texas' best

Ernie Villalobos, a senior at Mountain View High School, has certainly proven himself to be one of the best high school trumpet musicians in Texas. Earlier in the school year, Villalobos earned the First Chair trumpet position in the All-Region Band for 4A and 5A schools. This allowed him to advance to area 5A competition where he also earned the coveted first chair seat and qualified for the Texas Music Educators Association (TMEA) All-state competition in February.

During the TMEA All-State competition Villalobos auditioned once again for seat position. He competed in San Antonio among the finest trumpet players in the state for a spot on one of the All-State Concert Bands or Orchestras. Most high school musicians strive to gain a spot on the All-State Symphony Orchestra. Villalobos earned one of these prestigious spots. He was among seven of the top trumpet players in the state. He was one of only four El Paso area high school musicians to make the 137 member Orchestra.

With only three days to prepare, Villalobos and his fellow All-State Symphony Orchestra members had the privilege of performing under the direction of Yoichi Udagawa for the 2008 TMEA Convention. Udagawa, music director and conductor of three symphony orchestras, is on the faculty of the Boston Con-

servatory where he teaches conducting. In addition, he is the cover conductor for the Boston Pops Orchestra.



*Seek house help early*



Hola, mi gente. Within the next ten years, east El Paso county mortgage companies take a serious look at what has happened. The quick and easy sale of homes in a market where property values were shooting upward led to a market that is barely alive; more alive here in El Paso than in other communities.

The Mortgage Bankers Association reports that nationwide one out every two hundred homes will be foreclosed upon. That is a terrible cancer on the vitality of our communities and nation. But worst of all, it is a dagger in the hearts of good American families.

It is difficult for many El Pasoans to keep their finances current. They have to deal with rising taxes, rising gas prices, residual price increases because of the gas prices, and, in the worst cases, increasing mortgage payments due to variable mortgage rates.

Too many families face these pressures by thinking they can handle them. Unfortunately, juggling the books only makes matters worse. Then comes the emotional stress and the stress on the familial unit. Even the children understand that the household is in trouble. Many students attend school daily with the dreaded thought that tonight may be their last night in their home. That is a terrible burden.

The best way to handle this situation is to seek help at the earliest possible moment. Like a cancer, the earlier the diagnosis and treatment, the better chance there is for a cure.

My chief of staff attended a press conference on March 26 given by the Department of Housing and Community Affairs. The purpose was to make the citizens of El Paso aware of the Foreclosure Prevention Task Force; an entity created by the public and private sector to help families get through a financial crisis.

Let us all work together to save our homes.

*World Tuberculosis Day*



On March 18, I had the opportunity to participate with other local health leaders in an important discussion regarding tuberculosis awareness. This year's panel was hosted by La Fe Health Clinic Technology Center in honor of the "World TB Day" campaign. The forum was titled "Let's Talk About Tuberculosis: TB does not know borders" and included health officials from Juarez, New Mexico, and El Paso.

This year's World TB Day was about celebrating the lives and stories of people affected by TB: women, men and children; nurses; doctors; researchers; community workers — anyone who has contributed toward the global and local fight against TB.

I was proud to be part of this national effort to build more awareness of this prevalent disease. With El Paso one of the largest border cities in the nation, it is more susceptible to such an airborne disease and needs to remain to be at the forefront of building awareness.

Over one-third of the world's population has been exposed to TB at one time or another and new infections occur at a rate of one per second. Tuberculosis is a treatable disease and that's why it is up to us to make people aware of the symptoms.

I strongly encourage El Pasoans to be a part of the nationwide Stop TB campaign and inform themselves and others on how this disease directly affects them.

**Economic Stimulus Package**

I was pleased to visit the Hilos De Plata Senior Center on March 19. I had the opportunity to talk to 100 seniors about the upcoming 2008 economic stimulus package passed by Congress in early February 2008.

I had a candid conversation about the stimulus package and what it means for them as senior citizens. I also warned them about the possibility of identity theft during tax season so that they can be vigilant about who helps them with their tax filing preparation. The IRS has identified the existence of phone scams pushing the rebates, e-mails offering early refunds, and e-mails notifying recipients they are being audited. All phone calls and e-mails requesting personal account information over the phone on behalf of the IRS should be verified first before releasing any of your information.

I expressed the importance of filing cautiously so that they may receive their rebate. To receive a payment, taxpayers must have a valid Social Security number, \$3,000 of income and file a 2007 federal tax return. The IRS will take care of the rest. Eligible people will receive up to \$600 (\$1,200 for married couples), and parents will receive an additional \$300 for each eligible child younger than 17. Millions of retirees, disabled veterans and low-wage workers who usually are exempt from filing a tax return must do so this year in order to receive a stimulus payment.





TMA survey shows Medicare cut will force Texas physicians to limit patients

If the planned 10.5-percent Medicare cut to physician payments occurs on July 1, physicians will be forced to limit the number of Medicare patients they treat, the Texas Medical Association (TMA) announced today in Houston. TMA unveiled this and other sobering results of a new physician-member survey at Senior's Place, a senior citizen activity center. Sen. John Cornyn (R-Texas) explained how his new legislation, Ensuring the Future Workforce of Physicians Act of 2008 (S 2729) would stop the cut and reverse this dangerous trend.

Senator Cornyn's bill, which is receiving strong support from TMA, repairs the flawed formula Congress uses to calculate physician reimbursements, and saves seniors' health care. And, not a moment too soon, physicians say.

"I wish I could report to you that all is well, that one thing Medicare recipients don't have to worry about is finding a physician to care for them," A. Tomas Garcia, MD, member of TMA's Board of Trustees and president of the Harris County Medical Society, said. "But that is not the case."

Last week's TMA physician survey shows these sobering results:

- The percentage of physicians who accept all new Medicare patients has declined to an all-time low of 58.1 percent.
- Nearly one-third of physicians have decided to accept fewer new Medicare patients in the past three years. Only 4 percent are accepting more.
- For internists and family medicine special-

ists, who are on the front lines providing primary care to patients on Medicare, the situation is even bleaker. More than 45 percent say they have cut back on new Medicare patients in the past three years.

- Texas physicians will not refuse their current Medicare patients. Nearly 70 percent say that is something they will not do.
- But, more than 45 percent are considering accepting no new Medicare patients.
- Charity care may be an early casualty of the Medicare funding crisis. One-fourth of physicians say they already have reduced the amount of charity care they give. An additional 17 percent say they will make that change. Looking to the future, another 28 percent say they are considering reductions in charity care.

"With no real increase in Medicare payments to physicians in five years, and with constant drama and uncertainty over possible cuts in those payments, we're out on the edge of the cliff," noted Dr. Garcia, a Houston cardiologist. "And the fall will be a steep and painful one."

While physicians face annual cuts, the other key Medicare providers — hospitals, nursing homes, pharmaceutical companies — receive annual cost-of-living increases because their pay is calculated differently from physicians' reimbursements. Physicians received between zero- and two-percent increases over the last four years, and they face significant cuts in 2008. But Senator Cornyn's bill reverses that, fixing the flawed physician reimbursement formula, called the Sustainable Growth Rate formula. TMA physicians urge Congress to support Senator Cornyn's new legislation to reverse the dangerous trend so that Medicare-covered patients are not left without physicians to care for them.

## Eight Socorro ISD schools receive counseling award

for the work they do in preparing students for the next level. The eight schools are among 15 across Texas selected by the TSCA to receive the CREST, which stands for Counselors Reinforcing Excellence for Students in Texas.

"When people ask, 'what does a school counselor do?' the many things they do would be impossible to list. Counselors help students grow, learn, and excel. Counselors provide a wealth of information on academic, personal and social, and career issues that affect students. CREST is a continuous improvement document that gives a school counseling program an opportunity to demonstrate effective communication

Atkinson. "We are proud of our counselors. We see their impact on students and on families every day."

## EL PASO CENTRAL APPRAISAL DISTRICT

### Property Tax Protest and Appeal Procedures

The law gives property owners the right to protest actions concerning their property tax appraisals. You may follow these appeal procedures if you have a concern about:

- the market or special appraised value placed on your property
- the unequal appraisal of your property
- the inclusion of your property on the appraisal roll
- any exemptions that may apply to you
- the qualification for an agricultural or timber appraisal
- the taxable status of your property
- the local governments which should be taxing your property
- the jurisdiction in which you are being taxed
- the ownership of property
- the change of use of land receiving special appraisal
- any action taken by the Chief Appraiser, Appraisal District or Appraisal Review Board (ARB) that applies to and adversely affected your property

#### Informal Review

The El Paso Central Appraisal District has a trained staff to assist you.

In order to have a preliminary or ARB hearing, **you must file a written protest before your deadline** (see below for deadlines).

**If you receive a notice of appraised value**, a protest form is attached to the bottom below the perforation. If you wish to protest, simply tear off this form, sign the back, and return it to the El Paso Central Appraisal District.

**If you do not receive a notice of appraised value**, you should send a letter or postcard stating that you wish to protest your property value. Be sure to include your name and address or property identification number.

After your written protest is received, the Appraisal District will send you a letter notifying you of the date and time of your preliminary and/or ARB hearings. You are entitled to one postponement of your ARB hearing for any reason, if you are not represented by an agent. You may receive additional postponements if you have reasonable cause. All requests for postponements must be made to the ARB before the date of the hearing.

**However, if you have a question** about exemptions, procedures, or anything not related to a protest, you may call (915) 780-2131. Your call will be logged, your question noted, and given to the appropriate department for a call back.

#### Review by the Appraisal Review Board

If you cannot resolve your problem in a preliminary hearing with the Central Appraisal District (CAD) staff, you may have your case heard by the Appraisal Review Board (ARB). The ARB is an independent board of citizens that reviews problems with appraisals or other concerns listed above. It has the power to order the CAD to make the necessary changes to solve problems. If you file a written request for an ARB hearing (called a Notice of Protest) before the deadline, the ARB will set your

case for a hearing. You will receive written notice of the time, date, and place of the hearing. If necessary, you may request a hearing on Saturday or Sunday or in the evening. Prior to your hearing, you may ask to review the evidence the CAD will use to uphold their determination. The CAD may ask you for a copy of the evidence you plan to present. The hearing will be informal. You or a designated agent may appear in person to present evidence, or you may send notarized evidence for the ARB to review at your hearing. The CAD representative will present evidence about your case. You may cross-examine the CAD representative. The ARB will make its decision based on the evidence presented. The CAD has the burden of establishing the property's value by a preponderance of the evidence presented. You can get a copy of a protest form from the Appraisal District office at:

**Note:** You should not try to contact ARB members outside of the hearing. The law requires ARB members to sign an affidavit saying that they have not talked about your case before the ARB hears it.

#### Review by the District Court

After it decides your case, the ARB must send you a copy of its order by certified mail. If you are not satisfied with the decision, you have the right to appeal to district court. If you choose to go to court, you must start the process by filing a petition within 45 days of the date you receive the ARB's order.

#### Binding Arbitration

If you have protested the market value of your real property and the ARB has determined that the value is less than \$1 million dollars, you may request binding arbitration if you disagree with the value. The CAD will provide information and a request form with your order from the ARB. You must submit the request with a deposit of \$500 within 45 days of the date you receive the ARB order.

#### Tax Payment

If you appeal and your case is pending, you must pay the lesser of the amount of taxes due on the portion of the taxable value not in dispute, or the amount of taxes due on the property under the order from which the appeal is taken.

#### Requests for Evidence

You can request to review evidence to be used by the CAD in your formal ARB hearing by addressing it to the ARB at the El Paso Central Appraisal District office. The envelope should be labeled "**Request for Evidence.**"

### Deadline\* for Filing Protests with the ARB

#### Usual Deadline

On or before May 31, (or 30 days after a notice of appraised value was mailed to you, whichever is later).

Late protests are allowed if you miss the usual deadline for good cause. Good cause is some reason beyond your control, like a medical emergency. The ARB decides whether you have good cause. Late protests are due the day before the Appraisal Review Board approves the records for the year.

Military personnel on active duty outside the United States and property owners employed on offshore oil drilling, production facility or vessel, have until the date the taxes are due to file a protest.

\* The deadline is postponed to the next business day if it falls on a weekend or holiday.

#### Special Deadlines

For change of use (the Appraisal District informed you that you are losing agricultural appraisal because you changed the use of your land), the deadline is before the 30th day after the notice of the determination was mailed to you.

For ARB changes (the ARB has informed you of a change that increases your tax liability and the change did not result from a protest you filed), the deadline is before the 30th day after the notice of the determination was mailed to you.

If you believe the Appraisal District or ARB should have sent you a notice and did not, you may file a protest until the day before the 125th day after you receive written notice of taxes due on the property. The ARB will decide whether you were due a notice and if the notice was mailed to you.

**San Elizario HS students sign to play college football**

Friends, family, and school district personnel filled a large meeting room inside the San Elizario High School Library to witness a momentous occasion on March 20. As the large crowd of supporters and fellow students watched, seniors Esteban Reyes and Emmanuel Jacquez, with their parents seated beside them, each signed a letter of award to play football at New Mexico Highlands University in Las Vegas, New Mexico. By accepting to play college football, Reyes and Jacquez helped the San Elizario High School's football program reach a rare milestone, enabling student athletes to sign scholarship letters as seniors.

Head coach Alfredo Gurrola assisted Reyes and Jacquez in finding an opportunity to play at the collegiate level by preparing portfolios for the students, contacting recruiters and coaches and showing them videos of his star players in action. Gurrola who has only been coaching the San Elizario High School team for two years noticed something special about Reyes and Jacquez early on as he initiated his practice sessions.

"They welcomed me with open arms. When they played they never quit and Steven (Reyes) even played a whole year without an ACL. They are fantastic players," Gurrola said.

During the 2007 football season, Reyes who played the position of quarterback completed 1,652 yards passing, 12 touchdowns, 20 interceptions, rushed for 210 yards and three scores. Jacquez who served on the team's defense finished the season with 49 tackles, a fumble recovery, and a blocked field goal.

Describing what it means to the school's football program to have two players sign scholarship letters their senior years, Gurrola said, "It makes it believable, and makes it possible for others."

Reyes on the other hand was at a loss for words to express what he felt about receiving the scholarship from New Mexico Highlands University. "I'm speechless. I don't know what to say."

Gurrola continues talking with recruiters, hoping to finalize award packages for other students to go on to play football in colleges in Texas, Kansas, and New Mexico. For Gurrola, the signing ceremony held for Reyes and Jacquez is only the beginning of much more and better things to come for the San Elizario High School football program.
