### Healthcare grant

The U.S. Department of Health and Human Services (HHS) has awarded Centro de Salud Familiar La Fe a \$174,847 federal grant. The federal funding, provided through HHS's Ryan White HIV/AIDS grant program, will benefit the La Fe Community Advocacy Resources and Education (CARE) Center, which provides services for patients with HIV in El Paso. "The La Fe CARE Center provides critical medical care and treatment for those living with HIV in our community," said Congressman Reyes. "These funds will help La Fe continue providing services to those individuals who need it most." The Ryan White Comprehensive AIDS Resources Emergency (CARE) Act provides funding to states and other public or private nonprofit entities to develop, organize, coordinate, and operate health systems for the delivery of essential health care and support services to medically underserved individuals and families affected by HIV.

### Crime Stoppers

Crime Stoppers of El Paso is assisting the El Paso Police Department in locating two offenders who grabbed a man in a choke hold and held a knife to his back before taking his money, making this the "Crime of the Week." On Monday, March 31, about 11:30 p.m., the two suspects entered Adobe Grocery at 585 Giles. Suspect one grabbed and held a 70-year-old man in a choke hold, then pressed a knife to his back while demanding money from the cash register. Suspect two acted as cover and, on his way out, smashed the camera and monitor of the store's surveillance system with a baseball bat. Investigators from the Crimes Against Persons unit believe both suspects fled towards Carolina Drive, and K-9 tracked them to a possible destination at 718 Carolina. Suspect one is described as a Hispanic male in his early 20s, 5-foot 8-inches tall, 160-180 pounds, wearing a blue or gray hooded sweater, blue baggy jeans, armed with a knife. Suspect two is a Hispanic male, also in his early 20s, 5-foot 8-inches tall, 160-180 pounds, armed with a bat. ## Garcia receives Gates Millennium Scholarship

Canutillo High School (CHS) senior Miriam Garcia has been named a 2008 Gates Millennium Scholarship (GMS) recipient. The GMS scholarship will provide Garcia with four years of financial assistance to meet any unmet need as she attends Baylor University beginning in the fall, where she will major in Biology with a Pre-Med emphasis.

Garcia, daughter of Martha and Ruben Garcia of Westway, is currently ranked second in her senior class with a 101.1017 grade point average. She is a member of CHS's Health Occupations Student Association (HOSA) and has competed at the HOSA state and national levels. She is also a member of Future Business Leaders of America, National Honor Society, FFA, and the cross-country team. Garcia has also been a mentor in the Big Brothers Big Sisters program for the past four years.

Garcia stated that the application process for the Gates Millennium Scholarship was long but definitely worth it. It required two recommendations from teachers, answers to essay questions, evidence of financial need, and descriptions of community service and extra-curricular activities during her four years of high school.

Garcia will also have the opportunity to apply for Graduate School Funding for continuing Gates Scholars in the areas of education, engineering, library science, mathematics, public health and sciences.

The GMS program is more than just a scholarship. The GMS program offers Gates Scholars Academic Empowerment Services (ACE) to encourage academic excellence, mentoring services for academic and personal development, and an online resource center that provides internship, fellowship, and scholarship information.

### Property tax concerns

Hola, mi gente. On April 23, the Speaker of the House of

Representatives released a press informational announcing the creation of the Select Committee on Property Tax Relief and Appraisal Reform; to which I have the honor of representing El Paso County.

The purpose of the select committee is to gather testimony and information about property tax relief and reforming the property appraisal system. I know that just about everybody in El Paso county has a complaint concerning one or both of those subjects.

Over the past few years, the appraised property values in El Paso have risen tremendously. A significant number of people with whom I have spoken just cannot understand why there are such steep increases on their property. For the purpose of investments, such increases are a blessing. But I know that the great majority of homeowners do not immediately benefit from the increases that

the appraisal district has placed on their homes.

In general, increasing property should be a good thing. The problem is that while the property is increasing, most of us do not actually have more money in our pockets; it is a paper wealth. Because of that, the accompanying tax increases have a bad impact on our everyday budgets. This is especially true for those on low or fixed incomes.

There are two points that I want the select committee to review intensively.

The first is the manner in which increases are imposed. Right now, if a home in your neighborhood is sold at a higher price than yours, you can probably bet that you will have an appraisal increase. If you knew that your house was exactly the same as the house that sold, you might not object. The trouble is the folks at the appraisal district won't release that information to you; so there is no way for a protestant to compare properties.

I feel that is not fair and I will be in favor of changing that. I still believe that, as stated in the state tax

code, "each property shall be appraised based upon the individual characteristics that affect the property's market value." As it stands now, the appraisal district issues the appraisal based purely on the market; it is up to the homeowner to argue down the increase by providing proof to the district for a lower appraisal.

Which brings me to my second point. The process for appraisal protests should be changed. In fighting an appraisal, a homeowner almost has to be an attorney. If the district is going to appraise home based on sales of other homes, then the district should have enough people to accommodate each protest to the homeowner's satisfaction.

## Gender bender

They can vote. With apron strings no longer indelibly fixed to their waists, they have become powerbrokers and have acceded to the highest echelons of Corporate America. Their numbers swell the ranks of the most prestigious institutions of higher learning that this nation has to offer. They are tough, rugged, honest, sincere, caring, and now running for the highest political office of the land. In short, the "fairer sex" has come a long way, but not without hitting speed bumps and impassable along the way. Yes, it was long overdue, and, yet, with every lump of sugar comes a grain of salt. Women's health has become a bitter pill to swallow. After all, having their cake and eating it, too, has put women in the crosshairs of the same acute and chronic maladies afflicting their testosterone-infused, hairy, king of the jungle, Rambo-like husbands and significant others. So, perhaps it would be time well spent, examining the differences between men and women on a clinical and public health stage. Perhaps a reality check will be accorded, when the notion that gender matters in health is "slam dunked." Let the reader beware, that what follows is not a pretty picture, and has ramifications that go beyond the circle of influence of a simple "gender bender."

It is conventional wisdom that women outlive men, and this has been the case since the turn of the century. Reductions in the mortality surrounding maternity, labor, and birth have played a role in women's longevity. Lo and behold, however, since 1980, the gap in life expectancies between Rambos and Rambas has been narrowing, and men's gains in life expectancy now exceed those of women. How can this be accounted for? What or who is to blame? The answer, Dear Brutus, lies not in the stars, but in the higher rates of morbidity and psychological distress experienced by the carriers of two X chromosomes. Women, in fact, for better or worse, in this case, are subject to higher incidence and prevalence rates of anxiety, depression, worry, and demoralization. An uncertain world and a vacillating U.S. economy do not brighten immediate prospects, either.

There is a paradox here, which needs some form of explanation. Why do men continue to meet their Creators at younger ages than women, and, yet, are stricken by chronic illnesses at much lower rates than the latter? Gender differences in the patterns of disease might be revelatory on that score. Case in point, men, for whatever reason, are more often the victims of life-threatening chronic diseases such as coronary heart disease, cancer, cerebrovascular disease, emphysema, cirrhosis of the liver, kidney disease, and atherosclerosis. Women, on the other side of the coin, are more frequent targets of chronic disorders, including anemia, thyroid conditions, gall bladder disease, migraines, arthritis, colitis, eczema, and the list goes on and on. It doesn't end there, either, as women have more than their share of acute conditions such as upper respiratory infections, gastroenteritis, and a proverbial pot-

pourri of short-term infectious diseases. Women are not immune to the life-threatening chronic diseases afflicting men. They just experience them later in life. Clinicians, researchers, and public health professionals have been slow to realize this, and, consequently, there has been a gender bias in health care research and clinical practice directed at those mortal conditions. A "women don't have heart attacks" perspective has not only been abusive and dangerous, but has shaped clinical research studies. It is now clear, beyond any shadow of doubt, that treatments developed by studying men are not necessarily generalizable to women. Biological differences between men and women must be understood, with an eye to health advantages in one sex being employed to develop new pharmaceutical interventions to benefit members of the opposite sex.

Comparing the health of men and women is far from an easy task. Factors such as who specifically is being compared, the social and environmental causes of disease, the places where chronic conditions lurk, and the practice situations and social characteristics of the dominant group of medical professionals-physicians must all be considered. It is not a simple question of XX versus XY, as differences in men's and women's morbidity and mortality are a function of the combination of both social and biological factors, which tend to operate in opposite directions. While women derive advantages in longevity from sex differences that allow them to carry a fetus to term, men's claims to decreased morbidity appear to be related to lower levels of role stress, role conflict, and the demands of work and play. There is, however, some controversy on the biological side. Their stronger immune systems and estrogen contribute to women's greater longevity by lowering their risk of coronary heart disease prior to menopause, and, yet, their biology is hard-pressed to explain why women get sick more often than men.

Behavior and the socialization process between the sexes may also influence health. Women are taught from birth to accommodate others, and men to express anger and frustration more readily than the opposite sex. Those social characteristics may, in effect, account for the greater risk of psychological maladies, such as depression, in women. Social roles and their connection to disease will become fertile research terrain in the future.

All's fair in love and war, but biological, environmental, and social skirmishes between men and women on the health front benefit no one. They drive up health care costs at a time when the U.S. economy is barely limping along. So, like the "good hands people," in the future, steps must be taken to ensure that a simple gender bender never reaches the proportions of a full-fledged "head on." Men and women are different. Their bodies are different. Their health is different. The sooner that lesson is drilled home, the sooner ripe, old ages can be reached together.

## School board notes By Don Woodyard

UPPER VALLEY—With this issue, the County Courier expands its monthly coverage of area school district board meetings to six.

Each month readers will find the highlights of actions taken by trustees in the Anthony, Canutillo, Clint, Fabens, San Elizario and Tornillo school districts. Stories will be grouped by area. Anthony and Canutillo school districts will comprise the Upper Valley coverage. The other four school districts situated in the Lower Valley will be presented in a separate story.

### Canutillo ISD April 8

The school district's Early College High School program received a big boost from the Hunt Family Foundation. Marcus Hunt, head of the foundation, told board members that his organization was giving \$100,000 to the district for purchase of laptop computers for all students the initial class of the Early High School program.

"I have seen tremendous improvement in the school district," Hunt

said. "I am proud of what you have done."

"I see the school district as a model of success."

Earlier, in her superintendent's report, Dr. Pam Padilla underscored the importance of the computers. She had visited a school in Houston that was using laptops in a similar program as the one planned in CISD.

The Canutillo High School choir and its director, Willie Adame, were recognized for having earned a First Division rating in regional competition. This qualifies the choir to perform in the upcoming state solo and ensemble competition.

Praising the work of Adame for his positive role in affecting the lives of his choir, board member Yvonne Sanchez said, "Thank you for causing these futures to happen. Their hearts are here; they come back."

### Anthony ISD April 15

Of great concern to the board was a summary report from the Texas Education Agency that showed that

Anthony ISD ranks low in essential testing areas among the 1,100 school districts statewide.

The lowest curriculum area was in math and science where summary data from TEA showed AISD ranked 1,091. The district fared better in other areas. It was 850 in reading and 641 in writing. In all tests taken, the district was ranked 1,078.

"We need good math and science teachers," superintendent Ron Haugen told board members. "We need to close the gap." To help improve student scores and district rankings, he said he would utilize an instructional coaching position in math and science.

Another academic tool to improve test scores, Haugen said later in a telephone interview, would be implementing an accelerated math software program during the summer school. Also, there is specialized C-Scope software through Region 19 Education Service Center.

"We will also be looking at different structures on how to teach." One example of this, he explained, would be maximizing and utilizing a teacher's strongest academic talents to a greater advantage in the classroom.

"We didn't get this way overnight," the superintendent said, emphasizing the need to "take strides" to turn things around. "We need to do things differently."

The board took action to upgrade computer equipment in three areas. It was pointed out that present computers were outdated. The purchase of 55 new computers was approved and earmarked for students' use at a cost of \$55,000.

Dell computers for the high school open lab.

Apple computers for the BCIS lab and also for the band program "in order to provide students with new and varied technology," Haugen said in his summary of board meeting actions.

Needed renovations on the elementary school cafeteria will move ahead after the board approved the transfer of \$15,000. The district faces a September facility audit and needs to make repairs to bring the cafeteria into compliance with state standards. Work will include cleaning and painting, replacing ceiling tiles and work on cafeteria vents.

The next meeting of the Anthony ISD board is 6:30 p.m. Tuesday, May 20.

# School board notes By Don Woodyard

**LOWER VALLEY** — Coverage of area school boards expands to six with this issue of the County Courier. Specifically, significant actions by the board of trustees of the Fabens ISD will be featured in this and upcoming issues. This adds to on-going and comprehensive coverage of school board actions in Clint, San Elizario and Tornillo.

The Upper Valley school districts, Anthony and Canutillo, are covered in a separate story.

## San Elizario ISD April 9

Strains in the working relationship between SEISD and VEMAC, the district's long-time construction company, surfaced at the meeting. Dan Gonzalez, executive director for professional services for VEMAC, and Oscar Venegas, president of the company, addressed concerns from board members about construction delays.

Speaking on behalf of the other trustees, Armando Martinez spoke of a changing working relationship, which at first was "very accommodating" to district needs. However, he feels the relationship has declined in recent years because the company has grown so much that it couldn't respond in as timely a manner as it had.

"We feel we were put down at the bottom of the totem pole," Martinez said.

"It leaves a bad taste in our mouths," Martinez added. But he also pointed out that "the company's workmanship has never been in question."

Gonzalez and Venegas apologized to the board for the problems and the delays. "I'm sorry, really sorry,"

Gonzalez said to the board. They readily acknowledged and are appreciative of the fact that SEISD gave them a break 12 years ago when they first started out as Urban Associates.

"I really love this district," Gonzalez said. "It is one of my showcase districts; it's a showplace."

"We are competing against Fort Bliss — that is the school district's competition." He further explained that with this new competition, it was more difficult for VEMAC to find subcontractors to handle such things as plumbing, roofing and electrical work.

Also, Gonzalez said they had to take care of 103 construction change orders and deal with unexpected environmental concerns with buried storage tanks at worksites.

In regards to current projects, George Luevano reported that all three buildings had reached a substantial level of completion. Luevano is the director of support services.

The new Alarcon Elementary cafeteria has been approved by health officials and is serving meals. Minor technology problems remain with library.

In other action, the board approved the issuance and sale of San Elizario Independent School District Unlim-

ited Tax Refunding Bond, Series 2008. It levies an ad valorem tax for payment of the bonds.

## Tornillo ISD April 15

Tornillo Elementary School is hoping the third time will be as much of a charm as the first time.

For the third year in a row, the school is applying for funding from a Texas Educator Excellence Grant (TEEG). According to a TEEG paper, the purpose of the grant is "to achieve higher levels of student academic performance."

Teachers at Tornillo Elementary are already receiving fatter paychecks for having met their performance criteria for the past two years. Superintendent Paul Vranish said going for and receiving the financial rewards for the third is kind of like "triple dipping."

The first year, qualified teachers received an additional \$2,300 a year in salary. The same thing happened last year for the elementary school, bringing the bonus total to \$4,600.

The board approved the school's TEEG application for the third year which would bring bonus pay to more than \$6,000.

"Everybody is excited," Vranish said in a telephone interview Monday. "They see the money potential. They are licking their chops."

Like the elementary school, the high school has been cashing in as well for the last two years with the teacher paycheck incentives. The superintendent said it was in the \$1,500-\$1,800 range. The high school is going for a third year repeat also.

Tornillo Intermediate School has qualified for the 2008 Governor's Grant of \$50,000. Seventy-five percent of the grant (\$37,500) goes for teachers only. They could qualify for \$1,875 in additional income. The remaining \$12,500 goes for financial incentives to various staff positions from principal to crossing guards and receptionists.

The board nominated Vranish to run again for Superintendent of the Year for 2008. He received the honor last year.

Vranish said the board is initiating conversations about random drug tests for student athletes.

## Clint ISD April 16

Ramon Lozano, III is the new principal of Horizon High School. Trustees approved his selection by a unanimous vote. Lozano, who has nine years experience in the field of education, is presently assistant principal at Riverside High School in the Ysleta ISD.

The board approved expenditure of \$1.149 million for repairs to me-

chanical roof-top equipment and roof that were damaged in a hail storm in May of 2007. Sandra Odenborg, the district's director of support services, reported on another aspect of the hail storm damage.

In an agreed settlement with the insurance company, she said the CISD will receive \$415,989 for food damaged at six campuses.

Odenborg also reported that construction of the parking lot at Surratt Elementary School is "substantially completed."

## Fabens ISD April 16

Jose Cervantes outlined the district's summer school program.

The month-long session will run from June 3rd to July 2nd. Instruction for pre-K through 8th grade students will be in Fabens Middle School. For grades 9-12, classes will be held on the high school campus.

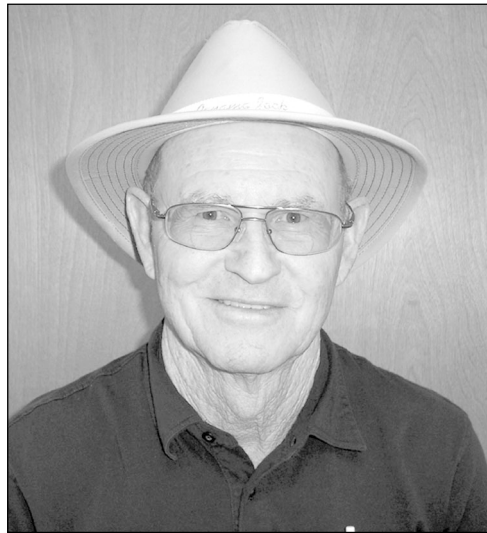
The board approved a request from the maintenance department for the purchase of a tractor.

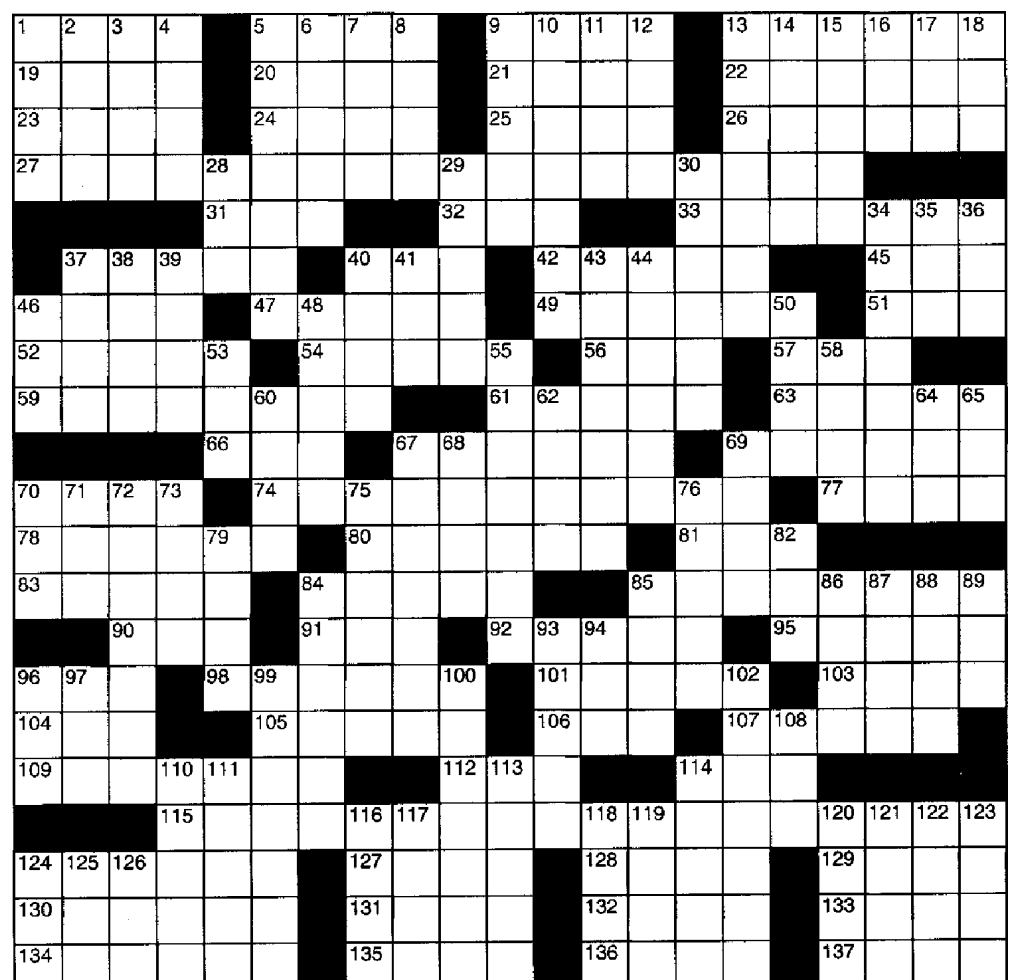

# Social Security Q&A By Ray Vigil

**Q:** I applied for my baby's Social Security number while in the hospital. It's been several weeks and I haven't gotten her card in the mail. What should I do? Should I re-apply?

**A:** Sometimes it can take a little longer than usual for your card to arrive. As long as you completed the

paperwork in the hospital, you can rest assured it's being processed. Some states take longer to process than others. If you need to show that you applied for your baby's card, you can use the receipt you got at the hospital when you submitted your baby's application. **Q:** I'm 62 and divorced. But my earnings weren't enough for me to qualify for Social Security. Can I get benefits as a divorced spouse?

**A:** In most cases, you can receive benefits as a divorced spouse on your former spouse's Social Security record if you were married to the former spouse for at least 10 years, are at least age 62 years old, are currently unmarried, and are not entitled to a higher Social Security benefit on your own record. If you would like to get an estimate of benefits you may

**Q:** How does Social Security decide if I am disabled?

**A:** For Social Security to consider you disabled, you must be unable to do work you did before and we must decide that you cannot adjust to other work because of a disabling condition. Also, your disability must last or be expected to last for at least one year or to result in death. Social Security pays only for total disability. No benefits are payable for partial disability or short-term disability. **Q:** Why does the Supplemental Security Income (SSI) application ask about my "living arrangements?"

**A:** Your living arrangement can affect your SSI payment amount. For example, a beneficiary's SSI payment may be reduced by up to one-third if the recipient receives food or shelter that is paid for by another person. Where you live, who else is in the household and what you and others pay towards the household expenses can all make a difference in your SSI payment.
