Franco works for new Anthony Town Hall

ANTHONY — A long-held dream is “closer to reality” for Anthony Mayor Art Franco.

The reality is a new town hall for the Upper Valley community. That reality is reflected in an architect’s concept and design of what the town’s new administrative building might look like.

The new reality is underscored in the Anthony Town Council giving a green light for its construction.

Franco estimates that construction on the \$800,000-\$900,000 building will start in late summer or early fall. It will be located on two and a half acres of land across from Anthony High School on Wildcat Drive. He hopes it will be completed in early 2011.

Franco, who has been mayor since 1993, says this will be the third town hall for Anthony. The first was located at the corner of Main Street and Washington and was only about 1,000 square feet.

The new town hall will be 5,000 square feet, the same size as the present facility. The difference, Franco points out, is that the new building will be designed and built from the ground up specifically as a town hall, whereas

the present building was adapted and remodeled to house various administrative functions.

“It will be more energy-efficient — more green,” the mayor says.

The new town hall will house, as is presently the case, the mayor’s office, the court, council chambers and convention and a visitors’ bureau operation.

The new town hall wasn’t the only topic of conversation Monday with Franco.

Another major item was money — millions of dollars that will be pumped into Anthony’s economy over the next few years.

“Pumped” is literally as well as figuratively true in describing two quality of life grants totaling \$10.6 million which will benefit the town.

Not only will they be pumping money into the economy, but they will be doing a better job of pumping water into the homes of Anthony residents.

Both grants, one federal and the other state, overlap and cover essentially the same areas — the improvement of water and sewer service to area residents. Specifically they include upgrades to lift stations, a new above-ground water storage tank, building a new water treatment plant and repairing water and sewer lines.

These funds allocated for the Anthony

area represent are in excess of the \$8.8 million which was first estimated for the cost of necessary water and sewer system improvements.

The federal grant, for \$6.6 million, came as a result of his meeting with U.S. Rep. Silvestre Reyes, the 16th District representative for the El Paso area. He met with Reyes and other congressional leaders from New Mexico as well as Texas in early April. He journeyed to Washington in his capacity as president of the Rio Grande Council of Governments.

The mayor describes this grant as “tentative” only because it lacks the final signing.

The second grant comes from the Texas Water Development Board is for \$4 million.

Once completed, Franco says the system improvements should take care of the town’s anticipated needs for at least the next 10 years.

Those anticipated needs will include commercial expansion. Construction started this week on Franklin Retail Center across from La Feria. A new Carl’s Jr. has also opened in Anthony.

Residentially, 20 new homes have been added in the Wildcat subdivision.

Quality of life improvements for residents are not solely in the area of infrastructure.

With funds from a \$780,000 grant from the Texas Parks and Wildlife, sod is being laid for four new soccer fields. The soccer fields are only part of a 56-acre recreational park under development along the north side of Franklin Street. It stretches from Miramontes Park east to Walgreens and north to the Texas state line.

Franco hopes to have the multi-purpose park completed by the end of the year. When completed, it will have a skateboard park, walking trails, baseball fields with lights, playground area and picnic tables.

Franco says there are three Town Council positions, two contested, coming before the voters in May. Franco’s current two-year term of office expires next year.

“Right now,” the mayor says, “the economy of Anthony is doing well. I foresee good things coming for Anthony.

“I feel really confident; I feel good. I look forward to the future.

“We are growing at a pace we can accommodate.”

Canutillo HS wins district UIL 2-4A

CANUTILLO — The Academic University Interscholastic League (UIL) students from Canutillo High School (CHS), recently won the school’s first District title in over thirty years. After competing in the district round, held at El Dorado High School, fifteen CHS students will advance to regional competition in San Angelo this month.

CHS garnered 328.33 points for the win, outdoing the next best competitor by 92.83 points during the 2-4A Academic UIL

meet. Along with CHS, other high schools competing were Parkland, Ysleta, Del Valle, Mountain View, San Elizario, Riverside, and Horizon.

According to CHS’s UIL Coordinator, Richard Jeffery, Canutillo HS Teams captured first place in Mathematics, Number Sense, Science, and Social Studies categories, advancing them to the regional meet along with the individual event winners.

Participants who are on both the Mathematics and Number Sense teams are Chris Abdul, Omar Garcia, Alan Lara, and

Flood control is better

Hola mi gente. El Paso County was hit with its first severe thunderstorm event of our spring/summer season. This walloped several areas with unusually large hail stones. Although the east county received the biggest part of the storm, some areas of central El Paso were also hit.

Most of you will remember the storms that hit our county in 2006. Those rainfalls were described as a 100 year flood event; in other words, rainfall accumulations that happen very infrequently.

On the last weekend of August in 2006, a massive thunderstorm unloaded tons of water just north

of Clint in the El Paso Landfill. The runoff from that burst created havoc for the residents around the City of Clint. It was also the first event of the 100 year flood event.

Many storm reservoirs filled to the highest level and caused county officials to prepare for the worst. I have to commend the City/County Office of Emergency Management for their handling of the month long emergency condition. Even the Rio Grande came very close to breaching its levies.

We were spared the catastrophic overflow by the river because of some heroic efforts by the El Paso County

Water Improvement District #1 (District). The workers for the district opened the irrigation gates at certain locations. This allowed the river to reduce the pressure on the levies.

The irrigation canals that the district manages diverted the water to flow quickly to the eastern most junction with the river.

What most people don't realize is that many of the irrigation gates had not been used in years and were frozen shut by corrosion. Many of those gates had to be destroyed in order to allow the water to enter from the river.

Chuy Reyes, the director of the District, did not get much rest during the month long deluge. He and his crew saved the county from some massive destruction.

I reminisce about the floods

because just last week my staff and I attended a ribbon cutting ceremony for a newly constructed flood gate just southeast of the City of Socorro. The new gate is an engineering miracle.

Because of the farming season, the old irrigation gate could only be replaced during a very small window of time. Add to that the need for innovative features and the need for funding, it is amazing that the new gate is now in place.

Congratulations to Congressmen Silvestre Reyes and Ciro Rodriguez for their effort in channeling Federal Stimulus money for this project. While many people complain about the money appropriated for the stimulus package, El Paso fared

very well with this one.

The canal which channels to the newly constructed gate actually originates close to UTEP on the west side. By using this gate, excessive waters in the Rio Grande can be quickly diverted. The engineering for the project allows for very quick flow of water as well thereby avoiding a levy breach in the city.

I was very impressed with the new gate. The water that flowed through it was beautiful. It is my understanding that there are plans for several more gate improvements thanks to the Congressman and to the District.

Veterans Post By Freddy Groves

VA home loans

Are you ready to use your veterans home-loan benefit to buy a house?

To get started, you'll need a Certificate of Eligibility. Go to www.homeloans.va.gov and click on VA Form 26-1880 to get a printable form to request your certificate. You'll need a copy of your DD-214 or its equivalent to go along with the request. Some lenders can get your certificate for you, but not in all cases.

If you already have a Department of Veterans Affairs loan but want to sell that property and buy another with your eligibility, you can do that under certain circumstances. If the house is paid off and you've sold it, you'll be eligible to buy another. If it's paid off but you still own it, you can get your eligibility restored one time. Use that same VA Form 26-1880 and provide proof that the loan is paid

off. If you let someone assume your VA loan, your eligibility can be restored only if another veteran was the purchaser and has eligibility available or pays off the loan.

Meanwhile, if you already have a VA-backed mortgage that you've refinanced, pull out your paperwork and go over it with a sharp eye: It's possible you were scammed. All across the country right now, veterans are learning that some lenders buried certain unauthorized fees in other categories. In some cases, veterans are getting their money back, but that likely won't happen unless you find the errors first.

EL PASO CENTRAL APPRAISAL DISTRICT 2010 Property Tax Protest and Appeal Procedures

The law gives property owners the right to protest actions concerning their property tax appraisals. You may follow these appeal procedures if you have a concern about:

- the market or special appraised value placed on your property
- the unequal appraisal of your property
- the inclusion of your property on the appraisal roll
- any exemptions that may apply to you
- the qualification for an agricultural or timber appraisal
- the taxable status of your property
- the local governments which should be taxing your property
- the jurisdiction in which you are being taxed
- the ownership of property
- the change of use of land receiving special appraisal
- any action taken by the Chief Appraiser, Appraisal District or Appraisal Review Board (ARB) that applies to and adversely affected your property

Informal Review

The El Paso Central Appraisal District has a trained staff to assist you with this process. For information on this process call (915) 780-2131.

In order to have a preliminary or ARB hearing, **you must file a written protest before your deadline** (see below for deadlines).

You may be able to appeal your property value on-line. **Please visit our website at www.epcad.org for more information.**

If you do not receive a notice of appraised value and want to appeal the 2010 value of your property, you should send a letter or postcard no later than **May 31, 2010** stating that you wish to protest your property value. Be sure to include your name, mailing address and the address or the location of the property you are protesting.

After your written protest is received, the Appraisal District will send you a letter notifying you of the date and time of your informal and/or ARB hearings. You are entitled to a postponement of your ARB hearing for any reason. You may receive additional postponements if you have reasonable cause. All requests for postponements must be made to the ARB before the date of the hearing.

If you file your appeal electronically (on-line), all communication will be by e-mail.

If you have questions about exemptions, procedures, or anything not related to a protest, you may call (915) 780-2131.

Review by the Appraisal Review Board

If you cannot resolve your problem at the informal hearing with the Central Appraisal District (CAD) staff, you may have your case heard by the Appraisal Review Board (ARB). The ARB is an independent board of citizens that reviews appraisals or other concerns listed above. The ARB may direct CAD to make the necessary changes to resolve your dispute. If you file a written request for an ARB hearing (called a Notice of Protest) before

the deadline, the ARB will set your case for a hearing. You will receive written notice of the time, date, and place of the hearing. If necessary, you may request a hearing on Saturday or Sunday or in the evening. Prior to your hearing, you may ask to review the evidence the CAD will use to uphold their determination. The CAD may ask you for a copy of the evidence you plan to present. You or a designated agent may appear in person to present evidence, or you may send notarized evidence for the ARB to review at your hearing. The CAD representative will present evidence about your case. You may cross-examine the CAD representative. The ARB will make its decision based on the evidence presented. The CAD has the burden of establishing the property's value by a preponderance of the evidence presented. You can get a copy of a protest form at:

Note: You should not try to contact ARB members outside of the hearing. The law requires ARB members to sign an affidavit saying that they have not talked about your case before the ARB hears it.

Review by the District Court or an Arbitrator or SOAH

After it decides your case, the ARB must send you a copy of its order by certified mail. If you are not satisfied with the decision, you have the right to appeal. If you choose to go to court, you must start the process by filing a petition within 60 days of the date you receive the ARB's order. In certain cases, as an alternative to filing an appeal in district court, you may file, not later than the 45th day after you receive notice of the ARB order, a request for binding arbitration with the county appraisal district. In certain cases originating in certain counties, as an alternative to filing an appeal in district court, you may appeal to the State Office of Administrative Hearings (SOAH). An appeal to SOAH is initiated by filing with the chief appraiser of the county appraisal district a notice of appeal with the applicable filing fee not later than the 30th day after you receive notice of the ARB order.

Tax Payment

If you appeal and your case is pending, you must pay the lesser of the amount of taxes due on the portion of the taxable value not in dispute, or the amount of taxes due on the property under the order from which the appeal is taken.

Requests for Evidence

You can request to review evidence to be used by the CAD in your formal ARB hearing by addressing it to the ARB at the El Paso Central Appraisal District office. The envelope should be labeled "Request for Evidence."

Deadline* for Filing Protests with the ARB

Usual Deadline

On or before May 31, (or 30 days after a notice of appraised value was mailed to you, whichever is later).

Late protests are allowed if you miss the usual deadline for good cause. Good cause is some reason beyond your control, like a medical emergency. The ARB decides whether you have good cause. Late protests are due the day before the Appraisal Review Board approves the records for the year.

Military personnel on active duty outside the United States and property owners employed on offshore oil drilling, production facility or vessel, have until the date the taxes are due to file a protest.

* The deadline is postponed to the next business day if it falls on a weekend or holiday.

Special Deadlines

For change of use (the Appraisal District informed you that you are losing agricultural appraisal because you changed the use of your land), the deadline is before the 30th day after the notice of the determination was mailed to you.

For ARB changes (the ARB has informed you of a change that increases your tax liability and the change did not result from a protest you filed), the deadline is before the 30th day after the notice of the determination was mailed to you.

If you believe the Appraisal District or ARB should have sent you a notice and did not, you may file a protest until the day before the 125th day after you receive written notice of taxes due on the property. The ARB will decide whether you were due a notice and if the notice was mailed to you.



A Hog loaded for bear?

Things can move pretty quickly in the world of sports, and nothing can change the landscape of one's favorite team quicker than a sudden trade — particularly to one's division rival. Such is the case at the Pennsylvania and Maryland border these days. Donovan McNabb has hit the Beltway, and Philadelphia

isn't sure what's hit it yet.

Donovan McNabb was to the Philly fan what Patrick Ewing was to the Knicks fan — both were larger-than-life stars who possessed enormous talent but, alas, couldn't bring home the championship. No matter what they accomplished during their lustrous careers, without

a ring McNabb will be known as "the guy who got tired in the Super Bowl," just like Ewing, one of the greats of his era, will be remembered for "the finger roll."

For the past 10 seasons, McNabb has been the face of football in Philadelphia. McNabb is the Eagles' all-time leader in career wins, pass attempts, pass completions, passing yards and passing touchdowns. Despite this, McNabb never seemed to earn the respect befitting a quarterback of his stature. The boos started to

rain in Philadelphia, and when the Cowboys ushered them out of the playoffs last season, the team's brass seemed anxious to usher him out of town, too.

McNabb joins a Redskins franchise that has been in complete disarray for more than a decade. With the exception of the brief Joe Gibbs nostalgia tour, the team has over paid free agents, pinned its hopes on coaches like Steve Spurrier and Jim Zorn, and squandered draft picks. Now, led by Mike Shanahan, skeptical fans are wondering if McNabb and the former Denver coach can bring visions of John Elway to Redskins Park. Like Elway when he took the Broncos to the championship, McNabb will turn 34 next season. And though McNabb has lost his mobility, his style of quarterbacking would seem to suit Shanahan well.

While it has always proven foolish to underestimate McNabb and

Shanahan, make no mistake about this Redskins team, it is not the "Hogs" of the '80s. And while that may seem like a high bar to measure a team by, it is an appropriate one. Those are the teams that won the NFC East and took home titles.

Philadelphia now turns to Kevin Kolb, 10 years younger than McNabb and the first quarterback in NFL history to throw for more than 300 yards in each of his first two career starts. Those are the sorts of things that have Philly fans showing optimism. And guess what Kolb does during his offseason? He hunts hogs (no lie).

Philadelphia better hope so, because McNabb will be loaded for bear when he makes his burgundy-clad return to Philadelphia.



Your good health By Paul G. Donahue, M.D.

DEAR DR. DONOHUE: I've had severe high blood pressure for many years. I have tried all the medicines you can think of. I am 62 and have had one ministroke. I'm not looking for another. I used to weigh 235 pounds. I lost 100 pounds. I watch my salt. I have tried everything. My family has a history of high blood pressure. Can you recommend anything? — F.

Nonsteroidal anti-inflammatory drugs are an example — Aleve, Advil, Motrin, aspirin and other NSAIDs. Don't drink more than two alcohol drinks a day.

More than 30 blood pressure medicines are on the market. I bet you haven't tried all 30 or combinations of them. Some brands come with two medicines in one pill, easing the burden of pill-taking. A new medicine, one completely different from all other medicines, is now available. It is Tekturna. Something must be done for your pressure.

Blood pressure that doesn't drop by making life changes (weight loss and diet) or by taking three or four blood pressure medicines is called resistant high blood pressure (hypertension). Your weight loss is admirable. It should have reduced your pressure.

Watching your salt intake is also important. That entails more than not using the salt shaker. It requires you to carefully look for the salt content (listed as sodium or sodium chloride) of all your foods. Commercial soups, frozen dinners, many canned goods and luncheon meats often have a high salt content. Your diet should be one of fruits, vegetables, whole grains (unrefined wheat, barley, rye and oats) and one where meat and fats are eaten sparingly.

Increase foods with lots of potassium in them: tomatoes, potatoes, prunes, lima beans, kidney beans, navy beans, bananas, oranges and orange juice, spinach, peaches, cantaloupe and broccoli. Potassium lowers blood pressure.

Exercise for 30 minutes every day. Get your doctor's approval first, and start out modestly. Brisk walking is fine.

For resistant high blood pressure, your doctor has to look for the less-common causes of it. Sleep apnea (loud snoring with pauses when there is no breathing), adrenal gland tumors, Cushing's syndrome, narrowed kidney arteries and rare tumors such as pheochromocytoma are cases in point.

Go over your medicines. Some medicines raise pressure.

DEAR DR. DONOHUE: When I walk upstairs, my knees make noises. They sound like bowls of Rice Krispies, snapping, crackling and popping. My wife thinks this has to be a sign of serious trouble. I have no pain. My knees are not stiff. I play 18 holes of golf three times a week. Should I make a big deal of this? — R.K.

If your knees are not bothering you, then knee noises usually do not indicate any serious problems. Tendons gliding over bones make snapping noises. So do bursting air bubbles in joint fluid.


No, you don't need to make a big deal of this.
