Homes take shape with sweat equity

HORIZON CITY — A group of people were busy pouring concrete for a sidewalk along Darrington.

A few streets over, a wooden framework for a house rises above a concrete slab foundation. It supports a roof on which a group of workers is cutting and then nails sections of wooden sheeting in place.

At a third location, a husband and wife proudly show off their new home. They and others had labored for nine months and gave "birth" to this and other new homes in the neighborhood.

It was the Saturday before the 4th of July, Independence Day. It carries particular relevance for them because they were working hard to achieve a measure of independence

from burdening house payments.

They not only shared common cause, but also shared a common root—the Lower Valley Housing Corporation (LVHC), a catalyst for positive change in the lives of people.

One of the on-site catalysts in the Horizon City area is Eric Hanson, an experienced builder who, for 15 years, has guided hundreds of eager families step by step through the entire process of building their own home and making their own dreams a hard-earned, sweat-stained reality. On average, groups of families take eight to nine months to build their own home.

In doing so, they cut the cost of a \$92,000 home down to a more manageable \$59,999.

Hanson's mother is Nancy Hanson, executive director for the Fabens-based corporation that has administered a mutual, self-help housing program since 1986.

"It's gratifying to know that you've touched

their lives — that you've made a difference," the son says. "It's very rewarding."

What he finds particularly rewarding are those people whom he has helped in the past. They will recognize him in a store and come up to him and say "Hi, how are you doing?"

"That's very, very special," he says with a smile.

On this Saturday, however, his words become action as he climbs nimbly onto a roof of a house on Cora Ruecker to check on the progress of work of several men who are cutting and laying sheeting. He had indicated there was a problem. Soon he was busy cutting with a circular saw.

This was on the job/roof training, a learning experience, that enables people to build the house themselves. On future days they will add to this body of building knowledge as

Meningococcal vaccine required for college students

Texas college students have new protection against a potential killer.

A new Texas law may protect college students from a deadly disease that strikes young adults living in close quarters like dormitories. The physicians of the Texas Medical Association (TMA) are reminding college-age students they are required to get vaccinated against meningococcal disease before heading off to college this fall.

Jamie Schanbaum knows how bad meningococcal disease can be. She contracted it in 2008 while attending The University of

Texas at Austin. She survived the disease and returned to her studies, but lost her legs and most of her fingers because of it. Named after her, the new "Jamie Schanbaum Act" requires new or transfer students entering college to get a meningococcal vaccine if they plan to live on campus.

"Meningococcal comes on quickly, with symptoms much like the flu, and can be fatal within 24 hours," says Donald Murphey, MD, a Fort Worth infectious disease specialist and advocate for TMA's Be Wise — ImmunizeSM vaccine program.

Meningococcal disease is a bacterial infection that spreads through coughing and sneezing, sharing drinks or utensils, and kissing or other person-to-person contact.

Meningococcal disease acts so quickly that about 11 percent of sufferers die from it, often within hours of the onset of symptoms — even if they have begun to receive treatment. As many as 15 college students die each year from it. Each year, some 1,500 cases of meningococcal disease are diagnosed in the United States. In Texas, more than 50 cases of meningococcal disease were diagnosed in 2009.

The disease also can be devastating to its survivors.

"Otherwise healthy students can end up in a hospital intensive care unit with severe blood stream infection and meningitis

Camp Lejeune benefit claims

It's not being widely advertised, but one by one, veterans are having their benefits claims approved for illnesses caused by decades of contaminated drinking water at Camp Lejeune, the big Marine Corps base in North Carolina. The Department of Veterans Affairs dragged its collective feet for years, denying there was a correlation, but more and more information has surfaced. It's not official, as research is still ongoing, but it's now being presumed in a few cases that illnesses were caused by the contaminated water. And the VA is paying — one at a time, on a case-by-case basis.

Here's a partial list of illnesses caused by the drinking water at Camp Lejeune: kidney cancer, non-Hodgkins lymphoma, bladder cancer, liver cancer, cervical cancer, prostate cancer, breast cancer, ovarian cancer, cervical cancer, lung cancer, leukemia, liver disease, miscarriages, birth defects (cleft palate, heart defects, Choanal atresia, neural tube defects) or low birth weight.

Claiming your benefits will take some work. If you're ill and

suspect it was from drinking the water at Camp Lejeune between 1957 and 1987, ask your doctor if it could be from exposure to these chemicals, found in the Camp Lejeune water:

- PCE (Tetrachloroethylene);
- TCE (Trichloroethylene);
- DCE (Dichloroethylene);
- Vinyl Chloride; and
- BTEX (Benzene, Toluene, Ethylbenzene and Xylene).

Ask your doctor to write a letter, and file your claim with the letter and your medical file attached. If you've filed before, file again.

Private insurance coverage is best workplace protection

Hola mi gente, I would assume that just about everyone is familiar with Workers Compensation. This benefit is provided to employees for injuries sustained in the work place.

Very few in Texas know that some form of protection for employees is required in order to employ workers. Most would assume that participating in the state program under the Texas Division of Worker's Compensation (DWC) is mandatory. That assumption would be wrong.

Employers actually have three distinct choices when dealing with the protection of employees. The first is participating in the DWC. By going this route, an employer is protected from lawsuits that may be considered by employees. The downside to DWC is the involvement of state bureaucracy in the process which at times can be cumbersome for both the employer and employee.

Another option that an employer can consider is to basically self insure the business. By this I mean an employer will put the business on the line for paying any treatment and rehabilitation costs in the event

an on the job injury occurs. While many businesses may be able to absorb the less serious injury claims, the business owner puts his or her business in jeopardy should there be a more serious claim. This would be the least preferable in the sense that major injuries would not be remedied if the business goes under during the treatment period.

The third option is for employers to pay premiums to an insurance company to provide medical coverage for any employees injured during work. This would be, in my opinion, the most preferred way to cover employees for a variety of reasons.

Workplace safety is the best way to avoid injuries. Because there is no protection for the employer from litigation in court for the injuries, there is a very high incentive to be proactive and prevent, to the extent possible, injuries from happening. By paying premiums to an insurance company, the employer actually gets a partner working toward the prevention of workplace injuries. The insurance company has a great incentive to keep the coverage profitable

by assisting the employer avoid worker injuries.

It has been my experience that injured employees have the most problems with the DWC. In no way do I suggest that the great state employees at the agency do not do their job well. They, as is the case with all state employees, are straddled by the laws that are passed by the legislature. In this case, the main purpose of the state program is to protect employers from being sued. The treatment of injuries is locked into a process defined by agency rules. Eventually, an employee faces the end of benefits even if there are still questions about the effectiveness of treatment and rehabilitation.

I cannot remember a phone call to my office where an injured employee received inadequate benefits from protection provided by a worker's compensation policy underwritten by an insurance company. This is perhaps one of the best examples how the private sector can do some things much better than a state agency.

in a matter of hours," says Dr. Murphey. "I've seen patients lose fingers, toes, arms, and legs with this infection in the bloodstream. Some patients suffering from meningitis are left with difficult lifetime disabilities."

Many who recover from meningococcal disease endure significant physical effects such as blindness, deafness, amputations, or brain or kidney damage.

College students are more at risk of the disease because of the close living quarters they share in college dormitories. One in seven of these students will die, according to the National Meningitis Association. The only other patient group at highest risk of contracting meningococcal disease is preschool children, doctors warn.

Yet meningococcal disease is preventable through vaccination. Doctors believe that as many as four out of five of the adolescents and young adults who contract the infection could have avoided it, had they been vaccinated. The meningococcal vaccine protects against four of the five common strains of the disease.

The new law requires college students to get the meningococcal vaccination at least 10 days before moving onto campus. And sooner is always better than later, doctors urge. "Building immunity takes some time, so it's better to get vaccinated now," explains Dr. Murphey. The new law, passed in 2009, took effect Jan. 1, 2010. This is the first year the meningococcal vaccination is required.



Business Tax Credit proposed for second chance at education

EL PASO – Gov. Rick Perry has proposed an initiative that will provide a business tax credit that in turn will help working Texans who never finished high school return to school to earn a diploma or GED.



“A single dropout is one dropout too many, so we must continue pursuing sensible education options that give every Texan a shot at a better life,” Gov. Perry said. “With the help of the 82nd Legislature, we can continue this collaborative approach to improving education and keep removing the barriers that stand in the way of dropouts completing their education and taking their rightful place in our workforce.”

The proposal, which requires legislative action, would provide a tax incentive to employers who grant their employees two hours a week of paid time off to return to school or study for their GED. Once the employees have received their diploma or GED, the employer is then eligible to receive \$1,500 per student in credit toward sales tax liability.

Over the next biennium, the proposal would grant an estimated \$15 million in sales tax credits, based on an estimated 5,000 dropouts a year taking advantage of the program. The program would be restricted to high school dropouts age 18 and over who are legal residents of the state. All employers who pay sales taxes or directly remit sales taxes to the state, and are in good standing, will be eligible to participate.

Ensuring that Texas remains a leader in job creation depends on the development of our workforce and is imperative to Texas’ future prosperity. Gov. Perry has previously outlined several education initiatives for the 2011 legislative session, including:

- A \$160 million expansion of the Science, Technology, Engineering and Math (STEM) program, increasing the number and scope of T-STEM Academies and funding STEM scholarships to help ensure students receive a competitive education in these subjects.
- Expansion of the Virtual School Network (VSN) to improve access to high-quality courses for students who have dropped out of traditional high schools. The VSN was created during the 2007 Legislative Session to establish a statewide network of online courses available to students across the state. These virtual courses give students access to classes their schools may not offer, additional access to dual credit opportunities, and additional flexibility to help keep students in school.
- Generation Adelante/Generación Forward, which encourages Texas high school graduates to pursue higher education by providing them with information about college applications, financial aid and college visits. These college fairs also give students the opportunity to speak with representatives from more than 30 colleges, universities and technical colleges from across the state.
- Requiring high school students to be enrolled in school or working toward a GED to be eligible to for a Texas driver license.

a family assault in progress. have since been filed against him. Leanos criminal history shows various arrests for Indecent Exposure, Public Lewdness and Probation Violation. He is believed to remain in the Borderland hiding with friends or relatives. Sheriff’s officials are asking the public for any information on the whereabouts of Leanos. Callers will remain anonymous and may be eligible for a reward if the information provided leads to the apprehension of the individuals featured.

they learn how to build walls, lay floors and hang doors.

Al Rozales is one of men working on the roof. He takes a break and explains why he is doing this. He is not a young man. He and his wife have their own home, but he explains that he is helping his daughter by helping to build a home for her. "Providing for her future," as he puts it.

"It's a real good program," he says. "People are dumb if they don't take advantage of it.

"I've never had any doubts about doing this; this gentleman helps you," nodding toward Hanson. He

points out that, while the homes are inexpensive, they are not cheaply made. He indicates that the materials and building practices are first-class and most likely, for instance, use more nails in construction than most builders do.

Another person who had no doubts is Eddie Vasquez and his wife Maria. They live at 716 Weiermann. They are living the dream they helped create not only for themselves but for the other seven families that comprised their work group.

After nine months work, they moved into their new home last January.

"No doubts — no leaks," he says proudly. "The motivation was learning; I liked to learn."

"Having a home is a dream. Now

it is a dream come true."

From bedrooms to baths to the garage and kitchen Maria takes you on a quick tour of the solid, 1,100 square-foot home. It has three bedrooms and one and a half baths.

The soft-spoken Maria says her motivation was working on her own house. "I liked doing it very much."

While out in the backyard, he exchanges banter with his next door neighbor, who labored alongside Vasquez to build his home.

The camaraderie that existed while building the homes remains. Vasquez says they and other member get together socially from time to time.

Sitting close to his wife on the sofa, he adds simply, "I'm very grateful to have a home."

Town of Anthony receives \$234,859

ANTHONY — The Texas Department of Rural Affairs (TDRA) presented the City of Anthony with an oversized, ceremonial check to recognize the community for its hard work in securing two grants from the agency. A grant of \$159,559 comes from the Texas Community Development Block Grant (TxCDBG) program; a second grant for \$75,300 comes from the TxCDBG portion of the American Recovery and Reinvestment Act. Agency staff presented the checks on June 7, 2010 in Van Horn, Texas.

“We are very pleased to present these ceremonial checks to the community,” said Charles S. (Charlie) Stone, executive director of TDRA. “Community development grants such as this help Texans in rural communities improve their quality of life significantly.”

The Town of Anthony will use

the grants to make water system improvements, benefiting the entire city. Improvements include a new pump and motor on water well #2, as well as a sand separator and a new well chlorinator system with a building.

“Texas CDBG is a competitive grant program, so the community is to be commended for their hard work and diligence in pursuing this grant,” said Mark Wyatt, director of TDRA’s community development division.

The grant comes from the Texas Community Development Block Grant program, the largest CDBG program in the nation. Rural cities with populations less than 50,000 and counties that have a non-metropolitan population under 200,000 and are not eligible for direct funding from HUD may apply for the agency’s TxCDBG program. This program serves approximately 1,017 eligible rural communities, 245 rural counties, and provides services to over 375,000 low- to moderate-income beneficiaries each year.



Your good health By Paul G. Donahue, M.D.

DEAR DR. DONOHUE: I would like to call your attention to a question you answered about emphysema. I think you should have mentioned alpha-1 antitrypsin deficiency. It would have been a good opportunity to bring this condition to the public's attention. I have it and was diagnosed at age 53, after having been misdiagnosed for eight years. I have been on Prolastin, which has stabilized my lung capacity. While more doctors are aware of this condition, there are some who are not. — D.C.

Intravenous infusions of the missing enzymes can benefit those with the deficiency. Your Prolastin is one such product. The booklet on emphysema and chronic bronchitis, the two chronic obstructive pulmonary diseases, discusses the more-common variety in detail. Lungs come equipped with their own janitorial crew. They inhale lots of foreign debris, and they create trash in their work of transferring oxygen into the blood and carbon dioxide out of it. The cleanup crew is trypsin, an enzyme. Trypsin, however, can go overboard, so another enzyme, called alpha-1 antitrypsin, stops it from overdoing the trash collection and destroying air sacs in the process. Emphysema is destruction of those delicate structures. Cigarette smoking is the No. 1 cause of emphysema, also known as one of the chronic obstructive pulmonary diseases, COPD.

DEAR DR. DONOHUE: I am inquiring about sebaceous cysts. During the past 20 years, I have had between eight and 10 of them on my back. They were removed surgically. My former family doctor, now retired, said there may be some prescription pills that can stop them from returning. I would like some insight from you. — W.M.

Symptoms of emphysema, regardless of cause, include shortness of breath with little physical exertion, cough and increased sputum production.

Sebaceous cysts are also known as epidermal cysts. Often found on the back, they're firm, round lumps that grow slowly. They can be pushed a little from side to side. Their cause is unknown.

The delay in your diagnosis of alpha-1 antitrypsin deficiency is par for the course. On average, the diagnosis takes eight years from the time a person first visits a doctor for emphysema symptoms. This illness should come to mind when a relatively young person or a person who has never smoked develops emphysema. A simple blood test for the level of the antitrypsin enzyme can secure the diagnosis.

If they're inflamed or painful, they can be cut out without a lot of trouble, usually in the doctor's office. The cyst wall must be taken too, or the cyst will return. Simply draining one of the pasty, greasy material contained inside doesn't end the problem.

Treatment is the same as treatment for smoking-caused emphysema. However, there is an additional treatment for alpha-1 antitrypsin deficiency emphysema.

Everyone would love to know of a pill that prevents or gets rid of them. I don't know of one, and I don't believe there is one.

Sowing seeds for retirement

If you're a farm worker, it's likely that you're busy right now. The spring planting season has ended, but the farm work has only begun. As you cultivate a bountiful harvest, we at Social Security want to remind all farmers to help cultivate future retirement and disability protection for any farm workers hired.

Most farm workers are covered by Social Security, but only if the employer reports the wages — which is

a legal obligation. By reporting farm workers' wages and paying Social Security taxes, you can help ensure they earn valuable Social Security retirement, disability, and survivors protection.

Farm owners also need to be aware that if they don't report wages and pay the taxes due, they are breaking the law and could be subject to an IRS penalty.

Some farmers try to rationalize

that farm workers can be considered independent contractors, in which case the worker must pay self-employment tax and the employer has no tax obligation. But if people are working under a farm owner's direction and control, they cannot be considered independent contractors. They are employees and their wages must be reported to Social Security. Some farmers hire "crew leaders" to manage their farm workers and to handle their wage-reporting responsibilities. In these cases, the crew leader is often considered the "employer" of the farm worker and has the responsibility for submitting wage reports.

If you run a farm and hire agricultural workers, this booklet is a must-read. But the most important thing to remember is what you probably know better than anyone else: folks reap only what they sow. Farm workers won't be able to reap the Social Security benefits they are due unless their work and wages are reported to us.




