### Crime Stoppers

Crime Stoppers of El Paso is assisting the El Paso Police Department in locating the vehicle involved in a fatal hit and run, and its driver, making this the "Crime of the Week." On Monday night, May 5, 2008, just before 9:00 a.m., Police officers responded to a hit and run collision at 10100 Cross Street in northeast El Paso. Unfortunately, it was a fatal hit and run. The preliminary investigation by officers from the Special Traffic Investigation unit revealed that 72-year-old Flavia Estrello was pushing her granddaughter, 2-year-old Aliana Gonzalez, in a stroller when they attempted to cross the street. A vehicle headed north on Cross struck both pedestrians, killing Estrello and seriously injuring the child. The vehicle then fled the scene, making a left turn from Cross onto Sun Valley Drive. Witnesses describe the suspect vehicle as dark colored and possibly a late model Ford Mustang. This vehicle would have shown damage to the windshield and to the right side of the front hood. ## West Valley Fire Department receives 911 grant

VINTON — Fire, medical, and law enforcement communications system in the Upper Valley will get a much needed boost thanks to the efforts of West Valley Fire Department (WVFD) Chief Bill Adler.

Chief Adler received notification recently that the El Paso County 911 District has awarded WVFD a \$29,530 grant for a transmitter antenna to enhance pager reception for fire, medical, and law enforcement personnel who serve Anthony, Vinton, Canutillo, Westway, and El Paso's Westside.

The new antenna equipment will be placed on an existing tower located on the WVFD premises in the Town of Vinton. The project should be completed by mid August,

according to Adler.

"All of our WVFD personnel use pagers to receive emergency calls, and we often have a weak signal in some of the Upper Valley areas because the antenna tower we are currently using is situated atop of the southern-end of the Franklin Mountains," said Adler. "The new antenna will improve response time from all emergency units in the area," he added.

Adler said that because all WVFD firefighters and emergency medical technicians (EMTs) are volunteers, they depend heavily on the pager transmitter system when their services are needed. The WVFD currently has 55 volunteers and 17 mobile units on-call. In 2009 they responded to 1,460 calls, he said.

"In fact, all of the fire departments in El Paso County proper including Clint, Fabens, Horizon, Montana Vista, San Elizario, and Socorro are staffed 100 per cent by volunteers,"

stated Adler, who has been a WVFD volunteer since 1996 and became chief in 2000.

The chief said that six WVFD members, including himself, are active firefighters for the El Paso Fire Department; the rest of his staff have varied backgrounds. "They range from tow truck drivers, locksmiths, engineers, project managers, detention officers, automotive technicians, security guards, welders, fire protection engineers to countless other occupations. When you get all of these individuals together, the possibilities are endless," Adler stated.

Besides responding to emergency calls, WVFD volunteers provide many forms of help to their communities, such as fire prevention and fire safety education to local schools, building plan reviews, inspections, community services, and rescues from almost anything or anywhere.

To become a firefighter or EMT volunteer, recruits must undergo an application process, a six month probationary training period, and must attend weekly training sessions to maintain their membership.

Roger Esparza, a WVFD volunteer for 18 years, said, "I am a volunteer firefighter because there is always a different scenario every time I respond to an emergency call; it is a real thrill, and I get to help my community." Esparza was appointed the first Fire Inspector for the El Paso County Emergency Services District #2 about two years.

WVFD, which is funded by the El Paso County Emergency Services District #2, operates on approximately a \$600,000 annual budget, said the chief.

"I am very proud to be associated with all of the fine folks that comprise the West Valley Fire Department. And, I encourage interested individuals to join their local volunteer fire department. It is a very rewarding experience," Adler said.

## San Elizario ISD boosts teacher salaries

Teachers beginning their careers at San Elizario ISD stand to receive a desirable starting salary package for the 2010-2011 school year. The base salary for first year teachers will now be \$42,126 up from \$41,000 last year. Additionally, all new and returning classroom teachers will receive a \$2,500 retention incentive, increased from \$2,000 in 2009-2010. Newly hired teachers will earn up to \$44,626 during their first year with San Elizario ISD. The district's Board of Trustees recently approved this modest increase to the teacher compensation scale in order to recruit and retain the best,

qualified classroom teachers.

The district's salary review committee worked diligently for several months to identify needed pay adjustments prior to presenting recommended changes for trustees to consider.

"The committee compared our salaries with those of the neighboring districts, and found that San Elizario currently offers very competitive salaries in most areas," said Connie Prieto, Interim Director of Human Resources.

Overall, the school board approved the following district-wide salary increases to be implemented in 2010-2011:

- A two percent increase to the teacher

## Veterans Post By Freddy Groves

### Bronze medallions for Veterans graves

When a veteran is buried in a national or state veterans cemetery, the grave has a government-issued marble or granite headstone or a marker. But the graves of veterans who are buried in private cemeteries without the government headstone often don't indicate that the deceased was a veteran. This easily can be rectified now. The Department of Veterans Affairs has bronze medallions that can be affixed to privately purchased headstones or markers of those veterans.

Eligibility is for veterans who died on or after Nov. 1, 1990, are buried in a private cemetery and who did not receive a government-issued headstone or marker.

The bronze medallions come in three sizes: 5 inches, 3 inches and 1-1/2 inches in width and include a kit (hardware, adhesive) used to attach the medallion to an existing headstone or grave marker. It is also suitable for a mausoleum or columbarium niche cover. Each includes the word VETERAN and the branch of service.

There's no specific application yet (one is being created),

so for now use VA Form 40-1330 Application for Standard Government Headstone or Marker. (Leave block 11 blank. Use block 27 to describe the medallion being requested, for example "Medallion 3 inch").

Only next of kin can apply, but the next of kin list goes by lineage: surviving spouse, children by age, parents (biological, adoptive, step, foster), brothers/sisters (half, step), grandparents, grandchildren, uncles, aunts and others down the family tree. Additionally, a person authorized in writing by the next of kin or a personal representative authorized in writing by the decedent also can order the marker.

## Por la Gente By State Rep. Chente Quintanilla

### Decisions based solely on profit are shortsighted

Hola mi gente. Last week, I shared with you my thoughts about how private worker's compensation insurance seemed to have significantly fewer problems than the state program. In this case, I do believe that the private sector had a better record than the government program.

Does that mean that I wholeheartedly support zero oversight? No. There are many examples that reinforce government regulation of business practices.

In too many instances, when big businesses are charged with regulating themselves, events occur that show it was not such a good idea. Some businesses become their own worst enemy.

British Petroleum (BP) enjoyed many years of lax government intervention and regulation in their pursuit of under sea oil wells. Their desire to maximize profits at the expense of safety, if the employee allegations are true, cost the company and stockholders a good chunk of wealth.

Apparently, after being informed by employees about deficiencies in the well, BP ordered the drilling to continue. Had there been more regulation and had BP been wary of government sanctions, the decision may have been different.

If BP had operated properly, that corporation would now be \$20 billion wealthier at the very least. That amount is the deposit made to the federal government as a minimal guarantee for claims arising from the disaster. In addition to that, stockholders would have a much higher price on their stocks. And the cost is far from over. Just imagine the lawsuits.

Another example is clearly tied to the financial breakdown over the past two years. The economic backbone of our nation was nearly irrevocably broken by the feeding frenzy in the stock market arena. The basis for the frenzy was a form of money marketing based on almost no solid value for the stocks.

My chief of staff told me a story about Walgreens during the time he lived in Chicago. At that time, the Federal Trade Commission regulated business in the 50 states. Walgreens had been sanctioned for retail practices that were found to be deceptive to the public. The sanctions required that Walgreens

take steps to make sure that all advertised sale items be available on the days of the sale.

During the time that the sanctions were in force, a funny thing happened to Walgreens: their sales started to skyrocket. The eventual president of Walgreens commented to my chief of staff that the sanctions greatly benefitted the company. It made the company focus on what was best for its customers. If the government had not changed its practices, Walgreens may not have become the strong company that we know today.

By pointing out these stories, it is not my intention to promote government regulation of business. Sometimes, business becomes its own worst enemy by prioritizing its profits over what is best for the public. When the feeding frenzy goes overboard, the consequences invariably are much worse than if the practices were restrained by some sort of regulation.

I remain your friend and public servant, Chente por la gente.

base pay scale which includes the \$1,300 stimulus incentive;

- A \$500 increase to the federally funded retention incentive for all teachers (from \$2,000 to \$2,500);
- A three percent increase to the support staff pay scales; and

- A two percent increase to the administrative personnel pay scales.



## Toyota rapid acceleration case raises questions of government motives

Did the United States government deliberately use its regulatory enforcement power to damage Toyota, and benefit government owned General Motors?

Reasonable people are asking this question around the world, as the U.S. Department of Transportation's National Highway Traffic Safety Administration's early tests of Toyota's supposedly sticky accelerators have found that driver error was the cause of the problem, not faulty parts.

Just six months ago, the Obama Administration's public relations machine was in full gear deriding Toyota for putting consumers at risk, fining them more than \$16 million, and declaring Toyota guilty for everyone in the world to hear. Lawsuits were filed, Congressional hearings were held, and most importantly Toyotas went unsold, while GM sales increased.

Now, it looks like this sudden acceleration problem was caused by, get this, drivers hitting the accelerator pedal rather than the brake, and Toyota owners not being smart enough to keep their floor mats from underneath the accelerator, causing it to stick in the fully-engaged position.

I guess that the government's next step will be to require a safety yellow sticker on every dashboard that says, "Warning: Pressing down on the accelerator will result on sudden acceleration."

The real issue here is that the very motives of the government are in question in publicly convicting Toyota before any real evidence had been collected.

Was the rush to judgment based upon the Obama Administration's general dislike for every business, or was it based upon the need to jumpstart the sales of General Motors vehicles?

We will never actually know the truth. Government control over functions that

are rightly in the private sector like auto manufacturing leads everyone to wonder whether regulatory justice is truly blind, or are the regulators blinded from justice by the inherent conflict of interest of being competitors in the marketplace?

Imagine if a prosecutor and judge stood to benefit financially from the outcome of a case. That great oxymoron, legal ethics, requires that they not participate in the case in order to allow an indisputably, honest outcome to be achieved.

The foundation of our legal system is found in the Biblical Book of Deuteronomy which states, "Hear the disputes between your brothers and judge fairly, whether the case is between brother Israelites or between one of them and an alien. Do not show partiality in judging; hear both small and great alike."


Beyond the moral implications of ensuring that everyone gets a fair, impartial judgment, the assumption that the U.S. government does not play favorites is foundational to our successful free enterprise system.

In many third world countries it is the norm for "favored" companies to receive government grants and other favored treatment over their private sector competitors. This expectation of an uneven playing field serves as a great disincentive to developing new business ventures that are separate from the government-controlled enterprises with the economy and people suffering as a result.

The very fact that the question could be reasonably asked about the U.S. government's motives in the Toyota sudden acceleration case further undercuts the belief that winners and losers are created in our economy based upon innovation, guts, business acumen, hard work and a willingness to risk everything

to achieve success. Instead, it reinforces the notion of who you know in DC, is more important than what you know in your business.

So long as the U.S. government has a car czar who oversees the activities at General Motors and Chrysler Corporations, every other auto manufacturer will always wonder whether these competitors are being tipped off to new regulations, and if they have any chance of getting a

fair shake through the regulatory process.

Selling the federal government stake in GM and Chrysler is the only way to restore a belief that the many regulatory arms of the government are acting in good faith, rather than capriciously. This should be job one of the new Congress in 2011.



### The Voice and the Boss

Black bat in hand, Reggie Jackson strode from the on-deck circle to thunderous applause. It was the biggest stage — October in the Bronx, the Yankees on the cusp of their first World Series win since the early 1960s. He had swung the bat only twice that game, but both swings had resulted in home runs. The mood in the stadium wasn't electric — it was positively nuclear.

And as he held his hand up and dug into the batter's box, Bob Sheppard's voice came over the Yankee Stadium public-address system.

"Right fielder...Reggie...Jack...son." And that was it. Any other

ballpark, any other game, and the PA announcer all but screams his tonsils out when Jackson steps to the plate in that situation. Not at Yankee Stadium, though... not with Sheppard at the mic. To play favorites or play to the crowd was beneath him and undignified. To him, Yankee Stadium was baseball's temple; to players and fans his voice was, as Jackson succinctly put it, "the voice of god."

For many New York sports fans, Sheppard's voice was the only one they had ever known. In a town that changes from minute to minute, he had been a mainstay at Yankee Stadium since 1951. Even after the

brash Cleveland shipbuilder George Steinbrenner bought the Yankees from CBS in 1973, Sheppard was almost overlooked in the deal. He basically came with the place.

Everything else, however, was pretty much tossed out, soup to nuts. And Steinbrenner was pretty much nuts — at least at first.

To be sure, "The Boss" was a great businessman. As a baseball executive, he ushered in the free-agency era and was the first to really understand the stadium makeover business. But as a Yankee owner, he led with his heart, and as such was quick to flame out. In his first 23 seasons he fired 20 managers. He would woo free agents like a star-crossed lover only to berate them when the honeymoon was over. Even the hot-dog concession contracts were cause for controversy.

In the end, Steinbrenner finally "got religion." Mellowed by age, he sat patiently in his box seat and watched the Yankees form a late-century dynasty. And when the Yankees moved to their new stadium, it was ironic that Sheppard and Steinbrenner didn't make it to the new park. Oddly, it seemed fitting that the two would leave us at the All-Star break.

Steinbrenner was famous for commandeering the back pages

whenever the Yankee's weren't supposed to be front and center, and his sense of timing didn't leave him, even in death.

Fittingly, Sheppard went first. After all, who better to announce Steinbrenner's heavenly arrival than the "voice of god" himself?

## Your good health By Paul G. Donahue, M.D.

**DEAR DR. DONOHUE:** I, like the letter-writer P.G., had to run to the bathroom constantly in order not to have an accident. I wanted to see my grandson graduate from college, so I consulted a urologist. He sent me to a place where treatments with an electrical probe were given. I went for six weeks and also did Kegel exercises. The quality of my life changed for the better, and now I square dance and do aerobics. Incontinence is no longer a problem. — E.M.

fast or if the episode lasts for a prolonged period, then treatment would be needed.

No one can be sure unless the rhythm comes on when a doctor is present or when you are hooked up to an EKG machine. That monitor you wore for three days can be left on for longer stretches of time. Or you could have someone take you to the emergency department of a hospital if you can reach it somewhat quickly. You can't obtain a diagnosis without such information.

Electrical stimulation of the pelvic muscles has successfully allowed many women to regain bladder control. It doesn't work for all, however. The stimulation strengthens muscles that keep the bladder closed, and controls overactive bladder wall muscles that contract forcefully and frequently.

Another technique is a device that delivers electric current to spinal nerves in the lower back. If those nerves respond to the current and keep the bladder closed, then a small unit is implanted under the skin for a permanent solution to this problem. One such device is called the InterStim.

**DEAR DR. DONOHUE:** My wife, 76, has degenerative arthritis of the spine. Can you tell me if this condition will progress to total disability? — J.D.

**DEAR DR. DONOHUE:** I have an EKG done every year. I also have worn a monitor that records heart activity for three days. Everything is fine. When I fall asleep most nights, I wake after about 10 minutes with a rapid heartbeat, and sometimes it takes quite a time before it settles down and I can get back to sleep. I rarely have such a rapid beat at any other time of the day. Do you know what causes this, or what it might be? I am 57. — S.B.

Degenerative arthritis is another name for osteoarthritis, the most common kind of arthritis. Almost every 70-year-old has a touch of it. It can be in the back, knee, hip, hand, fingers and ankle, or any of these locations. The rate of progression is unpredictable. A good many can continue to do most of the activities of life with minimum disruption.

If I had to make a guess, it would be paroxysmal atrial tachycardia, a sudden heart speedup for no reason. It's usually not a serious condition, and it doesn't indicate heart disease. If the rate is really

The last thing you want to do is sit in traffic on your way to the Social Security office, or to wait in line once you get there. From your doorstep to the local office and back again, you could spend a lot of extra time taking care of your Social Security business. Or, you could choose to visit our online office at [www.socialsecurity.gov](http://www.socialsecurity.gov) and complete your Social Security business in a matter of minutes with no commute whatsoever.

There are so many things you can do at our online office. For example, you can apply online for retirement benefits. Our website makes it simple, allowing you to apply for retirement benefits in as little as 15 minutes. In most cases, once you fill out the application, you're done. There are no forms to sign and no documents to submit. The direct link to applying for benefits online is [www.socialsecurity.gov/applyonline](http://www.socialsecurity.gov/applyonline).

Not ready to retire yet, or not sure? We have online resources that can help you plan ahead or make your decision. Our Retirement Estimator will allow you to enter different scenarios to come up with the retirement plan best for you. You can find it at [www.socialsecurity.gov/estimator](http://www.socialsecurity.gov/estimator).

Perhaps you need to file an application for disability benefits. A Disability Starter Kit explains the documentation and information

You can apply online for Medicare, if you're within four months of your 65th birthday. 

Magalde

Deputies were called to a residence in San Elizario in reference to a family violence incident that had just occurred at the San Elizario Mission grounds. Deputies met with a female victim who advised Deputies that her husband, Magalde, had violated an active Protective Order. She said that about an hour earlier she was attending the festival at the San Elizario Mission when she was approached by Magalde who began to argue with her. She said when she tried to walk away, Magalde proceeded to repeatedly punch her in the face with a closed fist. When she attempted to call 911 from her cell phone, he took it away from her. Magalde then took her truck keys and forced her into her dark blue 2001 Dodge Durango against her will and drove to a

residence in San Elizario. During that time he continued assaulting her, even biting her on her right arm. Magalde then took her wallet from her purse and drove off in her truck. Charges for all offenses mentioned have since been filed (Violation of Protective Order, Interfere with Emergency Call, Assault Causes Bodily Injury/Family Violence, Aggravated Kidnapping, Robbery, and Unauthorized Use of Motor Vehicle). Deputies searched the area for the stolen Durango, bearing Texas License Plate BP1-H517, but were unable to locate it. Magalde is a confirmed Barrio Azteca Gang member whose criminal history shows various arrests for Assault (Family violence), Probation Violation, Parole Violation, Violation of Protective Order, Possession of Marijuana, Burglary of Habitation and DWI. He is believed to remain in the Borderland hiding with friends or relatives. Sheriff's officials are asking the public for any information on the whereabouts of Magalde. People can contact the Sheriff's Office at 546-2280 or Crime Stoppers of El Paso at 566-TIPS (8477). Callers will remain anonymous and may be eligible for a reward if the information provided leads to the apprehension of the individuals featured.

## STRANGE BUT TRUE

- It was British mathematician, historian and philosopher Bertrand Russell who made the following sage observation: "If there were in the world today any large number of people who desired their own happiness more than they desired the unhappiness of others, we could have paradise in a few years."


