A low cost vaccination/microchip clinic for pets of low- and fixed-income families will be held on Saturday, Sept. 18, 2010 from 9 a.m. to noon at Las Palmas Market Center, 1331 George Dieter in the parking area between Lowes and Petland. Pets will be vaccinated for parvo/distemper, rabies, microchipped (with national registration) and be licensed for \$40. Owners should bring proof of low-income eligibility (Medicare, WIC cards, Texas Lone Star cards, proof of residence at HUD residential complexes, etc.) as the event is intended for low-income residents. Flu shots

This flu season, El Paso will be more prepared than ever to deal with a potential influenza pandemic. Immunize El Paso has received nearly all of their flu vaccine shipments, which translates to less potential for shortages or delays in vaccination. It is very important to get your flu vaccine this year, just as any year. Vaccine manufacturers have included two strains of the "seasonal" flu as well as the H1N1 strain in this year's vaccine. Additionally, Immunize El Paso opened the doors to their brand new eastside immunization clinic located at 1580 George Dieter at Vista Del Sol on Monday. The new clinic will serve children and adults seeking routine vaccinations as well as the flu shot Monday through Friday and will also feature Saturday clinics. New this year, Immunize El Paso will be partnering with the Texas Vaccines for Children Program to assist in helping increasing influenza immunization coverage amongst children across El Paso. Doing so will allow children who are un/underinsured or those who cannot afford their co-pays to receive a flu shot at a discounted rate of \$10. For

Espinosa receives Honor Medal

EL PASO COUNTY — "It does not matter that I will forever set off airport security.

"It does not matter that I cannot dance at my daughter's wedding.

"It matters that I am alive.

"It matters that Fernando Espinosa pushed me out of the direct hit by a moving vehicle.

"It matters that I will be around to rock my granddaughter to sleep and sing lullabies to her."

This is part of the narrative of Glenda Tanner, a journalism teacher at Franklin High School, who is undoubtedly alive today because of the quick thinking of Espinosa, a Boy Scout, who pushed her out of the way of a speeding car as he was escorting her across the street to her car late on the night of Jan. 22, 2010.

The car struck her left foot which was broken in three places. She now has metal plates in her leg. Fernie bore the major impact from the speeding car. His body hurtled over the hood of the car, and his head slammed into the windshield. He was then thrown to the ground.

He recalls, "I remember that as soon as I hit the ground, I quickly got up. I got up because I heard Mrs. Tanner calling my name and because I wanted to check on her."

Lying on the ground, the injured teacher recalls, "His face, bloody and broken, was the most beautiful face I could see at that time."

"Fernie has not fully recovered from the accident," says Sam Snoddy, scoutmaster of Troop 4 in which Fernie is a Life Scout. "He has a persistent blood clot in his left leg and is still taking Coumadin which has limited his activities in and out of Scouting."

At a Centennial Scouting dinner last Friday night, more than 200 Scout leaders and youth gathered for the ceremony in which Espinosa received one of the highest awards of the Boy Scouts of America, the Honor Medal with Crossed Palm for his selfless act of bravery.

Espinosa was only the 232nd recipient of the Honor Medal which was first presented

in 1938. The coveted award is given only in "exceptional cases to a youth member or adult leader who has demonstrated unusual heroism and extraordinary skill or resourcefulness in saving or attempting to save life at extreme risk to self."

Sponsored by Yucca Council, Boy Scouts of America, the dinner and awards presentation was held in the administrative building of El Paso Community College, 9050 Viscount.

In his presentation, Snoddy spoke of the

real meaning of what his young Boy Scout had done.

As he begins his own tribute, Snoddy quotes from the Holy Bible, the Gospel of John 15:13 — "Greater love has no one than this, that he lay down his life for his friends."

"Life is the most valuable object we possess. And when a young man such as you is willing to lay down that down for friends or his country, it shows the utmost extent of love.

"Even this love for friends has been rarely witnessed. Many people would have frozen or hesitated.

"Not Fernie.

"Deep within the recesses of his inner being, Fernie made that instantaneous decision to save Mrs. Tanner rather than himself.

"You either have it or you don't. Fortunately for Mrs. Tanner, he had it."

Snoddy goes on.

"Fernie, you are a credit to your parents, Scouting, the United States of America and yourself. You are a role model for all Boy Scouts."

Tanner adds a final tribute to Fernie and sees him as more than just a role model.

"Yes, Fernie is a Boy Scout. And if this doesn't earn him an Eagle Scout honor, I don't know what will. Because I do know this, he already has his wings.

"He is my hero."

The hero and Mrs. Tanner hugged.



Four school districts to hold elections

EL PASO COUNTY — Voters in four of the nine El Paso County school districts will have several board of trustees candidates to choose from when they go to the polls in the upcoming general election.

School districts — Canutillo, Clint, Fabens and Tornillo — will hold their next board of trustees election in November.

Early voting will begin Monday, October 18 and end Friday, October 29. School board election voters may cast their ballot at any of the early voting polling places throughout El Paso County.

Election Day is Tuesday, November 2. The polling places will be open from 7 a.m. to 7 p.m. on Election Day. Registered voters must vote in their precinct on Election Day.

Canutillo ISD

Seven candidates have signed up to run for three at large positions for a period of

four years on the Canutillo Independent School District Board of Trustees. The three positions up for election are currently held by Sergio Coronado, Shonda Jordan, and Yvonne Sanchez.

Candidates who have applied to run for the Canutillo ISD School Board are: Margarito Arellano, businessman, who served on the board previously for 15 years; Coronado, attorney, who has served on the board for eight years; Jordan, housewife, who has served on the board for four years; Patricia Mendoza, retired Canutillo ISD employee; Eduardo Orozco, UTEP student; Laure Searls, housewife, who has previously served on the school board for nine years; and Sanchez, administrator, who has served on the board for 13 years.

On Election Day (November 2), the five polling place locations for the Canutillo ISD school board election include the Vinton Fire Station, 510 E. Vinton Rd. for Precinct 2 residents; Canutillo Middle School,

Finding a job

Are you home now and separated from the service? Welcome back. Chances are you need a job. Here are some ideas to get you started:

- Post your resume, search for jobs and read job-search tips at VetJobs [www.vetjobs.com]. Also listed are veterans service organizations, broken down by branch of service – Association of the United States Army, Heli-Vets, Air Force Sergeants Association, Naval Intelligence Professionals, they're all there, and dozens more. Affiliation with one or more groups might help you in your job search. The VetJobs also includes a Career Advisor assessment. Normally \$250, the assessment is free on the VetJobs site.

- If you're leery of putting your information online in the JobVets assessment, consider career advice and information from the Department of Labor. The Transition Assistance Program is set up to help with transition within the first 180 days of separation or retirement. The program is part of Veterans' Employment &

Training Service at www.dol.gov/vets. Click Transition Services in the left column. Then scroll down to the fact sheet to see all it can do for you. Make note of the three-day workshops for help with writing a resume, interviewing and more.

- Remember this phrase: Veterans Preference. That can be the key that opens a door for you when it comes to getting a government job. Points are assigned to each federal job application with extra points to each qualifying veteran. The number of points depends on your particular situation. That's not to say you're guaranteed a job, but you will be given extra consideration. Sometimes that's all you need, right? Check the Veterans' Preference Advisor to determine your eligibility.

Students, education need level field

Hola mi gente. I recently read a commentary by a former colleague who wrote about education in The Texas Tribune. For those of you who are not familiar with the Tribune, it is an online only news publication. It began about a year ago and was hailed as the natural morph for print publications.

The colleague who authored the guest editorial was Kent Grusendorf. He was appointed by Speaker Craddick to chair the House Committee on Public Education and chaired from 2003 to 2006.

Grusendorf's article dealt with the lack of creativity in the education system today. His point is that there are so many rules and laws that

educators at the very local level are merely robots in the education world. He acknowledges that every one of those rules and laws were implemented for good reason. He was not clear as to why they do so, but it is his contention that now they are an impediment to creative education.

In my opinion, many of the laws were put into place because there was a shortfall by the state in achieving the constitutionally mandated effective public education. Until very recently, lawmakers actually worked to make public education beneficial for all Texas students.

I cannot recall a time that Grusendorf voiced any public

opposition to the federally mandated No Child Left Behind (NCLB) law passed by then President Bush. If anything on the books stifled creativity, the NCLB did so by changing education into a process of teaching a test. The program was intended to hold educators and administrators accountable for achieving certain standards.

This year test results for NCLB had a very mixed message. The state results from TAKS showed just about every school district improving significantly. The federal results were much less encouraging. One problem with the state standards

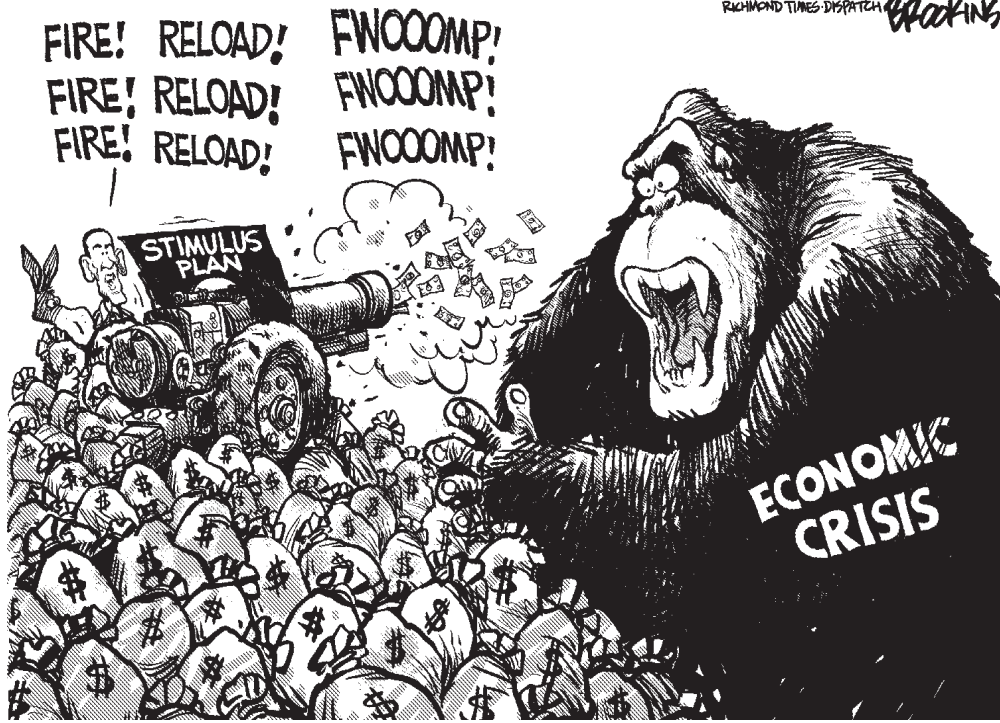

is that the Texas Education Agency (TEA) has no static baseline for measuring performance. This last year, the passing score was actually lowered so more students passed. Does that make sense?

I was not one to agree with Grusendorf on many education issues. One that I did somewhat agree with him was a voucher system. This system theoretically would allow families to choose schools that had better achievement levels. I would go along with the system if the same system provided transportation. No supporters of the voucher system would even consider that.

Why transportation? Without that, rural students, inner city barrio students and colonia students would have no choice. Only wealthier families with the capacity to transport their children would benefit from vouchers.

In the article, he never mentions equitable funding from the state for all school districts. The mantra by conservatives to have local control also means withholding shared wealth. Innovation in schools is no good if the actual standard does not apply to all students. Based on a consistent effort to diminish the Robin Hood funding of education, it seems like Grusendorf and his allies think equal innovations will result from unequal facilities.

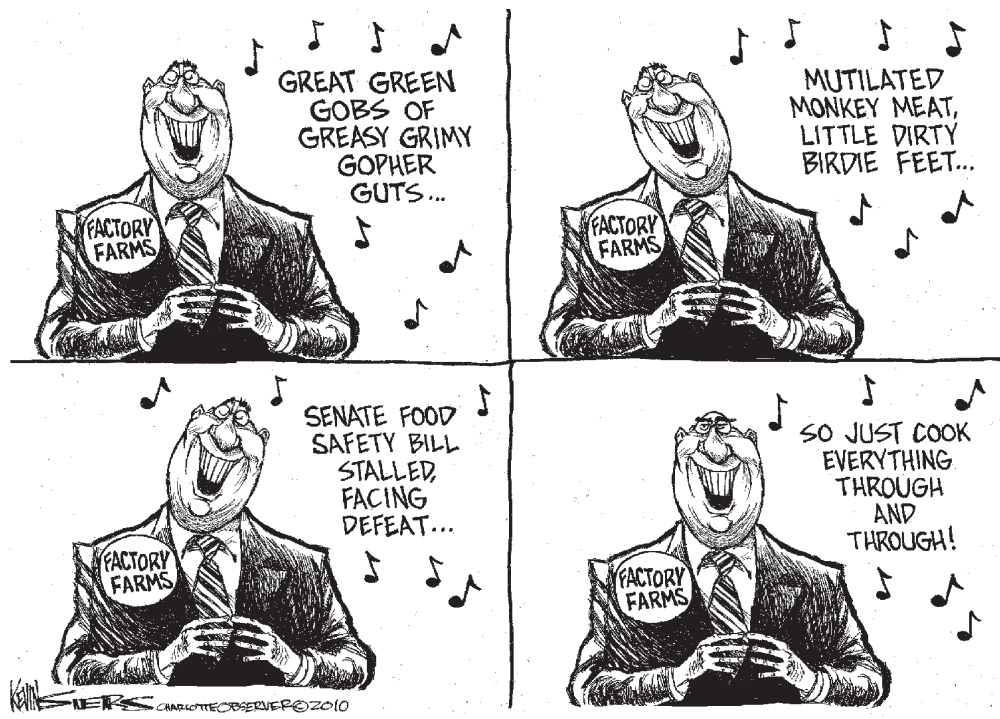

SECTION 504 SERVICES

The Fabens Independent School District provides the following educational services/options to identified disabled students who reside within the district.

 - ✓ assistance in reading for students with dyslexia in a reading program which meets the state's standards for a dyslexia reading program.
- ◆ Special education services are available to Section 504 students, if the students qualify for one of the specific disabilities under special education.

Defensive problems still plague Miners

I've got a rather fundamental football question, how difficult is it to play defense?

I'm sure that there are thousands of UTEP fans asking the same question today.

In fact, it's the same question El Pasoans have been asking for the last five years.

The Miners got smacked around by the Houston Cougars by the tune of 54-24 last Friday.

And as most of you can tell by the score, the Miners' latest revamped defense was as consistent as it has been over the last few years – it was non-existent.

The loss dropped the Miners to 1-1 on the season but the lack of even a mediocre defense means UTEP could be in for a lot of disappointing evenings this fall.

To make matters worse, the team announced that star safety Braxton Amy suffered a knee injury that will cost him the rest of the season and the rest of his UTEP career.

Well, back to Houston and the massacre.

Everyone knows that the Cougars may

be the best passing team in college football; so if quarterback Case Keenum went nuts against the Miners no one would have been surprised.

But it wasn't the Houston passing attack that killed the Miners, it was their running game.

Houston rolled up 308 yards and scored six touchdowns on the ground. In fact the Cougars looked more like Alabama or Ohio State running the ball right down the field at will.

Bryce Beall tore up the Miners, gaining 195 yards and scoring three touchdowns. Beall used the Miners defense as his own personal playground, averaging over 10 yards every time he carried the football.

Some of the numbers the Miners defense allowed are staggering. UTEP allowed 308 yards rushing, 348 yards passing, which comes out to a whopping 656 total yards. They gave up 32 first downs and an unbelievable 8.6 yards per every Houston play.

There are always between 115 and 120 division-1 college football teams competing all around the country every year. Over the last four seasons (all losing

ones) the Miners' defense has ranked 100th or worse.

And this year's crop of defenders is keeping the tradition alive. The Miners currently rank 108 out of 120 teams on defense.

And you can't blame UTEP's offense. Quarterback Trevor Vittatoe and the rest of the offense ranks 27th in the nation and is averaging 27.5 points a game.

Mike Price made yet another defensive coordinator hire prior to this season, bringing in Andre Patterson.

And though Patterson's squad looks as bad as any other of UTEP's recent defenses, you really can't blame the guy who can only play with what he's dealt.

It's no secret that the Miners just don't have the athletes they need to be competitive – but why don't they?

During Price's first two seasons at UTEP (both winning ones), the Miners were in the middle of the pack nationally – which is all you need when your offense is this good.

It always comes down to recruiting and UTEP has done a horrible job of luring talented defensive players to El Paso.

All I know is that the Miners had better get

things turned around quickly or I'm afraid Price won't have to worry about recruiting any players to UTEP next season.

Put the fingers down

If any of you watched any of the NFL games last weekend you may have noticed the players of both teams coming onto the field before the start of the game and raise their index finger to one another.

No, it wasn't a show of disrespect or the obligatory "we're number one" gesture. It was a show of solidarity among the players against the owners in the ongoing labor talks.

Let me say that the players are going about this absolutely the wrong way. The players are not going to get the support of fans that can barely afford tickets to the stadium.

The players would be better served if they kept their mouths shut, their fingers down, and let the guys in the blue suits tackle this stuff in the board rooms.

Just play football guys – fans don't want to be reminded about how much money you make while they had to leave one child home because they couldn't afford the \$400 price tag a family of four has to dish out at an NFL game.

I'm sure there are plenty of fans that would like to lift a finger at the whole NFL.

Baseball hits home

I earnestly began my sports-writing career in 1995, the last season the Atlanta Braves played at Atlanta-Fulton County Stadium, which was the scene of Hank Aaron's record-breaking home run in 1974 (and, coincidentally, the stadium where Barry Bonds hit his first round-tripper). The place – a real dump of a ballpark – was nicknamed "The Launching Pad." This was, according to legend, due

to the Georgia humidity, Atlanta's high altitude and the wind-breaking saucer shape of the stadium, which, supposedly, contributed to the high amount of home runs hit there. (It wasn't until Glenn Hubbard started hitting home runs with Bob Horner-like regularity that anybody actually believed that.)

I remember covering a game – John Smoltz was on the mound – when I realized I was barely paying

attention. Like most people at their job – even a dream job – my thoughts drifted elsewhere, and in those days, they usually meandered toward the object of my affection, a woman we'll call Marci because that was her name. Where was she? Would she meet up with me after the game? These were the days before cell phones. I mean, we had them, but they closely resembled the hand-crank phone kits that first lieutenants would use on battlefields to call in air strikes. I actually used to use a pay phone to call people from the press box. It was modern Stone Age stuff. Mr. Slate should have been my editor.

That's when I realized that for all of my talk about being such a baseball fan, expert, what have you... I had very rarely in my life ever watched a baseball game wire-to-wire before that season. Sure, we talked a good game – my friends and I would light up the lines on local sports talk shows as teenagers – but we very rarely committed the three hours or so needed to watch a full game.

Some 16 years later, I'm in the Royals press box at Kauffman Stadium, tapping out this column. The "new" Kauffman Stadium, which I can't stand – little more than a rolling digital billboard – leaves me nostalgic for Atlanta-Fulton County. But Zack Greinke reminds me a lot

of John Smoltz. Marci just got home from her yoga class, according to her Facebook page. My wife just e-mailed me a picture of our baby boy and texted my marching orders for the night: pick up milk, bring home dinner.

These days, a kid running all over the place, I fully understand the pastime concept. Not only can I now watch a full baseball game, I lament the fact that there are only 162 games in which to do so. Baseball – faithful and reliable – still hits home.

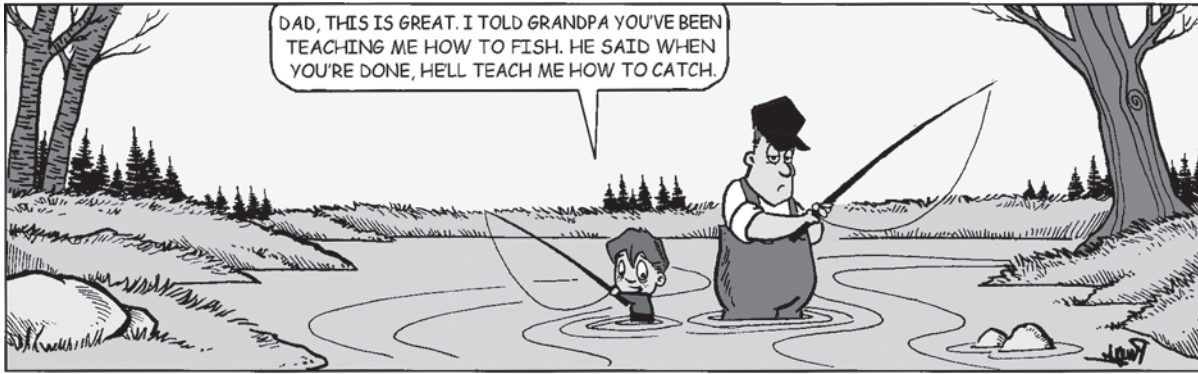

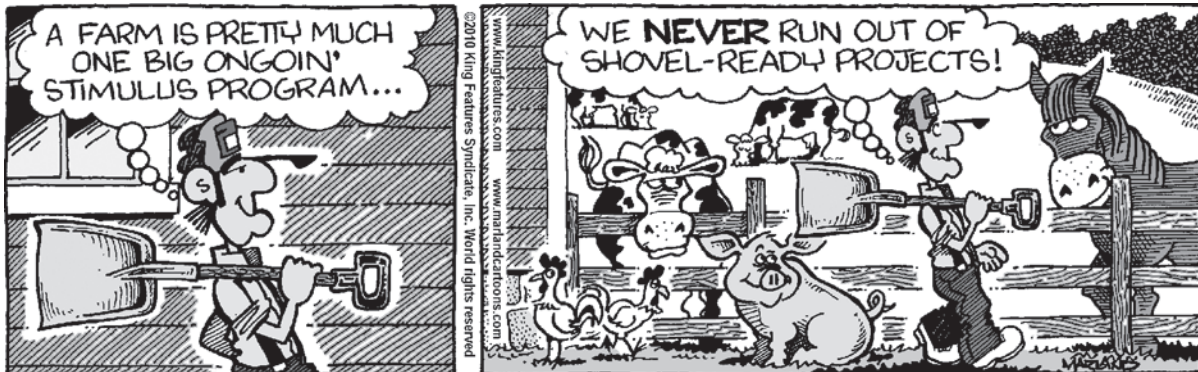

DEAR DR. DONOHUE: My adult daughter is unable to take vitamins without upsetting her stomach. She has taken them with and without food, and at different times of the day, to no avail. She takes no medicine except for thyroid. She has no gastrointestinal problems. — V.H.

legs three times a week. Age is another possible factor in failing to meet vitamin demands if older people subsist on a marginal diet of tea and toast.

DEAR DR. DONOHUE: I had a foot reconstruction operation some months ago. The foot doctor said I had to be off Celebrex until the foot completely healed. I had been on it for several years. I have osteoporosis and rheumatoid arthritis. Since being off Celebrex for four months, I don't have any more pain or stiffness than I did while I was taking it. Do I really need it? — V.M.

Has your daughter tried different brands of vitamins? The filler in some brands might be the cause of her stomach upset. Fillers are inactive ingredients that keep the tablet together.

The question really is: Does your daughter, or anyone, need to take a vitamin (multivitamin or otherwise) daily? Vitamins are nutrients that the body doesn't make for itself (except vitamin D). They're needed in extremely small amounts. The era of beriberi, scurvy and rickets is all but over since the discovery of vitamins. Most doctors have never seen a case of those vitamin deficiency illnesses.

If a medicine isn't doing anything for you, why take it? You've taken Celebrex for several years and now you've been off it for four months with no worsening of your symptoms. I'd say you made a strong case for not continuing it. Many, many other rheumatoid arthritis medicines are on the market. It's time for a change, or perhaps for a medicine rest if your doctor agrees.

Vitamins don't pep us up and they don't prevent heart disease or cancer as was once thought. In excess, they can be troublemakers. In spite of this, we're conditioned to believe that we need a daily multivitamin. Half of the adult American population swallows one every day.

DEAR DR. DONOHUE: When patients are admitted to a hospital by ambulance and their prescriptions are given to the hospital staff, are they returned to the patients upon discharge? These are expensive medicines. — E.M.

We can meet all vitamin needs through foods, with the possible exception of vitamin D. A diet that supplies fruits, vegetables, grains, dairy products and some meat provides the necessary vitamins. Meat is the source for vitamin B-12, but vegetarians can get that vitamin in other ways. Vitamin D is a problem for many. Sunshine converts a substance in the skin into this vitamin. Many people don't get enough sunshine exposure to achieve skin production of D, and people in northern climates can't get enough during winter months. All it takes is 15 minutes of sun exposure on the face, arms and

The medicines ought to be given back to the patients upon discharge. If they aren't, an inquiry should be made. If no answer is forthcoming, take the matter to the hospital administrator.

Social Security Q&A By Ray Vigil

Scams

These days, everyone needs to be cautious of scams – Internet, mail, and even phone scams – which can damage your credit score and pocketbook. Any time someone asks for your personal information, you should be wary. Particularly cruel are swindles that target Social Security beneficiaries.

Recently, Social Security became aware of a scam targeting beneficiaries in the Southern California area. Scammers telephoned beneficiaries to tell them they were due a “stimulus payment.” The scammer offered to deposit the payment to each beneficiary’s account once the personal and bank account information was provided. The scammer then contacted Social Security by telephone to request the benefits be deposited into a new account – the scammer’s account, to steal the payments. In a similar version of this criminal ploy, the scammer calls the beneficiary to “confirm” the beneficiary’s personal and financial information.

As a rule of thumb, Social Security will not call you for your personal information such as your Social Security number or banking information. If someone contacts you and asks for this kind of information, do not give it.

You should never provide your Social Security number or other personal information over the telephone unless you initiated the contact, or are confident of the person to whom you are speaking. If

in doubt, do not release information without first verifying the validity of the call by contacting the local Social Security office or Social Security’s toll-free number at 1-800-772-1213 (TTY 1-800-325-0778).

Another way to protect yourself is to keep your Social Security card and other important documents locked away in a safe place. Do not give personal information to just anyone. Also, check your Social Security earnings record. You can request a Social Security Statement online at www.socialsecurity.gov/statement. When you receive your Statement in the mail, you can verify the accuracy of the reported earnings and request correction if necessary.

If you’ve fallen victim to fraud or identity theft, be sure to file a report with the local police or the police department where the identity theft took place, and keep a copy of the police report as proof of the crime. Be alert when dealing with people who want your personal information, such as your bank account number, date of birth, and Social Security number. By using a little caution, you can protect yourself from scams.

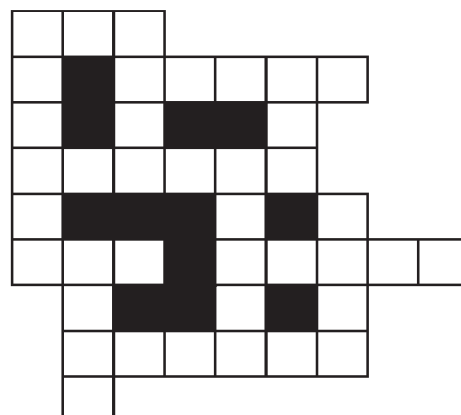
