## Lack of funds closes MHMR's Nueva Esperanza Clinic

EL PASO COUNTY – Due to its current budget crisis, El Paso County Commissioners voted recently not to put up \$376,000 for a program intended to keep the mentally ill out of emergency rooms.

As a result, the state-designated Mental Health/Mental Retardation Authority for El Paso County was forced to close the doors October 1 to its Nueva Esperanza Clinic and to establish a waiting list for services affecting 1,500 people with mental illness.

In 2009, El Paso Mental Health Mental Retardation opened the Nueva Esperanza Clinic, a collaborative program with El Paso County and University Medical Center (UMC), to serve indigent county residents who would otherwise go without medications to manage their illnesses.

The focus of the program was to get the acutely mentally ill into local, private mental facilities rather than have them languish in emergency rooms while transportation is arranged to take them to state-owned facilities outside the county.

To soften the blow, UMC proposed a plan to continue services for these individuals. Rene Hurtado, chief external affairs officer, said that MHMR will now work with UMC to continue providing the service to mentally ill patients who were being treated by the clinic. He said that MHMR caseworkers are currently assisting affected individuals in order to facilitate the transition process and are working to determine which consumers may be released from services.

Hurtado emphasized, however, that crisis services are not being affected for those individuals who pose an immediate threat to themselves or others. "The El Paso MHMR Emergency & Crisis Department will continue to remain open 24/7 for crisis intervention and the 24-hour crisis line at 779-1800 will remain operational as well," he said.

El Paso MHMR is funded by the state of Texas to care for approximately 3,000 adults and 600 children, although the actual need is much greater; it's more like 4,600 adults and 1,100 children, according to Richard Holt, chairman of the board of

trustees for El Paso MHMR.

"Our organization lost almost \$4 million during the 2009 fiscal year due to serving fifty percent more customers than funded by the state. This gaping cash hole is now being filled by serving only to our state target and through a refund from the state, a reconciliatory process we started in 2007," Holt stated in a recent report.

El Paso MHMR maintains numerous contracts with state and federal agencies to fund services. These contracts total more than \$39 million; local government entities provide

about \$3 million. The local MHMR has 450 employees working at 16 different locations across the region and maintains a 6-member provider network. A nine member board of trustees oversees the agency.

"It is important to understand that El Paso MHMR was created through an inter-local agreement so that citizens have access to local tax dollars. El Paso MHMR is not a taxing entity, so we can't levy taxes to operate our clinic. Furthermore, we can't divert state funds to operate local initiatives," Holt stated in his report.

# Get out and vote

Hola mi gente. On Monday October the 18th, early voting starts leading up to the 2010 general election on November 2nd. As I have in the past, I am asking that all of you who read this take the time to vote.

For your convenience, the El Paso County Elections department has designated 21 locations to be available to vote over a period of 12 days. With some variances, the polling locations will be open from 7am until 7pm with weekend days the only exceptions.

The last time that I checked, El Paso County had over 370,000 registered voters. Granted, there have been reports that our voting roles are inflated by as much as 50,000 voters because of people moving out or passing away. Still, our county has a tremendous voting bloc if only we would exercise it.

In the last gubernatorial election, a little over 93,000 El Pasoans

did their civic duty and voted on November 7 of 2006. That is a paltry 25% of the total registered voters.

If you decide you want to sit out this election, then grin and bear the next two years. You blew your chance to hold office holders accountable. If you know of someone who does not intend to vote, chastise them passionately. We need a good showing in El Paso County this election year (and of course every other election).

Unlike past years, the race for governor is very close. There have been consistently close public polls that basically show the candidates in a dead heat. While the rest of Texas closes their polls a 7pm central time (6pm El Paso time), our polls close an hour after. If the race is within 100,000 votes, our votes may decide the race. The eventual winner could possibly owe the residents of El Paso County a huge debt of gratitude.

Getting back to the actual act

of voting, you have the right and privilege to cast your vote in complete privacy. No one can legally disclose your vote; only you. In Texas, you have the right and convenience to choose the day and location that you cast your vote. You have the right to vote for whomever you wish. No one can take that away from you.

You also have the right to vote for each candidate individually; or, you can chose to vote a straight party ticket. There should be no judgment by anyone about your decision. Any good faith effort to exercise the right to vote, by straight party or not, should be respected. If a candidate fails to live up to promises or integrity, that is a sin by the candidate and not the straight party voter. Hundreds of thousands of Texans vote either straight Republican or Democratic tickets. It is a traditional method of voting in Texas.

I have wondered for years now what the magic button is that will wake up our community to the importance of voting. I have not come to any positive conclusion. I can only surmise that the reason so many do not vote is that they just don't care to improve our community. That is a sad reality.

it was stolen. On the same day, about 4:30 p.m., a potential buyer took a test drive in a 1993 Toyota Tacoma pickup truck and returned it one-half hour later to a dirt lot at 2100 Zaragosa. ### The good, the bad and the ugly

The news is mixed. Let's call it the good, the bad and the ugly.

The Good: Veterans Affairs chief Eric Shinseki is still in our corner. He faced down a group on Capitol Hill that is questioning his decision to add ischemic heart disease to the list of presumptives for Agent Orange exposure. Shinseki stepped right up and described his decision-making process to add the disease, even though the research evidence was limited/suggestive for exposure — meaning that it's not 100 percent conclusive.

The Bad: The title of a recent VA Office of Inspector General report is telling — Administrative Investigation: Prohibited Personnel Practices, Abuse of Authority, Misuse of Position and False Statements.

Of course the names in the report are blanked out, but what's left is pretty clear. In one case, a personal relationship with a higher-up was involved. I'd say that 83 phone calls in one month and 1,250 calls over the next two years could indeed indicate a personal relationship.

Then there's the mismanaged \$1.2 million in VA funds that netted a slap on the wrist.

With all the blanked-out names, it's hard to discern exactly who is who, but it also appears that three 10-point veterans (preference points awarded disabled or Purple Heart recipients, among others) were overlooked for promotion so that a position could go to someone else.

The Ugly: The VA is still trying to say that all those foul chemicals in the water at Camp Lejeune didn't cause cancer. The VA Health Care fact sheet hedges when it comes to childhood birth defects and leukemia, but it does grudgingly admit that there is a "limited/suggestive" link between those chemicals and kidney, esophageal, bladder, breast and lung cancers.

Recall that phrase from above: limited/suggestive. VA chief Shinseki added ischemic heart disease to the presumptives list based on a handful of studies saying that the evidence was limited/suggestive.

## Good for the goose

Today's society is in a constant state of flux. We move faster today than ever before, what with new advances in communication and society's incessant need for instant gratification. Laws, too, must change with the times, being constantly adapted to new contingencies, while at the same time maintaining certain unalienable principles. Indeed, life has become complex, and perhaps laws should be enacted to keep pace with those complexities. It is obvious that any statute or

law enacted cannot possibly be applicable to a multivariate playing field, but nonetheless must maintain a certain degree of malleability in both application and interpretation, in order to provide for a modicum of simple justice in a world tinted by shades of gray. Some examples will serve to bear out this point.

Let's take, for example, the case of handgun laws and registration. While states in the Midwest and Northeast of the United States have adopted a particular negative posture in

their regard, said point of view is not applicable to other areas of our great nation, where handguns and rifles are viewed as a necessary quotidian tool, in much the same manner as an automobile jack is to the trunk of our cars. While a jack is not something we think about on a daily basis, we are grateful for its place in our vehicles, when the time comes for that unexpected change of the "rubber guard." Perhaps handgun laws should be viewed in the same light, providing a certain lenience and understanding in their application to those instances, individuals, and areas of the country where a certain degree of deterrence on the part of the common citizenry is warranted. While it is certain that the closed living spaces of the Midwest and Northeast, with their higher populations and greater numbers and visibility of law enforcement personnel, demand a stricter code of application and enforcement of handgun laws, areas of the West, Southwest, and Northwest of our great nation require perhaps a looser interpretation, if not an all together different codification of those laws. The matter is complicated, but adapting handgun laws not only to a changing society but also to changing demographics, geography, and population migrations just makes good sense.

On the other hand, lest we forget their potential to rain on parades, it goes without saying that handguns are an all but necessary evil. In 2007, for example, a total of 12,632 people in the United States were murdered with firearms, and it is estimated that 48,676 were treated in hospitals for gunshot wounds received in assaults. Now, we must ask ourselves, how many of our troops placed in harm's way have succumbed to the power of the black powder? It appears that our civilian casualties far outweigh their body bag count. Physicians, in particular, are well aware that gun violence is a major public health concern, and one that hits home not only in the torso, but also in the pocketbook. It has been estimated that society bears the brunt of annual gunplay to the tune of over \$100 billion.


Cries of "self-defense" echo throughout the land, and the great State of Texas holds some preeminence in that regard. For years now, we have seen Texans raise their collective fists in outrage and heard their collective cry, if not roar, of defiance, when Northern politicians have only alluded to the possibility of stricter control of their handguns. The argument of the Lone Star State's vast gun-toting population has been that every man and woman has the right to bear arms and defend his or her homestead against possible invasion from without. Laws have been enacted to guarantee this right to the homeowner, and jurisprudence teaches us that test cases in Texas have always favored the defender's use of force to protect family. In fact, there is a running joke in Texas that if someone violates your property and trespasses, you are to shoot first, ask questions later, and be sure to drag

the body into your home, in order to cut your losses. Should an ambitious prosecuting attorney decide to make an example of your rush to judgment and violence, hold firm, as the National Rifle Association (NRA) will most certainly come to the rescue. Now, while that explanation of Texas law may be slightly exaggerated, statistics show that retail sales of firearms appear to corroborate the cultural wisdom of a large-scale Texas vigilante movement. Cross-border violence, with Mexican neighbors to the south of the Texas border, has also fueled the flames of the local and national gun lobby.


The two instances and laws mentioned above appear to confirm a tendency to adapt laws to current societal and cultural trends, in their enactment, applicability, interpretation, and enforcement. It nonetheless should be realized, however, that there are dangers inherent in a body of laws that is dynamic and in a constant state of interpretive flux. Referring back to our previous examples, without a uniform legislative standard of handgun availability, purchase, registration, transport, use, and storage, we run the risk of "returning to the future" and transforming ourselves into trigger-happy patriots with sophisticated weaponry that our forefathers could not have imagined in their wildest dreams. Also, who speaks for the "little people," in other words, those innocent bystanders who are wounded, maimed, and killed by stray bullets that false pride and fear coerced us into firing at the sound of a creak, crack, or scratch in some far off place in our homes in the middle of the day or night. Many an innocent bystander out on the sidewalk or street has paid the ultimate price for devil-may-care interpretation, implementation, and justification of a Bill of Rights that perhaps is too antiquated to be applied in its letter to a 21st century population of descendants who face challenges all together different from those of their forefathers.

So, it must be said that laws that are too strict in their vision do as much damage as those too loose for their and society's own good. Society and even culture changes on a continual basis, and perhaps laws themselves, if not in their immediate substance, at least in their interpretation and application, must be constantly molded and adapted to meet the ever-changing social challenges of melting-pot population dynamics. While the backbone of a federal law must be as straight in Nevada as it is in New York, the lengths and breadths of its limbs can be as diverse as a population's body shapes and sizes. When it comes to law and white shirts or blouses, one size does not fit all. A slight modification or a trip to the tailor, however, can make us all presentable, and then we can truly say that what's good for the goose is, indeed, good for the gander.

# Town of Horizon City, Texas

## Notice of Election

### ORDINANCE NO. 0182

**AN ORDINANCE OF THE CITY COUNCIL OF THE TOWN OF HORIZON CITY, TEXAS, CALLING AN ELECTION FOR THE SUBMISSION OF CHARTER AMENDMENTS AND A REFERENDUM ON THE DESIGNATED USE OF SALES TAX TO BE HELD WITHIN THE CITY, ON NOVEMBER 9, 2010; MAKING PROVISIONS FOR THE CONDUCT OF THE ELECTION AND OTHER PROVISIONS INCIDENT AND RELATED TO THE PURPOSE OF THIS ORDINANCE.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF HORIZON CITY:**

1. That pursuant to Section 2.01 of the City Charter, this Ordinance was introduced at the City Council meeting held on August 24, 2010, and a "Notice of Introduction of Ordinance" was published on August 20, 2010 in a newspaper of general circulation in this City, which notice summarized this Ordinance as introduced and gave notice of the time, date, and place of a public hearing to be held prior to the passage of this Ordinance, and the meeting at which this Ordinance is considered is open to the public as required by law, and that public notice of the time, place and purposes of said meeting was given as required by Chapter 551, Texas Government Code, as amended.

2. That pursuant to the Texas Election Code, as amended, (the "Code") an election (the "Election") shall be held in and throughout the Town of Horizon City, Texas, on November 9, 2010, which date is not less than sixty-two (62) nor more than ninety (90) days from the date of this Ordinance and the City Council hereby finds and declares it to be in the public interest that said Election be held on a uniform election date. At said Election, the following amendments to the Charter of the Town of Horizon City ("Propositions") shall be submitted to the qualified voters of the City:

### AMENDMENT NO. 12

#### Text of Amendment

Amending Article III, Section 3.01(A) of the City Charter, Number, Selection, and Terms of Office, to read in pertinent part as follows:

(A) The legislative and governing body of the City shall consist of a mayor and seven (7) council members and shall be known as the "City Council of the Town of Horizon City." However, regarding consecutive terms in office, the office of the mayor shall be considered separate from the offices of council members for the purposes of any term limitations set out in this charter.

### Ballot Proposition 1

FOR ( )

**Shall Article 3, Section 3.01 (A) of the City Charter be amended to provide that, regarding consecutive terms in office, the office of the mayor shall be considered separate from the offices of council members for the purposes of any term limitations set out in this charter?**

AGAINST ( )

### AMENDMENT NO. 13

#### Text of Amendment

Amending Article III, Section 3.01 (D) of the City Charter, Compensation, to read in pertinent part as follows:

(D) The mayor will be elected for a four-year term. Council members will be elected for four year terms. The mayor and council

members 3, 5, and 7 shall be elected in 2011 for an initial term of three years. Beginning in 2014 and thereafter, the mayor and council members 3, 5, and 7 shall be elected for a term of four years. Council members 1, 2, 4, and 6 shall be elected in 2012 and thereafter, for a term of four years.

### BALLOT PROPOSITION 2

FOR ( )

**Shall Article 3, Section 3.01 (D) of the City Charter be amended to provide that the term for the office of mayor and council members be changed from two to four year terms?**

AGAINST ( )

### AMENDMENT NO. 14

#### Text of Amendment

Amending Article III, Section 3.05 of the City Charter, Compensation, to read in pertinent part as follows:

(A) Commencing on October 1, 2011, each member of the City Council, with the exception of the Mayor, shall receive as a stipend the sum of one hundred twenty five (\$125.00) dollars per month.

(B) Commencing on October 1, 2011, the Mayor shall receive a salary on five hundred (\$500.00) dollars per month.

(C) In addition to the above, all necessary expenses incurred by the Mayor and members of City Council in performance of their official duties shall be paid by the city.

(D) Nothing herein shall prohibit the Mayor or a member of City Council from waiving the right to all or any part of such compensation or payment of expenses.

(E) From time to time, City Council, by a two-thirds (2/3) majority vote may adjust the City Council stipend and Mayor's salary by an amount up to five (5%) percent of the then stipend sum and Mayor's salary sum for a period of the succeeding twelve (12) months.

**Shall Article III, Section 3.05 of the City Charter be amended to provide that, commencing October 1, 2011, each member of the City Council receive a stipend of one hundred twenty five (\$125.00) dollars per month and the mayor shall receive a salary of five hundred (\$500.00) per month?**

### SALES TAX REFERENDUM

**WHEREAS**, the Town of Horizon City, Texas, is authorized to call and hold an election to designate the use of a certain portion of the sales tax for the benefit of the Town; and

**WHEREAS**, the City Council of the Town of Horizon City, Texas, does not desire to increase property tax levels within its municipal limits; and

**WHEREAS**, the City Council of the Town of Horizon City desires to designate the additional sales and use tax, which is already in existence by virtue of an election conducted in May of 1994, for the certain designated uses; and

**WHEREAS**, the City Council of the Town of Horizon City desires to designate this additional sales and use tax for street maintenance and economic development within the Town of Horizon City;

I.

That in compliance with Chapter 321.401 of the Texas Tax Code and, in accordance with the laws and Constitution of the State of Texas, an election be, and the same is hereby called and ordered for November 9, 2010, at which election qualified voters may vote for the purpose of approving or disapproving the designation of the previously approved additional sales and use tax for street maintenance and economic development.

6. The election precincts and voting places of the Election shall be as set forth in **Exhibit A** hereto, which exhibit shall be incorporated herein for all purposes.

(a) Early voting shall be conducted by Ms. Karen Ellefson, City Clerk, as the Early Voting Clerk, and the County Elections Administrator, Mr. Javier Chacon, is appointed as the Deputy Clerk for early voting. Early voting by personal appearance for all election precincts shall be held at the locations, at the times and on the days set forth in **Exhibit B**. Any locations, including mobile voting stations, that might be later identified by the Elections Department for inclusion or deletion, and their respective hours for early voting by personal appearance, shall be authorized for such election.

(b) Applications for early voting by mail shall be submitted to the Early Voting Clerk no earlier than **September 3, 2010** and no later than the close of business on **October 26, 2010**, at the following address:

9. The following persons are hereby authorized and approved as Central Counting Officials:

10. That notice of the Election shall be given by posting a substantial copy of this Ordinance, in both the English and Spanish languages, at the Town Hall and at three other public places in the City not less than twenty-one (21) days prior to the date of the Election and by publishing said notice, in the English and Spanish languages, on the same day in each of two (2) successive weeks in a newspaper of general circulation published in the City, the date of the first publication to be not more than thirty (30) days and not less than fourteen (14) days prior to the date set for the Election.

11. The Mayor and the City Clerk of the City, in consultation with the City Attorney are hereby authorized and directed to take any and all actions necessary to comply with the provisions of the Code and the Federal Voting Rights Act in carrying out and conducting the election, whether or not expressly authorized herein.

# Miners grab five wins out of six games

For the longest time (decades now) El Pasoans have complained about the ineptness of the UTEP football program – and for good reason.

Over the last 40 years, when it has come to losing consistently – the Miners have set the standard.

And even after Mike Price made his way here and led the team to two straight bowl-game seasons, the Miners quickly returned to their losing ways the last four years.

But this season things are looking up for the orange and blue.

The Miners won their fourth straight game Saturday, knocking off Rice by the tune of 44-24.

The win pushed UTEP's overall mark to 5-1 and 2-1 in Conference USA.

Now I don't know about you but a 5-1 UTEP record in football is enough to make me blush. And you would think that the Sun City would be buzzing about this year's team.

But that's not a buzz that I hear – it sounds more like snoring.

Don't get me wrong, I know the Miners' schedule hasn't been the toughest but they are doing what they have to do – beat the teams they're supposed to beat.

To say the Miners schedule is on the soft side is like saying Rosie O'Donnell may occasionally enjoy a midnight snack. UTEP's five victims have a combined record of just 5-23.

But regardless of the schedule, the Miners are controlling teams that have controlled them in recent years and that's all you can ask for – an improving program.

And while UTEP is stepping it up, another segment of El Paso is dropping the ball – the fans.

Through the first four home games of 2010, an average of just 31,991 fans have made their way to the 50,000-plus seat Sun Bowl.

That's not only disappointing, it's embarrassing.

El Paso is a town of nearly 800,000 – that means that less than a measly 4 percent of the local population is making it out to the game. Is that the best we can do?

Obviously not, the Sun Bowl has been filled before. So El Pasoans

can support the team – the question is why they aren't supporting the team now.

Maybe it's the economy. Maybe it's the fact that the Miners have flirted with winning in the recent past, only to go on a late-season losing streak. Maybe UTEP just does a lousy job of promoting its program.

Whatever the reason, the citizens of El Paso have only two more chances to see the Miners this season. And this could be a team that not only goes to a bowl game, but challenges for a league championship.

The funniest thing about the non-support is that this is coming from fans that complain about having

nothing to do in El Paso.

Three hours at the Sun Bowl with music, marching bands, video screens, cheering and booing, flying t-shirts, food and drink, friends, dancing cheerleaders and... oh yeah, division-1 college football is a great way to spend a Saturday night.

Throw in the fact that the team is winning and you've got one heck of an evening out.

At last week's 44-24 rout of Rice, the Sun Bowl was just over half full and that has got to be demoralizing to a young athlete. Be sure that other young stud athletes are going to see the attendance numbers and look for another place to play football.

We never hear about the high school athletes who visit or consider UTEP – only to change their minds after they see all the empty seats at the games.


It's a shame that El Paso fans are always so late to the party.





## Your good health By Paul G. Donohue, M.D.

**DEAR DR. DONOHUE:** For quite some time, my right shoulder has hurt. I saw an orthopedic doctor, who says I have a tear of my rotator cuff. He suggested surgery. What do you think of surgery for this? I am scared that I could be worse off after the operation than I am now. I am only 44 and am quite active. — K.M.

The rotator cuff is a band made up of the tendons of four back muscles. The tendons wrap around the topmost part of the upper arm bone, the humerus, to keep the bone in the shoulder socket. Tears of the rotator cuff are a common problem and one of the principal causes of shoulder pain. Small tears can heal on their own. Larger tears almost always require surgical correction. All surgical procedures demand respect. Something can always go wrong. Most people who have had surgery to correct a rotator cuff tear are glad they had it. By most, I mean more than 95 percent. I would not hesitate to have this surgery.

**DEAR DR. DONOHUE:** Five years ago, my left breast was removed because of cancer. Some lymph nodes also were removed. The surgeon told me never to have blood pressure taken in my left arm. I haven't. Sometimes I get a funny look, but I will not allow my left arm to be used. Someone asked why I can't have my pressure taken there. I was abashed. I'm not sure why. Please tell me. — R.M.

Removal of the breast and lymph nodes often disturbs lymph drainage in the involved arm. Lymph is fluid that comes from the blood and circulates around tissues and cells to nourish and protect them. It makes its way back to the circulation through vessels called lymphatics.

Removal of lymphatics can produce swelling of the arm, as the fluid cannot find its way back to the circulation.

Pressure from the blood pressure cuff could add to the disruption of fluid return to the circulation.

**DEAR DR. DONOHUE:** I just survived pneumonia. I was told by the lung specialist that I should get the pneumonia vaccine every year. I am 66. My sister-in-law told me that her doctor said pneumonia shots are not needed after age 65. Who is correct? — D.T.

The "pneumonia" shot is for one kind of pneumonia, pneumococcal (NEW-moe-KOK-ul), the most common bacterial pneumonia, one that can be quite life threatening for older people. The current recommendations call for a single shot of the vaccine for those over 65. If the vaccine was given before age 65, a second dose should be administered five years later. If people have any illness that weakens their immune system, they, too, need a booster shot of the vaccine.


