### Tornillo water

### Fabens water

Water service for the community of Fabens is operating under normal conditions and water supplies remain available for El Paso County WCID #4 customers. The District's water is a stand alone system and it does not receive water from any other water utility. Daily water samples continue to be normal with no indication of contaminants. The water restrictions issued by the El Paso Water Utilities do not apply to the town of Fabens. The District did experience several freezing problems and these were taken care of immediately by District staff. Numerous reports have been received by the office and the after hours answering service regarding water leaks on personal property. For customers with leaks or frozen water lines, it is recommended that they follow safety measures by flushing all water lines before usage.

### Crime Stoppers

Crime Stoppers of El Paso is assisting the El Paso Police Department in identifying and locating the person or persons responsible for a series of church burglaries, making this the "Crime of the Week." Beginning on Friday, January 7, 2011, there have been a series of overnight church burglaries that have targeted electronic equipment and musical instruments, as well as anything of value that can be taken. The first church was St. Luke's at 930 Redd Rd., but the burglars show no partiality to a particular religion. They have since hit the Church of Latter Day Saints at 7315 Bishop Flores Drive, Coronado Christian Church at 118 Belvidere, Mountain View Christian Church at 4959 Hondo Pass, Cristo Rey Catholic Church at 8011 Williamette, and a number of others. Most of the churches are in the northeast and on the Westside; but it appears that churches in Las Cruces and one in the Mission Valley are also targeted. Investigators believe that someone out there knows who the suspects are and can tell police their identities and descriptions. ## EPA rule would effect small land owners

El Paso Association of Builders (EAB) asserts that the federal government's Environmental Protection Agency (EPA) is being very unfair to the desert southwest when it comes to its proposed new Clean Water Act rule regarding post-construction storm water discharge.

EPA's new rule would require post-construction storm water discharge permitting and reporting for property owners of one or more acres of land in and around urban areas.

In 1990, EPA promulgated rules establishing Phase I of the National Pollutant Discharge Elimination System (NPDES) storm water program. The Phase I program requires owners of five or more acres of land to implement a storm water management program as a means to control polluted discharges. Phase I established a storm water management program to improve the nation's waterways by reducing the quantity of pollutants that storm water picks up and carries into storm sewer systems during storm events.

The proposed new Storm Water Phase II Rule extends coverage of the NPDES storm water program to small landowners but takes a slightly different approach to how the storm water management program is developed and implemented.

The Phase II rule would include developing and implementing construction site runoff control and enforcing an erosion and sediment control program for construction activities that disturb one or more acres of land (controls could include silt fences and temporary storm water detention ponds).

Also included in the proposal is a runoff control and enforcement program to address discharges of post-construction storm water runoff from new development and

redevelopment areas. Applicable controls could include preventative actions such as protecting sensitive areas (e.g., wetlands) or the use of structural methods such as grassed swales or porous pavement.

EPA officials claim that the expanded storm water program proposal addresses concerns about long term storm water discharges from developed sites, such as subdivisions, roadways, and commercial buildings or shopping centers that can significantly alter the hydrology of a site and can have a negative impact on receiving waterways.

El Paso homebuilder Bobby Bowling IV disagrees with the expanded program proposal and is trying to convince EPA officials that the desert southwest should be exempt.

Bowling, as an EAB member and a small business representative for the National Association of Home Builders (NAHB), participated recently in the Small Business Representative Regulatory Fairness Act (SBREFA) panel discussions that reviewed the proposed new storm water rule.

Under SBREFA, federal agencies must involve small businesses in the development of proposed rules through Small Business Advocacy Review Panels. SBREFA is designed to give small businesses assistance in understanding and complying with regulations and more of a voice in the development of new regulations.

"El Paso and other desert communities should be exempt from these portions of the Clean Water Act (CWA) because all rainfall either evaporates or percolates into the ground far before it ever reaches a body of water. Plus, a long time ago, developers here began building retention ponds to alleviate natural flooding patterns, so even less storm water is flowing here after a rain event," stated Bowling in EAB's recent Builders Outlook newsletter.

"It's crazy that our industry is building

and developing incredibly eco-friendly communities and infrastructure, yet the EPA keeps coming back to our industry to increase our costs of development and now, just simple land ownership, for an incredibly insignificant diminishing return for the environment," Bowling stated.

During the SBREFA panel review hearings, "I showed (EPA officials) an example for a 10-acre apartment project where their additional rule could add as much as a million dollars to the cost of the project. They kept mentioning that green jobs could be added, but I fail to see how any jobs can come from a project that is infeasible and won't be done," Bowling stated.

Bowling stated that also during the SBREFA hearings, several small business entity representatives voiced their concerns over the fact that the EPA continues to seek new rules limiting developers while continuing to ignore the farming and other unregulated communities.

According to EAB's newsletter, urban storm water discharge that includes storm water runoff from all development activity accounts for less than ten per cent of the problem. Other pollutants that make their way to the nation's waterways come from industrial and other development activities outside urban areas, but the vast majority comes from farms, which are unregulated and exempt from the CWA.

"Every property owner in the United States should be concerned about this rule. It could potentially burden cities with the task of spending billions of dollars to comply with an EPA rule that would do little or nothing to protect the nation's water bodies in some parts of the country," Bowling stated.

The formal SBREFA report is expected to be completed by March and a proposed rule from EPA would then be promulgated and published for public comment. The final rule would come in late 2011 or early 2012.

# Articular attack

Like a toy in the attic, collecting dust until polished and thrown back into the mainstream of the temple's hallowed halls, rheumatoid arthritis (RA) subtracts luster and adds exquisite pain to muscles and joints long ignored in a restful and tranquil hibernation. Dormancy breeds contentment, especially in the fairer sex, until some as yet unknown trigger unleashes a symmetric articular maelstrom that rivals a perfect storm and leaves its hapless wayfarers cursing the day they were born. In short, RA is no fun, and its countless victims, currently estimated at 0.8% of the U.S. population with three times more women than men suffering its ravages, to second that attestation. Most cases, 80% in fact, develop between the ages of 35 and 50 years of age, with the onslaught attributed to a possible infectious agent such as the measles virus or the virus causing infectious mononucleosis.

Whoever or whatever the culprit initiating the skirmish, the ebb and flow of battle results in devastation of joint linings and their associated blood vessels, along with an unhealthy dose of inflammatory cell invasion and edema. The latter cells release a barrage of activated substances and destructive enzymes that are up to no good, degrading the joints even further. If that were not enough, reserves are called up from the rear to discharge a battery of antibodies, which attack self-proteins called antigens that have no other fault than being in the right articular zone of combat at the wrong time.

Hostilities begin with vague symptoms of fatigue, loss of appetite, and muscle, bone, and joint pain, that gradually progress over the course of weeks or months to a more specific chain of cataclysmic events. Several joints, especially those of the hands, wrists, knees, and feet become involved symmetrically, with no prisoners taken in that 10% of the combatants who wage an acute and losing battle against fever, enlarged lymph nodes, and a spleen that roars its resentment to its increased girth. Pain in affected joints, aggravated by movement, is the alarm sounded and call to arms, with morning stiffness of greater than an hour duration interdicting immediate

obedience to the bugle's blare.

Inflamed joints are held in a flexed posture, resembling a "Z," the neck of a swan, or a buttonhole, in order to maximize their volumes and consequently minimize the hurt. Laboratory surveillance, counterintelligence, and a sending in of skirmishers to scout the terrain and lay of the land do little to extend the beachhead, as 5% of healthy recruits demonstrate rheumatoid factor, an autoantibody whose presence is not necessarily specific enough to warrant capitulation. In fact, RA may be mimicked or camouflaged by any number of conditions harboring rheumatoid factor; those being lupus, hepatitis B, tuberculosis, leprosy, syphilis, chronic liver disease, malaria, infectious mononucleosis, bacterial endocarditis, and a host of others all to ready to swing into action.

So, what to do? What weaponry in the possession of a modern-day bombardier or rheumatologist can slow the progression of disease, while at the same time lessening its cost in blood and treasure? Obviously, exercise directed at maintaining muscle strength and joint mobility is the first line of defense and stopgap measure to halt RA invasion. When lines are overrun, bigger guns are called to bear on troop movements of autoantibodies that if left to rape, pillage, plunder, and otherwise wreak havoc on the articular landscape, will inevitably result in disabilities so grave as to compromise daily activities and quality of life.

Enter the fray, low-dose anti-inflammatory steroids, and, if need be, disease modifying anti-rheumatic drugs (DMARDs) such as methotrexate and sulfasalazine, to temper RA destructive capacity. Symptom mitigation and pain relief via nonsteroidal anti-inflammatory drugs (NSAIDs), simple analgesics, and cyclooxygenase (COX) inhibitors (or Coxibs) may additionally be drafted into service. Finally, when all else fails, a resort to nukes, in the form of potent biologics, is authorized to control signs and symptoms of RA, slow damage to joints, and limit disability, all at the expense of a crippled defense budget.

Make no bones about it. When the dogs of war are unleashed by RA on unsuspecting joints, their bites are inevitable, at the cost of sometimes muted barks.

### Fiduciaries: The big money grab or fiduciary abuse

A Texas couple, one of them an attorney, was indicted last summer for stealing more than \$2 million from veterans they were sworn to protect. They'd been declared fiduciaries and legal guardians for veterans who'd been deemed incompetent to handle their own affairs. According to the 26-count indictment, this couple had been at it since 2003.

But what of veterans who are declared incompetent without any due process whatsoever?

The Department of Veterans Affairs took a married couple who didn't need money-managing help, said the veteran was 100 percent disabled with PTSD and declared him incompetent and in need of a fiduciary representative. With the stroke of a pen, this couple is no longer capable of making decisions about their money?

In another case, a son (with a power of attorney) had been handling his veteran father's money for many years. Suddenly, a doctor said the veteran was incompetent and the VA assigned an attorney to manage his money. The attorney grabbed the money in the account and put it into another one, which the son has no access to. All this without a hearing, without input from family and without the knowledge of the veteran.

The abuses go on and on, they include:

- Veterans forced to accept a fiduciary situation they didn't ask for, don't want and weren't told about in advance.

- Veterans who have their utilities cut off because the fiduciary hasn't paid the bills on time.

- Spouse fiduciaries who have been sued because the VA has appointed two fiduciaries, and the other one wants the money.

The Veterans Administration Office of the Inspector General (VAOIG) is great at nabbing those who steal from veterans, but what about the VA itself forcing veterans into fiduciary relationships against their will? When will it look at that?




# Texas vs. the Nation All-Star Game: The clock is winding down

Well how about that big game last weekend.

No, I don't mean the Super Bowl, I'm talking about that game they used to play in El Paso but they moved to San Antonio - the Texas vs. the Nation All-Star game.

The Texas team held on in the final moments to defeat the Nation 13-7 - but that wasn't the real story.

The real story happened in the stands, or more appropriately - it didn't happen in the stands.

You see, the game's promoter, Kenny Hansmire started the game in El Paso and originally declared that it would be here for years to come.

I don't think Mr. Hansmire is very good at math, because his interpretation of the term "be here for years to come," means only four short years.

From 2007 to 2010, the game was played in the Sun Bowl and drew a high of over 42,000

fans in 2009.

In fact, in the four years the game was held in the Sun Bowl, Texas vs. the Nation drew a total of 116,777. That comes out to an average of 29,194 fans per game.

That's quite a bit for a college all-star game that is not called the Senior Bowl.

But last year's game drew 26,041 fans, a big disappointment for Hansmire, who stood on the field at the end of the game looking a lot like my son when he was three years old and wasn't able to get the toy he saw in the grocery store aisle.

I think all you parents get my drift.

I don't want to say Hansmire threw himself on the floor and then proceeded to get up and take his ball and go home - but it was awfully close.

The guy was obviously upset with El Paso and vowed the game would never return to the Sun City right after that game was over.

A real glass-is-half-empty kind of guy.

Hansmire did take his game to what he thought were greener pastures - the Alamodome in San Antonio.

I think Hansmire figured he had struck gold

and would proudly see about 45,000 to 50,000 real football fans at the game.

Not even close.

Reporters at the game estimated the Alamodome crowd at a meager 10,000.

If Hansmire was distraught with the attendance at the Sun Bowl, I don't want to think about what kind of agony he's going through now.

First of all, it's Texas vs. the Nation. These are guys that will be drafted in the fourth round and beyond. Most will not be drafted and will sign free agent contracts.

It's like watching an all-star game of Double-A baseball players; some of them might be good some day but you have no clue which ones it will be, and the vast majority will never be heard from again.

In other words - there's no star power. Really, how excited can the average fan be about that?

Hansmire should have left his game here and El Paso would have supported it with 25,000 to 30,000 fans every year.

Now I'm not saying that I blame the guy for moving his game from El Paso to San Antonio

- but you have to know your product - and your audience.

It's like wanting to sell your new double cheese sloppy bacon burger at any five-star restaurant in Paris.

You think this year's Alamodome attendance was bad, wait to see what it'll be next year now that they've gotten a taste of it.

How much you want to bet Hansmire will be on the phone to Sun Bowl officials within the next year or so asking for another chance.

I think the way things are financially, El Paso will probably tell Hansmire he had his chance and he blew it.

I really can't see the game lasting much longer. This is the fifth year of the game and it gets absolutely no coverage nationwide.

Nine out of every ten fans have never heard of the game.

Again, without the big stars, the game will always struggle to find an audience. But Hansmire could have kept it going in El Paso for years to come.

I guess he doesn't know how much we El Pasoans hunger for any kind of entertainment - even an inferior all-star game.

### Vince Lombardi's neighborhood

It may come as a surprise to many, but there are still a few ways to see Vince Lombardi.

There is, of course, the trophy that bears his name and was just awarded at the conclusion of the Super Bowl. The brilliant minds at HBO commissioned an excellent documentary about the man, but the place that always sticks with me

is Lombardi Court in Middletown, N.J.

Lombardi Court is a nice place - it's a cul-de-sac with a bunch of nice homes, the kind of neighborhood where the kids have a very nice Halloween and get to ride their bikes in the street without worry. Still, the neighborhood does look over the largest cemetery for miles around,

and you'd think that would be just a little weird.

Cemeteries like Middletown's Mount Olivet, nestled in a historic part of Monmouth County, N.J., used to be on the outskirts of town, and for the most part, with good reason. For one, nobody is very enthusiastic about living near cemeteries, and you know that they're mostly kind of sad places, despite their parklike settings. They are filled with dead people, after all. But as anyone who's ever lived in a historic town can attest, the graveyard somehow

has become a fixture of our historic downtown centers, thanks to urban sprawl.

But Lombardi Court doesn't have that "this is kind of creepy" feel at all - in fact, just the opposite would be true. The street is named precisely for the reason that Vince Lombardi himself is buried just across the street.


The gravesite is rather unspectacular, save for the person buried beneath the typical gray granite gravestone. On most days, the plat is adorned with flowers (legend has it that locals partake in the ritual). But, just as they treat hometown hero Bruce Springsteen, the locals typically don't make much of a to-do about the situation. For those that know about it, it's little more than a curiosity or the answer to a trivia question.

Middletown is the kind of place where the millionaires work next to the minions. Sure, more than a few work on Wall Street, but these

aren't the guys you hear about on the news, ruining your life. In fact, Middletown lost more lives than any other town in the 9/11 attacks, and those lucky enough to have a job spend up to 40 hours a week just commuting to and from the city. Well-to-do or not, most are only a generation away from the blue-collar life embodied by towns like Green Bay or Pittsburgh.

The Middletown High School South Eagles have begun to mirror that work ethic on and off the field, winning state championships. Like their fathers, more than a few players know that the greatest football coach to ever live is buried right down the road. It may not be "Title Town" to most others, but the Lombardi spirit definitely deserves an honorable mention in Middletown.



## Your good health By Paul G. Donahue, M.D.

**DEAR DR. DONOHUE:** The tip of my husband's nose and his cheeks have become noticeably red this past year. People ask me – half kidding, half serious – if he's been drinking heavily. He doesn't touch alcohol. This doesn't bother him, but it bothers me. What is this? – N.D.

The probable culprit is rosacea (rose-A-she-uh). It starts as a reddening of the nose and cheeks, and sometimes can affect the forehead. The skin also develops webs of tiny blood vessels. Pimples – which look much like acne – break out. The final stage, which should never be reached these days, is the bulbous nose of W.C. Fields.

Rosacea is common. Fair-skinned people with light hair are the most susceptible. So are those who blush easily. The actual cause is a bit unclear. Some believe the skin mite Demodex is involved. It lives in hair follicles. But people without rosacea also have the mite, so a cause and effect is not certain.

People with rosacea often have eye involvement, something that's often overlooked but needs consideration. The eyes feel gritty and might burn. They, too, can become red.

Rosacea isn't a curable condition, but it is highly treatable. Your husband ought to steer clear of spicy foods, sunlight and extremes of heat and cold. That he doesn't drink alcohol is in his favor.

Metronidazole cream, gel or lotion, or Azelex (azelaic acid) cream can bring gratifying results. Over-the-counter benzoyl peroxide often works for an acne breakout. Sometimes oral metronidazole or an oral antibiotic is added to the program.

You or your husband would do well to contact the National Rosacea Society, which can provide you with informative literature and keep you abreast

of the latest changes in treatment. The society's website is [www.rosacea.org](http://www.rosacea.org), and its phone number is 888-NO-BLUSH.

**DEAR DR. DONOHUE:** Is it possible to have had a heart attack and not know it? I am a 59-year-old man and had my first-ever EKG this past week. The doctor tells me I had a heart attack. I have never had anything that felt like a heart attack. I don't smoke and never have. Heart attacks don't run in my family. My mother and father are alive at 85. I weigh 155 pounds and have weighed that since I was discharged from the Army, more than 35 years ago. Could this be a mistake? – R.S.

As many as 20 percent of heart attacks are silent, producing no pain or other symptoms. Those attacks are discovered when an EKG happens to be taken at a later date. It's also true that the EKG might show the pattern of an old heart attack without one ever having occurred.


If you want to settle the matter, consult a cardiologist. It's probably the wise thing to do.



**Social Security Q&A** By Ray Vigil

*Q: My neighbor is blind and receives Social Security benefits. Are there other ways for her to get letters from Social Security?*

**A:** Yes. Social Security offers a number of services and products specifically designed for people who are blind or visually impaired. Below are a couple of them.

**Special Notice Option:** If you are blind or visually impaired, you can choose to receive notices and other information from Social Security in special ways that may be more convenient for you. To find out more about this service, please go to our web page, *If You Are Blind Or Visually Impaired—Your Choices For Receiving Information from Social Security* at [www.socialsecurity.gov/notices](http://www.socialsecurity.gov/notices). In addition, if you have a question about a Social Security notice you receive, you may call our toll-free number, 1-800-772-1213 from 7 a.m. to 7 p.m. Monday through Friday or call or visit your local Social Security office and ask us to read it to you.

**Public Information Materials:** Many of our publications, such as brochures and fact sheets, are available in Braille, audio cassette tapes, compact discs, or in enlarged print. Our publication, *If You Are Blind Or Have Low Vision—How We Can Help*, and other publications in alternative formats can be

obtained by calling toll free, 1-800-772-1213, Monday through Friday, 7 a.m. to 7 p.m. If you are deaf or hard of hearing, you may call our TTY number, 1-800-325-0778.

*Q: I applied for my child's Social Security card in the hospital but have not received it. How long does it take?*

**A:** In most states it takes an average of three weeks to get the card, but in some states it can take longer. To check for the average wait time in your state, consult the chart at [http://ssa-custhelp.ssa.gov/app/answers/detail/a\\_id/74](http://ssa-custhelp.ssa.gov/app/answers/detail/a_id/74). If you have not received your child's card, and the time frame has expired, please visit your local Social Security office. Be sure to take proof of your child's citizenship, age, and identity as well as proof of your own identity. And remember, we cannot divulge your child's Social Security number over the phone. Learn more at [www.socialsecurity.gov](http://www.socialsecurity.gov).

*Q: How do I apply for Extra Help with Medicare prescription drug plan costs?*

**A:** You have several options for applying. You can:

- Apply online by visiting [www.socialsecurity.gov](http://www.socialsecurity.gov) and select "Get extra help with Medicare prescription drug costs" in the "Top Services" section on the left side of the page;
- Call Social Security at 1-800-772-1213 (TTY 1-800-325-0778) to apply over the phone or request an application; or
- Apply at any local Social Security office.

Anyone who has Medicare can get Medicare Part D prescription drug coverage. Some people with limited resources and income are eligible for Extra Help to pay for the costs – monthly premiums, annual deductibles, and prescription co-payments – related to a Medicare prescription drug plan. *Q: I have two minor children at home and I plan to retire next fall. Will my children be eligible for monthly Social Security benefits after I retire?*

**A:** Monthly Social Security payments may be made to your children if:

- They are unmarried and under age 18;
- Age 18 or 19 and still in high school; or
- Age 18 or older, became disabled before age 22, and continue to be disabled.

Children who may qualify include a biological child, adopted child, or dependent stepchild. (In some cases, your grandchild also could be eligible for benefits on your record if you are supporting them.). 
