#### Socorro cleans up

In Socorro's continuing mission to clean dangerous and possibly unhealthy material from some properties, the Socorro Planning and Zoning, Public Works and Police Departments are teaming up for Operation Clean Sweep. "With the dry weather and rising temperatures, it's only a matter of time before some unkempt properties become a health threat to our community. It's time to clean them up now before a fire or health hazard hurts one of us," said Sam Leony, Director of Socorro Planning and Zoning. Last Friday, March 4, police officers and code enforcers began responding to complaints in the initial phase of the Socorro clean up effort. Residents will receive a letter stating the complaint, after that, they can be cited for failure to cooperate. Finally, if necessary, the city can move in and clean up the danger and place a lien on the property for the cost of the clean up. Yards with vegetation growth in excess of 12 inches, vehicles without current registration and un-inflated tires as well as properties with any accumulation of trash or materials, which could promote a health threat, could be cited. Also a site obstruction, such as a tree or building could also be considered.

## San Elizario HS Navy cadets clean park

It would have been difficult to hear the sounds of children laughing and see them playing as overgrown dry brush and tall weeds some almost six-feet high obscured the Parque de los Niños, a community park in San Elizario, from street view. After learning about the dismal condition of the site, cadets with the San Elizario High School Navy Junior ROTC (NJROTC) program decided to do something to make the park more inviting for children in the neighborhood. On a recent Saturday morning, 20 NJROTC students led by Lieutenant Commander James W. Snarr and Chief Manuel P. Jaquez volunteered to clear all the dry vegetation

and debris from the park.

"Many times we ignore things that have a lot of meaning to us and we walk by them without lending a hand but when you help the community, you feel better because it helps everyone not just yourself," Chief Jaquez stated

The cadets descended on the neglected park with shovels, hoes, and other tools borrowed from Chief Jaquez and their own homes to cut weeds off at the ground level and to pickup trash. They stacked enormous piles of weeds and collected about 15 huge bags full of trash

## Be sure you're the only one receiving your Medicare benefits

officers and you have in common? receiving your Medicare benefits. They're all crucial in helping fight Medicare fraud.

Just last month, the federal government announced that it filed charges in fraud schemes around the country totaling more than \$225 million. All these alleged schemes had one thing in common - they sought to defraud Medicare.

Texas is one of the hot spots for these criminals who seek to steal Americans' hard-earned tax dollars at the expense of seniors. In Houston, the fraudulent claims involved physical therapy and chiropractors. In Dallas, they involved home health care and medical equipment.

The good news is that the new health care law will help crack down on waste, fraud and inefficiency in Medicare. The new law devotes \$350 million to fight fraud, which experts say will save the program as much as \$4.9 billion. Investigators will also be able to act more quickly when Medicare enrollees report fraud and even stop payments on suspected claims.

The same is true for calls you receive from people who say they're with the government or one of your medical providers. If you're suspicious, tell the caller you will call him back, and then verify his phone number.



## Money tight in Texas

will have reached the halfway point. The pace is picking up rapidly with more and more bills being heard in committees.

Unsurprisingly, the bills that the governor designated as emergency have proceeded on the fast track in the Senate and should be close to a floor vote in the house.

Any person with common sense would be puzzled as to why those bills are emergency issues and not the budget. With each passing day, more dismal news is published about the impact of the cuts. After a period of consistent positive economic growth, this budget with the extremely high numbers of jobs lost will put the recovery at a complete halt. It doesn't seem like most of the leadership sees that.

That's the bad news.

The better news is that Texans from all over are voicing their adamant demands that certain steps be taken to soften the budget impact. There are so many school districts that are strongly objecting to the cuts and also insisting that the rainy day fund be used that there is now a crack in the wall. Several members with seniority have finally spoken in favor of using the fund and also finding new revenues.

Only time will tell if the moderate voices take over.

It is very obvious that the number of bills that have been filed is well below the number of past sessions. There is probably a pair of reasons for that reduction. One is, obviously, the budget crunch. None of the

Hola mi gente. In ten days, the session bills that have a cost to the state associated with them will even get out of committee without a zero cost. Even bills that don't have a state cost but pass the cost to the local government will have a very hard time passing committees or floor votes.

> Just this morning, I was in a hearing where a water bill which would make conservation easier for districts to measure was put on hold because it would cost water districts about \$32,000. Although that is a small amount in some budgets, smaller districts like the ones in east El Paso County would not be happy that a new expense was mandated by the state. Hopefully, there will be no unfunded mandates in this session.

> At this point in time, we have a little more than eight weeks left to get bills passed. That is not a lot of time when you consider that redistricting and the appropriations bills will take up some of that time.

> Over the next few weeks, I will update you on the progress of the bills that I have filed including a bill that will help reduce the amount of tires dumped in the east county open areas. We were just on the phone with the Governor's office discussing the merits of the bill. There was no mention of veto.

> After Friday the 11th, no more new bills will be filed. Normally the house will have about four or five thousand bills filed. There are fewer than three thousand at this point.

> That may be a good thing because sometimes we over legislate.

live in Austin, and they have been working for over a year and a half to bring this event to fruition. The group hopes to make this an annual affair.

"We love El Paso, and our love for live music is why we decided to bring the music festival here. We felt that it was time for us to give back to our hometown. We want to provide an outlet for local artists and musicians to display their talents at a large scale event alongside international headliners," national and Martinez stated.

"Our goal is also to make an economic impact on El Paso, and hopefully have it become a success and something that people from El Paso, Juarez, Las Cruces, and the surrounding areas grow to love and enjoy," she added.

Paul said that the city's Museum and Cultural Affairs Department (MCAD) and the Convention and Visitors Bureau (CVB) helped them navigate through the city permits process.

In January, city officials granted the production company \$20,000 to help get the Neon Desert festival off the ground. "They saw that we were really serious about this, that we had good intentions and that it was more than about having a business and making money. They saw that we want to do this for El Paso," stated Paul.

"It's a first time event but we are modeling it after successful events," stated Bill Blaziek, head of the El Paso Convention and Visitors Bureau. "In fact, we talked about the humble beginnings of events like Austin City Limits and South by Southwest."

Paul stated that it would be great if it ever happens to be like Austin's popular music festivals years down the road. "But we're not trying to do that, just something similar to that on a smaller scale," he stated.

Tickets will cost \$25 for the first 1,000 ticket-buyers and active military, and \$35 general admission after that. For more information, visit the festival's website at neondesertmusicfestival.com.

#### Art contest

The Texas Clean Rivers Program (CRP) for the Rio Grande of the United States Section of the International Boundary and Water Commission (USIBWC) is sponsoring a drawing contest for students from kindergarten through twelfth grade. The contest is in honor of World Water Day, celebrated March 22 as an international day of observance and action to focus attention on the importance of freshwater and advocate for the sustainable management of freshwater resources. The CRP is seeking student artwork about the Rio Grande or the importance of water. Winning entries will be published in the 2012 CRP Rio Grande Basin Calendar. The contest is open to all schools within the Rio Grande Watershed in Texas. All submissions must be turned in by a teacher. There will be at least three winning entries, one in each of the following age groups: kindergarten - grade 2, grades 3 - 6, and grades 7 -12. All participants will receive a free calendar. Students are encouraged to draw how water is important to them, how the Rio Grande is important to them, or how they enjoy the river. 

#### Your good health By Paul G. Donahue, M.D.

DEAR DR. DONOHUE: Please explain why I have to take my shoes off late every day because my feet and ankles have swollen and don't fit into the shoes. I flop around in slippers without heels. In the morning, after a night's sleep, my feet are back to normal. I am 77 and take no medicines. - K.M.

I can't give you an unequivocal response because there are numerous causes of foot and ankle swelling.

The medical name for such swelling is edema. Even in relatively healthy people, occurs if people sit or stand for any length of time. Gravity pulls fluid out of the circulation, and it accumulates in the feet and ankles. This is especially true at older ages, when the circulatory system becomes somewhat leaky.

For this kind of swelling, the solution is to elevate the legs when sitting. The most effective elevation is raising the legs above heart level, something that can be done only by lying down with pillows propping up the legs. Getting up and moving about is another way to prevent fluid accumulation in the feet.

Heart failure is a more serious cause of such swelling. When the heart's pumping action becomes feeble, fluid escapes from blood vessels and again accumulates in the ankles and feet. Kidney disease with retention of body fluid is another cause of edema. Liver disease does the same.

Another condition called lymphedema produces the same picture. DEAR DR. DONOHUE: I am concerned about my brother, who is 63, diabetic, weighs 300 pounds and is 5 feet 8 inches tall. He falls asleep, wakes and falls asleep repeatedly at the table and when he sits down. Why? He says he's tired. He picked a scab on his leg and blood squirted out 6 inches. What does that mean? - Anon.

Your brother might have sleep apnea. His body size suggests that it could be the reason for his daytime sleepiness. Spurting blood indicates that an artery was broken. No one should pick at scabs, especially a diabetic.

Your brother needs medical attention. He has to lose weight both for control of diabetes and for control of sleep apnea, if that is what he has. He is at great risk of incurring the complications of diabetes - heart attack, stroke, blindness, kidney failure - if he doesn't start paying attention to his health.






