

Vinton Town Hall undergoes major renovation

The Village of Vinton's town hall facility is currently undergoing major renovation work as city officials move to meet mandatory fire code and American Disability Act (ADA) requirements as well as to reduce their building maintenance expenses.

The town hall facility, which was built in 1985, will get a new roof, a central heating and cooling system, ADA compliant doorways, necessary fire exits, and bathroom plumbing installation as part of the project, which started in April.

Workers have gutted out most of the building's interior to accommodate the renovations, and plans call for revamping of the front offices. However, no expansion to the building is included in the project.

Cost for the renovation work is estimated to be about \$182,000. Medlock Construction of

El Paso was awarded the bid and expects to complete the work in July. Project manager for the construction company is Gilbert Zuniga.

Light fixtures and electrical upgrades to the building are being paid for through a \$23,000 community block grant from the Texas State Energy Conservation Office, according to Village Clerk Jessica Garza. The grant, which is designed to include energy efficient features, was presented to the Village of Vinton in 2010.

The rest of the renovation costs are being financed by funds that were raised through the sale of tax notes, which was approved by village council members in 2008.

"The tax notes sale, which is similar to certificate of obligation bonds, garnered approximately \$1.1 million for the Village of Vinton," Garza said. "The notes were purchased by a bank in Dallas, and our repayment schedule is for ten years."

According to Garza, the tax notes revenue is also earmarked for the Village's on-going

projects to improve its water and sewer system infrastructure as well as its parks and streets. These projects are expected to continue through next year.

"This was the first time that Vinton officials have used a tax notes sale to raise money," Garza said.

The impact to Vinton residents will be a six and a half cent per \$100 tax rate increase beginning in 2011. For the average homeowner, the rate hike will be about \$42 more a year. The average home value in Vinton is approximately \$69,000. The latest census figures show that Vinton's population is nearly 2,000 residents.

Vinton resident Rachel Quintana said, "The rate increase is acceptable because we have to move forward as a community, and the improvements are necessary. Anything for the betterment of our community is a worthwhile investment."

The town hall building repairs required that the Mayor and city staff vacate the building and set up a temporary office in a mobile unit that is located behind the town hall. Additionally, the Village's council meetings are held at the West Valley Fire Station Conference Room, located at 510 E. Vinton Road.

For the time being, office hours of operation are from 8 a.m. to 6 p.m., Monday through Thursday, and closed on Fridays. Also, Vinton's Police Department has been relocated to a portable building across the street, at 501 Vinton Road.

"In the long term, we expect that the Village of Vinton will realize a decrease in electric, water, and maintenance costs because of these renovations," stated Vinton Mayor Madeleine Praino. "And our hope is to pass on the savings to our taxpayers."

According to Garza, original plans also called for the renovation of the office space adjacent to the town hall, which the village leases to the El Paso County Sheriff's Department, but when county commissioners announced last year that they would be building a Northwest Annex facility in Vinton, those plans were put on hold.

San Elizario ISD bus drivers compete at safety 'road-eo'

SAN ELIZARIO – The San Elizario Independent School District Transportation department came home with honors after participating in the 2011 El Paso County School Bus Safety Road-eo sponsored by the Education Service Center Region 19 and the Sun Country Association for Pupil Transportation on April 16. The event is opened to school bus drivers from the Region 19 area who compete for most skilled and safest school bus driver bragging rights. The Road-eo also serves to promote safety

and the important responsibility on pupil transportation to prevent school bus related accidents.

A total of eight San Elizario ISD drivers, four women and four men, competed in a field of over 60 drivers from different El Paso County school districts. District driver Adrian Ramirez placed in the top ten combo based on his driving skills and written test results. Rual Hooper earned first place for total points received in the written test with a score of 92 and he was the only one out of the 60 drivers tested that scored in the 90th percentile.

"We are very proud of these eight

VA cracks down on scammers

A percentage of government contracts are set aside for service-disabled veteran-owned small businesses. The Office of Small and Disadvantaged Business Utilization was set up to support, guide and counsel those small businesses, and there are many requirements: the veteran must own 51 percent of the business and be the highest officer in the company, to name just two. Additionally the veteran must have a letter from the Department of Veterans Affairs stating that there is a service-connected disability, as well as a DD-214 or its equivalent.

In other words, there's a paper trail. Theoretically, someone reviews the documentation.

How then did a guy in New York make \$16 million on VA service-disabled veteran-owned contracts when he wasn't 1) disabled; or 2) a veteran? A recent court case found the guy guilty of the scheming, as well as making false statements and witness tampering. I'm pleased to report that he could get up to 75 years in prison for it.

I'm also pleased to report that last October, the Veterans Small Business Verification Act was signed, and new levels of scrutiny in the awarding of contracts were developed.

Additionally there's a Vendor Information Page area online where each approved business was told in January to provide documentation within 90 days to verify that their business is indeed owned by a veteran. Failing to do so would mean that vendor wouldn't have a profile in the VIP database and the application would be considered incomplete. In other words, no contracts.

It looks like the VA plugged the hole through which untold millions of dollars were leaking due to non-verification. But we may never know just how many dollars have been lost this way.

Protecting Texas seniors from counterfeit check scams

Fraud against seniors is more widespread than most Texans realize. Well-informed seniors and their family members can help prevent the greatest generation from falling victim to fraudulent schemes – including a familiar counterfeit check scam that has re-emerged in recent weeks.

Law enforcement officials recently notified the Attorney General's Office that the so-called "Reader's Digest Sweepstakes" scam has reappeared around the state. Some Texans – usually senior citizens – may have received letters claiming the recipient won \$1 million in a sweepstakes. The letter claims its "Prize Award Department" drew the recipient's "ticket number" from a pool of thousands.

To appear legitimate, the letter fraudulently uses the Reader's Digest business logo and the Better Business Bureau's accredited

business seal – which falsely implies BBB accreditation.

Enclosed with the letter is a counterfeit check for several thousand dollars. Letter recipients are told to call a toll-free (800) number for further instructions. As is common in these types of scams, recipients who call the number are instructed to wire an up front payment to cover taxes or other administrative fees before the remainder of their "winnings" can be issued.

The scammers know that the up front payment amount sounds trifling compared to the \$1 million in prize money the victim thinks he or she has won. The victim often thinks it is worth paying the up front fee because the prize money far exceeds the alleged taxes and administrative costs.

But the prize money will never appear. Victims will simply lose

whatever money they wire to the scammers, which can have a devastating effect. In many cases, victims borrow or deplete their savings to come up with the money they are supposed to send in advance. It is a cruel blow when they realize they have lost that money to a con artist.

Counterfeit check schemes like the "Reader's Digest Sweepstakes" scam typically manifest themselves as an unsolicited offer for a prize or a job that seems too good to be true. In this case, Texas seniors should remember that the BBB has nothing to do with the Reader's Digest sweepstakes – and the publication itself does not require winners to wire money anywhere.

All Texans should be skeptical about unsolicited financial offers – or risk losing their life savings to a thief.

Assistance program holds meetings to help fund eligible homebuyers

EL PASO COUNTY – Like many communities throughout the nation, several neighborhoods in El Paso County have experienced high foreclosure rates. Responding to this need, a Consortium of non-profits agencies, led by the El Paso Collaborative for Community and Economic Development (the Collaborative) received a highly-competitive Neighborhood Stabilization award of \$10 million from the U.S. Department of Housing and Urban Development. Funds will be used to acquire and rehabilitate single-

family foreclosed and abandoned properties in 22 El Paso County census tracts located inside and outside of the City of El Paso.

The majority of the homes will be resold to low, moderate, and – for the first-time – "middle-income" households who may qualify for homebuyer assistance up to \$30,000. Two of the Consortium Members, Project Vida and AYUDA, Inc. will rent the homes they acquire to very-low income households. Another Consortium Member, Habitat for Humanity El Paso will resell homes exclusively to very-low income households who may qualify for assistance up to \$40,000. Habitat's Program includes a "sweat equity"

component where homebuyers will assist with the rehabilitation process.

As part of the neighborhood stabilization process, the Collaborative is offering special assistance to income-eligible members of law enforcement, fire-fighters, emergency medical technicians, active military, military reservists and teachers. Qualified "Good Neighbors" will not have to repay any of the homebuyer assistance they receive to purchase their homes. If you are thinking about buying a home, the Collaborative is conducting regularly scheduled orientation



Killing bills

Hola mi gente. Many of you no doubt have seen, or know of, the movie series titled "Kill Bill". The story line is about a beautiful woman who also happens to adept at martial arts fighting and the use of a samurai sword. The movies are quite violent.

We in the legislature have our own version of "kill bill", albeit without the violence. Thursday, May 12 is the last day that our house bills can be voted upon on second reading. Second reading is the first opportunity to approve or disapprove a bill; the final approval in the house is on third reading.

The house version of kill bill dates back to the very beginning of our state. The state constitution requires the house to write rules that determine the manner in which laws are passed. In these rules, there are certain dates that begin or end specific activities in the session. May 12 is the 122nd day of the 82nd Legislative Session, which means if a bill is not heard by that day and approved by majority vote, then that bill is dead (at least almost dead).

In past sessions, the daily calendar for kill bill day contained dozens of bills, perhaps, even in excess of 200 bills. Members were excited, anxious or disappointed depending on where a particular bill sat in the list. Those at the front one third had a good chance of having their bill voted on; those in the middle third experienced anxiety because somewhere in there was the last bill to be considered;

those in the last third wrote their bills off automatically.

The calendar for May 12 has been published and it does not resemble at all a calendar for kill bill day that I have seen in the past. There are very few bills on the last two days of second reading calendars. Unless there is a supplemental calendar adding more bills, the prospect of ending business before midnight on Thursday seems likely.

I mentioned before that bills would at least be almost dead if not on the calendar. There will be efforts to add unlisted bills to other bills in the form of amendments. This is tricky in that each amendment must be germane to the bill to which it is attached. Carelessly adding amendments could possibly kill a bill even if it passes the 122nd day deadline.

If the process does extend to midnight on Thursday, then members will anxiously monitor the position of bills hoping that the last bill voted on is listed after their bill. Sometime during the evening, the events on the house floor lead to "chubbing".

Chubbing is the state of silliness that eventually takes hold on this 122nd day of the session. Members will start extending debate on bills for no other reason than to stall the process. That adds to the stress and anxiety of those members whose bills are in the mix. This evening of legislative actions can be quite entertaining.

The disappointing reality of this day is that good bills will fail to pass on "Kill Bill Day."

Canutillo ISD earns anti-bullying certification

CANUTILLO – The Anti-Defamation League has designated and certified all nine of the Canutillo Independent School District schools as “No Place For Hate” anti-bullying campuses. Canutillo will become the only district in west Texas to be fully certified in this anti-bullying program thanks to its efforts to promote understanding and peace across its schools and community.

Officials with the national office of “No Place for Hate” were at Canutillo High School on Monday for an assembly and gave each of the nine CISD campuses a banner celebrating its year-long work to fight bullying. The assembly, attended by students, parents and educators featured cheerleaders and marching bands.

“We truly took a proactive approach

to this national problem that is plaguing schools,” said CISD Superintendent Dr. Damon Murphy. “Each one of our schools took the message of anti-bullying to heart, and embraced the concept of peace and understanding among students and adults. I am proud of the work that took place in Canutillo.”

To achieve certification as a No Place For Hate campus, each of the nine schools had to organize and implement at least three school-wide anti-bullying activities. The activities ranged from the creation of a Peace Garden at Bill Childress Elementary to adopting a “No Hate” theme to all homecoming activities last fall at Canutillo High School. As part of the campaign, all teachers, employees and Board of Trustees members signed a Resolution of Respect, which made commitments to act fairly, treat people with respect and report any bullying to the appropriate authorities.

One of my most outstanding memories as a kid growing up in El Paso was attending El Paso Sun Kings/Sun Dodgers/Diablos baseball games.

I remember first going to the games with my dad when I was about 7-years old and then later, when I got old enough, I'd go to the games by myself with my teenage friends.

I remember Paul Strelzen's booming voice and his mystical green weenie flag sticking out of his rather small press box window. His kazoo whipping the Dudley Field fans into a frenzy as they watched their home teams win a lot more games than they lost.

Now I may not be a connoisseur of fine cuisine but those Diablo dogs with chili and scoop of ice cream in a Major League team's plastic cap rivaled anything Emeril Lagasse could ever conjure up.

For nearly three decades the Diablos organization was named the best in the country or near the best. Owner Jim Paul introduced a P.T. Barnum-like atmosphere of wacky fun and fan participation to minor league baseball

that caught on all over the country.

And yes, Paul even helped a young man from San Diego by the name of Ted Gianoulas gain worldwide stardom by allowing him to perform at Diablos games. Of course you may remember him by his stage name, the San Diego Chicken.

Then the team moved out of the wonderful old ballpark to their new home in northeast El Paso at Cohen Stadium.

And though the new confines were a step in the right direction, things kind of began to go downhill from there.

First the new owners of the team did the unthinkable, they moved the team to Missouri in 2004 and the greatest minor league city in the United States was without baseball for an entire summer.

Then something good – and bad – happened in 2005. Baseball returned to El Paso, but it was a watered-down version of what local fans were used to.

Independent baseball's arrival revived the Diablos but the play on the field can be compared to watching the Texas Longhorns play baseball and then catching a local high school game.

Both are baseball, but there is quite a

difference.

So El Pasoans, though grateful to have some baseball during the summer, have had to settle for an inferior brand of it. And that's hard to do when affiliated baseball ruled here for over 40 years.

Now, there is new turmoil. Seems the Diablos have been going through Los Angeles Dodger-itis and have been having money troubles.

Talk around town is that the Diablos brass is busy trying to find a buyer for the team, which has already cancelled one of its exhibition games.

"The El Paso Diablos are in financial trouble," were the words. With all the tradition and history of this once-proud franchise, I never thought I'd ever hear those words.

For a city of over 800,000 people, and let's be honest everyone knows we really hover around the one million mark, it's unfathomable that the team is in trouble.

It's also unfathomable that El Paso doesn't have Triple-A affiliated baseball.

But in a city that hasn't started the Spaghetti Bowl East project, or done much with the Sportspark complex, and lost Western Playland, haven't built a multi-purpose arena

that many cities much smaller than El Paso already have, and lost minor league hockey and arena-light football... I guess I shouldn't be too surprised.

There was a time that young kids in El Paso had a great family-friendly place they could go to in the evening without fear of danger or manipulation. The Diablos games were a place a young kid could go with his dad or grandfather and learn about the wonderful game of baseball and have fun doing it.

The news that the Diablos are struggling doesn't give me a whole lot of faith for the coming season, but the new owners could play an instrumental role in bring affiliated baseball back to El Paso where it desperately belongs.

We've seen so many things fail in El Paso. Why, we're (UTEP) the only Conference USA member that doesn't even play baseball.

At some point over the last 40 years El Paso decided that this is the place you wanted to be if complacency was your kind of thing.

Well that kind of thinking is for the birds – don't believe me – ask all the talented young people who fly out of here every year the first chance they get.

Mendenhall carries the ball alone

The question posed to the listener was as follows: "Who cares what Rashard Mendenhall thinks?"

Because, as we all know, the only voices worth listening to are those of radio talk-show hosts who like to spend an inordinate amount of time – in some cases, full 15-minute segments of their show – to address the 140-word missives of a Pittsburgh Steelers running back.





DEAR DR. DONOHUE: Will you write about diverticulosis? I was twice hospitalized for it and had to stay there 12 days in all. When I left, they didn't give me any diet or medicines. I saw my primary doctor later, who didn't think I had diverticulosis because they didn't do much for me. Some tell me that you don't have to stay on a diet or take medicine. Is that so? -N.F.

need follow is one with plenty of fiber - 30 to 35 grams a day. Fruits, vegetables and whole grains are fiber sources. Many cereals are filled with fiber: Fiber One, All-Bran, Shredded Wheat and cooked oatmeal are examples. You do not have to take any medicines.

A diverticulum is a tiny pouch formed by the colon lining that has been pushed through the muscular colon wall. Its size varies from 0.2 to 0.4 inches (5 to 10 mm) in diameter, about the size of a small pea. Diverticulosis indicates that the colon has sprouted many diverticula. It's most often silent. Close to one-third of adults at 60 years of age have it. By age 80, two-thirds have it.

DEAR DR. DONOHUE: I will turn 65 shortly. My health is just fine. I am out and active. I do odd jobs like construction and hauling. Some friends want me to see a doctor just for a physical because I haven't been to one in 35 years. Why should I? All is OK with me. Is it true that 80 percent of men don't go to doctors? -C.F.

Diverticulosis is found in countries where grains are refined. Refined grains have lost their outer coat, the bran. Bran was, at one time, the principal source of fiber. Fiber keeps stool soft and easily pushed through the digestive tract. With too little fiber, the colon has to exert great force to move undigested food along. That force is responsible for pushing the colon lining through the colon wall to form a diverticulum on its outer surface.

You're getting on in years. Bad things happen with aging. You don't want to be surprised by a heart attack, a stroke or a cancer that has grown so big that it can't be treated, do you? Those are some of the reasons you should see a doctor. I like your fighting spirit.

When you were hospitalized, you had diverticulitis - inflammation of diverticulum. The neck of diverticula became clogged with bacteria and pieces of hard stool. The diverticula swelled. For mild symptoms, people can be treated at home by going on a liquid diet and taking antibiotics. For more severe involvement, people are hospitalized and fed intravenously and given intravenous antibiotics.

I don't believe that 80 percent of men never see a doctor.



Social Security Q&A

Military need to know

On Memorial Day, it's important to remember those who have made the ultimate sacrifice for our nation. We at Social Security honor the heroism and courage of our military service members and mourn for those who have given their lives in defense of freedom.

It's also important to recognize those service members who are still with us, especially those who have recently been wounded. They've served us; likewise we serve them.

Earnings for active duty military service or active duty training have been covered under Social Security since 1957. Social Security also has covered inactive duty service in the Armed Forces reserves (such as weekend drills) since 1988.

If you served in the military before 1957, you did not pay Social Security taxes, but we gave you special credit for some of your service.

You can get both Social Security benefits and military retirement. Generally, there is no reduction of Social Security benefits because of your military retirement benefits. You'll get your full Social Security benefit based on your earnings.

When you reach age 65, you'll also be eligible for Medicare. If you have health care insurance from the Department of Veterans Affairs (VA) or under the TRICARE or CHAMPVA program, your health benefits may change or end when you become eligible for Medicare. You should contact the VA, the Department of Defense, or a military health benefits advisor for more information.


