The Socorro Independent School District is accepting applications from those interested in serving on the District's 2011 Bond Accountability Committee (BAC). Applications are available on the Socorro ISD Web site, www.sisd.net, and will be accepted through August 5. Applications can also be picked up at the District Service Center, 12440 Rojas Dr. The purpose of the BAC is to ensure and promote communication and accountability surrounding all elements within Bond 2011. It will serve as an independent citizens committee that will report to the Board of Trustees and the general public. The BAC will be comprised of no more than 14 members selected via an open application process; representing a cross section of stakeholders. "The development of Bond 2011 was driven by community input and the completion of projects will follow this established precedence," said Board President Antonio 'Tony' Ayub. "We are looking for active citizens from throughout the District that will help ensure Bond 2011 is implemented as promised to voters. The committee will also play an important role in sharing information regarding Bond 2011 with the community at-large." Each member of the Board of Trustees will appoint two members to the committee upon review of all written applications. Appointments will be for a two (2) year term, which may be extended for additional two (2) year terms upon approval by the appointing

Texas Legislature creates instructional materials allotment for school districts

Recent legislation from the 82nd Texas Legislature, which ended in June, has school districts throughout the state scrambling to make sure they have the needed textbooks and technology resources for students and teachers when classes start next month.

The new legislation creates an allotment for districts for the purchase of instructional materials, technological equipment and technology-related services. This replaces the current adoption process that has the School Board of Education (SBOE) and Texas Education Agency (TEA) overseeing the ordering and receiving of instructional materials, like textbooks, and technology, like computers, separately.

Beginning this school year, the Commissioner of Education will establish an allotment for every district and open-enrollment charter school and determine the amount of the allotment per student each year on the basis of the amount of money available

in the state instructional materials fund to finance the allotment.

According to TEA officials, the instructional materials and disbursements will be requested by districts through the Educational Materials System (EMAT) beginning in August. Districts will request State Board of Education-adopted materials and Commissioner-adopted materials through EMAT, and the instructional materials allotment will be reduced by the value of the requested materials.

Disbursement of funds for instructional materials not on an adopted list, technological equipment and technology-related services will also be requested by a district through EMAT and the instructional materials allotment will be reduced by the amount of the disbursements.

Local school district administrators, however, are saying that the amount per student has not been disclosed, so it is difficult for them to start ordering instructional and technology materials for this school year.

TEA officials said that the amount of the allotment for each district for school years 2011-2012 and 2012-2013 is expected to be

announced soon. Meanwhile, Anita Givens, an associate commissioner for TEA says "Districts need to carefully consider all allowable uses for the district's allotment and prepare to budget the money over the two-year period."

The new legislation also transfers ownership of instructional materials from the state to the local district, and districts must now prioritize their instructional materials decisions to address the assessment and accountability requirements.

"Senate Bill (SB) 6 states that priority must be given to foundation curriculum subjects for which the essential knowledge and skills have been substantially revised and for which assessment instruments are required to satisfy foundation curriculum requirements," stated Givens.

Training on the new procedures started in July for school district administrators, textbook coordinators and other key personnel. "We anticipate offering additional training via TETN (Texas Education Telecommunications Network) during August," stated Givens.

Instructional materials for the visually impaired (braille, large type and audio) will remain the property of the state and will not be counted against a district's IMA, but districts will be responsible for purchasing bilingual/ESL materials with the district's instructional materials allotment.

"The transition from current practice to the new IMA will take time. We are working with publishers, depositories and freight carriers to provide instructional materials for the 2011-2012 school year as quickly as possible," Givens stated.

As for the textbook and technology-related services companies, according to Ray Rivera, a consultant for McMillan McGraw-Hill publishing company, he said that they are prepared to help with products information and training for school districts.

"We are maintaining materials specifically for products on the current adoption list as well as new products currently in review by SBOE, such as the science supplemental programs, which will be implemented this school year."

Texas college students must get meningitis vaccine

As Texas students prepare for college, it's critical they get vaccinated against meningococcal disease – more commonly called bacterial meningitis, says Donald Murphey, MD, a Fort Worth infectious disease specialist and advocate for the Texas Medical Association's (TMA's) *Be Wise – Immunize* vaccine program. "It might just save their life."

A new, stronger state law requires any

college student who lives on or off campus in Texas to get the meningitis vaccine. It applies to students under age 30 who will attend classes on campus.

"We're getting the word out now, because new college students will not be able to attend school if they don't receive the vaccine," says Dr. Murphey.

College students especially are vulnerable to the disease because new students are coming together from different places and share close living quarters. The only other

Not all benefits are widely known

In a nod of acknowledgment to the state of the economy, the Servicemembers Civil Relief Act has extended the length of protection time for foreclosures. You now have nine months from the end of military service, and during that time your property cannot be foreclosed. It's not automatic, however — you have to ask for it. Also, your loan must have been originated before active service to qualify. If you have a VA loan on your home, call 877-827-3702 to talk to a specialist, or go to www.benefits.va.gov and click on Home Loans.

If you have a non-VA loan and it's a subprime, you can refinance it as a VA loan at 100 percent of the property's value.

Here's a benefit that's not widely talked about: If you are permanently and totally disabled, your student loans can be discharged under certain circumstances. If you are not employable due to a service-connected disability, you don't need a doctor to say so.

If the disability is not service-connected but meets the definition

of disability, you'll need a doctor to fill out part of the form. Go to www.ed.gov and put this in the search box: Discharge Application Total and Permanent Disability. You'll find a form by that name. Or call the Disability Discharge Loan Servicing Center at 1-888-303-7818. It's possible that you also could be eligible for a refund of payments made since the date of disability.

To make sure you know all your benefits, go to the Department of Veterans Affairs site at www.va.gov and search for "Federal Benefits for Veterans, Dependents and Survivors." You'll find links to all your benefit topics, including prosthetics, mental health, life insurance, federal jobs, health care and more. Light it up

Hola mi gente. For those who live inside the city of El Paso, dark business streets are not much of a concern. There are very few parts of the city that are left without streetlights, especially business locations.

Well-lit business streets give shoppers a higher degree of confidence when shopping during the nighttime hours. If there were no, or very few, lights illuminating areas where shoppers park, then the crooks would have more confidence of getting away with muggings or worse crimes.

In the areas outside of the city of El Paso, well-lit business areas are not as common. Even though many are within the boundaries of the smaller cities, local budgets don't always allow for installing streetlights where they are needed.

The farther away from El Paso, the darker streets can get, especially when there is no moonlight.

It is fortunate that not all business streets have to rely on municipal funds to install streetlights. One example is Horizon Blvd. north and south of Interstate 10. The responsibility rests with the Texas Department of Transportation to maintain the blvd. from North Loop to the city of Horizon.

Recently, I received a letter from a constituent businessman who owns a barbershop on that strip of Horizon Blvd. between I-10 and North Loop. He wrote that the time was long past due to install the streetlights in that area. He was very correct when he pointed out the fact that businesses there were experiencing a very

high level of activity. That would include time periods during dark evening hours. The darkness also created a very unsafe environment for pedestrians and bicyclists.

My office responded to the business owner's concerns by sending a correspondence to the Texas Department of Transportation Chief Engineer for the El Paso area, Charles Berry. Mr. Berry has always been very quick to respond to our inquiries and needs. This case was no exception.

Last week, I received a reply letter from Mr. Berry informing me that work will begin on the installation of streetlights within weeks and should take no longer than five months to complete.

That is terrific news for the city of Socorro and the citizens who do business on Horizon in that area. Since school bus pickups are designated on that strip, most of the work should be completed by winter making it safer for students. It is less likely that those students will be waiting in dark areas vulnerable to traffic mishaps.

As I suggested before, well-lit streets are not a given in the county areas outside the city of El Paso. Because there is so little extra funding, sometimes it takes action by residents or business people, such as the letter to my office, to be aware that solutions to problems are available.

My office has a responsibility to respond to letters like the one in this article. We do our best to initiate the most reasonable solution possible. Those who ask for or demand changes also have a responsibility: to vote in every election. If we all do our part, the solutions will be easier to implement.



Texas launches mandatory boater education

AUSTIN – A new state law from the recent legislative session will require mandatory boater education for more people in Texas starting Sep. 1, a move supporters say will save lives and make crowded waters safer.

According to a legislative report by the state's Advisory Panel on Boating Safety, the primary cause of boating deaths nationally is drowning, with 543 in 2009, of which 385 were not wearing lifejackets, usually in rough weather or on hazardous water.

Changes to Texas laws targeting boating safety include: mandatory boating safety education certification for anyone born on or after Sept. 1, 1993 to operate a vessel with a motor of more than 15 horsepower or a wind-blown vessel measuring more than 14 feet in length. While all boaters are encouraged to take boating safety education, those born before Sept. 1, 1993, are exempt from required certification.

Previously, only 13- to 17-year olds were required to complete a boating safety course

to operate a vessel without adult supervision. Texas' state-approved boater education course is available as a one-day, classroom training, as a home-study course or as an online course at www.boat-ed.com. The course takes about six hours to complete. Costs range from \$13 for classroom course to about \$25 for the home-study course. Information about boater education, including schedules of upcoming classroom courses, is available at http://www.tpwd.state.tx.us/learning/boater_education/.

Boaters falling under the boater education requirement will be required to carry a valid ID and documentation of having taken and passed a boater education course. Failure to meet the requirements is a Class C misdemeanor, and violators have 90 days to complete a boater education course to have the charges dismissed.

The 82nd Texas Legislature during its regular session clarified the definition of a vessel to encompass such craft as standup paddle craft, kayaks and canoes. In Texas public waters everyone onboard a vessel that measures less than 26-feet in length must have a life jacket available and kids under 13 must wear one.

2011 Property Tax Rates in Town of Horizon City

This notice concerns 2011 property tax rates for the Town of Horizon City. It presents information about three tax rates. Last year's tax rate is the actual rate the taxing unit used to determine property taxes last year. This year's effective tax rate would impose the same total taxes as last year if you compare properties taxed in both years. This year's rollback tax rate is the highest tax rate the taxing unit can set before taxpayers can start tax rollback procedures. In each case these rates are found by dividing the total amount of taxes by the tax base (the total value of taxable property) with adjustments as required by state law. The rates are given per \$100 of property value.

are so similar and so profound? As a Caucasian person I would attest that I share many more common interests with my Hispanic neighbors, as to the issues important to El Paso, than I do with Caucasian people from other areas of America. My voting record certainly reflects those

common, locally rooted interests!

WhenChentewroteofthesacrifices made by our Hispanic military people I was deeply disappointed with his use of this information. While I certainly cannot speak for these heroes past and present, it is my desire to believe their service has

made our nation better was for ALL Americans – not only Hispanics. If there are Hispanic soldiers out there who wish to state otherwise feel free to do so – but I will be heartbroken. As a Caucasian person I desperately want to be personally grateful to you (and your families who often share the sacrifice) for the wonderful opportunities and privileges available in this country that you made possible through your service. Please don't take that away from me by suggesting that Hispanic people fought only for the benefit of other Hispanics. This concept was probably not the intention of the writing, but it sure sounded that way to me.

It should be noted that Japanese-Americans served bravely in World War II even while their families were placed in detention camps. White soldiers died on the battlefields of the Civil War so African-Americans could be freed. Yes, our country has shame in its history regarding discrimination and lack

of opportunity for non-elite groups. But we have somehow managed to continue moving together as a "melting pot" of people from just about everywhere – most of us refused to support discrimination. At any time in our history the majority truly cared about our brothers and sisters regardless of their "group." Nobody knows this better than a combat veteran and his "Band of Brothers" who have faced death on the battlefield while working together to stay alive. I speak of men such as my uncle and my brother; who served in our military for the betterment of ALL Americans.

Let me suggest one method to advance the cause of "One Nation, under God, indivisible, with Liberty, and Justice, for ALL." Let us all write as if we are One Nation, let us all talk as if we are One Nation, and let us all act as if we are One Nation. We owe it to each other.

patient group at a higher risk of contracting meningococcal disease is preschool children, doctors note.

Meningococcal disease is a deadly bacterial infection that spreads through coughing and sneezing, sharing drinks or utensils, and kissing or other person-to-person contact

Symptoms of the disease show up initially as the flu. However, the disease spreads so quickly that about 10 percent of sufferers die from it, often within hours of the onset of symptoms – even if they have begun to receive treatment. The threat is greater in adolescents and young adults. As many as 15 college students die each year from meningitis. Some 1,500 cases of meningococcal disease are diagnosed annually in the United States. Texas had 341 confirmed cases of bacterial meningitis in 2007 (patients of all ages).

The disease also can be devastating to its survivors.

“Otherwise-healthy students can end up in a hospital intensive care unit with severe bloodstream infection and meningitis in a matter of hours,” says Murphey. “I’ve seen patients lose fingers, toes, arms, and legs with this infection in the bloodstream.” Many who recover from meningococcal disease also endure blindness, deafness, or brain or kidney damage.

Jamie Schanbaum suffered similar effects. She contracted the disease in 2008 while attending The University of Texas. She survived but spent more than six months in the hospital. Ultimately she lost her legs and most of her fingers because of the disease.

Two years ago, the Texas Legislature passed the first Jamie Schanbaum Act, requiring new or transfer students planning to live on campus to get a meningococcal vaccine. This year legislators strengthened the law by requiring students who live off campus to be vaccinated as well. The move was prompted by the death of Nicolis Williams in February. Mr. Williams was a Texas A&M student who lived off campus and contracted

the disease. Because he lived off campus, current Texas law did not require him to be vaccinated, and he was unprotected. The new law is named the Jamie Schanbaum and Nicolis Williams Act in honor of Jamie and in memory of Nicolis.

The good news is that meningococcal disease is preventable through vaccination. Doctors believe that as many as four out of five of the adolescents and young adults who contract the infection could have avoided it, had they been vaccinated. The meningococcal vaccine protects against four of the five common strains of the disease.

Patsy Schanbaum, Jamie’s mother, likens the disease to a hurricane: “It comes and does all this damage, and we’re left to clean it up. Few people know the devastating effects of meningitis like our family does. It’s frightening.”

“The best thing anyone can do to avoid contacting meningitis or any other infectious disease is to ensure their vaccinations are up to date,” adds Murphey. health of all Texans.



Your good health By Paul G. Donahue, M.D.

DEAR DR. DONOHUE: My mother is 92 and lives by herself. She's quite independent and does well. A neighbor takes her grocery shopping, and we take her to other places she has to go. She is extremely set in her ways. I offered to have her home air-conditioned. She won't hear of it. She says she's used a fan all her life, and she likes to keep the windows open. I worry about someone her age tolerating heat, and it gets very hot here. Can you provide some arguments that would change her mind? – D.A.

a problem that I am reluctant to talk to the doctor about. It's a rectal itch. I have tried many preparations, but they haven't worked. What would you suggest? – L.F.

Your offer to air-condition your mother's home is a kind gesture and has lots of merit. I'm not about to challenge your mother. She has successfully lived a long life, and I could learn from her. People in the past lived comfortably without air conditioning.

I'll mention a few self-remedies, but if the itch doesn't leave promptly, see a doctor. Too many conditions are responsible for such an itch, and each one has a different treatment. Psoriasis, pinworms, eczema and Bowen's disease are a few of the conditions causing a rectal itch. The doctor isn't going to faint when you mention this problem. It's a very common complaint.

Your mother does have to be on guard for dehydration and heat sickness.

Make a couple of diet changes. Stop taking anything that has caffeine. The same goes for citrus fruits, tomatoes and chocolate. If these are the culprits, two weeks away from them should break the itch.

During hot summers, everyone has to stay well hydrated. Older people's sense of thirst is not as reliable an indicator of fluid needs as is younger people's thirst sense. She should sip water all day long, or she can choose any beverage she likes, including tea. Cooled drinks help keep the body cooled.

Use moist cotton balls in place of toilet paper. Or you can use commercial products like Tucks.

Evaporation is the chief means the body has for staying cool. Not only is an older person's thirst sensation blunted, but so is the ability to sweat. Evaporation of sweat cools the body. I don't mean visible sweat; the sweating I mean is imperceptible but constant. Her fan helps evaporate that imperceptible sweat. However, with a reduced capacity to sweat, older people are at greater risk of suffering from a heat injury.

Take an antihistamine before going to bed. Itching usually worsens at night.

Increased body heat increases the body's need for oxygen, and that stresses the heart.

Those are enough home remedies.

On very hot days, how about inviting your mother over to your house until the hot spell breaks?

DEAR DR. DONOHUE: What is *Proteus mirabilis*, and how does it affect a person? And how is it treated? – P.P.

DEAR DR. DONOHUE: I have

Proteus mirabilis is the name of a bacterium, a germ. It's often implicated in urinary tract infections, but it can cause infections elsewhere, too. Antibiotics eliminate it.



Social Security Q&A By Ray Vigil

Q: What is the benefit amount a spouse may be entitled to receive?

A: If you are eligible for both your own retirement benefit and for benefits as a spouse, we will always pay you benefits based on your record first. If your benefit as a spouse is higher than your retirement benefit, you will receive a combination of benefits equaling the higher spouse's benefits. A spouse generally receives one-half of the retired worker's full benefit unless the spouse begins collecting benefits before full retirement age. If the spouse begins collecting benefits before full retirement age, the amount of the spouse's benefit is reduced by a percentage based on the number of months before he or she reaches full retirement age. For example, based on the full retirement age of 66, if a spouse begins collecting benefits:

- At age 65, the benefit amount would be about 46 percent of the retired worker's full benefit;
- At age 64, it would be about 42 percent;
- At age 63, 37.5 percent; and
- At age 62, 35 percent.

However, if a spouse is taking care of a child who is either under age 16 or disabled and receives Social Security benefits on the same record, a spouse will get full

benefits, regardless of age. Learn more by reading our Retirement publication at www.socialsecurity.gov/pubs/10035.html.

Q: I'm thinking about getting disability insurance from a private company. If I become disabled and have a private policy, would it reduce my Social Security disability benefit?

A: No. Your eligibility for Social Security disability benefits is not affected by any private insurance you may have. But workers' compensation and certain other public disability payments may affect your Social Security benefit. You also should ask the company providing your disability protection what effect Social Security will have on the benefits they provide. 
