Wreaths Across America

Fort Bliss ceremonial units will participate in the Wreaths Across America Dedication Ceremony at the Fort Bliss National Cemetery, 9:45 a.m., Dec. 10. These units include the Team Bliss Color Guard, Ceremonial Rifle Team and a bugler from the 1st Armored Division Band. Wreaths Across America is a national effort to Remember, Honor and Teach about sacrifices by our veterans. In December 2010, over 500 participating locations hosted Wreaths Across America ceremonies overseeing the placement of 32,553 wreaths on the headstones of those who served and sacrificed for our freedoms. This year there are over 800 participating locations. The El Paso Composite Squadron, Civil Air Patrol, hosts the event at the Fort Bliss National Cemetery. Last year's event yielded over 4,000 wreaths upon headstones at FBNC. Organizers hope to receive enough donations to place at least 6,000 wreaths this year. Food Pantry opens doors in Anthony

About 150 upper valley families received a helping hand in providing food for their families recently as Anthony Texas Police Department (ATPD) teamed up with local businesses and organizations to open its newly constructed Food Pantry facility.

On a recent brisk November morning ATPD personnel, along with members of the United Methodist Church of Anthony, distributed food items to residents from throughout the upper valley including families from El Paso, TX and Dona Ana, NM counties to inaugurate its new food pantry program. Families received staples including rice, beans, milk, cereal, juice, and fresh tomatoes.

"Since July, when we started work on the building, we also started our fund-raising activities with the goal of becoming a partner with the West Texas Food Bank. Through this partnership, we are able to purchase food items at reduced prices," ATPD Chief Edward Miranda.

Anthony Guzman, partner relations officer for the West Texas Food Bank (WTFB), said that the El Paso food bank has about 100 partnerships established throughout the region to address hunger in the local communities.

"The face of hunger is no longer just among homeless or transient persons, it is also among working families who are struggling to pay their bills and buy food," said Guzman. He added that data shows that one in four El Paso area families qualify for some type of food assistance.

WTFB depends on state and national organizations, like Feeding America Hunger Relief, for its food stuff inventory. WTFB also has food distribution branches in Odessa and Alpine.

"We applaud Anthony's police department

Host a party for veterans

If you're in a veterans service organization, you still have time to organize a holiday party for patients in the closest Veterans Affairs medical center.

You'll need food, a few small gifts... and your ear. You see, it's your presence that will be most appreciated. Patients in our VA hospitals don't always get visitors. Some don't get any at all, especially the young ones whose families are clear across the country.

Here's a plan you can use. Modify it to suit your group's circumstances:

Call Volunteer Services at the medical center and tell them your group would like to have a Christmas party for one of the wards. Set a date and time. Lunch is ideal.

Verify that pizza or small sandwiches would be OK for the patients. Order the pizzas or sandwiches to be delivered from a nearby restaurant or deli, as well as drinks. Ask about using a large room that will accommodate everyone at tables with chairs. Gather up a CD player and holiday CDs for

music.

Ask what types of small gifts would be appropriate for the ward you'll be visiting. (Each will likely have different rules). Your gift list can include:

- Pens and stationery;
- Candy (ask if sugar-free is necessary) in sandwich bags;
- Military caps (by branch);
- Small handheld games;
- Puzzle books, with mechanical pencils (saving nurses from having to sharpen pencils); and
- A card signed by all your members.

All of these items in wrapped individual boxes (don't forget the bow!) will be much appreciated.

But it's the time you spend with each patient that they'll remember the most. No matter what your age or term of military service, you have something in common: You served. That alone will get conversations started.

Redistricting should bring better representation

Hola, mi gente. A very important issue that was addressed in the legislature this past session was redistricting. The House of Representatives and the Senate approved new boundaries for their districts. Many of those districts were contested several groups.

Redistricting is not an easy task. On the one side, political interests come into play. On the other side, certain racial or communities of interest come into play. The basis for the contests that were filed alleged that the maps were drawn in the interest of one political party at the expense of the voting rights of minorities.

The courts and the Department of Justice have been reviewing maps and testimony for several months. The federal court hearing the arguments determined that the conflicts were too extensive for a judgment at this time. In other words, after additional months of testimony and submissions of evidence, the court will be in a better position to rule on the legal arguments.

Last week, the court issued recommended interim maps that, if approved, would contain the boundaries for the primary and general election in 2012. Although it was my

feeling that the boundaries in El Paso would be unaltered, the court did find cause to amend the boundaries between districts 77 and 78 – districts in central and west El Paso County.

The El Paso delegation unanimously, and in the interest of continued harmony, approved five district boundaries that were desired by each member. The court altered the original maps in such a way as to make it more difficult for the incumbent in district 78. The changes were based on a balance of minority voters in both district 77 and 78.

In the same process, the districts in other counties were also changed. Apparently the judges had reason to believe that specific boundaries violated the rights of Hispanic communities of interest to elect a candidate of their choice based on shared values.

If the recommended interim boundaries remain, many experts believe that the current imbalance in the House membership, 101 Republicans and 49 Democrats, could be reduced immediately with complete parity after subsequent election cycles.

The process is of course necessary because of court cases in several

states where judgments decreed voting rights violations. There are concerns that several steps in the last session may result in Hispanic voters finding their right to vote impeded.

Whatever the outcome of the court cases and the reviews by the Department of Justice, the 2012 elections are being impacted.

Already, the filing period for candidates has been reduced partly because of the redistricting and also because the final filing day was changed to an earlier date. The El Paso County Elections Department has found it difficult to finalize voting precincts with all of the changes that have occurred in the past 6 months.

At one point, the Elections Director, Javier Chacon, presented to the Commissioners a map of voting precincts that culminated many, many hours of work by his staff. Now the interim maps have created the need for even more changes.

We should be very appreciative of the director and his staff for their hard work in service to El Paso voters.

for recognizing the need and doing something about it,” Guzman said about the new food pantry program.

Anthony's new facility is located in the back of the ATPD and town hall premises (601 Wildcat Drive). It was built and financed largely through the ATPD officers' fund-raising efforts. They were instrumental in procuring monetary and materials donations for the building's construction, according to Miranda.

Businesses assisting with the construction project were Jobe Concrete, Zia Homes, 84 Lumber, Commercial Roofing Systems, Foxworth-Gailbraith, and Villareal and Sons Electric Co. Gary Porras, of Garrick Electric Co., helped supervise the work.

The police chief said that plans are to coordinate with community organizations like the local Methodist church to maintain the food pantry program. Also helping stock the pantry are: Sierra Providence Teen Center of Anthony, St. Patrick's Cathedral of El Paso, St. Patrick's Church of Canutillo, Westside Custom Classic' Car Club, Anthony Rotary Club, L and F Distributors, Denny's Restaurant in

Anthony, Osh Kosh, Carters, Lowe's Home Improvement (Westside), and National Truck Stop of Vado, NM.

“With the help of folks like these donors, we hope to hold a community-wide food distribution event at least once a month,” stated Chief Miranda. “However, if a family needs immediate assistance we will be available to do that too.”

The police chief said that there is no income requirement, only address, family member count, and estimated income to be eligible to receive food

items from the pantry. “No one will be refused, no matter what size the family is,” Miranda said.

Rev. Francisco Escalera, pastor of the United Methodist Church of Anthony, said that they are honored to join with the police department in helping feed the struggling families in their communities.

“I believe there are many families in the area who need help especially among the unemployed and our senior citizens who are surviving on a fixed income,” said Escalera.



Texas’ private sector continued to grow in October, adding 13,500 jobs. Texas’ total non-farm employment has expanded by 231,600 jobs over the year to reach an estimated 10,616,500 positions in October. Overall, Texas added 2,500 jobs over the month. Texas has experienced positive annual job growth in the past 18 months with annual growth rates above 2.0 percent for the last five consecutive months. Texas’ seasonally adjusted unemployment rate was 8.4 percent in October, down slightly from 8.5 percent in September, and remains below the national unemployment rate of 9.0 percent.

Wanted

Victor Eduardo Ortega, 22, who also uses Victor Lopez, is this week’s Manhunt Monday Most Wanted for a violent assault and robbery that took place in East El Paso County on October 9, 2011. Ortega is 5’3” tall and weighs 206 pounds. He has black hair and brown eyes. Deputies were called to a home in Sparks where a male victim told authorities that just minutes earlier, he heard noises coming from the front of his home where his truck was parked. He proceeded

to exit his home and discovered that a power generator (\$2,000 value) had been taken from his pick-up truck. He got into his vehicle and drove around in an attempt to locate the suspect(s). While driving, he spotted his power generator in the back of a Toyota pick-up truck. He approached three male subjects who were standing next to the truck to ask about the generator. A confrontation ensued where the thieves proceeded to violently assault the him, taking his cell phone, wallet and his pickup truck. He went to a nearby residence to call 911. He suffered serious but non-life threatening injuries. Ortega knows he is wanted and is now on the run eluding capture. It is believed he remains in El Paso County, hiding with friends or relatives. It's going to get worse

Joe Posnanski is at Penn State. Not only is he at Penn State, the former Kansas City sportswriter has lived there for the past year for the purpose of writing the definitive biography of Joe Paterno. The Sports Illustrated ace columnist has received a \$750,000 advance for the book, which is supposed to hit shelves by next Father's Day.

After Paterno's firing, apparently

saddened that his book would no longer have a fairytale ending, Posnanski vented during a lecture on held on campus, a class (and I'm not kidding) called "Joe Paterno: Communications and the Media." While Posnanski has gone on record saying he felt Paterno should have been fired, he felt it was done in a classless manner (via messenger) and that the media was to blame.

A student in the class tweeted his remarks. The rush to judgment here has been extraordinary, Posnanski said, and that lack of official statements mean journalists are going to have to guess. said about that in the horrifying and stomach-turning grand jury findings. People have jumped to many conclusions about Paterno's role and his negligence, and they might be right. I'll say it again: They might be right. But they might be wrong, too. And I'm writing a book about the man. I can't live in that world of maybes."

Well, whatever world you're living in, Joe, it certainly doesn't have many journalists. Is it a reporter's fault because they're being stonewalled by officials who are trying to cover up crimes? This is the first time there's been a 24-hour news cycle? Not the days when a newspaper would put out a morning, afternoon and late final edition? Reporters never tried to scoop one another in that world of "maybes" you write of? You say you don't know all of those things you listed about Paterno, and you're writing a big-shot book on the man!

Here's the \$750,000 question then, Joe: with all of that access... why don't you ask them yourself?

Posnanski and other Paterno apologists decry "the rush to judgment." Sandusky is in no rush. On the news show "Rock Center," it took him nearly 18 seconds to answer Bob Costas's question as to whether he was sexually attracted to young boys. So don't throw the reporters under the bus when they do what law enforcement was supposed to have done more than 15 years ago... get the facts, and then nail those responsible to the wall.

This isn't a world of maybes, it's a fact: It's going to get worse.



Your good health By Paul G. Donahue, M.D.

DEAR DR. DONOHUE: I had my annual PSA test, and it came back 3.5 ng/ml. My doctor said anything below 4 is good. My past scores have never exceeded 0.5. I am concerned with the rate of increase from last year. Need I be? Should I get checked in six months to ease my mind? – B.B.

DEAR DR. DONOHUE: My son had surgery for diverticulitis and was discharged from the hospital two days later. He had to return to the hospital because of terrible stomach pain. The doctor did a second surgery and submitted material to the lab. The report came back that he had C. diff. I would appreciate so much any information on this. – M.M.

PSA (prostate-specific antigen) is a blood test used for the detection of prostate cancer. It's far from being a perfect test, but it is the only one we have. Not only is the test imperfect, but experts disagree on how the test numbers should be interpreted.

Many insist that a man's age should define what the normal range for it is. The younger the man, the lower should be the acceptable PSA.

Results from large studies yield conflicting information. One study suggests that a PSA of 2.5 ng/ml ought to prompt additional testing, such as a prostate biopsy. Another large study uses 4 as the cutoff for ordering more investigation. And a third sets the upper limit of normal at 3.5.

PSA velocity is another factor that enters into interpreting the test. If the PSA value increases in one year by 0.75 or more, then the possibility of cancer exists and further testing is suggested – a biopsy. Your value increased many times that number. I believe you need to have that checked out soon. In fact, if a man has a PSA value of less than 4 on previous tests, and his PSA has increased by 0.35 in one year, that man should be advised to have a biopsy.

C. difficile (diff-uh-SEAL) is a bacterium. It can be acquired anywhere, but most often in the hospital. In the digestive tract, it is a distinct minority. However, antibiotics can kill off the normal bacteria in the tract and the C. difficile bacterium then experiences explosive growth. That can cause minor intestinal problems to major intestinal catastrophes with voluminous diarrhea and fierce pain. All of this is due to toxins (poisons) produced by this germ.

Stopping antibiotics is the first line of treatment. If that doesn't bring relief, then the antibiotic metronidazole often cures patients. Should metronidazole fail, the antibiotic vancomycin is a trusted standby. Sometimes attempts to re-establish a normal bacterial population for the colon are successful in ending the problem.

Social Security Q&A By Ray Vigil

If it's not .gov, it's not Social Security

When you go on a road trip, you need to follow the signs to arrive at the right place. Going online can be very much the same. Look for the “.gov” at the end of the web address – if it isn't .gov, it isn't the real Social Security website – www.socialsecurity.gov.

Countless consumers nationwide are victimized each year by misleading advertisers who use “Social Security” or “Medicare” to entice the public to use their services. In many cases, these companies offer Social Security services for a fee, even though the same services are available directly from Social Security, free of charge. These services include:

- Updating a Social Security card to show a bride's married name;
- Replacing a Social Security card; and
- Getting a Social Security number for a child.

These for-profit businesses may cleverly design their websites, so when people use Internet search engines, their advertisement pops up. They may even make their advertisement look similar to the real Social Security website. And some of these sites, at first glance, appear to be affiliated with Social Security. But upon closer examination, these are for-profit companies charging

individuals for a service that is provided free by Social Security.

For instance, a quick Google search on “replacing a Social Security card” brings up paid advertisements for websites that charge a fee just to get an application for a new card. That service is absolutely free from Social Security.

The law that deals specifically with misleading Social Security and Medicare advertising prohibits people or non-government organizations, like for-profit businesses, from using words or emblems that mislead others. Their advertising cannot lead people to believe that they represent or are somehow affiliated with or endorsed or approved by Social Security or the Centers for Medicare & Medicaid Services (Medicare). But that doesn't stop advertisers from trying.



Prepare to use only ONE word from any marked (♥) letter string as each unscrambles into more than one word (ex. ♥RATHE becomes HATER or EARTH or HEART). Fit each string's word either across or down to knot all twelve strings together.
