## Anthony's festival unites TX-NM communities

Sunny skies and a warm breeze greeted fun-seekers to the First Annual Family Sports Festival sponsored by the two towns of Anthony (Texas and New Mexico) this past weekend.

The two-day sports festival was coordinated by the mayors of the two Anthony municipalities and provided an afternoon of music, games and food at the Anthony Texas Municipal Park, which lies between the adjacent towns.

The Texas community was incorporated as the Town of Anthony in 1952. Anthony NM was incorporated in 2010. The two towns have evolved from farming settlements into small industrial and commercial centers serving as bedroom communities for the cities of Las Cruces NM and El Paso


TX. Today, the Texas side has about 4,400 residents, and New Mexico's side has approximately 9,360 residents.

The mayors joined efforts to bring their communities together through a variety of park activities including a senior dance-a-thon, Zumba dancing, a car show, lucha libre, amusement rides, and competitive tournaments in softball, soccer, volleyball, and skateboarding.

Musical entertainment was provided by different musical groups including the Crosstown Trio, Los Survivorz Band, Lozano Brothers, Animo, Evolution, and Rodhuiz.

"We're hoping this festival becomes a big event every year," said Anthony TX Mayor Art Franco, who has been in office for over 18 years. "We also want to show off our community – not

## North Loop project to ease traffic in rush hour

During the morning and afternoon rush hours on North Loop between Loop 375 and Horizon Blvd., commuters have experienced traffic backups several blocks long. After more than a decade of waiting, the City of Socorro is finally getting the much needed face lift on North Loop.

Commuters along North Loop may have noticed a second set of telephone poles being laid behind existing poles. The space between

the poles is the area that will eventually be the expanded road after the completion of a project that was planned years ago.

The project is a continuation of road improvements on North Loop that began in the early 1990s. The section of the road inside the City of El Paso was completed years ago. It was only this stretch of North Loop inside Socorro that was slow to be completed.

Former State Representative Chente Quintanilla recognized the problem from the beginning of his term. "In 2003, I began asking for the project in Socorro to be started," said

Quintanilla. "Since the mid 90s, the improvements seemed to be stuck in administrative procedures."

The project is managed by the El Paso Metropolitan Planning Organization (MPO), a federally authorized organization made up of local elected officials responsible for transportation management. As a state rep, Quintanilla was a member. Elected officials from the City of Socorro were also members.

The project that was approved years back calls for the widening of North Loop to six lanes. In order to do so, the MPO was

required to go through several steps including environmental assessments, utility placements and the acquisition of property from private individuals.

According to an MPO planning document, the total cost of the project is \$28,500,000. Quintanilla was displeased that funding for the project was regularly appropriated to other projects inside the city of El Paso.

"While it took almost twenty years to get to Socorro, projects for the UTEP ramps and the Fort Bliss Spur were completed in record time," said Quintanilla. "While commuters in Socorro battled bumper to bumper traffic, football fans going to UTEP games were given a higher priority. I let the MPO leadership know I was not happy about that," said Quintanilla.

The detailed plans for the project were finally completed in August of 2008. The biggest hurdle, obtaining the property for the road right of way, was completed in February of 2012. The project was official put out to bid later that year.

The City of Socorro stands to gain significantly from having the project finished. Socorro's Public Information Officer David Garcia said, "We are so excited that this plan is finally coming through. This means easier traffic flow and is actually part of our master plan to improve the traffic flow in Socorro."

With the completion of this project, other important road projects such as the widening of Horizon Blvd. from North Loop to Socorro Road can be prioritized.

*Clinical trials for Alzheimer's*

If you're a Vietnam veteran, the Alzheimer's Disease Cooperative Study might need your help. It's been doing a clinical trial about Alzheimer's disease in Vietnam veterans who have traumatic brain injury (TBI) or post traumatic stress disorder (PTSD), with or without any symptoms of Alzheimer's.

The purpose of the study is to learn how previous injuries affect veterans as they age, which will add to the information needed to help those injured in Afghanistan and Iraq. Researchers will be able to identify veterans who are at increased risk for Alzheimer's disease, and create preventive treatments. It sounds very worthwhile.

The study, called Brain Aging in Vietnam War Veterans by the Alzheimer's Disease Neuroimaging Initiative, will take place at ADNI locations at 19 universities and research centers in 11 states.

During the clinical trial, researchers will study changes in the brain scans, cognitive tests and cerebrospinal fluid. Three separate groups will be studied: Vietnam veterans with TBI but without PTSD, and having mild

cognitive impairment; Vietnam veterans with PTSD but no TBI or cognitive impairment; and control-group Vietnam veterans with no TBI or PTSD who are comparable in age.

Basic criteria:

- Men and women 50 to 90 years of age.
- Must live within 150 miles of testing site.
- If receiving VA disability payments, they must be for something other than TBI or PTSD, or no disability at all.
- There are specific criteria for TBI and PTSD, as well as medical condition exclusions, so refer to the information at [www.clinicaltrials.gov](http://www.clinicaltrials.gov) (see trial identifier NCT01687153).

**Before you rent, do your homework**

Maybe you're a college student looking to rent your first apartment; or a downsizing homeowner reentering the rental market for the first time in decades. Whatever your situation, there are many precautions you should take before renting any property. The last thing you want is to be saddled with a 12-month lease you can't afford or to be stuck in a neighborhood you've come to detest.

As one who's been there, let me share a few tips for renting a home:

- Before you even start looking, know how much you can afford to spend. Housing is the biggest monthly expense for most people so if you miscalculate what rent is affordable, your budget will suffer from the get-go. Besides rent, don't forget such additional expenses as a security deposit, utilities, cable/satellite, Internet access, renters insurance, parking and laundry facilities and one-time move-in expenses like window treatments, appliances or rugs.

- Scope out the neighborhood. Determine how safe you feel walking around, especially if you'll be parking on the street. Come back to see if the neighborhood's character changes at night or on the weekend. Also note the proximity to parks, schools, grocery stores, public transportation and busy commuter routes.

Thoroughly inspect each potential rental:

- Consider total useable space – sometimes a smaller unit with a well-designed floor plan is more desirable than a larger space with a poor layout.

- Use a tape measure to measure each room to determine whether your furniture will fit. Ensure there's sufficient closet, cupboard and storage space.

- Look for safety features like deadbolts and peepholes on exterior doors, well-lit corridors, stairwells and parking structures, smoke detectors, fire extinguishers and bars or other security features on first-floor windows.

- In multi-unit buildings, note the condition of common areas – that's a clue how attentive the owner/

manager is regarding upkeep.

- Note the condition of appliances, plumbing fixtures, floors/carpeting, electrical outlets and switches, light fixtures, walls and windows. If you spot damaged or worn items, ask whether they'll be replaced. If not, make sure they're noted in the rental agreement.

- Check the water pressure and hot water quality.

- Check seals around doors, windows and vents; if leaky, they can boost utility bills.

- Look for evidence of previous water leaks and mold.

- Check for soundproofing, especially if there are adjoining apartments.

Once you find a suitable place, read the rental agreement carefully. Don't hesitate to ask a lawyer or more experienced friend to review it. If not spelled out in the lease you may want to ask the landlord:

- How much is the security deposit and what are the requirements for getting a full refund?

- How are rent increases determined?

- What happens after the lease term ends? Often, it'll convert to a month-to-month rental agreement where you can leave anytime with proper notice (usually 30 days).

- How many tenants are allowed?

- What are building policies for things like houseguests, noise curfews, maintenance and repairs, pest control, smoking, lost keys and pets?

- Can you sublet the unit before your lease expires?

And finally, be aware that many landlords check credit reports of potential tenants. Before you start looking, check your own credit report so there are no surprises. You can order one free report per year from each of the three major credit bureaus – Equifax, Experian and TransUnion. (Order through [www.annualcreditreport.com](http://www.annualcreditreport.com); otherwise you'll pay a small fee.)

**Canutillo ISD takes stance on bills**

CANUTILLO – The Canutillo Independent School District Board of Trustees recently approved separate resolutions that outline the District's position on two new proposed laws that impact education in Texas: House Bill 179 on the recall of school-board members, and

House Bill 2004 on the assessment of Limited English Proficient (LEP) students new to the country.

The Board unanimously voted in favor of issuing a resolution urging Texas lawmakers to expand HB 179 to include all state elected officials who are susceptible to recall elections. The current version of the bill targets school-board members only.

“The effort to create legislation

to provide for a review and recall process of elected officials should apply to all elected officials and not be selectively proposed or implemented to relive certain officials from equal scrutiny by voters within their jurisdiction,” the resolution reads. “Legislation providing new rights to voters should be fair, unbiased and apply equally to all elected representatives.”

Trustees also voted unanimously to support HB 2004, which would establish a minimum enrollment of three years before state assessment requirements become valid for students in certain subgroups, like those who do not speak English because they have only recently moved into the state from a foreign country.

The passage of HB 2004 “would provide a framework to address and account for certain demographic differences between LEP student populations and other student populations for the purpose of testing and accountability measures,” trustees said in their resolution. The Board “supports the passage... and respectfully requests that the Legislature consider, evaluate and pass it as originally drafted.”

Board President Armando Rodriguez recently traveled to Austin to meet with legislators and plans to be in further contact with them to further stress the District's stance on these bills and other proposed legislation affecting public schools.






# Socorro leaders gear up for celebration

The community of Socorro joined the United States of America after the United States was victorious in the Mexican-American War (1846-1848). To commemorate the 165th anniversary of this event, the City of Socorro will hold the biggest fiesta in East El Paso County.

Socorro will celebrate the Fiesta del Valle to celebrate the event during the Cinco de Mayo

weekend over May 4, 5, and 6. According to David Garcia, Socorro's Public Information Officer, the event will be very special. "The event will outshine other traditional events that are held to celebrate Cinco de Mayo," Garcia said.

In February of 2012, the city council recognized that a significant anniversary was to occur in 2013. The council members agreed that a special event was needed to celebrate the anniversary.

"What makes the event even more special is that we are having the Fiesta del Valle in

Bulldog Championship Park," said Garcia. "The fiesta not only celebrates the anniversary but also celebrates the growth of the city, the families and the students who make it such a special community." The park was dedicated in honor of the Socorro High School baseball team that won the high school state championship in 2011.

Friday night will focus on the students. The fiesta will begin after school hours and will end at the curfew hour as required by law for minors. There will be dance-offs, band competitions, and a fireworks display just

before curfew.

On Saturday, the Fiesta will begin at 10 a.m. with a full assortment of entertainment for families to enjoy. The parking lot at the park will be closed to vehicles so that the vendors and booths can occupy that space. Garcia said that 20 booths have been authorized to serve those in attendance. There may be additional booths available now, and those who are first to request the final spaces will fill the remaining booths.

The festivities on Saturday will also end with fireworks.

On Sunday, a special guest – the Counsel General of Mexico – will be in attendance. There will be a combination of Jazz early on Sunday with Mexican music closing the Fiesta that night.

"The people in the area love to party," said Garcia. "When you have a great place to party, a community that loves to party, all you need is the reason to party. The 165th anniversary of Socorro is the special reason for the party."

Free parking will be provided at the Community Centers located on Moon Road and Old Hueco Tanks Road; and, the center on Rio Vista. There will be free shuttles to the Fiesta operating each day.

The City of Socorro will be announcing more details and all of the participating bands soon.

"The city is proud to hold perhaps the largest fireworks display in the county and the largest Cinco de Mayo fiesta in East El Paso County," said Garcia. "We are also proud that our fiesta celebrates the 165th Anniversary, our families and our relationship with Mexico."

into their companies and grow their business – all of which are good for Texans and our growing economy.” Perry’s plan would reduce business taxes by:

- Reducing the franchise tax rates by 5%;
- Providing a \$1 million deduction for businesses with revenue up to \$20 million;

- Lowering the rate for EZ Form filers; and
- Giving companies relocating to Texas from out of state a one-time deduction of moving expenses in the first year they pay the franchise tax.

Perry’s business tax relief plan would also have the effect of making permanent the current small business tax exemption. That exemption currently impacts 29,000 businesses and is set to expire in 2014. “Business

is the economic engine of our state and Gov. Perry’s plan will only serve to fuel that engine,” Association of Business President Bill Hammond said. “Government doesn’t create prosperity, business does. By reducing the tax burden on Texas businesses, businesses will keep hiring more workers, reinvesting in their companies and driving the economic success of our state.”

## Canutillo ISD meeting focuses on corrective action, superintendent search

Canutillo Independent School District’s (CISD) implementation of Texas Education Agency’s (TEA) corrective action plan and its search for a new superintendent are progressing steadily but cautiously, said district officials during a town hall meeting held recently.

CISD Board of Trustees President Armando Rodriguez and interim Superintendent Annette Brigham shared information and fielded questions for nearly two and a half hours about the district’s current TEA audit situation and its search for a new superintendent during the Saturday morning meeting held in the Canutillo High School cafeteria.

The pair stood before an audience of 30 persons and spoke frankly about the recent TEA audit that reported Canutillo High School’s scheme to manipulate course credits of limited English speaking students.

According to the TEA audit, Limited English Proficiency students and new students from Mexico were intentionally held back in ninth grade or promoted to the eleventh grade in order to prevent them from taking the tenth grade standardized tests during the 2010-11 school year.

Brigham said that even before TEA began its audit, the district was proactive and had implemented months ago a corrective plan of action that essentially is the same one TEA sanctioned.

The interim superintendent said that the plan establishes procedures for awarding credits; credit recovery; graduation plans; foreign credit review and testing. It also includes a contract with Region 19 and Region 20 education service centers to create regulations for awarding credits and testing students, she said.

“As the district has been growing, our policies and procedures were not being kept up with the growth,” Brigham related.

As for the superintendent search, Rodriguez said that the CISD board is considering two local area administrators and one from the Round Rock school district as its finalists and that the board expects to name its next superintendent in May.

The district has been without a superintendent since December when former Superintendent Damon Murphy resigned. Murphy had been linked to the El Paso Independent School District’s (EPISD) cheating scandal and later to cheating accusations at Canutillo.

The three finalists for CISD’s top job include Pedro Galaviz, the current director of secondary education at Round Rock Independent School District; Ricardo Lopez, current area superintendent at Ysleta Independent School District and former Del Valle High School principal; and James Steinhauer, current assistant superintendent for research and evaluation for EPISD.

CISD’s superintendent opening elicited 72 applicants. The list was narrowed down to 12 candidates by the search agency hired by the district. Of these, the board chose six to interview personally.

“We interviewed six candidates and all of them were highly qualified for the job, but we thought the best were these three,” said Rodriguez.

During the town meeting, some of the concerns regarding the superintendent search that were mentioned by audience members revolved around the board’s selection process.


Lilia Martinez, a Canutillo community member who attended the meeting, said that she was concerned about the board’s process for selecting the finalists. “I am not comfortable with the selection of the three superintendent finalists,” Martinez said.

Martinez pointed out that CISD Trustee Leticia Gonzalez works as an executive assistant for Steinhauer in

EPISD's research and evaluation department. "If she participated in the selection of these three finalists, then I believe there is a conflict of interest."

Martinez added that Steinhauser is mentioned six different times in the recently released EPISD cheating scandal audit. "That does not exude a vote of confidence from the community," she said.

Lily Maldonado, a district resident and employee, said, "I just wish the board had given the community more choices than just the three finalists that they have selected for us."

In the coming weeks, board members, with community input, will be trying to determine which one is best equipped to move the district forward. Each candidate is tentatively scheduled to spend a day in the district to hold meetings with stakeholders including faculty, staff, parents, residents, and students, as well as go through another interview with board members.

Steinhauser is scheduled to be in the district Thursday, April 18; Lopez will visit the district Monday, April 29; and Galaviz will hold his meetings Tuesday, April 30. The meetings start at 5:30 at Canutillo High School. A complete schedule of the visits will be posted on the district's website according to CISD spokesperson Gustavo Reveles Acosta.

# What Texans should know about providing their Social Security number

According to the federal trade Commission, Texas ranks fifth in the nation for identity theft complaints. In 2011, more than 24,000 Texans were identity theft victims and as a result, lost thousands of dollars and hours of time attempting to correct their credit ratings and personal financial history.

Identity theft occurs when a criminal illegally uses someone else's personal information – a name, address, driver's license number, credit or debit card account number or Social Security number – to commit fraud or other crimes.

Fortunately, increased identity theft awareness has made Texans much more cautious about freely providing their personal information. One particularly sensitive part of a person's identity is his or her Social Security number (SSN). Many Texans call the Office of the Attorney General (OAG) to ask when and where they are required to give out their SSN.

One of our most commonly received questions on this subject is, "Can a private business ask for my Social Security number?" Generally, the answer is yes. The law does not

prohibit a business from asking for a person's SSN; however, the customer has options and does not have to provide that information.

Texans are not legally required to provide their SSN to private businesses unless the transaction is one which triggers mandatory Internal Revenue Service notification. Texans should be aware, though, that businesses can refuse to provide products or services to customers who fail to provide their SSN.

If a business insists that customers provide their SSN and customers feel this is not justified, customers may want to ask for a supervisor or manager to discuss the situation. If the company is unwilling to budge, Texans may want to consider taking their business elsewhere.

Be aware that while federal law does not forbid a business from asking for a person's SSN, it does mandate that the business protect any numbers it collects. People who

provide their SSN to a private business should familiarize themselves with the company's privacy policy.

Texas law also requires that businesses safeguard their clients' sensitive personal information, including names, addresses, financial information and SSNs. The OAG has charged several commercial vendors with unlawfully failing to protect such information.

Many Texans also inquire about government agencies and whether they have the right to ask for a person's SSN. Federal law does compel government agencies to ask for a SSN in certain instances.

For example, certain government agencies, including taxing authorities, human resource offices and departments of motor vehicles, can require a SSN as mandated by federal law.

Federal law does provide protections when citizens are required to divulge their SSN. The Privacy Act of 1974

requires that all government agencies that request Social Security numbers provide a disclosure statement on the form. The statement explains whether citizens are required to provide their SSN or if it is optional. Additionally, the document details how a person's SSN will be used.

The Office of Information and Regulatory Affairs in the U. S. Office of Management and Budget provides guidance and oversight regarding the Privacy Act of 1974. Interested Texans may read the Act on the U.S. Department of Justice website at [www.usdoj.gov](http://www.usdoj.gov).

The Privacy Act also provides that citizens cannot be denied government benefits or services if they refuse to disclose their SSN – if the disclosure is not required by federal law or if the disclosure is to an agency which has been using SSNs prior to January 1975.

Texans who are asked to give their SSN to a government agency but do not receive a disclosure statement may want to cite the Privacy Act and contact their U.S. congressmen or senators.

**Social Security Number Points to Remember**

- You do NOT have to give your SSN to a private business.
- If you do give your SSN to a business, get a copy of their privacy policy.
- If you are required to give your SSN to a government agency, you must be provided with a disclosure statement.
- NEVER give out your SSN or other personal information over the phone or by email.
- Report ID theft to your local police department.
- File an ID theft complaint on FTC's website at [www.ftc.gov](http://www.ftc.gov) or call (877) ID THEFT.

# Clint teachers fund projects through grants

Five Clint ISD teachers were awarded grants this year from the El Paso Community Foundation Classroom Fund initiative to implement projects in their classrooms. The Classroom Fund supports innovation, program enhancement, and supplies for the classroom to support teachers.

Pedro Jimenez, Criminal Justice Instructor at Horizon High School, was awarded a classroom set of books, *The Penguin Guide to the United States Constitution*, for students in his Court Systems and Practices course. The students use the information when they are analyzing the United States Supreme Court, comparing U.S. court systems with court systems around the world and when conducting mock trials in class.

The Horizon High School Moot Court Club sponsored by Jimenez also uses the book to prepare for competition where students argue a real case that is currently being presented to the Supreme Court.

“Because the Supreme Court only hears cases that violate the Constitution it is vital that the students understand how the Constitution works, and this book aids in that process,” Jimenez.


James Ryan, a teacher at Desert Hills Elementary, received a grant in the amount of \$1,000 that provided two iPads for his classroom for math and reading support.

“We take advantage of the iPads throughout the day with whole group, small group and individual instruction,” said Ryan. The students also use the iPads to take photos and video.

Students in Kimberly Contreras’ class at Frank Macias Elementary now have an array of art supplies provided by the \$900 award she received from the fund. Everything from aprons to wooden easels to watercolor paper, canvas frames, poster boards, paint, brushes and more were delivered straight to her classroom just last week. Painting moon phases, sculpting landforms, and creating biospheres are just some of the projects the students will be able to do with the new supplies.

Marisol Moreno, also a teacher at Frank Macias Elementary, was awarded a grant for \$700 to purchase a large world map for the classroom along with multicultural books that include different versions of the story of Cinderella.

“We use the map to learn about

geography and also to locate areas where there are different world views and perspectives. For example there are many stories of Cinderella and different cultures have different definitions of beauty,” said Moreno.

“I think overall it teaches students that there are always multiple perspectives than just their own,” said Moreno.

Carmelita Ledesma, a teacher at Red Sands Elementary, was also awarded

a grant to provide her students with a “comfy” area to enjoy and have fun reading including a couch, chair and coffee table. The students will learn to read independently by reading the pictures, reading the words and retelling the story.

“They can dream to their little heart’s content with all the fun and joy of their comfy gear as they develop a love for reading and become lifelong readers,” said Ledesma.

Former New York Times reporter Marcia Chambers and Vanderbilt University's Journal of Transnational Law have done expansive work on the subject in

regard to private-club memberships, and I'm certainly not here to belittle the subject. Still, let's not forget that we live in a world where discrimination exists, and to think otherwise is foolish. Ms. Chambers would be the first to admit that there are a myriad of private clubs in New York City alone, never mind Shoal Creek, Ala.

What's interesting to note is that in some famous cases, when a group or subset of people has been denied access to clubs, they often begin their own clubs and then set upon excluding other people, too. Again, there are too many examples to point out, but Groucho's remark is said to

have been made to the membership board of the Hillcrest Country Club in Los Angeles. Marx was not Jewish, but the board allegedly agreed to waive that condition if he agreed not to use the swimming pool. Marx is said to have appealed on behalf of his daughter: "She's half-Jewish... can she wade up to her knees?"

Once, when asked what his handicap was during a pro-am at a private club, Sammy Davis Jr. looked at the reporter with disbelief. "Handicap? I'm a one-eyed, negro Jew!"

Those Hollywood guys are a bunch of kidders, but the situation had a different edge when it came to the 1960 presidential election between John F. Kennedy and Richard Nixon. History shows Kennedy to be one of the leading presidents in terms of civil rights,

but having grown up in an infamous family only one generation removed from the "Irish need not apply" and anti-Catholic discrimination days, he admitted associations were complicated matters.

When Nixon was criticized for his membership in The Burning Tree Golf Club, Nixon all but stammered and fell all over himself trying to explain away the "exclusive" policies the club made no efforts to hide. A week later, when it was learned that Kennedy was in the club and was sponsored by Nixon to join only seven years earlier, Kennedy gave a good-natured smile and laughed at the reporters.

"Hell," he said. "They don't even allow Catholics!"



## Your good health By Paul G. Donahue, M.D.

**DEAR DR. DONOHUE:** I had an echocardiogram. The findings are consistent with "moderate to severe aortic stenosis with trace mitral and tricuspid regurgitation and mild pulmonic insufficiency, with left atrial enlargement and left ventricular diastolic dysfunction. The ejection fraction is greater than 65 percent." My doctor referred me to a cardiologist, who told me I need surgery. I am 86 years old and do not feel it would be safe. Will you explain in plain English what I have, and if surgery would lengthen my life span? – M.I.

are made. It's a less-traumatic procedure. Replacement of your heart valve will increase your life span and will do away with the severe symptoms that come from a narrowed aortic valve.

Forget about the mitral, tricuspid and pulmonic heart valves. These three valves have an insignificant leak. Your aortic valve, however, is your main problem. The aortic valve closes after the heart pumps blood out to the rest of the body. Your valve is so narrow (stenosis) that it creates an obstacle to emptying the heart of blood. That has given rise to "diastolic dysfunction." Your heart can't fill with blood normally, as it should between heartbeats (diastole). It is less stretchable. The aortic valve trouble has caused it to thicken. Early on in aortic stenosis, all goes well. When the valve narrows to a critical size, about 1 square centimeter, symptoms arise, and heart damage progresses more rapidly. The three most important symptoms and signs of aortic stenosis are shortness of breath when up and about, chest pain with activity and fainting spells. Once these symptoms appear, a downhill course in heart health is to be expected.

**DEAR DR. DONOHUE:** What elevates a person's white blood cell count? What can a person do about it? Mine has been high for a while. – B.L.

White blood cells are the body's warriors. They fight germs and perform other tasks to protect the body from infection. The normal white blood cell count is 5,000 to 10,000.

Infections, inflammation, trauma, some noninfectious illnesses, leukemia and stress (including emotional stress) raise the count. So do dehydration and cortisone medicines.

If no illnesses are found, it's not unusual to ignore the higher-than-normal count. If suspicions of hidden illness are high, then further testing has to be done – like a bone marrow test. A person can do nothing on his own to lower the count.

Even though you're 86, age is not a contraindication to surgery. If your health is otherwise good, you could be a candidate for it. Discuss with the doctor the surgery he has in mind. Ask if you might be able to receive a new valve inserted into the heart through a surface blood vessel by way of a catheter. No extensive incisions

**Social Security Q&A** By Ray Vigil

**Q:** I'm planning to retire next year. I served in the Navy back in the 1960s and need to make sure I get credit for my military service. What do I need to do?

**A:** You don't need to do anything to apply for the special credit for your military service—it is added automatically. For service between 1957 and 1967, we will add the extra credits to your record at the time you apply for Social Security benefits. For service between 1968 and 2001, those extra military service credits have already been added to your record. So you can rest assured that we have you covered. Read our online publication, *Military Service and Social Security*, at <http://www.socialsecurity.gov/pubs/10017.html>. And when the time comes to apply for retirement, you can do it conveniently and easily at [www.socialsecurity.gov/retireonline](http://www.socialsecurity.gov/retireonline).

locator/.) Data on your application will be matched with data from other federal agencies. If there is a discrepancy that requires verification, we will contact you. Learn more at [www.socialsecurity.gov/extrahelp](http://www.socialsecurity.gov/extrahelp).

**Q:** I have young children at home and I plan to retire next fall. Will my children be eligible for monthly Social Security checks after I retire?

**A:** Monthly Social Security payments may be made to your children if they are:

- Unmarried and under age 18;
- Age 19 if still in high school; or
- Age 18 or over, who became severely disabled before age 22 and continue to be disabled.


