# Tigua grant

The U.S. Department of Health and Human Services has awarded the Ysleta del Sur Pueblo a \$104,792 grant. The grant will be used to revitalize Tuy Pathu Tiwa – the Tigua native language – through pre-kinder education. Currently less than 2 percent of the Tigua population can speak Tuy Pathu Tiwa fluently. Ysleta del Sur Pueblo aims to create an immersion program that will preserve and revitalize the Tuy Pathu Tiwa language. The program will be implemented in three stages: curriculum design, professional devolvement, and beta testing. The program is intended to be multi-generational and parents will be strongly encouraged to participate in the program with their children. By 2015, Ysleta del Sur Pueblo aims to have created a generation of Tiguas capable of passing on the Tuy Pathu Tiwa language. "Preserving the language of the Tiguas is vital to protecting the cultural richness and traditions of the Pueblo," U.S. Rep. Gallego said. "This grant will help create a community based program that teaches pre-kinder Tiguas, with parental involvement, the Tuy Pathu Tiwa language. When it comes to language, our



# Will your kids inherit your debt?

Many people finally get around to after you die? writing a will in order to safeguard Your nest egg was decimated by the recession, bad investments or simply living longer than expected and now you've got a mountain of bills you can't pay off.

Will your kids inherit your debts

The short answer is, not in most their assets for their heirs. But what cases. But there are situations where if you've got the opposite problem: someone could be legally responsible for paying off your bills after death. Plus, aggressive creditors have been known to coerce heirs into paying off debts for which they're not responsible, just to be left alone.

If you're afraid that your financial

legacy will be a heap of unpaid bills, here's what you need to know and prepare for:

In general, children aren't responsible for paying off their parents' unsecured debts - things like credit cards, personal loans and medical bills, which aren't collateralized by physical property. If there's not enough money in the estate to pay off those bills, creditors will have to write them off.

There are several exceptions, however:

- If your child, spouse or other acquaintance is a cosigner on a credit card or loan (e.g., mortgage, car, personal loan), they share equal responsibility for paying it off. This is why you should always think twice before cosigning anyone's loan.
- If someone is a joint account holder - that is, their income and credit history were used to help obtain the loan or credit card they're generally responsible to pay off the balance.
- Widows and widowers are responsible for their deceased spouse's debts if they live in a community property state.

Note that authorized users on your credit cards aren't liable for repayment since they didn't originally apply for the credit. Chances are they were simply "piggybacking" on your credit record to help build their own. However, to protect authorized users from being bothered by creditors after your death, you may want to remove them from your accounts.

If you have outstanding secured debts upon death, such as a mortgage or car loan, your estate must pay them off or the creditor can seize the underlying asset. For example, if you were planning to leave your house to your kids, they'll need to either pay off or continue making payments on any outstanding mortgage, property taxes insurance, or risk foreclosure.

Depending on your state's laws, there are a few types of assets, like life insurance proceeds and retirement benefits, which you can pass along to beneficiaries that generally won't be subject to probate or taxation and thus may be safe from creditors.

Just be aware that if you name your estate as beneficiary for an insurance policy or retirement account, creditors can come after the money to pay off your debts. Thus, it's usually wise to name specific individuals as beneficiaries - and back-up beneficiaries, in case they die first. Also, if your beneficiary is a cosigner on any of your debts, creditors can pursue him or her for any balances owed.

Check with a probate attorney or legal clinic familiar with your state's inheritance and tax laws. Free or low-cost legal assistance is often available for lower-income people.

Bottom line: If you expect to leave unpaid debts after you die, alert your family now, so that together you can plan a course of action. You don't want to blindside your loved ones in the midst of their grief.







### **Crime Stoppers**

A 19-year-old is killed at the hands of a hit and run driver. Investigators from the El Paso Police Department's Special Traffic Investigation Unit are asking for the public's assistance in finding the person responsible

through the Crime Stoppers "Crime of the Week." On the early morning hours of Saturday, July 12, 2014, 19-year-old Joe Anthony Hernandez was walking along the area of Lomaland and Gateway West, when a vehicle struck him and fled the scene. Based on evidence at the scene, investigators believe the vehicle to be a 1999 Ford Mustang, with damage to the hood area and windshield. Investigators have also learned that, there was a dark colored truck, and a small light colored car with several individuals that parked at the Whataburger. The occupants of these vehicles attempted to aid the victim, but left the scene before emergency

crews arrived. Investigators are also asking that any witnesses come forward and contact police immediately. 

shadow desert. That is because two massive mountain ranges, the Sierra Madre Occidental on the west and the Sierra Madre Oriental on the east, border the Mexican portion of the Chihuahuan. These mountains block most of the moisture from the Gulf of Mexico and the Pacific Ocean from reaching the land, and are the main reason that this desert developed.

An important characteristic of the Chihuahuan Desert is the many small mountain ranges which run through it including the Franklins and the San Andres and Doña Anas in southern New Mexico. A few hours after Hamm's pitch, police were firing tear gas in Ferguson and Hamm's bobblehead was already going for \$45 on eBay.






