## Museum invites visitors to experience Ancient Rome

EL PASO COUNTY – El Paso Museum of History will present the exhibition, *Julius Caesar: Military Genius & Mighty Machines*, for the first time in the United States. Museum officials announced recently that El Paso will be the premier location in the country to display the unique exhibit.

The showing will open to the public beginning September 21 and be on display through January 10, at the history museum (510 N. Santa Fe St). The public is invited to expand their knowledge on the ancient Roman civilization.

The exhibition features war machines, transportation machines and civil machines, recreated scaled artifacts, digital files of images and computer animations.

"This exhibition brings to life one of the most technologically significant times in the history of mankind and covers an epic period of history, from the triumphant victory of Julius Caesar over the Gaul at the Siege of Alesia in 52 BC to the transformation of Rome from a Republic into the mighty Roman Empire," stated Barbara Angus, a museum official.

The interactive replica machines described by Marcus Vitruvius Pollio in the first century BC in his famous work *De Architectura* were built by the Teknoart specialists under

the auspices of La Sapienza, University of Rome, according to Angus. "The exhibition includes for each machine a metal stand and a glass showcase with rare facsimile replica of

volume and scrolls of the era," she added.

Ticket prices for the exhibit are: \$12 for individuals 6-years-old and up; \$8 for students and active military (with ID), and seniors (62+); \$6 for Groups of 10 people or more; and free for EP Museum of History members and children 5-years-old and under.

An opening reception for the exhibit will be held from 6 to 8 p.m., Saturday, September 20, for museum members. Entertainment, a live performance by Eden Enterprises, live music, and finger foods will be offered during the evening event.

# Don't be surprised by retiree healthcare costs

Retirement isn't cheap. Even though you're no longer drawing a paycheck, you still must pay for housing, food, utilities, transportation and healthcare, to name just a few expenses. As prices continue to escalate, it's not surprising that the ages at which people expect to retire – and when they actually do – have crept up in recent years.

Speaking of healthcare costs, here's a number that'll stop you in your tracks: According to an annual Fidelity Investments study of retirement costs, the average couple retiring in 2014 at age 65 is expected to need \$220,000 (in today's dollars) to cover their medical expenses in retirement. Those planning to retire at 62 can expect another \$17,000 in additional annual expenses.

Fidelity's estimate includes Medicare premiums, deductibles, co-payments and other out-of-pocket costs, but notably does not include most dental or vision services, over-the-counter medications or, most importantly, long-term care.

When Fidelity polled pre-retirees aged 55 to 64, 48 percent believed they'd only need \$50,000 to cover their healthcare costs in retirement. That's quite a reality gap.

If you're planning to retire in the next few years and are concerned you haven't saved enough money to cover your healthcare expenses, here's a sampling of what you can expect to pay:

- Medicare Part A helps cover inpatient hospital, skilled nursing facility and hospice services, as

well as home health care. Most people pay no monthly premium for Part A. However, in 2014 there's a \$1,216 deductible for each time you're admitted as an inpatient, plus a \$306 daily coinsurance after 60 days (\$608/day after 90 days).

- Medicare Part B pays toward medically necessary doctor's services, outpatient care, durable medical equipment and many preventive services. It's optional

# Phoenix VA Hospital investigation ends

Earlier this year, a physician whistleblower at the Department of Veterans Affairs hospital in Phoenix said that 40 veterans died while waiting for care. He claimed that schedules were jerry-rigged and falsified. The topic exploded into 225 more allegations in Phoenix and 445 around the country.

The VA Office of the Inspector General began investigations at 93 other facilities. Its report concluded that scheduling problems are "a nationwide systemic problem." The scandal led to the resignation of VA chief Eric Shinseki.

The investigation revealed that in Phoenix alone, 3,500 veterans likely never received an appointment because of falsified wait lists. Patients who were new to the Phoenix area, had recently been in the ER or who'd been hospitalized had difficulty getting appointments.

In detailed case studies, patients waited months with uncontrolled diabetes, waited seven months for a cardiology appointment that would disclose the need for bypass surgery, waited six months for an appointment that would reveal a brain tumor... and more.

Conclusion: Patients encountered obstacles that affected their care and certainly didn't help their overall outcomes.

However, the bottom line in Phoenix is that investigators found no proof that those 40 veterans died because of delays in care.

The OIG came up with a number of recommendations. For example, the health-care facilities will review the detailed case studies for disclosure to patients and families, ensure continuity of mental-health care, make changes to ensure timely access to primary care and establish a process whereby facility directors notify the Under Secretary of Health when the standards aren't met.



### Preventing bullying and cyber-bullying

Parents, educators and law enforcement officials are increasingly recognizing that bullying is a serious problem that can pose a real threat to a child's well-being.

Young victims of bullying can suffer long-term consequences that haunt them long into adulthood. A research study published in 2013 showed that 19 to 26-year-olds who were affected by bullying as children are four times as likely to have been charged with a felony as adults. For the perpetrators, bullying can cross the line and become a criminal violation with lifelong consequences.

Bullies typically choose their victims based upon a particular vulnerability or a specific trait. Some simply choose victims randomly. For example, a bully may target a child because of the child's height or academic successes. To intimidate their victims, bullies rely upon a variety of harmful behaviors such as hitting, teasing, threatening, spreading rumors, damaging belongings, and excluding others from social groups.

In an increasingly electronic world, cyber bullies rely on technology to torment others. Cyber bullying occurs when teenagers use the Internet, cell phones, or other devices to send or post texts or images that are intended to hurt or embarrass their victims. Put differently, cyber bullies may attempt to destroy or smear a victim's reputation with emails, blogs, forum posts, text messages, and other electronic media.

Bullying situations often involve seemingly powerful aggressors and victims who feel helpless. Sadly, some students who suffer bullying at school may believe that violence is the only way to defend themselves – but it is not. Texas law allows bullied students' parents to request that their children be transferred to another classroom or school. The law also requires that all schools display a student code of conduct that imposes disciplinary consequences for young bullies.

Parents and students alike should be aware that some instances of cyber bullying can cross the line and become criminal conduct. Texas law defines criminal harassment as "sending repeated electronic communications in a manner reasonably likely to harass, annoy, alarm, abuse, torment, embarrass, or offend another." Texas teenagers who suffer from cyber bullying or harassment should save all communications from a bully and

report those threatening or hurtful messages to a parent, teacher, law enforcement officer, or other trusted adult.

By working to prevent young Texans' bullying, harassment and intimidation, adults can help protect young people and make our communities safer. Parents and teachers are often best poised to build a child's self-confidence and teach the student how to peacefully resolve their problems. Parents and school personnel should always take bullying seriously so that children are not embarrassed or afraid to tell adults that they have been bullied.

To help children deal with bullies, parents should work to bolster children's self-assertiveness and self-esteem. They should also teach their children to solve problems without resorting to violence. Victims of bullying should be taught that they should immediately report the bully or cyber bully to an adult.

Parents should also teach children that if they witness bullying, there are positive steps to end a potentially dangerous situation and help the victim. Witnesses must not watch or encourage the bully, since bullies typically desire an audience. Instead, witnesses and bystanders should go to the victim's aid if it is safe to do so and report the incident to an adult. Parents who observe any bullying should take action to stop it right away – even if their own child is responsible for the bullying.

To ensure children and teenagers know how to safely resolve a bullying incident, parents and teachers should teach students to:

- Report to an adult any type of bullying – including theft, physical attacks, online harassment, abusive text messages, etc.
- Protect themselves and others. Young Texans should follow rules and stay out of trouble, avoid gangs, walk to school with friends, and be aware of their surroundings.

- Be cooperative and respectful. Conflict resolution exercises, parental involvement in school or summer activities, and spending time with family can help offer children opportunities to experience appropriate social interaction with their peers.

Together, parents, children, teachers and law enforcement authorities can help prevent bullying and cyber bullying, reduce crime and build a brighter future for all Texans.

and has a \$104.90 monthly premium (although higher-income people pay more). There's a \$147 yearly deductible, after which you're responsible for 20 percent of Medicare-approved service amounts, provided the doctor/

provider accepts Medicare. Note: There's no annual limit for out-of-pocket expenses.

- Medicare Part C (Advantage) plans are offered by private insurers as alternatives to Parts A and B. They're usually structured like HMO or PPO plans. Most cover prescription drugs (so Part D is unnecessary) and some also provide dental and vision

coverage. You must use the plan's doctor, hospital and pharmacy provider networks, which are more restrictive than under Parts A and B.

- Advantage plan costs vary considerably, based on factors such as annual out-of-pocket maximums, monthly premiums, co-payments and covered medications. Some Advantage plans cost no more than

Part B, while others have a higher premium (to account for drug and other additional coverage).

- Medicare Part D helps cover the cost of prescription drugs. It's optional and carries a monthly premium. These privately run plans vary widely in terms of cost, co-payments and deductibles and medications covered. The 2014 national average monthly premium is about \$32, although plans can cost up to \$175 a month. Plus, higher-income people pay an additional surcharge. You may not find a plan that covers all your medications, but aim for one that at least covers the most expensive

drugs.

Use the Medicare Plan Finder at [www.medicare.gov](http://www.medicare.gov) to compare Part D and Advantage plans in your area. To learn more about how Medicare works and what it does and doesn't cover, read "Medicare & You 2014" at the same website.

Bottom line: Even though Medicare does pay a significant portion of retiree medical care, make sure that when you're budgeting for retirement you take into account the many out-of-pocket expenses you're likely to encounter.

# Violence off field of play sparks national discussion

What an opening couple of weeks in the NFL.

The hits, the punishment, the taunting, the trash talking, the finger pointing, the unnecessary roughness, the unsportsmanlike conduct... and we haven't even brought up any of the actual play on the field yet.

And I'll bet you thought concussions were the NFL's biggest problem.

I can't remember a time in my life where so much talk surrounding the league originated from all the action off the field.

When George Orwell wrote 1984 I guess some of us thought some segments of it could come true, but it's pretty clear that it's here in full force.

In the novel Orwell writes about a country where everyone is being watched and monitored at all times. And one wrong move or word or thought could lead to your demise.

People were encouraged to turn in anyone who didn't tow the line and the idea of any independent thought was not only discouraged,

it was outlawed.

And that brings us to the media's latest feeding frenzy.

The Ray Rice situation is about as bad as it gets. Getting mad at your significant other is nothing new. In fact, today, any relationship that lasts for a significant amount of time gets a round of applause.

But there is no more cowardly act for a man than to hit a woman, who usually is about half his size to begin with.

And for many guys, that's why they do it – because they can. You'll never see them, as the saying goes, pick on somebody their own size.

But the cast of characters who have now become synonymous with the Ray Rice elevator incident keeps growing.

First there is NFL Commissioner Roger Goodell, who many people blame for everything concerning the league.

Goodell came under fire, understandably, for giving Rice a light two-game suspension for what we all knew was a knockout punch of his then-girlfriend.

When TMZ (who uncovers more things than the CIA by the way) released the "inside the elevator" video, Goodell suspended Rice

indefinitely.

Now the big question is did Goodell watch the disturbing video months ago and still only hand out a two-gamer. He says he never saw it until recently.

An investigation will reveal what the truth is but in the court of popular opinion, somehow Goodell has emerged as a bigger villain than Rice.

But when a scandal of this magnitude hits the fan, it's amazing how many people are eager to prove their mental mediocrity.

I feel sorry for Indiana Pacers forward Paul George, who suffered a devastating leg injury and will miss next season. The really bad news is that his fingers are functioning well enough to send stupid tweets.

Like the one where he basically said that if a woman behaves, she won't get hit, and he said Rice should be able to play immediately.

Of course, George has issued the obligatory apology (because he had to) and says he doesn't condone hitting women.

The National Organization for Women president Terry O'Neill has asked for Goodell's resignation.

What puzzles me is that NOW hasn't asked anything of the actual perpetrator, Ray Rice,

or of the police, who never charged Rice with anything.

And how about the Ravens fans, especially the women, who showed up in droves at the Thursday night game wearing Ray Rice jerseys in support of the guy who hauled off and knocked his girlfriend unconscious with one punch.

I guess as long as you can score a touchdown, the rules of decency and respect and law can be thrown out the window.

But the most embarrassing conduct stemming from this incident has come from the sports media.

They aren't trying to report the incident, they're trying to steer it in certain directions.

ESPN just got all kinds of negative publicity for falling all over themselves over-hyping the whole Michael Sam story.

Now they're asking every guest they can whether Goodell should be fired? They spend almost no time talking about Rice, who actually committed the horrible act.

If Goodell lied about the video and is trying to cover it up, he should be fired.

But let's wait until we find out.

If the players all say they should have due process – then so should he.

### Feet of clay

Let's imagine a world where guys like Ray Rice really mattered to the average person. If ever there was such a place, it was Piscataway, N.J. Rice, you see, used to be the town's favorite son and was the poster child whose smiling visage once adorned the pillars of Rutgers Stadium.

Now he is the poster child for domestic abuse in America.

At first, the town didn't want to believe what they had heard, that

Rutgers' all-time greatest running back – a Super Bowl champion, Pro Bowler and All-American – had cold cocked his fiancée in an Atlantic City elevator. That he dragged her unconscious body out through the lobby as attendants watched and did nothing.

"He was the nicest guy," came the refrain from the sports bars of Manalapan, Spotsboro and Edison. "He'd do anything for you!"

While the Giants were getting beaten up on "Monday Night Football," restaurant workers paused to gather around the manager's smartphone so they could see the video of Rice beating a woman senseless. Even the idiots who first said, "What? Did she hit him first?" came away shaking their heads. "That's not right."

Neither was the way the NFL had handled the situation up to that point. The guy who was booked last March on charges of third-degree assault hardly had the book thrown at him by Roger Goodell or the Ravens ownership. They suspended the guy for two games. One game for every punch he landed in the

elevator. Seeing, as they say, is believing, and that video took the very real problem of domestic violence out of the elevators, out of the kitchens, out of the bedrooms and basements, parking lots, and most notably, it took Rice out of the locker room.

Some will say that was important because it led to real change. The NFL would go on to suspend Rice "indefinitely" and institute new rules. Penalties against players – convicted or not – now will now be a six-game suspension for a first offense and a banishment of at least one year for a second offense. Also, they will undergo some sort of "training."

Of course, it doesn't go far enough. What are we teaching kids who go to games, wives at tailgate parties, fans rooting for their teams when they see guys like Rice take the field? What message does it

send when the camera pans to guys like Michael Vick, who oversaw the torture of animals in his basement for years? That it's OK to do those things if you can move the ball downfield?


The real message, as always, has to come from the ultimate authority in cases like this, and I'm not talking about commissioners, judges, clergy or team owners. The last time I checked, the rules had already been made quite clear: Love thy neighbor. It's that simple, but it's not easy.

Demand more from your teams and those around you. Demand good character. In the end, common sense and humanity should prevail, and the only way it will is if you have the will to say something about that too.



## Your good health By Keith Roach, M.D.

**DEAR DR. ROACH:** Traveling for a length of time – say, six hours or more – on a train, bus or plane makes me rather tired. Others I discussed this with have had similar experiences. I find this strange, because for most of the travel time I am sitting doing nothing but reading or daydreaming. My question is: Do physiological changes taking place in the body brought on by the long period of sitting while in transit account for the fatigue, or is it simply mental boredom? – R.S.

five minutes. Products that sit on the shelf for a long time lose their vitamins. As a student in organic chemistry, I did an experiment to find how much vitamin C was in certain products. Fresh fruits and vegetables (especially red bell peppers) had a great deal. A canned juice purportedly high in C had none at all. Even vitamin C tablets had lost 20 percent of their stated value even before their expiration date.

Orange juice containers will swell if bacteria in the juice release gas, at which point it should (obviously) be discarded. However, I wonder if the swelling in five minutes has to do with the air in the carton expanding due to the relative warmth of the air compared with the refrigerator.

I think it's both mental and physical. Prolonged sitting recently has been shown to put people at increased risk for heart disease, as well as the known risk of blood clots. Getting up and walking around is always a good idea physically, and might help mentally as well.

More than simple tiredness, chronic fatigue syndrome is all-encompassing. The booklet on it explains the illness and its treatment. **DEAR DR. ROACH:** I keep getting little black splinters under my fingernails that disappear on their own. I also have little black splinters under both of my big toenails that have not disappeared and have been there for a while. What is this? – D.F.

These sounds like splinter hemorrhages. The most common cause of these is trauma to the nail bed, but some dermatologic conditions can cause this as well, such as psoriasis and lichen planus. However, the most worrisome (but unusual) condition is infective endocarditis, an infection of the heart valves. Any fever or fatigue should be promptly evaluated by an internist.

**DEAR DR. ROACH:** Orange juice was a staple for breakfast when we were growing up. Mom would say, "Hurry up and drink your orange juice before it loses its vitamins." I've noticed that when a carton of OJ is left out for even five minutes, it swells up, apparently due to some pretty volatile organic compounds. I've learned through the years that Mom was usually right. Was she right again? – M.E.K.

# Social Security benefit verification

Need verification of your Social Security benefits? There's no need to visit or call an office to get the verification you need. Simply visit [www.socialsecurity.gov/myaccount](http://www.socialsecurity.gov/myaccount).

There are a number of reasons you may need written verification of your Social Security benefits. You may need to provide it to an energy assistance program or for subsidized housing. Perhaps you're ready to make a major purchase, and you're trying to get a loan from a bank or financial institution. Or maybe you're applying for state benefits or moving into a new apartment or home. You can use this benefit verification letter for any reason that someone requires proof of your income.

In addition to offering proof of income, the letter is an official document that verifies your Medicare coverage, retirement or disability status, and age. If you

need verification that you have applied for benefits but have not yet received a decision, it also serves as proof that you applied.

Whatever your reason, if you need verification of your income from Social Security, obtaining it is easy and convenient.

Create a *my Social Security* account and you can instantly get your benefit verification letter online and obtain one anytime you need it. You also can use your account to manage your benefits, check your benefit amount, or change your address, phone number, and direct deposit information. Millions of people have already opened their accounts. In fact, someone opens a new *my Social Security* account about every six seconds!

You can also get a benefit verification letter mailed to you by calling 1-800-772-1213 (TTY

**Q:** I receive Supplemental Security Income (SSI) benefits. How do I notify Social Security that I have changed my address?

**A:** If you receive SSI payments, Social Security needs your correct mailing address to send you notices and other correspondence about your benefits even if you receive your benefits by direct deposit. As

an SSI recipient, you must report any change in living arrangements or address by calling our toll-free number, 1-800-772-1213, or by visiting a local office. If you do not notify us in a timely manner, you could end up receiving an incorrect payment. It's important that you report changes timely since some changes can affect your benefit amount.


