Hueco Tanks may be a UNESCO world heritage site

EL PASO COUNTY – Recent discussions regarding the candidacy of Hueco Tanks State Park as an UNESCO (United Nations Educational, Scientific and Cultural Organization) World Heritage site has raised concerns from community groups as to how to strike a viable and acceptable balance between the use and protection of the unique site.

To help come to a consensus concerning Hueco Tanks' future, El Paso Museum of Archaeology will host a special presentation, entitled *Bridging Knowledge Systems at Uluru-Kata Tjuta, Australia: A Study of UNESCO World Heritage Nomination Dossier Materials*, beginning at 11:30 a.m., Saturday, October 11, at the museum, 4301 Transmountain Road.

The free event will feature Dr. Mark H.

Palmer and his analysis of a case study of the Uluru-Kata Tjuta (formally called Ayers Rock) Mount Olga National Park. The world-class mountain park is located in the southwest corner of Northern Territory, Australia.

A UNESCO World Heritage Site is a place (such as a forest, mountain, lake, island, desert, monument, building, complex, or city) that is listed by UNESCO as of special cultural or physical significance. The list is maintained by the international World Heritage Program administered by the UNESCO World Heritage Committee, which is composed of 21 UNESCO member states that are elected by the General Assembly.

In his presentation, Palmer will use a case study of Uluru-Kata Tjuta to offer a guide for a possible plan for Hueco Tanks that will be satisfactory to those parties concerned. He stated that his talk is based on a hybrid set of documents that attempts to bridge indigenous and scientific knowledge systems to increase

the sustainability of a cultural landscape. Palmer is currently an assistant professor and director of the MU GIS Certificate Program in the Department of Geography at the University of Missouri – Columbia. He earned a Master's Degree in Geography and

Water, sewer work affects Garcia Elementary traffic

CANUTILLO – The installation of water and sewer pipes in the neighborhoods near Gonzalo & Sofia Garcia Elementary School will force the closure of portions of Westside Drive for three or four months.

Construction crews will close Westside from Artcraft Road to Borderland Drive starting Monday, Oct. 6. Construction will take between 90 and 120 days, contractors told the Canutillo Independent School District (CISD).

The work in the area will not impact water or sewer service to the neighbors in the vicinity or the any CISD facility.

CISD expects traffic and school-bus related complications during the time that Westside is closed, and administrators within the CISD Facilities & Transportation Divisions have already begun developing plans to help ease traffic jams and bus route delays.

Traffic from neighborhoods south of Artcraft into Garcia Elementary will be detoured through Upper Valley Drive and Borderland to access Westside Drive. Parents are invited to leave ample time starting Monday when dropping off their children at school to compensate for the higher-than-normal traffic congestion.

A total of seven bus routes – three that serve Garcia Elementary School and four that provide after-school transportation to students at Canutillo Middle School, Canutillo High School and Northwest Early College – are impacted by the closures. Bus drivers have been trained on alternate routes to take to avoid delays.

"We are a District that is growing and this is part of that growth process," said Dominic Padilla, CISD's executive director for facilities and transportation. "We ask that parents be patient as we continue to work with our stakeholders in making sure our schools operate in an efficient manner."

SISD schools create programs to promote bullying prevention

EL PASO COUNTY – Students at SSG. Manuel R. Puentes Middle School came up with a new tactic this year to kick off their Olweus Bullying Prevention Program and get the anti-bullying word out. Students in grades sixth through eighth produced a four-minute music video on the subject.

It took more than two weeks, a trip to a music studio, the work of 45 students and help from choir teacher, Lluvia Fuentes, and drama instructor, Trever Thurman to finish the video.

“It is one of the best student-directed videos I have seen,” said Principal Libby Tidwell. “It’s heartfelt. This will get more students to pay attention.”

The video shows a young girl treated badly because she’s new at school. Christina Perri’s “Human,” performed by choir students Maddisen Contreras and Breana Walter, plays throughout the video.

The two choir students sang the song at a professional studio, Fuentes said.

“They were so excited,” she said. “It gave them a chance to see what singers really go through when recording songs.”

For Jason Barba, 14, who plays one of the bullies in the video, the project has been a dream come true and also helped his self-esteem.

“I have always been bullied,” Barba said. “So being on the other side was like therapy for me. I feel better about myself now.”

Thurman, who taught the young video producers, said he hopes all students get a chance to see it. It will help students learn to rely on each other and rid the school of bullies.

“You are only as strong as the person next you,” Thurman said. “That’s how to get a bully free environment.”

The Olweus Bully Prevention Program, a nationally known initiative, has been used district wide for several years. Designed for students in elementary, middle and high schools, it has been proven to prevent or reduce bullying in a school setting.

At the beginning of each school year, Socorro Independent School District schools begin their yearly program with kick-off events, such as community pizza nights, rallies, parades and assemblies.

Here is what other SISD campuses are doing to help stop bullying:

• **Americas High**

The high school had a rally for the freshman class. Motivational speaker Travis Brown, also known as Mr. Mojo,

encouraged students to stand up for themselves. Brown, who had the Trailblazers laughing and chanting positive sayings, travels across the United States and Canada to promote anti-bullying.

• **Elfida P. Chavez Elementary**

As part of its Olweus anti-bullying initiative, the Moose administration asked former second-grade teacher, Gail Ann Wisdom, to read and talk about her new book, “Trouble with Bullies.” Wisdom, who taught for more than 22 years, retired five years ago from Elfida Chavez. She wrote and published the children’s book about bullying and shared it with second- and third-grade students in the library.

• **Helen Ball Elementary**

The school kicked off their Olweus Bully Prevention Program with a pep rally featuring special guests from the El Paso County Sheriff’s Anti-Bullying Coalition. Deputy Armando Alvarez and Deputy Eddie Arreola spoke to students about ways to stop bullying. The school also announced the winner of their school-wide anti-bullying poster contest, which was the third-grade class who created a “Bullies are Despicable” poster covered with bunches of colorful minions. Finally, the school revealed their anti-bullying slogan for the year: “Keep Calm and Stop Bullying” and moustaches were passed out to all the students to remind them of the slogan.

• **Horizon Heights Elementary**

Students rallied together to stop bullying. Special guest Chico, the Chihuahuas’ baseball team mascot, attended and students listened to Principal Jimmy Vasquez deliver a message on how the school can be bully free.

• **Bill Sybert Elementary**

The school’s Olweus assembly included a skit by students on bullying and the school choir singing Taylor Swift’s “Mean,” Michael Jackson’s “Man in the Mirror” and Selena Gomez’s “Who Say.” The highlight of the program was motivational speaker, Alina Arredondo, a Socorro High and UTEP graduate, born without limbs. Arredondo, an intern with U.S. Rep. Beto O’Rourke, D-El Paso, talked about her experiences with bullies and how she handled those situations.

• **James P. Butler Elementary**

The school split the program in two sessions. Students from kindergarten to second grade were first to hear Maribel Pidone and Rosario Flores, assistant principals at the school. The administrators shared the rules for Olweus, explained who James P. Butler was and named their mascot, Jay. Third to fourth grade attended a similar program later that morning. The program ended with the coyote chant.

• **Dr. Sue Shook Elementary**

The elementary school had children singing

New claim forms

New claim forms are coming, says the Department of Veterans Affairs. It plans to produce a one-size-fits-all disability form for veterans, their families and survivors. The VA says the new form will eliminate guesswork and make it easier for applicants to “clearly state what benefits they are seeking.”

At this point, an initial benefits or compensation claim could be written on a sheet of notebook paper and still be a legal claim opening. But doing it that way means information often is missing if actual forms aren’t added soon.

What I don’t get is why this haphazard method of applying for benefits was ever allowed to start. Place the call to the VA, say, “I need the right form to apply for (fill in the blank),” and the form is sent. Right?


With the new forms, applicants will be told up front what additional information is needed. Theoretically, including the correct information or evidence the first time will allow the VA to move more quickly to process the claim.

The VA also plans to streamline the “Intent to File a Claim” process, giving veterans a whole year to produce the information needed to complete the claim. (If you intend to file a claim but don’t yet have all your information or evidence, file now. Your start date will begin when the VA first receives it, not months from now when you have all your information to send in.)

You don’t actually need to fill out a form at this point. You can write on a sheet of paper that you intend to file a claim, briefly state what the claim is for, and give your identifying information. You’ll be sent the correct form.




Vinton unveils 'Little Free Library'

On Wednesday, October 20 at 10 a.m. State Representative Joe Moody (El Paso, District 78) and the Village of Vinton Mayor Madeleine Praino will unveil their collaborative effort to encourage literacy and the love of reading among Vinton's residents while highlighting accessibility and funding for library services outside the city of El Paso.

"In 2011, the Texas legislature made massive cuts to library funding," said Moody. "Due to those cuts non-city residents must pay \$50 a year for a library card. Meanwhile just getting to the closest library branch is a problem for most Vinton families. We need to bring library services here to this community."

Praino became aware of the situation when a concerned citizen brought it up at a city council meeting. "[Moody] and I looked at our options and realized bringing the Little Free Library Program to Vinton was a good first step. However, the libraries need to be stocked. So we are asking the community for book or

monetary donations. With enough support we can expand the program even more."

The Little Free Library Program is a non-profit organization that encourages individuals to create and display small, stocked bookshelves in an outdoor setting. The bookshelves or "Little Libraries" are cared for and maintained by stewards in the community. Passersby are encouraged to take a book, leave a book, or both.

Five Little Free Libraries will be open to the Village of Vinton with the main unveiling occurring at 10 am in front of Mariposa Park on the corner of Copper Rd. and Steel Dr. The libraries were built and donated by the Woodworkers Club of El Paso while books have been donated by Books are Gems, the El Paso Public Library, private citizens and other organizations across the border.

Those interested in donating funds or slightly worn books are encouraged to drop them off during regular business hours at the Village of Vinton City Hall located at 436 Vinton Rd, Vinton, TX 79821 or with the Office of State Representative Joe Moody, 5675 Woodrow Bean, Suite 12.

Public Planning at the University of Northern Arizona and a doctoral degree in Geography at the University of Oklahoma.

Since 2005, Palmer has published eleven peer-reviewed articles and book chapters; six as a single author, five as co-author, in which five of these are directly pertinent to his upcoming presentation. He stated that his current research focuses on the social aspects of geographic information systems and the uneven development of these systems by government agencies regarding the indigenous communities of North America.

Palmer explained that by studying the integration of indigenous knowledge systems into the geosciences and the use of digital technologies like GIS, he aims to determine how culture traits, like language, storytelling, education, and performance, influence the use and understanding of geographic information.

The special presentation is sponsored by the El Paso Archaeology Society, El Paso Museum of Archaeology, and State Senator José Rodríguez and State Representative Mary Gonzalez.

continues excelling in his career as an engineer and business owner. Ibarra was selected as the Honored Ex for San Elizario High School's 2014 Homecoming festivities held the week of September 29 through October 3.

Ibarra graduated from San Elizario High School in May 2007 where he was actively involved in wrestling and the career and technology student association Skills USA where he served three years as president for the district of El Paso. The fact that Ibarra left home to attend college and became successful also makes him a great role model for other students from San Elizario High School Whittington added.

Ibarra's company has grown over the last two years and as a result he is able to contribute to his hometown not only by motivating students but also by recruiting employees from San Elizario. He doesn't stop at just offering people jobs but also helps them relocate and provides other forms of assistance during their first month of employment. Ibarra is currently preparing to take the Fundamentals of Engineering Exam.





Your good health By Keith Roach, M.D.

DEAR DR. ROACH: I am 66 and have multiple sclerosis. Should I get the shingles vaccine? On the one hand, I know it is recommended for everyone. However, I do have a compromised immune system, and it could be risky to inject a virus. Neither my family doctor nor my neurologist has an opinion – they say it is a toss-up. – D.E.P.

an MRI? – B.

There are two issues here: Could the shingles vaccine, which is a live virus, cause shingles? And secondly, can it cause your multiple sclerosis to flare? Both of these are somewhat controversial.

The first question is less so. There is recent evidence that between the MS (or other autoimmune diseases) and its treatment, the immune system is still good enough to prevent any viral disease. The second question is more problematic, with MS experts divided in their opinions. Normally I would ask you to seek your doctors' opinions, but since they haven't been much help, I will just say that the risk of causing a flare of MS is theoretical and small, but the downside of shingles is so great that I would, in general, recommend the vaccine to someone in your position.

People on high-dose steroids or other medications that suppress the immune system should not get the vaccine. Neither should people with leukemia, lymphoma or advanced HIV.

DEAR DR. ROACH: What is the difference between a CT scan and

A CT (computerized tomography) scan uses X-rays to create an image that looks like a slice through the body, head or a limb. The quality of the picture is excellent, but it has much more radiation than a regular X-ray. An MRI uses powerful magnetic waves to create an image that also looks like a slice. It uses no radiation. CT scans are cheaper and faster, in general. One isn't necessarily "better" than the other. MRI tends to be better for looking at soft tissues, like the brain, and CT usually is better for looking at bones. Your doctor, or the consulting radiologist, can tell you which is more likely to be better in your individual situation.

DEAR DR. ROACH: I read your response to T.M. about his PSA level. Rather than a biopsy, would a PCA3 urine test be as good? – S.R.

The prostate cancer antigen 3 gene (PCA3) has been proposed both as a screening test by itself, and as a confirmatory test after an abnormal PSA test. It was a bit better than PSA as a screening test, and shows promise as a test to reduce unnecessary biopsies for men with abnormal PSA levels. However, the most recent study from Brown University in 2013 concluded that there isn't yet enough evidence to start using this test on a routine basis.

Social Security Q&A By Ray Vigil

Q: My grandfather, who is receiving Supplemental Security Income (SSI), will be coming to live with me. Does he have to report the move to Social Security?

A: Yes. An SSI beneficiary must report any change in living arrangements before the 10th day of the following month. If you do not report the change, your grandfather could receive an incorrect payment and have to pay it back, or he may not receive all the money that he is due. Failure to report a change to us could result in the deduction of a penalty from his SSI benefits. Your grandfather also needs to report the new address to us to receive mail from us. You can report the change by mail or in person at any Social Security office. Call us toll-free at 1-800-772-1213 (TTY: 1-800-325-0778). You can get more information by reading *Understanding SSI* at www.socialsecurity.gov/ssi.

Social Security number on it with your other important papers. Do not carry your Social Security card with you. Also, we strongly advise against laminating your card. You should question anyone else other than your employer who asks for your Social Security number or your card. Not everyone you do business with needs it. Learn more at www.socialsecurity.gov/ssnumber.

Q: I have children at home, and I plan to retire next fall. Will my children be eligible for monthly Social Security payments after I retire?

A: Your children may get monthly Social Security payments if they are:
• Unmarried and under age 18;
• Age 19 and still in high school; or
• Age 18 or over and became severely disabled before age 22 and continue to be disabled.

Q: Can I use the metal or plastic versions of Social Security cards that some companies make?

A: We don't recommend it. There is no need to have a replica of your card. In most cases, the only time you may need to produce your Social Security card is when you apply for employment. At other times, we strongly recommend that you keep anything with your


