Elderly falls

Researchers at the University of Illinois in Chicago deliberately tripped senior citizens in the process of developing ways to prevent them from falling down, CBS News reported. Professor Clive Pai headed up the study and he says that it could become a virtual "vaccine against falls." He calls it "implicit learning. We don't give any instruction. They don't have to be motivated – they're naturally motivated because they don't want to be on the floor." The Association of Mature American Citizens says the procedure is not as cruel as you might think, explaining that the elderly participants in Pai's study wear harnesses. After a while, they learn to catch themselves. Pai and his team say that after as few as 24 fake falls the older adults in the study were 50 percent less likely to fall as they go about their daily chores. Stretching exercises, vision exams, strategic handrails, the avoidance of sudden moves and the use of a cane, if necessary, are also good ways to prevent dangerous falls, according to AMAC.

Food trailer stolen

A customized trailer that serves as a mobile kitchen, was stolen from a fenced lot in east El Paso County. Deputies from the El Paso County Sheriff's Office are asking for assistance in identifying those involved in the theft through the Crime Stoppers "Crime Spot." The theft is believed to have taken place between the early morning hours of Saturday, Oct. 25, 2014 and the afternoon of Monday, Oct. 27, 2014. A 2005 crew cab Ford Lariat F-150 with Texas license plates BA96267 that was used to pull the trailer was also stolen. The trailer is a white 2007 International modified utility trailer with Texas license plate 307790H. In total the amount of the property stolen is valued at more than \$100,000. Investigators from the El Paso County Sheriff's Office, are certain that someone has information on the theft. Tech support scams prey on unsuspecting computer users

EL PASO COUNTY – Scam artists are using the phone to try to break into your computer. They call, claiming to be computer techs associated with well-known companies, like Microsoft or Dell. These scammers claim that they've detected viruses or other malware on your computer to trick you into giving them remote access or paying for software you don't need.

The scam attempt happened to James Frazier of El Paso recently. He said that he got a call one Saturday afternoon. "I was told it was the Windows technical support center," Frazier said. "They said there was a problem with my computer and that they would fix the problem and would install an antivirus program to protect against future attacks."

So, Frazier proceeded to follow the caller's instructions and before he realized it, he had given the caller control of his computer. He became suspicious, however, when the caller insisted that he pay a \$250 fee with a credit card before the problem can be fixed. Not sure if the supposed Windows technician was legitimate or a fraudster, he decided to hang up.

Frazier said that that night he was unable to sleep because he kept mulling



over the possible consequences for having given a stranger access to his computer, which has all his personal and financial information. The next morning, Frazier contacted a friend, Ismael Prieto, who is an IT support engineer and owner of TCB El Paso Computer Repair Service.

Frightened by the supposed virus – and

reassured because of the reputation of the company the fraudster is claiming to represent – many consumers agree to pay the fee and give the criminal remote access to the "corrupted" computer. The hackers charge a consumer to download harmless

Construction of the five-screen wall required global communication, as City of El Paso project managers worked with designers in New Zealand and



Finances By Jason Alderman**Five important money questions to ask**

Valentine's Day is often a time to reflect on your relationship, and consider the next step. If your relationship is heading toward joint finances, it's essential to talk about it first – openly and honestly.

This year, consider thinking beyond the roses and candlelight dinners to a potential future of merged finances. Here are five key questions that should drive your conversation:

Where are you financially as individuals? Take time to talk about your household debt – including student loans, credit cards, mortgage and medical bills, and share your credit reports from the three major credit reporting agencies (Equifax, Experian and TransUnion). Each can be obtained once a year for free (<https://www.annualcreditreport.com/index.action>). It's also important to discuss assets – not only the savings and investments you hold, but also how future job or education plans can improve the marriage or family's financial health.

What are your money personalities? This is a personal finance question that many financial planners still ask to get a sense of your money management habits. It's intended to identify which person in the relationship is the spender or the saver. It's particularly important to ask each other whether you save or spend to make sure you're on track to achieve your long-term goals.

How do you want to live? This question is about shared financial and personal goals and how you will achieve them together. Discuss how you've been living thus far, and what you might change. Be honest about where you want to live, what kind of home and family you want to have, what kind of career or retirement you want and start discussing concrete ways you both will get there.

How will you handle everyday spending? Determine how you will share accounts, pay bills, budget, save for the future and bank – jointly, separately or both. Figure out how will you jointly manage credit and the smartest ways to save for retirement. If you want a family, decide how you'll plan for kids financially. Finally, work together when problems come up. As with all issues in a relationship, ongoing communication is key.

What if you need help? There are options if you or your partner doesn't know where to start. Licensed financial and tax professionals can provide guidance on issues from

Veterans Post By Freddy Groves**A decade of delays**

What's going on in Aurora, Colorado? A new Department of Veterans Affairs medical center, to be used by veterans in Colorado, Kansas, Nebraska and Wyoming, was first approved for construction in 2004, and it's still not up. Groundbreaking for the new facility began in 2009 with completion planned for 2013.

When the builder contract was signed in 2010, the agreed-upon price was \$582.8 million ... before the design was even completed. Since then, the contractor has complained about late payments, incomplete plans, change orders that went unprocessed for over a year, switching from a shared facility to a stand-alone hospital, relocation of the facility, and the discovery of an underground spring and a buried swimming pool.

No one was watching the architect, who had designed costly additions like curved walls. Medical-equipment planners weren't used, and instead the VA got input from others with limited experience. By January 2013, they were still haggling about trying to

redesign the hospital to fit the actual budget.

At a recent meeting of the U.S. House Committee on Veterans' Affairs, which was to sort out all the details, the actual cost of the project still wasn't known. The guess at this point is that it will be more than \$1 billion – double the original estimate and a decade after the decision was made to build the facility.

In December, work came to a halt when the construction company pulled its workers off the site after a federal board of contract appeals said the VA had breached the contract. Then came word that the Army Corps of Engineers was taking over management.

Now, a decade into the project, the estimated opening will be in 2017... maybe.

Aurora isn't the only location with these problems.





San Elizario HS students learn financial skills

SANELIZARIO—San Elizario High School sophomores received a crash course on how to provide for a family and maintain a household during a “Breaking the Cycle of Poverty” simulation held on January 28. Representatives from the Federal Reserve Bank of Dallas, El Paso Branch and United Way of El Paso County (UWEPC) helped to guide San Elizario students through different role-play activities in this one of a kind financial literacy event.

Students were divided into groups and assumed the lives of families in different situations. They were tasked with providing for basic necessities and shelter on a limited budget. Volunteers from the Federal Reserve Bank, UWEPC and San Elizario High School hosted tables representing community resources and services such as a bank, a social service agency, an employer, utility companies, a grocery store, daycare provider, etc. The students visited the different tables to obtain assistance for their fictitious families. The overall purpose of the simulation was to enable students to look at their community from a variety of angles and recognize and discuss potential change within society. Students also received lessons on “College and Careers” and “Learning to Budget and Save” from the volunteer agencies.

The “Breaking the Cycle of Poverty” simulation at San Elizario High School was only the second time the opportunity was offered to high school students in El Paso County according to event organizers.

Congress slashes conservation

When thinking about the \$1.1 trillion spending bill recently passed by Congress, one might ask, what does Congress have against conservation?

They made huge cuts to conservation programs, such as the Conservation Stewardship Program (CSP) that supports conservation practices on cropland, pastureland and rangeland, totaling \$402 million over ten years. This cut means 2.3 million fewer acres enrolled in the program.

This anti-conservation spending bill also cut the Environmental Quality Incentives Program (EQIP) by \$136 million for this fiscal year.

While the CSP is designed to reward farmers and ranchers who have a history of integrating conservation, EQIP will help them develop a conservation practice for the first time. Both programs support practices such as cover crops, diverse cropping systems, as well as rotational grazing practices on pasture, rangeland, and cropland restored to a grass-based system.

These are the conservation-based farming practices we need more support for, not less. This is especially true in the face of climate change impacts on agriculture, and the increased need to protect and restore water quality.

So while they cut the conservation programs that help farmers and ranchers integrate risk management through conservation-based farming practices, they left intact the unlimited federal crop insurance premium subsidies and farm program payments that encourage risk taking and agriculture consolidation by the nation’s largest and wealthiest farms.

This is an anti-farmer, anti-conservation bill that is representative of crisis-driven legislation stemming from a dysfunctional Congress. Join us and fight for annual spending bills that are forward-looking, and create opportunity.

programs that are available for free online to demonstrate the alleged virus. Other times, they install tracking software that gives the fraudster access to personal information on the computer.

According to consumer reports, the estimates of the scope of this scam vary widely. For example, Microsoft reported that the average victim lost \$875 and had to pay \$1,700 in repair bills. The Federal Trade Commission (FTC) reported that it had received more than 40,000 complaints about this scam since it initiated a crackdown in October 2012, and an official with the FTC's

consumer protection bureau said he thought the number of victims was probably higher.

Despite government action to identify and stop scam artists running these schemes, copycats continue to defraud consumers.

As for Frazier's situation, Prieto was able to retrieve all of his files, clean his computer of viruses and malware, re-set the Internet's network connection, and install new software. Prieto pointed out, however, that there was no telling what information the scam perpetrators were able to access and capable of using. Subsequently, Frazier contacted his bank and credit card companies to alert them of the incident, and he changed all of his passwords.

Prieto said that the best way to

minimize the risk of falling victim to this scam is, first, know that legitimate companies will not call you without solicitation and tell you that you must pay for tech support; and never allow someone to take remote control of your computer unless you are absolutely certain that they are representing a legitimate company.

In addition, consumer advocates recommend that individuals refrain from disclosing sensitive financial information such as passwords, credit card, or bank account routing numbers over the phone; and when buying things over the Internet or phone, use a credit card or a debit card so that you can better dispute fraudulent charges.

If you believe that you are the

victim of a tech support scam, take the following actions:

- Immediately delete the tracking software from your computer.
- Call your credit card company and ask to have the charges reversed.
- Check your bank and credit card statements for inaccuracies. If you find any, ask that those charges be reversed.
- Contact the major credit reporting agencies (Equifax, Experian, and TransUnion) and notify them of the potential for fraud on your account.
- Change any passwords that you gave out.
- Visit FTC's [identity theft website](http://ftc.gov/complaint) (ftc.gov/complaint) and file a complaint.




Chester Jordan students take green message to Fort Bliss

EL PASO COUNTY — Chester E. Jordan Elementary's Green Science Team members don't limit themselves to talking to others about the environment only on campus. They take their green message wherever they go.

Recently, the 21-member group, made up of third, fourth and fifth graders, decided to share the message with Fort Bliss soldiers and their families the only way anyone in today's techno world can: by creating a flash mob.

These "recycling hero minis," along with Fort Bliss Recycling's soldiers, danced and sang in front of shoppers inside Freedom Crossing. The military spectators were surprised by the gesture.

"I take pride in all our student's accomplishments," said Principal Jesse Sepulveda, whose school is the first Silver Leadership in Energy and Environmental Design (LEED) in El Paso. "But what they did at Fort Bliss was extra special. This video went viral and made its way to the Pentagon. What a thrill and what an honor. As the only Silver Certified Green School in this region, our hard work is truly paying off. Our students truly are making ground in this technology-based and global world."

The Green Science Team, who won a 2012 Texas Environment Excellence Award (TEEA) in the youth category for their work in the community and who last April participated in El Paso's Earth Day celebration, were asked by its partner, the Fort Bliss Recycling, to help recognize the military community for keeping the Post green.

Three weeks before the event, students practiced the songs and dance for the flash mob event, said Mary C. Salas, advisor for the Green Science Team. The students did two songs, which were versions of existing songs but with lyrics about recycling. The songs were "I'm a Little Teapot" and "Twinkle, Twinkle, Little Star." The Fort Bliss recycling team provided the "Recycling Hero" masks and capes. The 3rd Brigade Combat Team, 1st Armored Division produced the event.

"The spectators were truly surprised and there were quite a number of camera phones on," said Salas, also SCI-E curriculum coach at Chester Jordan. "I can honestly say that the activity in the food court stopped for that moment. We had a great applause and many congratulatory comments."

In fact, the children's partner, Fort Bliss Recycling, was awed by what the group had accomplished in such a short time. Members said it was "better

than they had hoped it could be." A video of the event was made and students saw it later on "Armed Services" online services, Salas said.

"The kids were greatly excited," she said. "I had comments from 'This was the best day of my life!' to 'When are we doing this again!'"

Sepulveda said besides the fun the students have, these activities help prepare them for their own careers.

"This creates opportunity for success in school academically and opens doors for success in their own futures," Sepulveda said.

The Miners are down to just six guys who see any regular action. Star forward Vince Hunter is playing a little more carefully after hurting his left knee and being forced to wear a brace.

Floyd will now have to count on help from little used center Hooper Vint and guard Lew Stallworth to give the other guys a breather.

The Miners, who looked like the best team in the league three weeks ago, have struggled immensely in recent games.

Maybe it's the fatigue setting in. Maybe it's bad luck. Maybe it's something else.

But Tim Floyd has got to be wondering how many more times he's going to have that "I've seen this situation before" feeling?

In the past though, the Miners have responded well to adversity for Floyd.

Maybe he'll have a little déjà vu about that, too.

Atrial fibrillation is a chaotic lack of rhythm in the heart muscle, caused by abnormal electrical impulses. The goal when treating atrial fibrillation is to reduce the risk of stroke and minimize symptoms.

You are quite right. There are four kinds of fat. Two are healthier – monounsaturated and polyunsaturated, and these are found in healthy oils, like olive oil and canola oil. Two fats are unhealthy – trans-saturated, also called partially hydrogenated, and saturated, which is fully hydrogenated but isn't ever really called that.

One new approach to treatment is radiofrequency ablation – that is, using radio waves sent through a small tube placed directly into the heart through a leg or arm vein. The high-powered radio waves can destroy the cells causing the atrial fibrillation, or can isolate those areas from the rest of the heart. A surgeon can do a “maze” procedure to prevent the abnormal impulses

called that.

Trans-saturated fat is not healthy. Food companies make it by adding hydrogen to vegetable oil at high temperature. The chemical bonds are "trans," which are not normally found in nature. The process makes the fat more solid at room temperature. It isn't much of an exaggeration to call trans fat toxic, since even modest amounts increase risk for heart disease from blockage of the arteries. I recommend as little trans fat in the diet as possible – preferably none.

Saturated fat isn't healthy either, but it isn't as bad for you as trans fat. There are two major kinds of saturated fat: Those that come from animal products (butter, red meat), and those from tropical sources, like palm and coconut. Most experts think tropical saturated fats are not as unhealthy as those found in animal products. Nonetheless, I recommend keeping saturated fat intake low. The American Heart Association recommends less than 16 grams for a person on a 2,000-calorie-a-day diet.


