### Sales tax holiday

Texas Comptroller Glenn Hegar reminds shoppers they can save money on certain items priced under \$100 during the state's annual sales tax holiday. This year, the sales tax holiday is scheduled for Friday, Saturday and Sunday, Aug. 7 - 9. The law exempts most clothing, footwear, school supplies and backpacks priced under \$100 from sales tax, which could save shoppers about \$8 on every \$100 they spend during the weekend. "As the father of three young children, I know back-to-school expenses can really put a strain on family budgets this time of year," Hegar said. "This is an opportunity for families to save some money and prepare for the start of the school year." ## County tax assessor-collector's main office moving

EL PASO COUNTY – El Paso County's new Tax Assessor-Collector's Office employees are scheduled to move into their new home in August as renovation work to a refurbished facility that is located at the entrance to Ascarate Lake Park nears completion.

Final steps for the relocation process were taken recently when county commissioners court approved the purchase of new furniture for County Tax Assessor-Collector Ruben Gonzalez and his staff. Commissioners awarded a \$74,000 contract to Facilities Connection, Inc., to furnish the new Ascarate Annex, which was formerly a U.S. Army Reserve Center.

The \$1.3 million renovation project of

the 60-year-old Army Reserve building began in December 2013. The facility, which also will house the county's AgriLife Extension Service Office, was supposed to be finished in September 2014, then it was pushed back to March.

The renovation project took longer than expected because, according to county administrator Steve Norwood, "Any time you're doing a remodel, you are going to run into construction delays." He added that there were also some delays in ordering the furniture.

Nonetheless, Gonzalez and his staff are excited about the imminent move. "I'm looking forward to moving. Our employees are looking forward to moving. It's going to be a very nice facility," Gonzalez stated in a recent news report. He said that the public would be notified soon about a set date for the official move.

At least 40 county employees are relocating to the new site, where parking will be free not only to tax office employees but also to the public.

Gonzalez, a former regional manager for the Texas Department of Motor Vehicles, was named the new county tax assessor-collector in February. Gonzalez, a native El Pasoan, was appointed by commissioners' court to cover the unexpired term of Victor Flores, who had almost two years left in office but resigned in February because of health issues.

Gonzalez, who retired from the Texas Department of Motor Vehicles in 2011 after more than 38 years, has experience supervising vehicle, title and registration laws, and training and supporting tax assessor-collectors and their staffs. He stated that he assisted and trained tax assessor-collector offices in Brewster, Culberson, El Paso, Hudspeth, Jeff Davis and Presidio counties.

As tax assessor-collector for El Paso County, Gonzalez earns about \$93,200 a year and oversees 76 employees. Among his office's duties are issuing automotive license renewals, registrations, title transfers, collection of road and bridge fees, alcoholic beverage permits, and hotel-motel occupancy taxes.

Other duties include assessing and collecting of all taxes imposed on property within the county. Since 1986, however, the City of El Paso through an inter local governmental agreement, with the cooperation of the County Tax Assessor-Collector and approval of county commissioners and 29 other taxing entities, has been collecting property taxes throughout the county.

The county tax assessor collector department maintains four offices. In addition to the main office at the new Ascarate annex, it operates three branch offices including Ysleta, Northeast, and Fort Bliss; and it has ten full service contracted deputy agencies located throughout the county.

# Make sure your college freshman is money-smart

Does your college-bound freshman know how to handle money at school?

Campus life can test even the most disciplined young adults on money matters. In the final weeks before you help your student pack up for the dorm, it's a good time to pack in some money lessons as well.

Start with what college will cost. On average, the Class of 2015 graduated with a little over \$35,000 in student loan debt, according to Edvisors (<http://blogs.wsj.com/economics/2015/05/08/congratulations-class-of-2015-youre-the-most-indebted-ever-for-now/>). Depending on your financial situation and how you've planned for your child's college education, start with an overview of how your student's college costs will impact your finances now and after graduation.

If your child will be paying off personal or student loans once they graduate, discuss how that

reality should define financial choices throughout college. That doesn't mean saving every penny and having no fun at all, but such a talk should reinforce how handling money intelligently, setting priorities and getting a jump on savings can position your child for a much stronger financial start upon graduation.

Train them to budget. If your child hasn't learned budgeting skills (<http://www.practicalmoneyskills.com/budgeting>), it's time for a crash course. Budgeting is the first essential skill in personal finance. Teaching children to budget now gives them a head start on dealing with post-graduation debt or long-term goals like affording a home or car. Because teens often live their lives on smartphones, familiarize yourself with the growing range of budgeting apps (<http://www.usatoday.com/story/money/2015/04/27/budgeting-apps-affect-spending-habits/26190991/>) to keep their money management on course.

Talk through on-campus banking and credit needs. Many parents start their kids with custodial savings and checking accounts at their local bank when they are younger. If your bank has branches in the teen's college town, that relationship can easily continue. Responsible credit card use is also wise to start in college. Keep in mind that The Credit Card Accountability, Responsibility and Disclosure (or Credit CARD) Act of 2009 requires that anyone under 21 without independent income have a co-signer to qualify for a card. As such, you'll be able to keep track of your child's credit use. However, if they default, you'll be on the hook – so monitor your child's bank and credit relationships closely until you agree they're ready to manage them on their own.

Cover credit monitoring and identity theft. With smarter online thieves emerging every day, your child is at risk of identity theft from the minute he or she

is assigned a Social Security number. While most teens generally don't have a credit report until they start earning a paycheck at age 16, be on the lookout for fraudulent activity earlier (<http://www.consumer.ftc.gov/articles/0040-child-identity-theft>) and make sure they get in the habit of ordering the

three free credit reports (<https://www.annualcreditreport.com/index.action>) they are entitled to each year. Throughout college, consider sitting down with children so you can review their annual credit reports together.

Bottom line: There's plenty to

### Coming soon: Veterans ID card

You'll soon be able to stop carrying a folded-up, faded copy of your DD-214 in your wallet in order to identify yourself as a veteran. The Veterans Identification Card Act of 2015 (H.R.91) has passed the House and Senate. Soon you'll be able to get a Veterans ID card, if you don't already have one from being signed up for health care or for having served for at least 20 years.

A card that clearly identifies you as a veteran will be helpful in a number of ways when you need to verify your veterans status: a reduced rate on your property taxes, veteran car tags and discounts in restaurants, travel, hotels and car rental, Amtrak, movie theaters, national parks and lots of retailers and services. (If you didn't know you can get so many discounts, dig around on the Internet.)

It won't, however, get you any veterans benefits you don't already have. And you might

have to pay a small fee to cover costs. (That's because it took years to get the legislation this far as there were a few naysayers who decried the cost of producing something they say you don't need.)

One big benefit of having the new ID card is that if your paper DD-214 is lost, it contains too much personal information – like your date of birth, place of birth, service number – and worse in this day and age, your Social Security number. Wanna-be phonies can make use of a lost DD-214 to create an authentic-looking paper copy, using your info and their name. The new cards will have your photo and name, as well as a number that is not your Social Security number.

Now the bill for the ID card goes to the president for his signature. Surely he'll sign it, right?

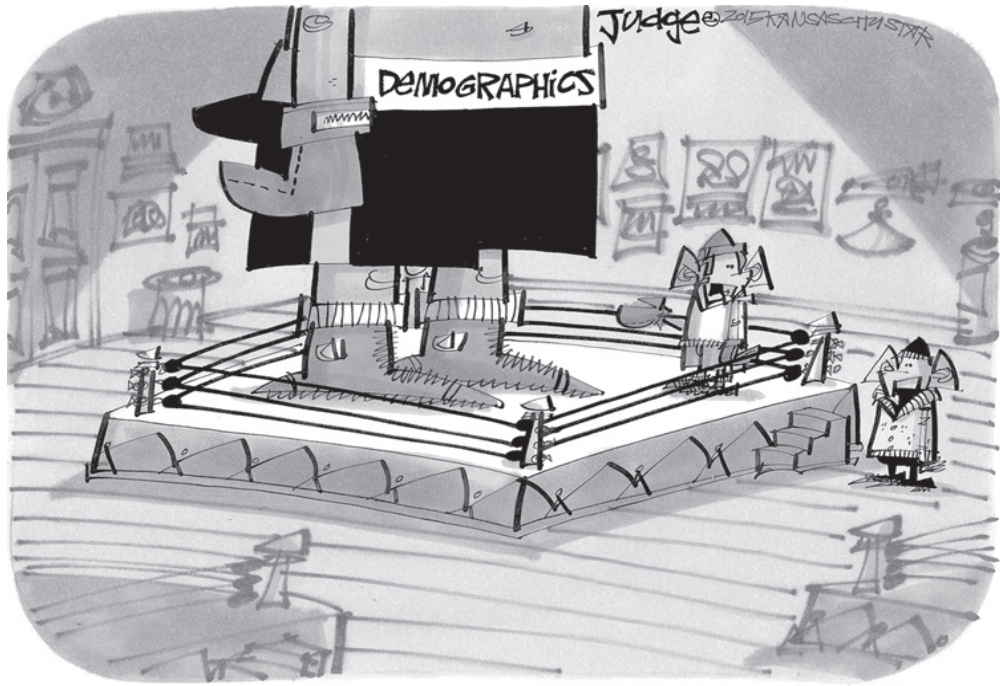
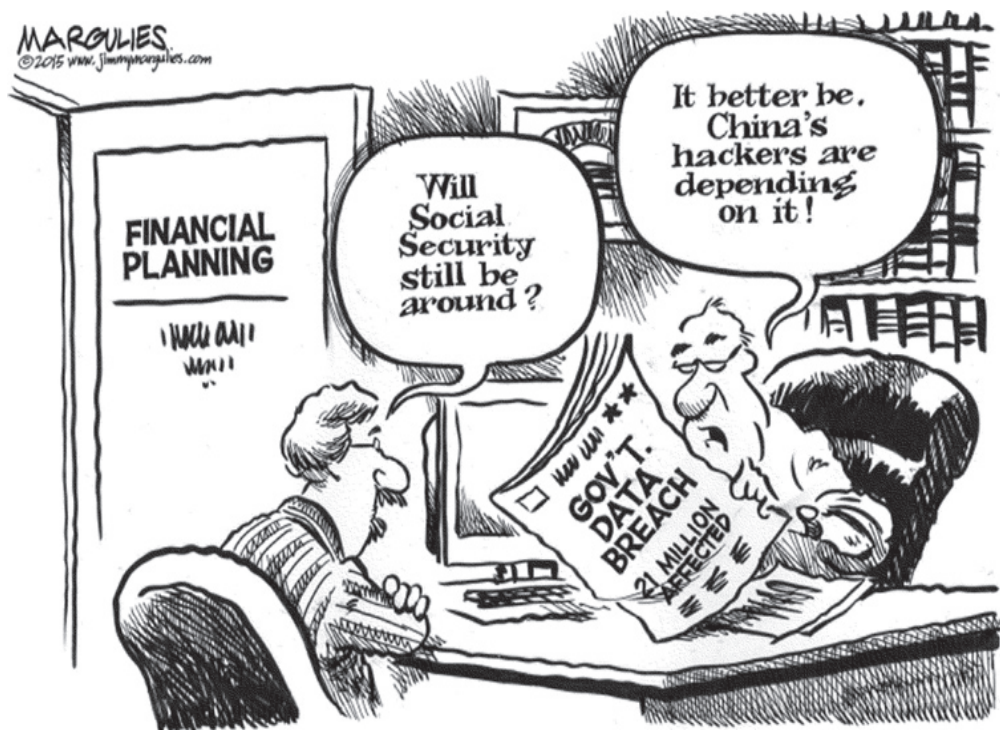

Project Vida will reopen clinical services on August 3, 2015, from 9:00 a.m. to 1:00 p.m., on the grounds of La Clínica Guadalupana, 901 Ascension, in the Agua Dulce colonia near Horizon City. Festivities will include a Health Fair and screenings, workshops on enrolling for health insurance, a brinca-brinca and other activities for children, a giveaway of 150 food baskets from El Pasoans Fighting Hunger, and lunch provided by Clint Independent School District. Registration for primary health care services will be available for those needing sliding scale fees. Most insurance will be accepted including CHIP, Medicaid and Medicare. Originally established by the Sisters of Charity in 1995, La Clínica Guadalupana closed in 2010 due to the financial pressures of providing uncompensated care. Representatives of the Sisters and other community partners and officials will be on hand to celebrate Project Vida's resumption of health care services in the area. The Clínica Guadalupana building is still under renovation. However, funds provided by the U.S. Department of Health & Human Services/Health Resources & Services Administration (HRSA) to refurbish and reopen the clinic also allow Project Vida to provide primary health care services on site from the agency's Mobile Clinic until the building is ready to open.

## Record flight

It took Charles Lindbergh 33 and half hours to make his historic New York to Paris solo flight in 1927. Lucky Lindy's Spirit of St. Louis carried 425 gallons of fuel for the 3,500 mile journey. Switzerland's André Borschberg had no fuel aboard his plane, the Solar Impulse 2, when he took off on his record-breaking solo flight from Japan, landing 4,000 miles and nearly five

days later in Hawaii on July 3, reports the Association of Mature American Citizens. Borschberg's achievements: he broke the distance record for a solar-powered flight; he broke the endurance record, as well; and, of course, it was the longest solo flight by the pilot of any kind of airplane. But, his trip is not over. The aviation pioneer is out to break the round-the-world record. "This oceanic flight to Hawaii demonstrates that if technological solutions exist to fly a plane day and night without fuel, then there is potential for these same efficient technologies to be used in our daily lives, and to achieve energy savings to reduce CO2 emissions," Bertrand Piccard, Borschberg's partner and co-founder the company that built the aircraft.

# Miners' open season with three straight away games

It may be very difficult to believe but the UTEP Miners are only a couple weeks away from opening their spring training camp in Ruidoso.

On Aug. 6, the Miners will officially start the 2015 season with the obvious goal being to improve on their 7-6 record of a year ago and get to another bowl game.

This year's road to a possible postseason game will be much tougher than it was last season.

First of all, the Miners open the 2015 campaign with three straight road games.

That's hardly a polite way of congratulating coach Sean Kugler for turning the program around.

Here's another (what should be unacceptable for a program that wants to change it's image) disappointing factor about this year's schedule – UTEP plays only five games at home while playing seven games on the road.

What happened there? I know that the first two games, at Arkansas and at Texas

Tech, will put some much-needed mullah in the UTEP coffers. But if the idea is to build a successful program, you can't put butts in the seats if the Sun Bowl isn't being used.

And I don't mean any disrespect but the first home game of the season is against Incarnate Word. Who thought that one up?

Everyone I talk to mocks the matchup and they make comments like, "what happened, was Montwood unavailable?"

The home opener is almost a month into the season and there's a good chance that El Pasoans are going to lose interest if the Miners struggle early.

Let's be honest, it's tough to get excited about a home opener in the fourth week of the season, let alone a home opener against Incarnate Word.

The timing of this scheduling mishap couldn't come at a worse time. Kugler turned a 2-10 squad into a bowl team in just one year.

He very clearly told everyone what kind of a team he was going to put on the field and the Miners' new tough guy persona was very evident last season.

And there's no reason to doubt that the

improvement is going to continue. It's just too bad that the fans here will have very few opportunities to enjoy them in person.

The only good thing is that, except for the NMSU game in Las Cruces, all UTEP road games will be televised.

As far the play on the field, the Miners should have one of the best running games in the country.

If there's one thing Kugler loves to do is run the football down the throats of his opponents, controlling the clock and keeping the other guy's quarterback off the field.

Star tailback Aaron Jones, who rushed for over 1,300 yards and scored 14 touchdowns last year, is back and as determined as ever.

The much-maligned UTEP defense was actually competitive last season, giving up 11 fewer points and 100 fewer yards than the year before.

The biggest question mark coming into 2015 involves the most important position on the field – the quarterback.

Unfortunately, none of the three front-running quarterbacks separated themselves from the others during spring

practice.

Garrett Simpson, Mark Leftwich and Ryan Metz will continue the battle in Ruidoso. If neither emerges it could be a really tough year for the Miners.

Of course the season will take on a whole different direction if the Miners were to go out and win one of their first two road games against Arkansas or Texas Tech. That would change things entirely and then fans would flock to that Incarnate Word matchup just to welcome their heroes home.

There's a big difference between 45,000 Sun Bowl fans and 25,000.

But respect is still lacking. ESPN ranks Arkansas #10 in the nation. Out of 128 teams they rank UTEP #111.

I'm sure coach Kugler loves that. He can pound that into his players until they're sick of hearing it and may go out on the field and do something about it.

Then it will be up to Bob Stull and the powers that be, to give the Miners the advantage when it comes to scheduling future games.

The program and the UTEP fans deserve better than this year's yawner of a home schedule.

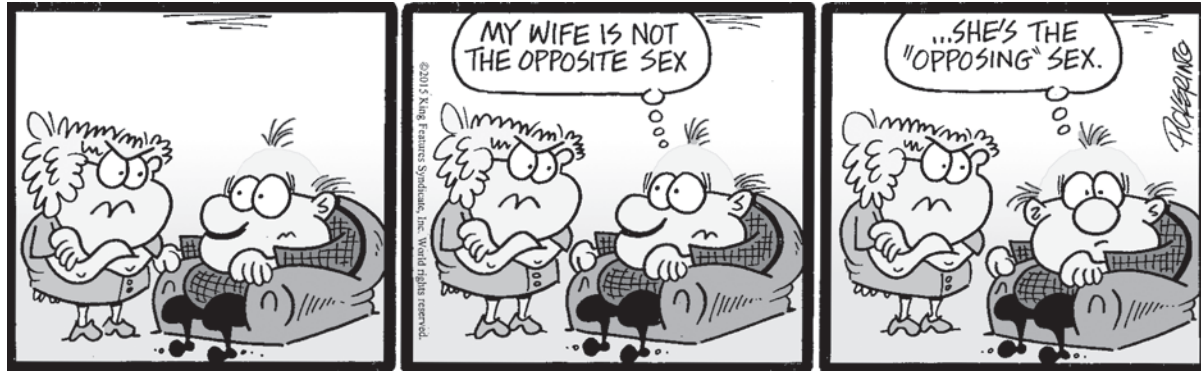

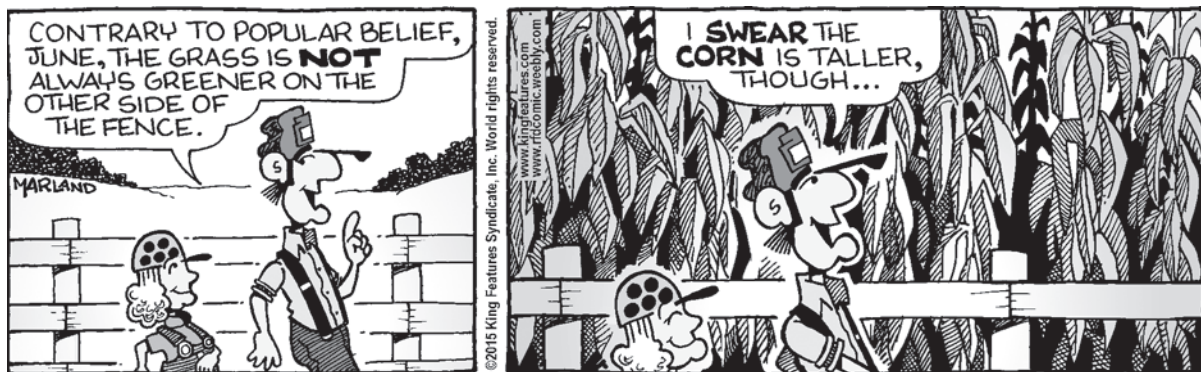

Your good health By Keith Roach, M.D.

DEAR DR. ROACH: I am a 66-year-old white female, 5 feet, 5 inches tall (was 5 feet, 6 inches), weighing 170 pounds. Even though I use gym weight machines for upper and lower body three times a week, walk daily for two miles and spend 15 minutes on a motion trainer at the gym, I cannot stand up easily after gardening on my knees or getting on my knees on the floor. Is there anything I can do to regain the ability to get up off the floor/ground without a struggle? – S.C.

the bulging vein is still present, albeit less tender. Should I have this removed surgically, or will it eventually disappear? – S.D.

A hemorrhoid, a normal vascular structure, can develop a blood clot (“thrombosis”), and then can be exquisitely painful. Often, the clot is removed at the time of examination, giving immediate relief. In most cases, the clot will be reabsorbed within a few days. However, in very large hemorrhoids, occasionally surgery is necessary.

It sounds to me that despite your good exercise regimen, you may have weakness specifically in your thighs – what we call “proximal muscle weakness.” There is a very long list of medical illnesses that affect these muscles specifically (my textbook lists 28 different diagnoses), including common conditions such as low thyroid levels and vitamin D deficiency. I would recommend a visit to your doctor for a careful exam of your nerves and muscles to see if my suspicion is correct. Your doctor may suggest a trial of vitamin D.

There is some suggestion that thrombosed hemorrhoids may indicate a higher risk for colorectal cancer. You should be sure that you have had a recent colonoscopy.

DEAR DR. ROACH: A few years ago, my granddaughter, who was raised in Costa Rica, got Dengue fever. I heard that if you get it a second time, it can be fatal. Is this justified? I am worried about her going back to Costa Rica for holidays. Is there a vaccination or specific treatment? – A.R.B.

If no medical cause is found, I would work specifically on strengthening the hip muscles, which extend the thighs. A trainer at the gym can show you those exercises.

Dengue fever is common, but people who live in areas with Dengue are at much higher risk than travelers. The worst complication of Dengue, called Dengue hemorrhagic fever, happens in people who previously have had an episode of Dengue, so the concern for your granddaughter is justified.

DEAR DR ROACH: I am a 65-year-old man, and two weeks ago I developed a painful hemorrhoid almost overnight. I had never had hemorrhoids before. My primary-care doctor examined me and said I had a “thrombosed hemorrhoid.” It is not very large and in the past week, the pain has diminished, but

There is no commercially available vaccine for Dengue (yet), and no specific treatment. The most effective prevention for travelers is avoiding mosquitos by staying in well-screened

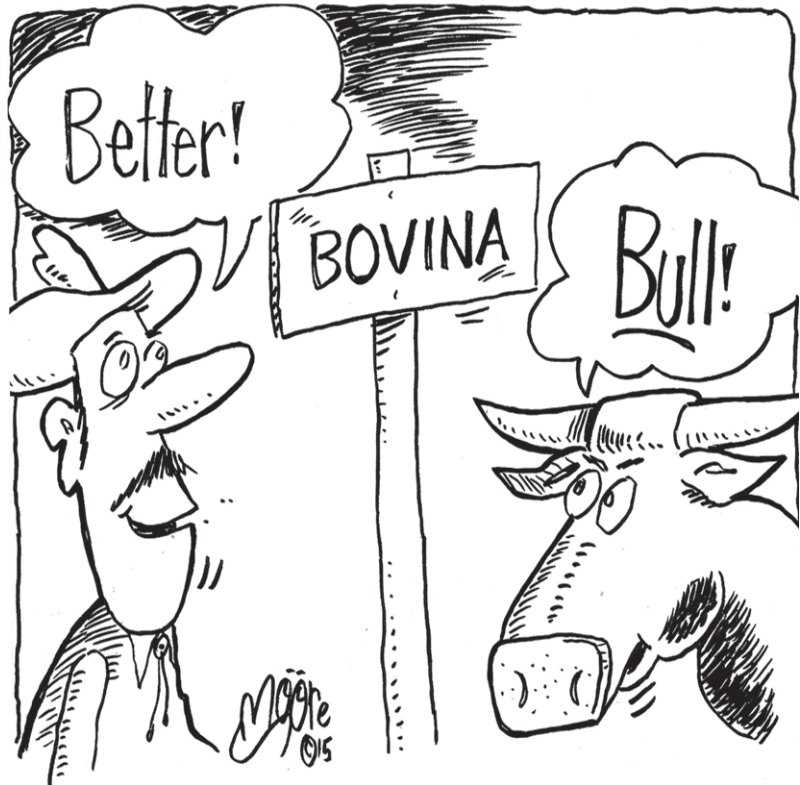

## Social Security Q&A By Ray Vigil

**Q:** This summer, I'll turn 65 and, because of my financial situation, I thought I'd be eligible for Supplemental Security Income (SSI). But my neighbor told me I'd probably be turned down because I have a friend who said he might help support me. Is this true?

**A:** If your friend helps support you, it could have an effect on whether you get SSI and on the amount you would receive. If you have low income and few resources, you may be able to get SSI. However, if you are receiving support from your friend or from anyone else, we will consider that income when making a decision on your SSI eligibility and amount. Support includes any food or shelter you receive that is paid for by someone else. For more information, visit [www.socialsecurity.gov/disabilityssi/ssi.html](http://www.socialsecurity.gov/disabilityssi/ssi.html).

**Q:** I have a 24-year-old daughter who has been disabled by recurrent neuroblastoma since birth. Will she be eligible for benefits as my disabled child?

**A:** Yes. In general, an adult disabled before age 22 may be eligible for child's benefits if a parent is deceased or starts receiving retirement or disability benefits. We consider this a "child's" benefit because we pay it on the parent's Social Security earnings record. The "adult child"—including an adopted child or, in some cases, a stepchild, grandchild, or step grandchild—must be unmarried, age 18 or older, and have a disability that started before age 22. 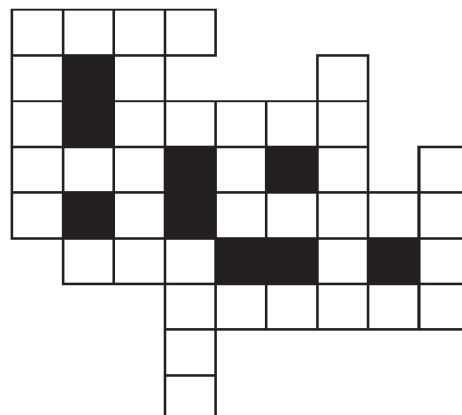

There may never be a truly "level" playing field in that regard. But in the meantime, here's hoping that the next time a woman leaves the starting line, steps up to the plate or walks out of a tunnel, the adult sport fans among us will notice more than what she is wearing but what kind of game she is bringing.
