### House calls

If you are a baby boomer, you might recall the days when doctors made house calls, says the Association of Mature American Citizens. They don't do that anymore because they say the practice is time consuming and inefficient. Or is it? Dr. Thomas Cornwell, a Chicago-based physician, is one of the few doctors who still make house calls. He is also CEO of the Home Centered Care Institute and he told the New York Times recently that that many elderly patients who are treated at home might receive better care at less cost. "I had a 92-year-old patient with a very high temperature. I brought in a portable X-ray and diagnosed pneumonia; she didn't have to go to the hospital, and lived four more years," Cornwell recalled.

## Rotary Clubs develop community leaders

As part of local Rotary Clubs' recognition of the Rotary International foundation's 100th anniversary, two local chapters recently hosted a special presentation by Dave Anderson, District 5520 governor for Rotary clubs in New Mexico and Far West Texas.

Anderson, a native of Ridgewood, New Jersey, said that he first fell in love with the Southwest at age 14 when he attended Philmont Scout Ranch in Cimarron, New Mexico. He is a graduate of the University of Denver and a veteran of the U.S. Air Force. As an airman, he was stationed in the Southwest before overseas assignments to Vietnam, Korea, England, Germany, and Greece. He is also a recipient of the Airman's Medal

for Heroism. He and his wife, Maureen, are members of the Del Norte Rotary Club in Albuquerque, where he is a past president. He is semi-retired from his company, Paragon Technical Services, a federal government contractor.

The guest presenter spoke to the Rotary Club of Northeast El Paso and the Rotary Club of West El Paso respectively during meetings held on separate days. To both groups, Anderson delivered a message based on the worldwide organization's 2016-17 theme of "Rotary Serving Humanity".

"This year marks the 100th anniversary of the Rotary Foundation," Anderson said. "What began with a donation of \$26.50 has become a \$3 billion effort today by Rotarians herein our communities and around the world in support of humanitarian efforts," he added.

Anderson explained that Rotary

International's goal of eradicating polio that began in 1985 is getting closer to reality each year. "We're almost there," Anderson told Rotarians. "There are currently only 19 active cases of the disease and those are centered in Afghanistan and Pakistan. There has not been a new case on the entire African continent for two years," he stated.

Rotary has been the leader in the global fight against polio, joining with partners World Health Organization, UNICEF, U.S. Centers for Disease Prevention, and the Bill and Melinda Gates Foundation, according to club officials.

The local region's Rotary organization includes 68 clubs and some 2,600 members in District 5520, which is the largest Rotary district geographically in the United States. Local district clubs have been active in raising funds and working on projects through the Rotary's global grants program. In the past few years, members have been able to raise nearly \$750,000 collectively for regional project. They have also been involved in foreign endeavors such as providing clean water for Guatemalans, medically repairing cleft palate defects and cross-eyed conditions in children throughout Mexico, and promoting efforts that lead to the clean disposal of hypodermic needles, according to the district governor.

"There is an important need today to expand Rotary's base membership in each of the region's 68 clubs," Anderson told local Rotarians, bringing his message back home. "Rotary is an ideal environment for developing leadership in communities all across this region. We're no longer our father's Rotary Club, and we invite young future leaders who share our humanitarian goals to join us from all walks of life and careers," Anderson said. He added that the district and international organizations are ready to help with local projects in terms of community grants.

Rotary Club Northeast El Paso president Jimmy Melver and West El Paso president Ofelia Mietzko, each supported Anderson's comments about the need for continual support of the foundation's PolioPlus program and the importance for expanding club membership in order to continue making an impact in the local communities.

# Make sure every dollar you give to charity counts

Deciding to make a charitable contribution can arise from a desire to help others, a passionate commitment to a cause or the aim to give back to a group that once helped you or a loved one. Choosing which organizations you want to support can be difficult. There are over a million public charities in the United States according to the National Center for Charitable Statistics, and every dollar you give to Charity A is a dollar you might not be able to match for Charity B.

Whether it's a friend's charity run or supporting an animal rescue, often the decision to give comes down to a mix of internal and external factors. You have to determine which causes are most important to you, and with outside help you can compare how effective various charities are at using their funding.

Many non-profits do incredible work, but it's always smart to verify their claims. You can start your due diligence by double checking an organization's tax-exempt status using the Internal Revenue Service's (IRS) Exempt Organizations Select Check Tool. Once you verify its non-profit status, you want to make sure it's well run and makes a significant impact. There are several non-profits that evaluate and rate charities. You can find their guidance online and use it to compare charities and inform your gifting.

Sometimes a specific event rather than a general cause can spur you into action. When this happens, if you want to be

sure that your money goes to support that particular cause you might want to narrow your search to charities that let you specify how your donation will be used. Otherwise, your money might not directly support those affected by the crisis.

Donating to a non-profit with effective programs and processes is the way to go if you're trying to help as many people as possible, but you can also make contributions to individuals or families through a crowd-funding website. There's something special about knowing exactly who and how you're helping, and they'll appreciate the aid from a stranger. Similarly, you can help entrepreneurs by making a microfinance loan through a non-profit. You can relend the money you're paid back to continue supporting small businesses.

If you're looking for ways to increase your contribution, ask your employer if it has a matching program. Some companies will double, or even triple, your gift to select nonprofits. If your company doesn't offer such a program, you could speak to your human resources department or boss about establishing one.

Third-parties also fund matching campaigns for charities. You can ask a charity if there's a campaign running and make sure your donation qualifies. Unless there's a pressing reason to make a donation today, you may want to put your money aside and wait until a matching campaign starts.

You might be able to increase your financial impact without outside help if you can claim a

tax deduction for your donation. Calculate your tax savings each year and put the money back into your charity fund. Donated-related deductions can sometimes be confusing, and you may want to check with a tax professional or look online for tips from the IRS.

Your charitable gift could be the start of a legacy of giving among your family. By making donations a regular event during your children's formative years, you're establishing charitable giving as a family value that they can take into their adult lives. To engage children, make a donation to support a child's favorite cause and show them how the money makes a difference. For example, you could follow up a donation to a non-profit animal rescue with a visit to the shelter to see how the money helps the staff take care of the animals.

**Bottom line.** Making a donation is one way to support a cause you believe in and ensure your gift has a meaningful impact. You can do this by having money available when it's needed, donating to worthwhile charities, looking for ways to increase your financial impact and passing on a legacy of giving.



# A great view from the little orange cone

I wonder sometimes whether we realize how lucky we all are.

We all live in one of most fortunate times in the history of the establishment of this little blue planet.

I'm not exactly sure how things were for the citizens of ancient Egypt or what kinds of amenities were available for those who lived during the days of the Roman empire, but there's no doubt that we have it as good as any peoples have ever had it.

And why are we so lucky? It's an easy answer... technology.

Think about all the technical

advantages we take for granted every day.

For instance, I didn't have to grab my homemade sling and go out and hunt for my dinner. I merely, and rather heroically I might add, drove my car to the grocery store and picked out my pre-wrapped piece of chicken.

No muss, no fuss.

And do you know how I went there - I actually drove my own car. Christopher Columbus never had a car.

From hand-held telephone/computers to electricity to running water to flying on airplanes to clothing to advancements in medicine to the internet to reaching the stars - technology has turned the world

upside down and made all our lives so much better.

On a smaller scale, but just as relevant, is the role technology has played in the world of sports.

Over the years, there have been some drastic changes in the way sports are played, covered, marketed, officiated and coached.

There was a time that all teams bussed to their locations. Now they enjoy first-class accommodations on luxury airliners and get to their destinations in one-tenth the time.

Would you believe there was a time that games were shown on TV without instant replay or slow motion or graphics or even color?

Even my own world of reporting has changed drastically over the last 20 years due to advances in technology. When I first started this gig I was using a typewriter.

For those of you under 20, ask your parents.

I remember watching John McEnroe yell at the officials over what he thought were blown calls. Now that electronic line calling is available, a series of cameras can replay exactly where the tennis ball hits the ground and no amount of yelling can argue with that.

Pretty soon there will be no need for umpires to call balls and strikes because the same kind of technology is already available for baseball.

Of course most baseball guys are still stuck in the stone ages so don't expect that change for a while.

That doesn't mean that every techie has a good idea.

Take the glow puck in hockey for instance. The superimposed glowing line following the puck was supposed to make it easier for fans to see on TV. It didn't.

The NBA tried to switch to a synthetic basketball a decade ago. They switched from leather to some kind of synthetic material. Though cows around the country

rejoiced, the players did not and the idea was scrapped.

There have been thoughts of changing to an orange baseball; some golf clubs have changed to the point of being illegal; until it was perfected, artificial turf caused way too many injuries.

But once in a while, a little improvement comes around that really makes an impact.

The world of college and pro football has added an almost unnoticeable tweak to the way they cover the game that has changed things immeasurably.

And it's called the Pylon Cam. Everyone knows the pylon is the little orange marker that sits on the corner of each end zone.

How many times did cameras have to zoom in from far away to see if a player had crossed the goal line or had gone out of bounds?

Now, with tiny cameras inserted in the pylon facing down the goal line and down the sideline, the fans and the officials have a bug's eye view of difficult angles that were never available before.

And instead of the blurry images zoomed in from 60 yards away, we get a sharp image from a few inches away.

I wonder how long it'll be until they break out the drone cam.



# Your good health By Keith Roach, M.D.

**DEAR DR. ROACH:** I am a 77-year-old male. I had to stop playing golf about two years ago due to joint pain. I had psoriasis from age 15 until I was 40. I am retired from the Navy and had to be hospitalized twice during my time in service due to my skin. Why it disappeared at age 40, I don't know. Is it possible that I could have psoriatic arthritis? One doctor I saw said that I had to have psoriasis in order to get it. I saw that you said that sometimes the arthritis shows up before the skin lesions. Can it show up after you have quit having the lesions? – S.S.

Indeed, psoriatic arthritis can show up years after psoriasis starts and when there are no skin lesions. Often, pits in the nails or other nail changes are seen in those with psoriatic arthritis.

However, having psoriasis doesn't protect you from other types of arthritis, such as osteoarthritis or rheumatoid arthritis. Since psoriatic arthritis is so destructive, you should see an expert, perhaps a rheumatologist.

**DEAR DR. ROACH:** Do varicose veins in the leg still return blood? Does circulation diminish if they are removed? Should the elderly avoid removal? What if a vena cava filter exists for a one-time

Varicose veins are dilated veins. They are very common, especially as we get older, and they seem to run in families. They often come because of leaky valves inside the veins. A previous blood clot is a risk factor, and a filter may make varicose veins and clots somewhat more likely.

They do continue to function, returning blood. They should be treated conservatively, with leg elevation, exercise and compression, such as using pressure stockings. I seldom recommend more-aggressive therapy, but if they are symptomatic (pain, tightness, skin irritation) despite a good trial of conservative treatment, they can be treated with laser or radiofrequency ablation, by injecting medication into or around them, or by vein stripping. A vascular surgeon is the expert on these treatments.

**DEAR DR. ROACH:** I am a 63-year-old male who had a subarachnoid hemorrhage in 2008. The source of the bleed could not be found, and fortunately I came out of it in good shape, with no adverse effects. My doctor prescribed diclofenac [an NSAID] for joint and muscle pain, and it does help. Do you see a problem with this, considering that it thins the blood? – T.O.M.

Since the aneurism wasn't repaired, I would not recommend taking the NSAID unless your consulting neurosurgeon has specifically told you that it is

**Don't be scared of using secure services**

Autumn is the season of dressing up as monsters and watching scary movies in the dark. Even though most of these tricks and treats are just for fun, some of them can be scary, and for good reason. One of the most common threats we face is identity theft. Just imagine someone stealing your information and pretending to be you. You would have no control as this person acts in your name, spending money – and possibly, ruining your credit.

That is one trick you can do without, which is why we've added an extra layer of security for our customers when they interact with us online.

Your *my Social Security* at [www.socialsecurity.gov/myaccount](http://www.socialsecurity.gov/myaccount) is a safe and secure place to do business with us.

On July 30, 2016, Social Security implemented a new layer of security, asking account holders to sign into their account using a one-time code sent via text message. This second layer of security requires more than a username and a password is known as "multifactor authentication." Although we have always provided the "extra security" option to account holders, we implemented this new process to comply with the President's Executive Order on *Improving the Security of Consumer Financial Transactions*.

As before July 30, current account holders will be able to access their secure account using only their username and password. We highly recommend the extra security text message option, but it will not be required. If you are uncomfortable with texting, we will be creating an option where you will receive a code via email.

We strive to balance security and customer service options, and we want to ensure that our online services are both easy to use and secure. The *my Social Security* service has always featured a robust verification and authentication process, and it remains safe and secure.

There's no requirement that you access your personal *my Social Security* account as a result of the steps we are taking. However, when you do access your account, we encourage you to sign up for the extra security text message option. You can access your account by visiting [www.socialsecurity.gov/myaccount](http://www.socialsecurity.gov/myaccount).


