
Bare-knuckle logging

If you get a scam email, you can create a spam folder in your files to store them, and you can go to your settings and automatically block future emails from that account. Every computer should have some type of security program like the one above.

Beware of scammers

EL PASO COUNTY - Unsuspecting victims are losing thousands of dollars to all types of scams that can be financially and emotionally devastating - especially during the holidays.

Scammers, using either phone calls or emails, seek to find a person's vulnerability through a variety of approaches. Some of these scams involve false sweepstakes or lottery winners, family or friend emergencies, debt collections, credit card issues, adware or malware problems, tech support services, charities, utilities, government grants, travel or vacation offers, and tax collection demands.

Threatening phone calls demanding money is one of the most common ways scammers find victims, according to federal law enforcement officials. Often times they use scare tactics, like jail time. And they won't stop because they are on the job 24/7, constantly re-inventing old tricks with new ones, officials noted.

A current scam, that the U.S. Marshals agency is alerting the public about, is where impostors tell victims that they can avoid jail time for missing jury duty by paying a fine with a debit or gift card.

Federal law enforcement officials said that scammers attempt to make themselves sound credible by providing fake badge numbers or names of actual law



This month Medical Marketing and Media magazine published its 2017 Health Influencer 50, a "list of professionals regarding physician practice autonomy, across the health care spectrum." tort reform, and intrusive government

The magazine writes that these "influencers" made their impact by innovative thinking and "patient-centric" strategies. As expected, the ever-present Google, Facebook, Twitter, and several medical marketers were amply represented. Disturbingly, five of the top eleven influencers pharmaceutical

Only three of the named organizations were actually involved in the delivery of medical care: Dignity Health, the fifth largest health system in the nation; Ascension, the largest nonprofit health system in the U.S.; and the Cleveland Clinic.

One troublesome "patient-centric" strategy is the ubiquitous brazen directto-consumer pharmaceutical ad. One crafty example is an "informational" or public service-type announcement persuading the viewer to get vaccinated against pneumococcal pneumonia. Ummm. Was the ad sponsored by a health plan? Medicare? The American Academy of Family Physicians? No. The sponsor it is their job to make money. It is our (credited in very small print) was Pfizer, congresspersons who are not doing their the vaccine's manufacturer.

Apparently, the influence of many of these entities extends to Congress. The 2017 lobbying expenses of *Medical Marketing* Magazine's number one "influencer," GlaxoSmithKline, totaled \$3,070,000. The other influencers' lobbying costs: Gilead Sciences (#2), \$2,650,000; Allergan (#4), \$2,380,000; Johnson & Johnson (#8), \$3,160,000; Pfizer (#10), \$8,510,000; and Bayer (#11), \$7,050,000. Overall, the pharmaceutical manufacturing industry hired more than 800 lobbyists to the tune of \$132,405,742.

The mega-health insurer Blue Cross/ Blue Shield's vice president of Strategic more than triple that of the next health results in reasonable prices. insurer that employs lobbyists.

Or perhaps BCBS was rewarded for navigating its way out of the financial depths of the Affordable Care Act's essential benefit mandates. Of the 35 BCBS companies, 23 reported a collective \$1.9 billion decline in earnings for the first nine months of 2015 and 16 reported net losses because the ACA's "free" services resulted in claims paid exceeding premiums collected. But by 2017 BCBS along with the rest of the health insurance industry managed to regain its profits by increasing rates, restricting provider networks, and changing benefits packages.

At first glance, physicians appear to be playing hardball with the big boys. In 2017, the American Medical Association



enforcement agents or judges. Caller ID may also appear to show that they are calling from a court or a government agency. The scammers tell the victims to buy the card, and then call back over the phone.

When in doubt as to whom to report it to, call the El Paso County Sheriff's Department or the El Paso Police Department.

Email and pop-up scams should be reported directly to the Federal Trade Commission (FTC) at uce@ftc.gov. Bank scams should be reported immediately to the Internet Crime Complaint Center.


