### Easy driving

With gas prices falling over the past few months but remaining higher than they were last summer, the personal-finance website WalletHub has released its report on 2018's Best & Worst Cities to Drive in. To determine the most driver-friendly places in the U.S., WalletHub compared the 100 largest cities across 29 key metrics. The data set ranges from average gas prices to annual hours in traffic congestion per auto commuter to auto-repair shops per capita. El Paso was ranked 8th in this study. Corpus Christi (2nd) and Plano (5th) were also in the top ten. Other stats include:

- Greensboro, NC, residents spend the fewest annual hours in traffic congestion per auto commuter, 4, which is 25.5 times fewer than in Los Angeles, CA, the city where residents spend the most at 102.
- Gilbert, AZ, has the fewest car thefts (per 1,000 residents), 0.49, which is 33.1 times fewer than in Oakland, CA, the city with the most at 16.23.
- Oklahoma City, OK has the lowest average gas price, \$2.58 per gallon, which is 1.5 times lower than in San Francisco, CA, the city with the highest at \$3.85 per gallon.
- Riverside, CA, has the lowest average parking rate, \$1.43 per two hours, which is 19.2 times lower than in Buffalo, New York, NY, the city with the highest at \$27.44 per two hours.

## Clint ISD to hold first single-member district election

EL PASO COUNTY – The Board of Trustees of the Clint Independent School District has changed its voting format from a total at-large system to a combination single-member/at-large system. The combination consists of five single-member district positions and two at-large positions.

What does that mean? It means that all seven seats on the Board will no longer be voted on by all the voters in the District. Now five of the seats will be voted on only by voters within the boundaries of the single-member district. This also provides for the opportunity for equal representation on the Board among the three communities of Clint, Horizon City and Montana Vista.

There are four positions up for election this year on November 6, 2018. The four positions are Single-Member District 1, Single-Member District 2, Single-Member District 4 and At-Large Position A. Voters will be replacing current at-large

board members Hilda James, Robert Lara, Arleen Parada and Jim Pendell unless any of them choose to run for the At-Large position A or Single-Member District 2.

Then in November of 2020, the remaining three positions will be up for election. The positions are At-Large Position B, Single-Member District 3 and Single-Member District 5.

Candidates for Single-Member District positions must reside within the boundaries of that district. Candidates for At-Large positions may live anywhere within the boundaries of the Clint Independent School District. All registered voters residing in the school district may vote for At-Large Position A (and B in 2020). Registered voters who reside within a Single-Member district, may only vote for Single-Member candidates in that district.


What does it take to be a board member? The qualifications according to policy BBA (legal) are:

- A qualified/registered voter;
- Be 18 years of age or older on the first day of the term

TEXAS – With a new school year about to start, parents of public school children would be wise to review their kids' test

results on the state's assessment exams (STAAR) that students completed in the spring. The review would help gauge a child's performance and identify strengths and weaknesses as he or she enters the next grade level.

As a whole, most Texas

students successfully met grade level or achieved higher level performance on all five State of Texas Assessments of Academic Readiness (STAAR) end-of-course assessments and for

# The real conflict with Iran

It's Tehran's turn for the "fire and fury" treatment.

In response to Iranian President Hasan Rouhani telling Donald Trump not to "play with the lion's tail" because "war with Iran is the mother of all wars," the president fired back in an emphatically all-caps tweet warning of "CONSEQUENCES THE LIKES OF WHICH FEW THROUGHOUT HISTORY HAVE EVER SUFFERED BEFORE."

Since the last time Trump theatrically threatened a regime with destruction he quickly turned around and had warm talks with Kim Jong Un in Singapore, his Twitter account has lost some of its deterrent force.

But the exchange of words has focused attention on a growing confrontation with Iran, in which the United States has the upper hand. When Trump pulled out of the Iran deal earlier this year, there were warnings that it

would split the Western alliance, prompt an Iranian nuclear breakout or leave the U.S. isolated and unable to effectively sanction Iran on its own.

Instead, Iran is in the midst of an economic crisis before the U.S. has truly ratcheted up the pressure. In less than a year, the Iranian currency, the rial, has lost half its value. There have been broad-based demonstrations around the country. Major multinational companies are pulling back from doing business in Iran, including General Electric and Siemens.

Iran wasn't in position to take economic advantage of the windfall of the nuclear deal. It was most interested in funding its terrorism and foreign adventurism, and even if it weren't, its economy is hopelessly corrupt.

U.S. sanctions begin to snap back on Aug. 6, and although the administration's goal of getting Iranian oil exports to zero by November


is unrealistic, Iran could lose 1 million barrels a day in exports (in May, its exports had hit a record 2.7 million barrels a day).

This is nothing less than financial warfare against the regime, aimed at denying it hard currency to fund its foreign operations and ultimately at destabilizing it. The administration denies that it has a policy of regime change, but U.S. demands for a new deal are so sweeping and fundamental that Tehran couldn't comply short of a radical reorientation toward becoming a normal state.

The economic campaign is coupled with a strategy of backing our allies – Israel, Saudi Arabia and the United Arab Emirates – to the hilt in resisting Iranian aggression in Syria and Yemen.

With proxy forces across the region, Iran has cards to play, and the regime is inherently dangerous. At a time when it should be doing everything to curry favor with the Europeans, one of its diplomats was arrested in Germany for plotting a terror attack on an Iranian opposition group in France.

But Iran lacks several advantages



enjoyed by North Korea. It doesn't have an overwhelming, powerful patron like China. It unites Israel and the Arab states, and none of our regional allies are pressuring us to negotiate with Tehran the way South Korea pushed us to talk with Pyongyang. Finally, Iran doesn't yet have nuclear weapons.

This gives the administration leverage. The mullahs shouldn't fear presidential tweets as much as the economic clampdown to come.


be filled at the election or on the date of appointment, as applicable;

- A resident of the district he or she desires to represent for six months before the filing deadline;
- A resident of the state for 12 months before the deadline;
- Not be mentally incapacitated (as defined in policy); and
- Have not been convicted of a felony (as defined in policy).

However, the most important qualification

is that candidates have a genuine and heartfelt concern for the educational needs and wellbeing of all the students enrolled in Clint ISD, as well as the nearly 1,500 employees of the District.

## 2018 Property Tax Rates in El Paso County Emergency Services District #1

This notice concerns 2018 property tax rates for the El Paso County Emergency Services District #1. It presents information about three tax rates. Last year's tax rate is the actual rate the taxing unit used to determine property taxes last year. This year's *effective* tax rate would impose the same total taxes as last year if you compare properties taxed in both years. This year's *rollback* tax rate is the highest tax rate the taxing unit can set before taxpayers can start tax rollback procedures. In each case these rates are found by dividing the total amount of taxes by the tax base (the total value of taxable property) with adjustments as required by state law. The rates are given per \$100 of property value.

Of course, Dez only listed his name when he tweeted what Jones had said. Bryant responded by saying that the Cowboys needed a scapegoat and that the problem wasn't him – it was the "garbage ass play calling."

There were many times Dez ranted and raved on the sidelines complaining about the play calling, and I'm not sure he didn't have a point some of the time.

But the truth is, most of the time it was because the ball wasn't thrown his way.

I'm not sure that anyone is going to be surprised that Dez finally broke out of his

silence, but Frederick and Lee were both shocked about being singled out.

Lee said he and Bryant did butt heads at times but that was because he wanted the receiver to be more accountable to the team and his teammates. Lee added that a lot of the players felt that way.

He also said that he loved Dez and wished him well.

Frederick simply said that Bryant was always a good teammate to him and that he didn't know of any fifth-year players (like himself) who make personnel decisions.

There was definitely pressure on Prescott to get the ball to Bryant last season, and many times he tried to force the ball in to him.

Like any team, when Bryant was unstoppable the Cowboys put up with his

THE HISTORY CHANNEL

mathematics and reading tests in grades 3, 4, 5, 6, 7 and 8, according to statewide results for the spring 2018 administrations that were released in mid-June by the Texas Education Agency (TEA).

Additionally, the spring 2018 STAAR results reflect increases in most of the courses from the assessment scores of the previous school year.

Students receive a STAAR performance label of Masters Grade Level, Meets Grade Level, Approaches Grade Level, or Did Not Meet Grade Level. Performance labels of Masters, Meets, or Approaches Grade Level indicate achievement on the assessment. They are also meant to provide clear, accurate information for parents in terms of how their student is performing, specifically in regard to students meeting grade level.

Parents are encouraged to visit [www.texasassessment.com](http://www.texasassessment.com) and "Log In, Learn More" to see specific information regarding their student(s). With a student access code (provided by your local school district), parents can view a variety of resources and assessment components, including each STAAR question and answer – along with their student's answers.

The website also provides resources designed to help parents prepare their son or daughter as they progress from grade level to grade level. Resources include tools to support a student's ability to read and write, as well as tips and questions to help plan and prepare for college and a career.

# The great vitamin debate

DEAR DR. ROACH: Do you prescribe vitamins or treatments to enhance the immune system? – C.N.

I do not. In my opinion, a healthy diet makes a deficiency of a vitamin or mineral severe enough to weaken the immune system unlikely. Stress reduction (through many techniques) and good sleep are more important than supplements.



People think that a daily vitamin and mineral supplement is like an insurance policy against a good diet. However, many studies have shown that taking vitamins does not, in general, lead to improvements in prevention of disease, including heart disease, cancer or infections. So I would be much more likely to recommend a better diet (especially in the fresh fruits and vegetables) than I would a supplement.

Many adults have not gotten all the vaccines that are recommended, and these are a huge benefit to your immune system for those specific bacteria and viruses.

DEAR DR. ROACH: I am an 81-year-old male in generally good health. I am maybe 10 pounds overweight. I have had no heart attacks or cardiac symptoms. I walk on the treadmill for exercise. I have controlled hypertension, and have been taking simvastatin, 10 mg. My LDL is 71, very favorable. My HDL is also good, at 73. Several years back, when I started the statin, my doctor added Zetia, 10 mg. At the time, I wondered why this would be OK, and he said, "Well, there is a certain synergy there." While I have continued taking the Zetia and suppose it might be helpful, I wonder if I need it. I say this because it is rather expensive (about \$500 a year with my part D coverage). It is the only thing I take that costs me this much. My reading of the literature suggests that while Zetia might help the LDL level, there is no evidence that it improves longevity (i.e. cardiovascular). – J.P.

This is a confusing subject, because the theory (that lowering cholesterol protects your heart) and the evidence (that it actually works) don't exactly align. High cholesterol certainly is associated with a higher likelihood of heart blockages, which can lead to heart attack and death. However, not all treatments that lower cholesterol reduce risk of heart attack.

On the one hand, there are treatments that lower cholesterol that do help your heart. The Mediterranean diet clearly reduces

risk of heart attack. Dr. Dean Ornish's plant-based diet of very little fat and little or no meat, in combination with stress reduction and smoking cessation, actually reverses blockages in arteries in some people. Statin drugs reduce cholesterol and help prevent heart attacks, at least in people at high risk for them.

On the other hand, ezetimibe (Zetia) reduces cholesterol, but like most nonstatin drugs to treat high cholesterol, it has not been proven to reduce heart disease risk. It tends to have few side effects and probably is not harmful. But you are correct

that it is expensive, and like all medications, it can possibly cause harm. Being conservative about medication, I very rarely prescribe it. Studies are ongoing, and I will readdress this topic when there is more evidence.

**VA links with National Cancer Institute**

A recent move by the Department of Veterans Affairs will allow seriously ill veterans to access a wider range of cancer treatments. The VA has just hooked up with the National Cancer Institute.

The program is called NAVIGATE, standing for NCI and VA Interagency Group to Accelerate Trials Enrollment. Those trials will be held at 12 VA sites across the country, with the facility in Boston serving as the coordinating center.

Veterans can benefit by taking advantage of clinical trials run by the cancer institute. These trials often use experimental treatments, such as immunotherapies and precision medicine, which are individualized to the patient. Treatments often are cutting-edge and not offered elsewhere.

While the VA already has other types of research running at over 100 sites, it's been difficult for it to start and complete trials, such as the ones

run by NCI. With NAVIGATE at the helm, veterans with cancer will have much easier access as they work toward a cure.

One of the programs run by the VA's Office of Research and Development is the Million Veteran Program (MVP), which seeks to collect a blood sample and health info from a million veterans. The goal is to study how genes affect health, especially with cancer, diabetes and PTSD, and to learn why some treatments work for certain veterans but not others. The VA Technology Transfer Program seeks to speed up access of VA technology and patents, by both veterans and the civilian population. Currently the VA has hundreds of patents ranging from a collapsible wheelchair and an ankle-foot prosthesis to a method to screen skin for tissue damage.

If you want to consider signing up for one of the cancer trials, talk to your VA physician.



- Take the time to presort laundry in order to cut down on laundry time. Designate a day of the week to wash bulky items like towels or comforters, so that the increased drying time of these loads does not delay your normal washing.

- When's the last time you cleaned your freezer's automatic ice bucket? Before a trip to the beach, lake or park is the perfect time. Go ahead and empty all the ice from the bucket into your cooler, then wash with a mild soap and rinse thoroughly. Allow to air dry before reinserting the bucket in the freezer and restoring ice service.

- Use a mail sorter at the kitchen sink to store sponges upright and separated. They usually have enough slots to fit several sponges, each with air surrounding it so that it will dry quickly and evenly. Dry sponges collect less bacteria, which can end up making your sponge smell bad! If the mail sorter is metal, give it a coat of clear spray sealant to prevent rusting.

- Back to school hack: Invite several friends from previous years to meet up at a local park in the days before school starts. If new kids have moved into your neighborhood, be sure to invite their family too. Knowing someone can take the stress off of first-day jitters!
