Everyone who joins the Arbor Day Foundation in September will receive 10 free trees as part of the Foundation's Trees for America program. Through Trees for America, everyone is encouraged to plant trees, which benefit the environment and improve the quality of life. With nearly 1 million members and supporters, the Arbor Day Foundation is the nation's largest nonprofit organization dedicated to planting trees. People joining this month will receive one of the following tree packages based on their location: 10 Arizona Cypress, 10 Live Oak or 10 Mix trees including eastern redbud, white pine, sugar maple, white flowering dogwood, pin oak, red maple, river birch, silver maple, northern red oak and Colorado blue spruce. The trees will be shipped postpaid at the right time for planting between October 15 and December 10. The 6- to 12-inch trees are guaranteed to grow or they will be replaced free of charge. Easy-to-follow planting instructions are enclosed with each shipment of trees. New members of the Arbor Day Foundation will also receive The Tree Book, which includes information about tree planting and care. Archaeological society to host award banquet

Cruz Camargo will be featured speaker

EL PASO COUNTY - El Paso Archaeological Society (EPAS) will hold its annual Award of Distinction banquet on Saturday, September 15 beginning at 6 p.m. at the State Line Restaurant, 1222 Sunland Park Drive.

This year, EPAS will present its honorary award to Joan E. Price, an independent filmmaker and educator, who is being recognized for her extensive work on the petroglyphic and pictographic records that she has compiled regarding rock art found throughout the American Southwest including Hueco Tanks State Park in Texas and Three Rivers petroglyph site in New Mexico.

Price, who earned a master's degree of fine arts from the University of California at Santa Barbara, has been a prolific researcher of the prehistoric Puebloan and Apachean archaeology and cultural landscapes since moving in 1994 to the Jornada Mogollon area that is near Tularosa, New Mexico.

Using her background in Native American cultural and civil rights productions, exhibits and informational campaigns, Price has created numerous

independent media projects in Northern New Mexico and Arizona. She was also guest curator for the Institute for American of the typical brush house, or wickiup, used by indigenous Indian Arts Sacred Mountains: World Heritage exhibit and people of the El Paso area and to speak with Camargo. This is produced two feature films on the sacred landscapes.

In 1999, she founded the Rain House Center for Southwest Learning with Dr. Kay Sutherland to facilitate exchange between Native peoples north and south of the international border. They also produced an ethnographic survey on Hueco Tanks for Texas State Parks in 2001.

Price stated that she relies on contemporary Native American interpretations, scientific and ethnographic research, and her own field work at Three Rivers Petroglyph site for the past 20 years to conduct guided tours, to create PowerPoints presentations for professional conferences, and to support research publications on the concept and evidence of Native American ancestral

Price is currently an active member of EPAS, the Jornada Research Institute of Tularosa NM, and a board member of the Tularosa Basin Historical Society in Alamogordo.

Featured speaker for the recognition banquet will be Cruz Camargo, an El Paso businessman and descendant of the indigenous Manso tribe that settled in the West Texas region. Camargo will share stories about his heritage – its traditions and culture - in his presentation, titled "The History and Culture of the Manso People".

"Camargo is one of the few people of his Tribe who can share the connection between present and past, the continuation of traditions and ceremonies, the artifacts which are still actively in use and details of the life his people lived before the arrival of the Spanish in this area," stated Marilyn Guida, an EPAS member and banquet organizer.

Camargo stated that he will share with the audience his knowledge about how the Manso people used to live as hunters and gatherers, about the crops they raised, the native plants, tools, and medicines they used, about the homes and villages they built, and about the ceremonies they celebrated.

San Eli ISD preps students for education beyond high school

SAN ELIZARIO – The San Elizario Independent School District (SEISD) is implementing a College Credit Pathway Initiative to support the various opportunities for postsecondary success offered at San Elizario High School (SEHS). This initiative will help SEISD to incorporate the new Texas higher education plan - 60X30TX - by streamlining those goals within the postsecondary decision making of students at SEHS. The College Credit Pathway Initiative is a bold plan as it hopes to ensure 100% of SEHS students are on track to earn a certificate, license or degree by 2030.

"A campus that provides any type of college credit opportunity for their students, is a good school," said Maribel Guillen, SEHS Principal. "We have the best of both worlds at our school. high school with sports and extra-curricular activities while at the same time a Dual Credit institution."

Students will be afforded the opportunity to enroll in one of four distinct college credit pathways offered at SEHS:

Dual Credit Academy

The Dual Credit Academy at San Elizario High School is a comprehensive program that flexibility to select courses based Elizario ISD.

prepares students for continued on post-secondary goals while success at a post-secondary institution. Students accepted into the academy are provided with an opportunity to earn as a dual credit or AP course are many as 43 dual credit hours. These college credits are based on a focused concentration of tuition. courses aligned with El Paso Community College's (EPCC) core curriculum plan (SB 1091). For school year 2017, dual credit students saved an estimated \$70,000 in tuition.

Advanced Placement Academy

The Advanced Placement (AP) Academy enables willing and academically prepared students to pursue college-level studies while still in high school. SEHS offers 17 advanced placement courses along with an opportunity to take the AP exam. A qualifying exam score helps students earn credit or placement at most fouryear colleges and universities in the United States. For school We are still a comprehensive year 2017, SEHS students who took and achieved a qualifying score on an AP exam saved an estimated \$605,000 in tuition.

Advanced Placement/ **Dual Credit Hybrid**

Western Tech Associates Program

This partnership between Western Technical College and SEISD will give SEHS students the opportunity to graduate from high school while at the same time obtaining an Associate's Degree from Western Tech in the area of Refrigeration, Heating, Ventilation and Air Conditioning. The cost of this program is usually \$36,000 but because this is a Dual Credit instructional offering, this cost is being subsidized by local scholarships from Western Tech and a reduced tuition rate which will be paid for by SEISD. This financial support ensures that this opportunity will not impact the students' future federal financial aid and will be offered at zero cost to the families and students participating in the program.

"This initiative will transform the high school experience of our students by laying out a sequence of courses that students will follow while simultaneously being advised and monitored to


The Manso Tribe

The Manso people were encountered by the Spanish in the area of the Rio Grande near what is now El Paso during the Rodríguez-Chamuscado (1581) and Espejo (1582) expeditions and by the group of settlers led by Don Juan de Oñate (1598). Oñate is believed to be the one who either used the words that became "Manso", or Oñate repeated words that the Manso people spoke to him. The name Manso may not have been the name the people used for themselves. Spanish reports indicate the Manso helped the Oñate settlers cross the Rio Grande near what is now Socorro, Texas. The Guadalupe Mission (established in 1659), in what is now Ciudad Juárez, was originally a mission for the Manso people and was built largely with their labor.






