With couples spending an average of over \$38,000 on their wedding and the industry bringing in \$78 billion in revenue in 2019, the personal-finance website WalletHub has released its report on 2020's Best Places to Get Married as well as accompanying videos. To help couples find the most wedding-friendly destinations, WalletHub compared more than 180 of the biggest U.S. cities across 27 key indicators of cost-effectiveness, convenience and enjoyment. The data set ranges from average wedding cost to venues and event spaces per capita to weather. El Paso was rank 3rd best marriage site in this report. Other stats:

• El Paso, TX has the lowest average wedding cost, \$12,633, which is 3.3 times lower than in Bridgeport, CT, the city with the highest at \$41,457.

· Orlando, FL has the most event planners per capita, 98, which is 16.3 times more than in Baton Rouge, LA, the city with the fewest at 6.

• Yonkers, NY has the most photographers per capita, 239, which is 47.8 times more than in Laredo, TX, the city with the fewest at 5.

• San Francisco, CA has the most musicians per capita, 19, which is 73.1 times more than in Wichita, KS, the city with the fewest at 0.26.

Shooter sought



EL PASO COUNTY - Although April 1st is referred to as "Census Day", most El Paso County households will actually start receiving an invitation to respond to the 2020 Census beginning in mid-March.

The invitation letter will include an Identification (ID) number that is tied to the household's physical address. Once the household residents get their letters, they are then encouraged to go online with the ID number to respond to the Census. However, the ID number is not required to respond to the Census questionnaire, according to Oscar Arriaga, Census Bureau media specialist for the El Paso and Las Cruces region. He added that individuals can also respond over the phone or wait for a paper form to arrive after a few weeks.

Census Bureau officials noted that about 95 percent of households in the local area will receive the invitation letter in the mail, while the other five percent

Among the members are the County of El Paso, City of El Paso, Paso del Norte Community Foundation, Region 19, Rio Grande Council of Governments, elected officials, business leaders, community-based organizations, and other stakeholders who are committed to a complete count, according to Enrique Mata, senior program officer for the Paso del Norte Health Foundation (PDNHF).

The PDNHF program officer stated that the committee was established to develop and implement a robust, collaborative campaign to work in conjunction with the national Census 2020 efforts so that the greater El Paso area can have the most complete and accurate count of residents possible. "If the household has not selfresponded to the Census after a series of mailing reminders, we will begin sending enumerators (census takers) door to door to collect the responses," stated Arriaga. The media specialist also advised concerned individuals to visit the bureau's website if they have any questions about how and where to be counted, about different language support options, about safety/ privacy issues, and about avoiding scams. On Feb 24, 1868, the U.S. House of Representatives articles votes 11 of impeachment against President Andrew Johnson, nine of which cite Johnson's removal of Secretary of War Edwin M. Stanton, a violation of the Tenure of Office Act. He was the first president to be impeached in U.S. history.

 On Feb. 25, 1873, Enrico Caruso, the greatest tenor who ever lived, is born. Caruso recorded scores of arias of three and four minutes in length - the longest duration that could fit on a 78 rpm record.

• On Feb. 26, 1564, poet and playwright Christopher Marlowe is baptized in Canterbury, England, two months before the birth of his fellow playwright William Shakespeare. Historians believe Marlowe served as a spy for Queen Elizabeth while at Cambridge. He was nearly denied his master's degree in 1587, until the queen's advisers intervened.

 On Feb. 27, 1827, a group of masked and costumed students dance through the streets of New Orleans, marking the beginning of the city's famous Mardi Gras celebrations. Early French settlers brought the tradition of Mardi Gras to the U.S. Gulf Coast at the end of the 17th century.

• On Feb. 28, 1983, the celebrated sitcom "M*A*S*H" bows out after 11 seasons, airing a special two-and-ahalf hour episode watched by 77% of the viewing audience. It was the largest percentage at the time ever to watch a single TV show.

• On Feb. 29, 1940, "Gone with the Wind" is honored with eight Oscars, including one for Hattie McDaniel for her portrayal of "Mammy," a housemaid and former slave. She was the first African American actor ever to win an Oscar.

The Benefit Statement, also known as the SSA-1099 or the SSA-1042S, is a tax form we mail each year in January to people who receive Social Security benefits. It shows the total amount of benefits you received from us in the previous year so you know how much Social Security income to report to the IRS on your tax return.

If you live in the United States and you need a replacement form SSA-1099 or SSA-1042S, simply go online and get an instant, printable replacement form using your personal my Social Security account at www.socialsecurity.gov/myaccount. A replacement SSA-1099 or SSA-1042S is available for the previous tax year after February 1.

If you already have a my Social Security account, you can log in to your account to view and print your SSA-1099 or SSA-1042S. If you don't have access to a printer, you can save the document to your computer or email it to yourself. If Security online services.

you don't have a my Social Security account, creating one is very easy to do and usually takes less than 10 minutes.

If you're a non-citizen who lives outside of the United States and you received or repaid Social Security benefits last year, we will send you form SSA-1042S in the mail. The forms SSA-1099 and SSA-1042S are not available for people who receive Supplemental Security Income (SSI) benefits.





Sneezing can provoke this unusual vertigo

DEAR DR. ROACH: After many years of various treatments, including allergy shots, food studies and an ear tube, I was recently diagnosed

with *"semicircular* canal dehiscence." Can you explain what this is and the treatment (besides surgery) to relieve the symptoms of inner ear pressure, dizziness and pressure and pulsation in the head? Are there any medications? - J.D.W.

Semicircular canal dehiscence syndrome is an unusual cause of vertigo. Vertigo is sometimes referred to as dizziness, but



"dizziness" may refer to both unsteadiness (a feeling that you are going to pass out, which medically is referred to as "presyncope") or true vertigo (a sensation of movement when the person is actually still). The vertigo in semicircular canal dehiscence syndrome is different from most other causes of vertigo because it can be provoked by loud noises, coughing or sneezing. It is caused by abnormally thin bone in the semicircular canals, part of the organ of balance in the inner ear. The diagnosis is confirmed by a CT scan of the temporal bone.

The only treatment I have read that consistently is effective is surgery. An ear tube is sometimes tried in people who have symptoms with pressure changes. Medications used in some cases of vertigo, such as meclizine (Antivert), usually will make SCDS symptoms worse in the long term. Anti-nausea medications like ondansetron (Zofran) may help if nausea is severe, but have their own side effects. Vestibular rehabilitation by a specially trained physical or occupational therapist may have some benefit if surgery isn't contemplated.

DEAR DR. ROACH: My father is 72 years old. This year he was diagnosed with an enlarged prostate. For now, the doctor has inserted a catheter. My question is: What process or what treatment is best at his age? We are in the Philippines. – M.M.C.


Enlargement of the prostate gland is a common problem for men in their 70s and older. Sometimes it gets so bad that a man cannot urinate at all or the pressure in the bladder is at risk of damaging the kidney. In those cases, a catheter often is used as a temporizing measure. Unfortunately, a catheter causes inflammation, so it may actually worsen the prostate problem temporarily while still protecting the kidneys. Because of this, the catheter usually needs to be kept in only for about one to two weeks.

During this time, medication usually is started to try to reduce prostate size. For most men, a benign (not cancerous) enlarged prostate can be treated with medication - an alpha blocker, like tamsulosin, sometimes with a second medicine, like finasteride. If that doesn't work, there are several surgical options.

His doctor needs to be sure that the enlarged prostate isn't cancer. A physical exam and blood tests may answer that question; other times, a biopsy is needed.

There is no best treatment for everyone. It depends on how large his prostate is, any other medical problems he may have and the expertise of the doctor treating him.

In the United States, the options include a traditional surgery, called a transurethral resection of the prostate (TURP); laser-based treatments; other heat-based treatments (microwave, water vapor ablation and radiowave); and even more newer treatments that are less well-studied. In general, medical therapy is worth a try for most men before considering surgery.






