El Paso VA Health Care System's new westside facility increases vets' access

EL PASO COUNTY – El Paso's Veteran Affairs Health Care System's newest facility is now open for local area veterans, as the agency expands its services to support the growing number of veterans in the region.

According to the new facility's clinic manager, Kraig White, local area veterans represent a larger share of the population than on the state and national levels. Veterans account for 8.2 percent of El Paso County's residents over 18, compared to 7.2 percent in Texas as a whole. White said that the new clinic was needed because there was no more room to grow at the 23-year-old Piedras Street main VA center.

The new clinic, which includes two primary care teams, began operating at 50 percent staff capacity recently and will be available for in-person meetings with patients. However, patients will have in-person appointments with medical staff only when it is deemed medically necessary, White stated. The rest of the appointments will be conducted remotely, he said.

The next phase of the plan will be implemented after data shows a seven-day decline in local COVID-19 cases, White noted. Upon reaching the case decline target, the clinic will be able to conduct in-person appointments at 25 percent patient capacity, he explained.

The new 15,000 square-foot facility, located at 1870 Northwestern Drive, is West Texas and Southern New Mexico's first significant expansion of the system's primary care capacity in nearly a decade, according to VA health care officials.

Cost for the new community-based outpatient center was

about \$2.3 million. Construction of the facility was done by Elevation Companies LLC, based out of Denver, Colorado. Plans are for the VA to lease the building from the construction company for 10 years.

The new center is expected to create 61 new jobs, with priority given to job applicants who are military veterans. El Paso VA Public Affairs Officer Ginette Bocanegra said that the new center will allow the VA Health Care System to care for more veterans at its own facilities.

"We were having to send a lot of patients to the community

EPCC receives ED grant

EL PASO COUNTY – The Department of Education TRIO Programs has awarded a \$707,647 federal grant to El Paso Community College (EPCC) for the Student Support Services Program (SSSP). It is the largest award in Texas and the eighth largest in the nation. The objective of the grant is to provide academic and other support services to low-income, first-generation or disabled college students to increase students' retention and graduation rates, facilitate their transfer from two-year to four-year colleges, and foster a supportive institutional climate.

"The EPCC Student Support Services Program team are dedicated to our students' success and strengthening our El Paso community through education," said Lucia Rodriguez, Student Success Director at El Paso Community College.

"The SSSP staff work daily to accomplish great student success results that ensure our students start strong and finish their education."

The SSSP has helped first generation students at EPCC for more than 30 years. As a result of this grant, an additional 600 students will be served each year over the five-year grant program. SSSP Manager, Cynthia Velasco, is excited for the opportunity to continue fostering an institutional climate supportive of student success. "In addition to academic tutoring, students receive advice and assistance in postsecondary course selection, information on financial aid programs and benefits, counseling services designed to improve financial and economic literacy and activities to assist students apply and enroll in four-year programs of postsecondary education. We assist students to develop academically and personally on their

EPWater offers payment assistance

EL PASO COUNTY – Customers who have been financially-impacted by the COVID-19 pandemic can now apply to receive payment assistance to help with past due bills. Visit epwater.org/covid19assistance for details of the program and the application.

EPWater received grant funding in the amount of \$500,000 for the COVID-19 Assistance Program. Customers who qualify can receive a credit of up to three months, and no more than \$500, toward past due balances. Customers are encouraged to apply right away since funding is limited.

The flu shot helps prevent influenza

It might also reduce your risk of developing Alzheimer’s Disease

The Centers for Disease Control (CDC) says it is particularly important this year that we get our flu shots this year because the coronavirus has put an unprecedented strain on America’s healthcare resources. As CDC epidemiologist Mark Thompson put it in a recent article published by NPR: “No year is a good year to get the flu, but this year – with COVID-19 also raging – it’s especially bad.”

Recalling the deadly outbreak of the Spanish Flu in 1918, the same article described the need to promote the flu vaccine this year as “arguably the most important U.S. effort to prevent influenza’s spread among Americans in a century.”

“Indeed, there is an extensive list of the benefits of

flu shots, the newest of which is research that shows the flu vaccine and the pneumonia vaccine are linked to a reduced risk of Alzheimer’s Disease,” reports Rebecca Weber, CEO of the Association of Mature American Citizens (AMAC).

Weber explains that research reports presented at the Alzheimer’s Association International Conference recently show that flu shots may reduce the risk of the disease. She cites an Alzheimer’s Association news release that describes several separate studies.

One of the studies was conducted by a team led by researcher Albert Amran at the University of Texas Health Science Center at Houston. They used a nationwide database of 9,000 individuals 60 years of age and older and found that those who had a flu shot had at least a 17% lower risk of Alzheimer’s.

Another study carried out at Duke University in Durham, North Carolina by Dr. Svetlana Ukraintseva found the Alzheimer’s risk for people between the ages of 65 and 75 who had been vaccinated against pneumonia was reduced by as much as 40%. That study was conducted among 5,146 participants.

The Alzheimer’s Association chief science officer, Dr. Maria Carrillo, noted that the research presented at the Association’s conference “calls for further studies in large, diverse clinical trials to inform whether vaccinations as a public health strategy decrease our risk for developing dementia as we age.”

The immortal Indianapolis

This summer marks the 75th anniversary of the worst disaster in the history of the United States Navy – the sinking of the USS Indianapolis.

Three hundred men died in the initial catastrophe on July 30, 1945, then the survivors cast into the sea suffered unimaginable horrors, abandoned for days without food or water in shark-infested waters.

As long as tales of the sea move human hearts, the story of the Indianapolis will shock and inspire.

She was a heavy cruiser, in between a larger battleship and smaller destroyer. Sleek, fast and elegant, she bristled with firepower – her 8-inch guns could fire a 250-pound shell 18 miles. Franklin Roosevelt made her his ship of state, and she became the flagship of the Navy's 5th Fleet.

During World War II, she saw significant action and suffered a debilitating kamikaze strike at Okinawa. Quickly repaired, she embarked on a secret mission to deliver components of the atom bomb dropped on Hiroshima. She then proceeded unaccompanied to Leyte in the Philippines.


A Japanese submarine stumbled upon her on a dark night. It fired six torpedoes, two of which struck the ship in quick succession right after midnight. The ship sank in 12 horrifying minutes.

Nine hundred men made it off, suddenly in the middle of the Philippine Sea at night with their home, their weapon, their mistress gone. Only about half had a life jacket or life vest. They were spread over miles. Many were wounded.

At first, they were hopeful about

a rescue that didn't come for four excruciating days. The ship's SOS call was picked up at three places, but the message was ignored. A failure in the Navy's tracking system meant no one noticed when the Indianapolis didn't




NOTICE OF TAXPAYERS' RIGHT TO ELECTION TO REDUCE TAX RATE
If the district adopts a combined debt service, operation and maintenance, and contract tax rate that would result in the taxes on the average residence homestead increasing by more than eight percent, the qualified voters of the district by petition may require that an election be held to determine whether to reduce the operation and maintenance tax rate to the voter-approval tax rate under Section 49.23603, Water Code.

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

THE HISTORY CHANNEL

• On Aug. 17, 1978, the Double Eagle II, with three pilots, completes the first trans-Atlantic balloon flight when it lands near Presque Isle, Maine. The helium-filled balloon had flown 3,233 miles in the nearly six-day odyssey.

• On Aug. 18, 1958, Vladimir Nabokov's controversial novel "Lolita" is published in the U.S. The novel, about a man's obsession with a 12-year-old girl, had been rejected by four publishers before G.P. Putnam's Sons accepted it.

• On Aug. 19, 1960, in the USSR, captured American U-2 spy plane pilot Francis Gary Powers is sentenced to 10 years imprisonment for his confessed espionage. Only 18 months into his sentence, the Soviets released him in exchange for Rudolf Abel, a senior KGB spy who was caught and convicted in the U.S. five years earlier.

• On Aug. 20, 1920, seven men, including legendary football star Jim Thorpe, meet to organize a professional football league. The meeting led to the creation of the American Professional Football Conference, the forerunner to the National Football League.

• On Aug. 21, 1911, theft of the Mona Lisa is discovered. After a two-year search for the painting, former employee Vincenzo Perugia was captured attempting to collect a ransom.

show up at Leyte. Day by day, hundreds more men died.

During the day, the sun tortured them. The salt water weakened them. Thirst agonized them. Their life jackets began to give out.

They died of exposure and exhaustion. They died from the nightmarish attacks of circling sharks. They died from the terrible temptation of drinking salt water. They died from madness. They died from sheer despair, giving up and sinking beneath the waves.

Still, somehow, at the extreme edge of human endurance, 317 men survived when a plane on a surveillance mission finally came across them.

For Capt. Charles McVay, a new agony began. As the Indianapolis sank, he had considered going down with the ship before getting swept away by a wave. At first separated from his men, he had the horrifying thought that he

alone might have survived.

The Navy court-martialed him for not having zigzagged to evade attack, even though his orders only made it mandatory during the day, even though the maneuver was of dubious effectiveness, even though the captain of the Japanese sub said he assuredly would have sunk the Indianapolis anyway.

There was a much stronger case that McVay had been let down by the Navy, since he wasn't apprised of reports of Japanese subs operating in his vicinity and the Navy, shockingly, lost track of his ship. Yet McVay was found guilty. A broken man, he took his own life in 1968, and the Navy didn't expunge his record of wrongdoing until 2001.

It's another tragedy associated with a ship whose drama, heartbreaking and astonishing, will never leave us.

McCarthy, Cowboys should enjoy a special season

After months of speculation and uneasiness, the National Football League opened its training camps last week.

Because of the pandemic, it was unclear whether the league would get off the ground this season.

Professional baseball, basketball and hockey have proved that sports could be played during these difficult times, though it hasn't always been easy.

But let's face it, while having those sports again has been nice, nothing compares to the popularity of the NFL.

No other sport in America even comes close.

And speaking of America, it wouldn't be professional football if we didn't take a close look at America's team, the Dallas Cowboys.

So if there really is going to be an NFL season, we might as well talk a little football.

Last season the Cowboys underachieved with a mediocre 8-8 record.

The Cowboys blew out every team they were supposed to, and lost almost every close game they played in almost every way imaginable.

So in my humble opinion, and I'm not alone on this, it mostly came down to coaching.

Don't get me wrong, in the "nice guy" department, I think Jason Garrett is a class act. But it takes more than a bunch of butt slaps to get players motivated and in the right position to win.

Enter new head coach Mike McCarthy, a no-nonsense take-charge leader who coached the Green Bay Packers to a Super Bowl victory.

Returning are 1,000-yard receivers Amari Cooper and Michael Gallup. The Cowboys also drafted the very talented CeeDee Lamb out of Oklahoma. And don't forget tight end Blake Jarwin, who is expected to have a breakout season.

And of course the Cowboys still have one of the best offensive lines in the league. They lost center Travis Frederick to retirement, but Zach Martin, Tyron Smith, La'el Collins and Joe Looney are there to cover the loss.

On defense, Dallas improved its line by adding run-stoppers Gerald McCoy and Dontari Poe, along with pass-rusher Everson Griffin, to join defensive end DeMarcus Lawrence.


At linebacker, the Cowboys are set with three of the best in the league, Sean Lee, Leighton Vander Esch and Jaylon Smith.

As far as the secondary, Dallas did add veteran Ha Ha Clinton-Dix, along with drafting Trevon Diggs. But the Cowboys have a bunch of unproven young guys who are going to have to step up quickly. The best of the returners are probably Jourdan Lewis and Xavier Woods.

Dallas will have a solid veteran kicker in former Ram Greg Zuerlein, but return one of the worst punters in the league in Chris Jones.

Even with all this talent, the Cowboys' most important addition won't play a single down. McCarthy's experience, especially his decision-making late in games will prove to be the biggest adifference. And for the first time in a decade, the players won't have a "buddy" to lead them, they'll have a proven head coach.

providers, because our goal is to have them not wait beyond 30 days from the day, they request an appointment," she said. "So, with this center, we get to welcome veterans back into our own VA clinics."

Michael Amaral, director of the El Paso VA Healthcare System stated that the northwest

facility is VA's first opportunity to expand the primary care capability in the El Paso market. He said that the new clinic is going to add three new primary care teams, when it becomes fully operational, which should give El Paso's VA healthcare system about 4,000 new patient capabilities.

According to officials, the new clinic will be able to offer area veterans a variety of services including physical therapy,

prosthetics, audiology, mental health care, social work, women's health, lab, and telehealth.

The VA currently operates a 10,000-square-foot primary-care clinic inside the Hospitals of Providence East Campus' medical office building, at 2400 Trawood Drive in East El Paso.

It also operates a 12,500-square-foot primary-care clinic in Las Cruces, which is also part of the El Paso VA system. The Las Cruces clinic is located at 1635

A healthy diet includes omega-3 and omega-6

DEAR DR. ROACH: It seems that eating a healthy diet with an emphasis on nuts and seeds, fruits, vegetables and grains is the best choice for anyone.

It's been well-documented that omega-6 is inflammatory, whereas foods containing omega-3 are not. It seems to me that we should be consuming foods that have more omega-3 in them. The only problem is that, from my research, all nuts and seeds with the exception of chia and flaxseeds have a much higher



ratio of the omega-6 to the omega-3. This appears to be the case with most foods, no matter which food group they are in. How can any of the healthy foods be beneficial when so much more of the "bad fats" are being ingested? – Anon.

Dietary fats are categorized into four groups: monounsaturated, polyunsaturated, saturated and trans-saturated. It is accepted that monounsaturated fats have a healthy effect, reducing heart disease risk, while trans-saturated fats are clearly harmful.

The effect of saturated fats on health is mixed, but those that come from processed meat increase heart disease and diabetes risk. Saturated fat overall has little effect on heart disease risk, but swapping saturated fat with unsaturated fats (both polyunsaturated and monounsaturated) appears to reduce heart disease risk.

Polyunsaturated fats are categorized into the omega-3 family and the omega-6 family. I also have read in many places that omega-6 fats are "bad fats," causing inflammation. The best evidence, a 2014 review of all controlled trials published, showed that omega-6 fats are NOT inflammatory and that they DECREASE risk of heart disease compared with meat-based saturated fats.

We should be consuming both omega-3 and omega-6 polyunsaturated fats, mostly from plant sources. The data support that nuts and seeds are foods we should be eating more of, but we also should be eating good sources of omega-3, including fatty fish, the chia and flaxseeds you mentioned, as well as walnuts and canola oil. Most people have to work harder to get omega-3 oils but get plenty of omega-6.

DEAR DR. ROACH: I have recently started transitioning to a plant-based diet for preventative health reasons. While discussing the benefits of nuts and seeds with a dietitian, they had a disclaimer that flax seed can interfere with medications and to eat them two hours before or one hour after taking medications. I would not sit down and eat a handful of flax seeds, but now I am afraid to use them in the meals I prepare at all. Can you help me make a good decision in using them? – J.E.

For people eating reasonable amounts (like a handful or two) of flax seeds as part of a meal, it is unlikely that they would interfere with medications enough to cause any significant problem, for most medications.

There are two situations that might merit concern: In powerful anti-clotting agents, such as clopidogrel, flax seeds might prompt increased activity. Secondly, flax seeds may lower blood sugar a small amount. In combination with insulin or oral diabetes drugs, the blood sugar could possibly dip lower than expected. I doubt either of these interactions is likely to cause harm, but it is reasonable to discuss with your doctor if you are on one of the classes of medications mentioned.



Scam pharmacist sentenced

Most of us are locked down due to the coronavirus, but apparently the wheels of justice keep on turning.

A few months ago I wrote about a Houston pharmacist, his wife and their pal who scammed the government out of \$21 million in fake pharmacy orders. The guy and his wife have now been sentenced.

Their scam was to whip up medicinal creams and gels that they would mail to injured state and federal employees, then send the bill to the government after their pal created fake prescriptions. The Feds got them for a laundry list of charges, including conspiracy to commit health care fraud, conspiracy to pay and receive kickbacks, 11 counts of health care fraud and three counts of wire fraud dating back to 2009. Many government

departments were involved, including the Department of Veterans Affairs.

The pharmacist, age 75, won't see daylight again for 10 years, and he has to pay back \$12 million in cash and forfeiture. The wife, however, is somehow getting off light. She's 68 and has to pay back pay \$950,000 in restitution and forfeiture, but will serve a mere 30 days in home confinement.

How does that work, one wonders. Due to the pandemic, nobody is going out. Thirty days at home doesn't seem like much punishment since we're all doing it anyway. She pleaded guilty to one charge. Does that play into it, that she admitted her role? And did he get 10 years because he argued against the charges and tried to pass off the medications he was sending out as marketing materials. Then again, maybe her portion of the "forfeiture" had to do with giving up that (very) upscale house in Houston.

Their accomplice is still on the lam. Anoop Kumar Chaturvedi, age 48, is a legal

permanent resident from India. The government wants to find him. If you know where he is, call the Office of Inspector General of the U.S. Post Office at 1-888-877-7644.


