Teen drivers

With teens obtaining driver's licenses during the summer more than any other season and an average of seven teens dying every day from motor vehicle injuries, the personal-finance website WalletHub has released its report on 2021's Best & Worst States for Teen Drivers, as well as accompanying videos and expert commentary. In order to determine the safest and least costly driving environments for U.S. teenagers, WalletHub compared the 50 states based on 23 key metrics. The data set ranges from the number of teen driver fatalities to the average cost of car repairs to the presence of impaired-driving laws. Texas was rated 8th in the report, ranking (1-Best; 25-Avg.):

- 27th – Teen Driver Fatalities per 100,000 Teens;
- 21st – Teen DUIs per 100,000 Teens;
- 1st – Presence of Distracted-Driving/Texting-While-Driving Laws;
- 19th – Vehicle Miles Traveled per Capita;
- 7th – Presence of Occupant-Protection Laws; and
- 1st – Presence of Impaired-Driving Laws.

Escobar, Gonzalez announce re-election bids

EL PASO COUNTY – During the 2020 election, Veronica Escobar, a Democrat, convincingly defeated Republican challenger, Irene Armendariz-Jackson, with more than 64 percent of the vote. And Escobar is confident she can do it again, as she announced recently that she would run for the office of the U.S. Representative for Congressional District 16, which encompasses El Paso County.

The Mexican American congresswoman, who was first elected in 2018, said that she plans to run for a third term in the 2022 mid-term elections. Escobar was the first woman elected to the seat and one of the first two Latinas from Texas to serve in the U.S. Congress. Before being elected a district representative, she served as an El Paso County Commissioner and El Paso County Judge.

Escobar stated that since taking office in 2018, she has consistently prioritized three main issues- reforming immigration laws, expanding healthcare programs, and protecting the environment.

"I'm proud of the work my colleagues in the House and I have accomplished so far," Escobar said in a recent news release. "We've gotten vaccines into arms, put money into peoples' pockets, helped small businesses, and restarted our economy," she stated. "We're cutting child poverty in half, working on addressing the climate crisis, and building an infrastructure bill that will invest in our country and our people," she added.

At the state level, Texas House Representative Mary González is also showing that she too has enduring power

among local political heavyweights as she plans to run for re-election for a fifth term.

González was first elected State House of Representative for District 75 in November 2012. Her district covers parts of El Paso County including Socorro, Horizon City, Clint, Fabens, San Elizario, Tornillo, and the East Montana area.

In a recent public statement, González asserted that during her time in the legislature she has fought hard for

her constituents, raised awareness on key issues, and modeled leadership in authentic and integral ways. And she related that she is excited to be running for re-election.

González stated that in this year's legislative session, she is especially proud of her co-authoring House Bill 103, or the Leilah Hernandez Act, which was signed into law recently by Governor

EL PASO COUNTY – Daniel Eduardo Gamboa, an International Student from El Paso Community College (EPCC), has been accepted to Georgia State University after receiving a 100 percent Transfer Campus Atlanta Scholarship for up to three years of undergraduate studies. He will attend starting fall of 2021 and study Performing Arts.

Gamboa was born in Durango, Mexico and moved to and lived most of his life in Ciudad Juarez. Tornillo Independent School District announced its policy today that this school year, healthy meals will be offered every school day to all students at no cost. Typically, a student's household must meet income eligibility requirements to qualify for free or reduced-price meals. However, the United States Department of Agriculture (USDA) issued guidance that allows schools to offer meals to all students at no cost for the 2021-2022 school year. Each school/site or central office has a copy of the policy, which may be reviewed upon request.


While no application or eligibility determination process is required for your student to receive free meals this school year, the income eligibility requirement will likely resume in the 2022-2023 school year.

What doctors think about the COVID jab

Many patients tell us that their doctors are pressuring them to get the COVID jab. The American Medical Association (AMA) claims that 96 percent of doctors are themselves fully vaccinated. So, if 9.6 out of 10—not a mere 4 out of 5 doctors recommend something, it must be "right for you."

As far as I have heard, the message from state and local medical societies is "take the lead, get your shot, volunteer at a vaccination center, educate your hesitant patients."

There is probably some person with an M.D. degree backing up your employer's threat to fire you, or a college's threat to deny your child an education, or some committee's decision to deny your medical exemption. It might appear that doctors are all "speaking with one voice," as the AMA constantly urges.

Dr. Anthony Fauci, Bill Gates, Joe Biden, Dr. Jill Biden¹, Klaus Schwab, executives at Pfizer and other manufacturers, and the anonymous Big Tech "fact-checkers" all want you to get the jab.

In addition to threats, there are incentives: free French fries in New York City; free ice cream for unaccompanied children in Canada; or a chance to win a scholarship, a firearm, or \$1 million. One medical association offers permission to attend a celebratory "happy hour" (drive there, drink, and drive?).

The Association of American Physicians and Surgeons (AAPS) decided to check out the AMA's 96 percent claim. We recall that the "one voice" has sometimes been wrong, and the four percent right.

It turns out that the AMA's 300 survey respondents² were not inclusive of all doctors. In the AAPS survey³, nearly 60 percent of some 700 respondents⁴ said they were NOT "fully vaccinated." Of these, 80 percent said "I believe risk of shots outweighs risk of disease."⁵

Both physicians and nonphysicians were invited to submit comments about side effects in patients that they were aware of. More than 2,500 did so, and these are available just as entered¹⁶—no screening, editing, or fact-checking. They mention deaths, from heart failure and other causes; an amputated

leg due to blood clots; strokes, paralysis, brain fog, emotional disturbances, and other neurological problems; intestinal inflammation necessitating removal of part of the small intestine; menstrual problems and miscarriages; "several episodes of sky rocketing blood pressure along with flash bang headaches," never experienced previously; flares of previous auto-immune conditions; and much more.

A non-medical professional wrote: "All kinds of adverse reactions that The Media isn't reporting. Doctors are being muzzled and threatened for telling the Truth and caring for their patients." Another wrote: "It would require a book to list all the adverse events occurring now and the deluge of others that will surface in time." One reports that her 87-year-old mother has had unrelenting pain in the injected arm. "Doctor trips yield nothing. The doctor does not know what to do." Reporting that "24 year old healthy female has passed out 7 times after second shot," a nonprofessional asks that with a disease with a 99+ percent survival rate, "Why get experimental shot in first place?"

Bad things happen to people all the time, and sometimes right after they have had a shot. The shot may have had nothing to do with it. But when there is no other explanation, and the reports keep piling up, responsible public health officials will investigate diligently. At some point a harmful program may be stopped, and a product, such as the swine flu vaccine, withdrawn. It might take a long time. It took 5 years⁷ to withdraw thalidomide, approved in Europe as "safe and effective" for all, after somebody noticed the connection to babies being born without limbs.

Remember that your doctor may only see pro-vaccine material and may suffer repercussions from an employer or insurance panel for not meeting vaccine goals. You might ask him some questions, such as what does he think of the first autopsy report⁸ on a COVID-vaccinated patient, who had spike proteins in every organ?

General good advice for life applies here. (1) Don't fall for the hard sell. If you have to sign up immediately (before you look under the hood), or

Trump's huge 2023 decision

Sometime in 2023, Donald Trump will presumably make the most momentous decision by a single person affecting the fate of the Republican Party in decades.

He will decide whether to run for president again, and that will determine who's the frontrunner (Trump, if he's a go) and the contours of the race.

If Trump runs, he will, one assumes, blot out the sun. Everything will be about him – his record, his pronouncements, his animosities. Much of the conservative mass media will get on board, while the mainstream media – inadvertently aiding him, yet again – will be even more intensely hostile.

The choice between this and a more "normal" nomination battle is Trump's alone.

Perhaps not since Dwight Eisenhower turned aside Harry Truman's entreaties to run for president as a Democrat and threw his hat in the ring as a Republican has someone had such "yea or nay" influence over the nation's politics.

Trump's continued sway has been a boon to his most hardcore cadre, but it is a problem for Trumpism, at least if that term is to mean anything more than personal loyalty to

him. In particular, his staying power risks overshadowing and distorting the development of the populist wing of the party, which should be about more than "Stop the Steal" and adherence to one man, even if that man has defied political gravity.

Trump lost last November and contributed more than his share to the Georgia Senate losses that have added trillions of dollars to what Joe Biden can plausibly spend.

He no longer has any formal power, whereas six months ago he could move aircraft carrier groups.

He's off social media and is not nearly as omnipresent on traditional media as when he was holding impromptu press conferences on his way to Marine One.

And yet, his grip on the party has barely loosened, if at all.

Why? Most important, he avoided the stigma of a loser by falsely claiming he really won.

He connected with his voters at a cultural level deeper than any of his policies, creating an enduring bond.

His voters still think he's the only one who truly gets the threat from the left, and the only one willing to fight with the requisite

ferocity.

Finally, they think Trump is being persecuted by social media companies and worry they could be next.

The lesson of the defenestration of Liz Cheney is that you can't run headlong into these sentiments and expect to survive in leadership.

Mitch McConnell, who has made his disdain for Trump clear, has taken the more prudent course of declining to elaborate on his well-known views, and isn't going anywhere.

But there's no doubt that what it means to be a populist in the Trump mode is overly determined by Trump himself.


Until recently, Elise Stefanik was a moderate Republican from New York state. She became the alternative to Cheney for the party's populists by toeing the line on Stop the Steal, an issue that isn't liberal, conservative or populist, but pure Trump.

The Trump effect is stark in Ohio Republican politics. One would think Rep. Anthony Gonzalez, a featured speaker last year at an event of the populist policy shop American Compass, would have more populist credibility than Senate primary candidate Josh Mandel, a run-of-the-mill establishment

Republican. Yet Gonzalez voted to impeach Trump, so Mandel is earning populist points by calling him a "traitor."

On the other hand, another likely Senate candidate, J.D. Vance, who represents a sincere, thought-through populism, will have to answer for his lack of enthusiasm for Trump in 2016.

If Trump does decide to run, even if he's less dominant than advertised, he'll squeeze out potential candidates like Missouri Sen. Josh Hawley, who are most determined to run as his direct successors.



They, like most everyone else in the party, will have to hold their breath until Trump comes down one way or the other in 2023.


Currently, González' legislative assignments are vice chair of the state house appropriations committee and a member of the public education committee. She is also vice chair of the Mexican American Legislative Caucus of the TX House of Representatives and is the first chair of the Texas House LGBTQ Caucus.

The Clint, TX native is the first openly LGBTQ woman to serve in the Texas Legislature. She is also the first openly pansexual elected official in the U.S., according to her office.

THE HISTORY CHANNEL

• On July 5, 1865, in London, revivalist preacher William Booth and his wife, Catherine, establish the Christian Mission, later known as the Salvation Army, to wage war against the evils of poverty and religious indifference. The Army currently works in 75 countries.

• On July 6, 1957, Liverpool teenagers John Lennon and Paul McCartney meet for the first time. Lennon was a member of the Quarry Men, scheduled to play at a public event. Two weeks later, Lennon invited McCartney to join the band.

• On July 7, 1983, Samantha Smith, an 11-year-old American girl, begins a two-week visit to the Soviet Union at the invitation of Soviet leader Yuri Andropov after she wrote him a letter as part of a school project.

• On July 8, 1776, a 2,000-pound copper-and-tin bell now known as the "Liberty Bell" rings out from the tower of the Pennsylvania State House (now Independence Hall) in Philadelphia, summoning citizens to the first public reading of the Declaration of Independence. In the fall of 1777, the bell was hidden in Allentown to save it from being melted down by the British and used to make cannons.

• On July 9, 1993, British forensic scientists announce they have positively identified the remains of Russia's last czar, Nicholas II, his wife and three of their daughters. The scientists used mitochondria DNA to identify the bones, which had been excavated from a mass grave near Yekaterinburg in 1991.

• On July 10, 1962, the U.S. Patent Office issues Swedish engineer Nils Bohlin a patent for his three-point automobile safety belt. The traditional two-point belt had been known to cause severe internal abdominal injuries in a high-speed crash.


checking account. He has told her she will have to sell her house to cover the costs of her nursing home care.

Ohtani having the greatest baseball season... in history

The Major League Baseball season's annual All-Star game is coming up this week, which means the regular season is about 60 percent complete.

That means that every team has played about 90 games. These are enough games into the season to determine who the frontrunners are for the MVP awards.

In the American League, as usual, the MVP frontrunner belongs to the Los Angeles Angels.

The only difference is that we're not talking about Mike Trout.

Well, to be totally honest, Ohtani is having a season like no other player has had in the 150-year history of Major League Baseball.

As of last weekend, Ohtani led the majors with 30 homeruns.

He was also in the top ten in runs batted in, runs scored, triples, total bases, slugging percentage and he was even

tied for 12th in the league with 12 stolen bases.

That's just him hitting, on the mound he has started 12 games with a record of 3-1. He has an earned run average of 3.60 and he has 83 strikeouts in his 60 innings pitched.

He is one of the best hitters in the entire league and he is the best starting pitcher on the Angels' staff. All this is completely unheard of.

And the craziest thing of all is that almost nobody knows about him. This shows you how terrible professional baseball is at promoting its sport.

Here they have a 26-year-old Japanese player who is redefining the way the game is played and MLB is sitting on its hands, again.

It's funny – in little leagues across the country – the best player is the pitcher who also plays in the field and bats during every game.

But for some unknown reason, once they get older they are told that they can't hit anymore and have to concentrate solely on pitching.

Bo Jackson proved that an athlete could not only play two professional sports at the same time, he proved that an athlete could be an all-star in both at the same time.


Ohtani is proving once and for all, that pitchers can also be baseball players.



Dust mite allergy triggers cough

DEAR DR. ROACH: For months, I have had a persistent cough that I have been unable to get help with. I saw an allergist about three years ago and was told I am allergic to dust mites. I was first referred to a lung doctor where X-rays showed that my cheek sinus drains were completely blocked, and then to an ear, nose and throat doctor, who also confirmed this diagnosis. This ENT doctor recommended I have surgery to unblock the drains and clear out the sinus area. I understand that sinus drainage can cause coughing and wonder if this would still make me cough. I sometimes cough until I can cough up something, and this seems to stop my cough for a while. I was using a nasal rinse for a while until about two weeks ago when it caused my nose to bleed. The ENT doctor prescribed antibiotics and oral steroids that did not make any difference. It doesn't seem to make any difference whether I'm home or sitting in the doctor's office, I'm still coughing. What is the best way to deal with dust mite allergy? – J.S.



There are many causes of chronic cough, but postnasal drip is at the top of the list. Dust mites are indeed a common allergen, and symptoms may include runny nose, watery eyes, sneezing and cough from postnasal drip. Specific treatment for dust mites should include physical barriers, such as covers for pillows and mattresses, and sometimes for other soft surfaces, like furniture cushions, but this is only part of an effective strategy. Removing as many fabrics as possible (draperies, carpets, stuffed children's toys) where dust mites can live is essential. Regular cleaning is necessary, and high efficiency particulate air (HEPA) filters for vacuuming have been shown to reduce dust mites. A low-humidity environment can be very effective in discouraging dust mites, and cooler air – especially at night – can reduce irritation of nasal passages caused by dry air. Many interventions for a prolonged period are necessary to reduce dust mite infestation and the symptoms associated with them.

This is critical, because the issue of the sinuses is probably secondary to ongoing allergic exposure. Fixing your sinuses will not fix your ongoing symptoms. Without control of the allergens, you will continue to have symptoms and may even develop sinus blockages again, no matter how good a job the surgeon does on your sinuses.

DEAR DR. ROACH: I am 90 years old. My husband and I donated blood as often as needed, over 100 times, but last week my doctor said I tested positive for syphilis. I about fell off my chair. I haven't slept for four nights. Have you ever heard of this? – E.

The screening test for syphilis, called the VDRL or RPR test, is not particularly accurate. About 1-2% of people will have a false positive result. Meaning, the test is positive but they do not have syphilis. There are many possible causes, such as infection and autoimmune disease, like lupus, but some people, particularly older people, will have a positive test for no identifiable reason.

In your case, I am sure it is a false positive, but your doctor may do a more specific test, such as an FTA-ABS, to be 100% sure. You shouldn't let it keep you awake at night.

Blue Water Navy and Agent Orange claims

One of the first lawsuits brought against the Department of Veterans Affairs for benefits for veterans who were exposed to Agent Orange was in 1986. At issue in *Nehmer v. U.S. Department of Veterans Affairs* was the fact that the only medical condition acknowledged by the VA was chloracne... a very serious skin condition caused by exposure to dioxins and dibenzofurans. It's been a very long haul since then to get the VA to acknowledge (and pay for) other damage done by Agent Orange.

The Nehmer Law was created for veterans, spouses, children and parents of any Vietnam veteran who should have received exposure benefits but didn't. Since

1991, the VA has paid out billions of dollars in AO exposure benefits for diabetes, ischemic heart disease, Parkinson's disease, cancers and more, but they've resisted every step of the way.

In November 2020, attorneys went back to court to force the VA to address the exposure suffered by Blue Water Navy veterans who literally drank, breathed and showered in AO while on ships in the harbor. The Blue Water Navy Vietnam Veterans Act of 2019 extended the presumption of exposure to include more than aboard-ship service.

Now, thanks again to Nehmer, the VA is required to readjudicate any denied Blue Water claims. The reviews started in April. No new claim is required, and any changes to claims are supposed to be automatic. It applies not only to veterans, but their survivors as well. Still at issue is whether the VA will pay retroactively for denied claims.


