#### **Energy costs**

With around 27% of American households are having difficulty meeting their energy needs, the personal-finance website WalletHub has released its report on 2022's Most & Least Energy-Expensive States, as well as accompanying videos and expert commentary. To better understand Americans' energy costs relative to their location and consumption habits, WalletHub compared the average monthly energy bills in each of the 50 states and the District of Columbia using a special formula that accounts for the following residential energy types: electricity, natural gas, motor fuel and home heating oil. Texas was rated 6th in the report, ranking (1-Most Expensive; 25-Avg.):

- Avg. Monthly Energy Bill: \$416
- 33rd Price of Electricity
- 22nd Price of Natural Gas
- 45th Natural-Gas Consumption per Consumer

Over the holiday weekend, the president slammed gas stations for the purported sin of prices to motorists.



Atlanta with minimal provisions. Needless to say, it was an extra unplanned expense.



# San Elizario Independent District SPECIAL EDUCATION/CHILD FIND

The San Elizario Independent School District provides services for children who are eligible for special education. Eligible special education students will be afforded a free, appropriate public education beginning on their third birthday and continuing through their 21st year. Children who are identified as auditorially impaired, visually impaired or deaf-blind may be served from birth through 21 years of age. The San Elizario Independent School District provides special education and related services to students residing within the District boundaries. A student with a disability must meet eligibility guidelines in one or more areas including physical disability, intellectual disability, emotional disturbance, learning disability, autism, speech impairment, traumatic brain injury, visual or auditory impairment. This impairment must significantly affect the student's ability to progress adequately without support services.

If a child is experiencing learning difficulties, the parent may contact the person listed below to learn about the district's overall general education referral or screening system for support services. This system links students to a variety of support options including referral for special education evaluation. Students having difficulty in the regular classroom should be considered for tutorial, compensatory, and other support services that are available to all students. At any time, a parent is entitled to request an evaluation for special education services. Within a reasonable amount of time, the district must decide if the evaluation is needed. If the evaluation is needed, the parent will be notified and asked to provide consent for the evaluation. The district must complete the evaluation and the report within 45 school days of the date the district received the written consent. The district must give a copy of the report to the parent. If the District determines that the evaluation is not needed, the district will provide the parent with a written notice that explains why the child will not be evaluated. This written notice will include a statement that informs the parent of their rights if they disagree with the district. Additionally, the notice must inform the parent how to obtain a copy of the Notice of Procedural Safeguards-Rights of Parents of Students with Disabilities.

# Educación Especial / Programa De Identificación De Niños (Child Find)

El Distrito Escolar Independiente de San Elizario provee servicios a los niños que califican para recibir educación especial. Los estudiantes que califiquen recibirán una educación pública gratuita y adecuada comenzando con su tercer cumpleaños hasta el fin de su vigésimo-primer año (21). Los niños que son identificados con problemas auditivos, visuales, sordos o ciegos pueden ser atendidos desde su nacimiento hasta los veintiún años de edad. El Distrito Escolar Independiente de San Elizario provee servicios de educación especial y otros servicios relacionados a los estudiantes que vivan dentro de los límites del distrito. Un estudiante con una discapacidad debe cumplir con las guías que reúnen los requisitos en una o más áreas incluyendo: discapacidades físicas, discapacidad intelectual, alteraciones emocionales, discapacidad de aprendizaje, autismo, discapacidad del habla, daño cerebral por trauma, o discapacidad visual o auditiva. Esta discapacidad debe afectar significativamente la habilidad del estudiante para progresar adecuadamente sin asistencia.

Si un alumno está teniendo dificultades en su aprendizaje, los padres pueden contactar a la persona encargada (ver información al final) para que les informe acerca del programa general de derivación (referral) del distrito o sistema de detección para servicios de asistencia. Este sistema enlaza a los estudiantes con una gran variedad de opciones de apoyo que incluyen la derivación para que se le practique una evaluación de educación especial. Los estudiantes que estén teniendo dificultades en un aula regular deber ser considerados para recibir tutoría, planes de compensación educativa y otros servicios de apoyo que estén disponibles para todos los estudiantes. Los padres tienen derecho, en cualquier momento, de pedir una evaluación para recibir servicios de educación especial. El distrito debe decidir, dentro de un plazo razonable, si dicha evaluación es necesaria. En caso afirmativo, el padre será notificado y se le pedirá permiso para realizar la evaluación. El distrito debe llevar a cabo la evaluación y el reporte sobre los resultados dentro de 45 días escuela a partir de la fecha en que el distrito recibió el permiso del padre por escrito. El distrito debe proporcionar una copia del reporte al padre. Si el distrito determina que la evaluación no es necesaria, debe proporcionar por escrito una notificación que explique el por qué. Esta notificación por escrito debe incluir una declaración que informe al padre sobre sus derechos si es que no está de acuerdo con la decisión del distrito. Además, la notificación debe informar al padre cómo obtener una copia del Aviso sobre Garantías Procesales-Derechos de los Padres de Alumnos con Discapacidades.

# Moments in time THE HISTORY CHANNEL

- On July 11, 1922, the Hollywood Bowl, one of the world's largest natural amphitheaters, opens. Its stagewasawoodenplatform with a canvas top, and audiences sat on moveable benches set on the hillsides of the surrounding canyon. In 1926, a group of Los Angeles architects built the Hollywood Bowl's first shell.
- On July 12, 1957, Dwight D. Eisenhower becomes the first president to ride in the newest advance in aviation technology: the HMX-1 Nighthawk helicopter, administered jointly by the Army and the Marine Corps.
- On July 13, 1960, Senator John F. Kennedy of Massachusetts is nominated for the presidency at the Democratic Party Convention. Four months later, on Nov. 8, Kennedy won 49.7% of the popular vote, edging the 49.6% received by Richard M. Nixon, a Republican.
- On July 14, 1789, Parisian revolutionaries and mutinous troops storm and dismantle the Bastille, a royal fortress built in 1370 that had come to symbolize the tyranny of the Bourbon monarchs. This dramatic action signaled the beginning of the French Revolution.
- On July 15, 1606, the great Dutch master Rembrandt van Rijn is born in Leiden.
   Rembrandt completed more than 600 paintings, many of them portraits or self-portraits. By the age of 22, he was accomplished enough to take on his own students.
- On July 16, 1935, the world's first parking meter, known as Park-O-Meter No. 1, is installed in Oklahoma City, Oklahoma. Indignant opponents of the meters considered paying for parking un-American, as it forced drivers to pay what amounted to a tax on their cars without due process of law.
- On July 17, 1975, as part of a mission aimed at developing space rescue capability, the U.S. spacecraft Apollo 18 and the Soviet spacecraft Soyuz 19 rendezvous and dock in space. During the 44-hour Apollo-Soyuz embrace, the astronauts and cosmonauts conducted experiments, shared meals and held a joint news conference.

We recently traveled to Baltimore and stuck with Taxis. We saved quite a bit because we didn't pay for a rental car and we didn't have to pay parking fees at the hotel.

I don't like to fly in storms. I do want the airlines to make my safety a priority. I would rather arrive late than never. Just be aware that in the age we currently live in flying can be frustrating.



### Chest CT can't replace screening mammogram

DEAR DR. ROACH: I am due to have a mammogram in July, but around the same time I am supposed to have a chest CT as a follow-up

to my chondrosarcoma cancer. I have a CT every other year, and an X-ray on the opposite years of both my affected arm and my lungs. Does a chest CT have the potential of showing a similar finding as a mammogram? I would just as soon not have to expose myself to so much radiation all in one month. I'm 66. There is a history of postmenopausal



breast cancer in my family, in my mother's mother. – T.M.H.

A mammogram is an X-ray that is designed specifically to look for abnormalities in breast tissue. Mammograms have been extensively studied and proven to reduce mortality in women between the ages of 50-74 (outside these ages, there remains extreme controversy).

CT scans are X-rays taken from many angles and then reconstructed in a computer to provide a look at many slices of the part of the body being looked at. A CT scanner can be set to emphasize bones or soft tissue, and work is ongoing now with CT scans designed specifically for breast abnormalities. The CT scan you get as follow-up to your chondrosarcoma (a rare cancer of cartilage) is designed to look in lung tissue for abnormalities and has not been evaluated as a means of screening for breast cancer, although I do know that some may be found anecdotally.

The CT scans you get as a part of your cancer follow-up are not an adequate substitute for ongoing mammography, which is particularly important in your case due to a family history. I do understand the concern about radiation, but a mammogram has very little radiation - approximately the same you would get from naturally occurring radiation sources in seven weeks of walking around.

DEAR DR. ROACH: I read a news report that vasectomy increases risk of prostate cancer. Should men avoid this procedure due to *concern for prostate cancer? – T.S.V.* 

Several studies have looked at this possibility, and the results are conflicting. A 2014 study of about 50,000 U.S. men showed an increase of about 15% in the risk of fatal prostate cancer, but a 2016 study of 360,000 U.S. men showed no increase in risk. In June 2019, a study of over 2 million Danish men showed a 15% increase in overall prostate cancer risk. To put the risk in perspective, about 500 men would need to have a vasectomy for one additional man to get prostate cancer, in the Danish study. It is not clear that the vasectomy caused the prostate cancer.

It is possible that there is something about men who choose vasectomy that puts them at higher risk to begin with; however, the authors were unable to find a known risk factor to support that possibility.

Even if vasectomy does lead to an increased risk of prostate cancer, it still has similar or lower overall risk than other forms of birth control, and is a good choice for a man who is absolutely sure he does not want to father any more children, as a vasectomy should be considered permanent. Attempting reversal is possible, but there is no guarantee of success.




